





# Mayoral candidates meet for first public forum

Business growth, infrastructure, labor unions among topics discussed

Springfield needs to create a more "business-friendly" permitting process for construction and improvement projects, and the city should spend more of its money to fix streets, sidewalks and sewers, mayoral candidate Misty Buscher said at a Jan. 25 debate with incumbent Mayor Jim Langfelder.

"We need to streamline our services in city hall," Buscher, 52, the elected city treasurer for the past almost eight years, said at the mayoral candidate debate at the Hoogland Center for the Arts.

The debate was sponsored by *Illinois Times*, *Springfield Business Journal*, Midwest Family Broadcasting and the Greater Springfield Chamber of Commerce.

Langfelder, 63, is seeking a third consecutive four-year term in the April 4 election for a job that pays \$130,800 annually. He told the debate audience of more than 300 people that his administration, with the help of federal COVID-19 relief dollars, has put the city in its best financial shape ever after weathering a two-year state budget impasse under former Republican Gov. Bruce Rauner and amid the current three-year-long COVID pandemic.

"During this unprecedented time, I continued city services while protecting our workforce, with zero layoffs or furloughs," Langfelder said. "We did over \$50 million of infrastructure improvements (and) provided \$1.5 million in utility assistance to struggling businesses and residents."

Buscher said she would have devoted more COVID relief funds to the city's crumbling infrastructure. "Infrastructure has been ignored in our community for way too long," she said.

If elected, she said she would put in place an all-online system for permitting and business plan submissions.

Businesses say the city is "difficult to do business with," Buscher said. She didn't fault city employees.

"It's the system in place," she said.

Buscher said she would create a position for a city employee who would keep applicants updated on the status of their permits and plans.

"Currently, we have to have the public search with us and call us and leave messages to find out where that process is," she said.

Langfelder touted the current computer system that helps keep track of city permitting requests, though the mayor said he is "listening to our business community ... to make our services better."

The candidates commented on a variety of issues as they answered questions submitted

by audience members and posed by debate moderator Bernard Schoenburg, a retired *State Journal-Register* political reporter and columnist.

POLITICAL LEANINGS: Buscher, a self-described moderate Republican seeking one of the city's officially nonpartisan elected posts, attended a rally that Donald Trump held in Springfield in November 2015 after the Sangamon County Democratic Party endorsed her initial successful bid for city treasurer that

Buscher said at the time that she thought Trump would bring a "refreshing change," and that his presidential candidacy helped move her from being an independent to a Republican.

"I voted for the candidate who I thought was going to bring new jobs, job creation, corporations, back to our states," she said. "I came from a finance background, and it was important to me that we had jobs back in our community. ... That person did not govern the way I thought they would."

Buscher said she has Democrats and Republicans "on my team." But she wouldn't say who she voted for in the 2020 presidential race when Trump lost to Joe Biden. She also wouldn't say who she voted for when Democratic incumbent Gov. JB Pritzker defeated Republican challenger and state Sen. Darren Bailey in 2022.

Langfelder in 2016 didn't make a preelection endorsement in the governor's race when Pritzker unseated incumbent Republican Gov. Bruce Rauner in 2018, but he said he voted for Pritzker in 2018 and 2022. Langfelder said he is a moderate "Kennedy Democrat." He said he voted for Biden in 2020. When asked whether he would vote for Biden again in 2024 if Biden runs, Langfelder said, "I would have to wait and see."

#### RELATIONSHIP WITH CITY COUNCIL:

Buscher said she would work to mend relations with, and communication between, the mayor's office and the 10 alderpersons when it comes to matters in front of the council. The mayor casts a potentially tie-breaking 11<sup>th</sup> vote on the council.

Council members "seem to go on a fact-finding mission on most Tuesday nights," Buscher said. "We need to communicate as an administration what's on the agenda, why it's on the agenda, and answer their questions. ... I want our aldermen to be empowered to do their job. They are the people who touch our citizens every day."

Langfelder said he has a "good relationship" with the council that has benefited the city, though he said during the forum that the council blocked some initiatives he favored.

He alluded to a report from Business Insider, a New York-based business and financial news website, that in 2020 proclaimed Springfield the best city in America to live after the COVID-19 pandemic. "We've done that by keeping the council together, as well as our community, during these very challenging and difficult times for all of us," Langfelder said.

"Direct communication" with the mayor's office is always available to council members, he

said. He added that his deputy mayor calls each council member every week about upcoming agenda items, and there's a council coordinator who can assist members as well.

#### **RELATIONSHIP WITH LABOR UNIONS:**

Langfelder said union leaders aren't supporting him this election cycle, which is surprising to many rank-and-file members. But he said he has a good relationship with unions and supports project labor agreements on city-funded projects.

Buscher received more than \$25,000 in campaign contributions from labor unions in the fourth quarter of 2022, including from Laborers Local 477 and unions representing iron workers, plumbers and sheet-metal workers.

"My relationship with unions is, I'm a woman of my word, and the unions know I'm a woman of my word," she said.

She said the city hasn't done a good enough job enforcing project labor agreements and prevailing-wage rules. "Labor knows that I will enforce the rules we have on the books, and that's all they're asking for," she said.

**ATTENTION TO THE EAST SIDE:** Buscher said the city needs to spend more, and pay more attention to, improving the care of streets, curbs and sidewalks on the east side, where poverty rates are higher than in most of the city.

Langfelder said he has worked to improve the east side, pointing to council approval of, and city assistance for, the scheduled \$38 million redevelopment of the Poplar Place housing site by owner Chicago-based Related Midwest.

**NEW BUSINESS PREFERENCE**: When asked what kind of new businesses he would like to see come to Springfield, Langfelder said he would prefer to "retain what you have and build upon it."

He said the city already is working with the health care community to expand and complement its footprint. "You do that across all our industries, with regards to education, energy, and really assess what we have and what would build upon their important assets," he said.

Buscher said she wants to attract more businesses in the technology sector. "I have a 28-year-old who works in tech, and we have no jobs in Springfield for her, none. That's a problem if I want my daughter to live in the town I live in."

# City TIF administrator on leave following arrest

Amid a mayoral candidate's criticism that Springfield isn't doing enough to promote economic development, a city employee described as the face of those efforts is facing a misdemeanor charge that he violated an order of protection against his estranged wife.

Ravi Doshi, business projects manager and tax-increment financing administrator in the city's Office of Planning and Economic Development, is on a "family leave" following his Dec. 28 arrest by Springfield police.

He was released from the Sangamon County Jail on his own recognizance the next day while the misdemeanor case proceeds. He has pleaded not guilty.

Doshi, who isn't represented by one of the unions covering city workers, didn't return a phone call seeking comment.

Mayor Jim Langfelder said he was aware of Doshi's arrest and expected Doshi to return from family leave sometime in February.

Langfelder said the case against Doshi was part of a "messy divorce situation." The mayor referred further questions about Doshi's status to Lynne Wooden, acting director of the economic development office.

Wooden declined to answer questions about Doshi, referring an *Illinois Times* reporter to city human resources acting director Ronald Cook. Cook said Doshi remains a city employee, and in late 2022 or early 2023 began to take up to 12 weeks of unpaid leave as part of the federal Family and Medical Leave Act. Cook said Doshi can opt to use accumulated sick time and vacation time to avoid going without pay.

City Treasurer Misty Buscher, who is challenging Langfelder's bid for a third consecutive four-year term in the runup to the April 4 election, said at a mayoral candidate debate Jan. 25 that the city needed to become more "business-friendly" to attract and retain more employers. Langfelder took issue with Buscher's statement.

Wooden's own employment situation could change in coming months. The 64-year-old former banker said she isn't sure how long after the April 4 election that she will remain with the city.

Wooden is paid \$105,525 per year and was hired by Langfelder in July after OPED had gone without a director since Langfelder fired Val Yazell in spring 2021.

The mayor said he is able to hire acting department directors for a year before they

require council approval. He said in July that he wouldn't ask the council to approve Wooden until after the April election. Before she joined city government, Wooden retired from banking in June after 10 years at INB.

Wooden said last summer that she didn't expect to be a long-term municipal employee, and she said on Jan. 31 that her plans haven't changed. But she said she hasn't set a date to retire from her city job.

Doshi, 36, has worked for the city since August 2021 and earns \$69,000 a year, according to city records. He previously worked for Gateway Foundation as a counselor, working with men who had substance-use disorder.

The criminal charge against Doshi, which carries a potential penalty of up to one year in jail, says he violated a protection order obtained by Alexa Doshi when he contacted her "by electronic means" on Dec. 23.

Alexa Doshi, 27, filed for divorce against Ravi Doshi on Nov. 10, citing "irreconcilable differences." They have three children, ages 7, 5 and 2.

Sangamon County Associate Judge Jennifer Ascher granted Alexa Doshi an emergency order of protection on Nov. 9. In her request for the order, Doshi said her husband has "a history of drug and alcohol abuse, but has claimed to be sober."

In early November, after Alexa Doshi had left the couple's Springfield home with the children, she said in the order of protection request that her husband "admitted he is still drinking" and that she fears for her safety.

Alexa Doshi said in the request that police found her husband "drunk and unconscious" at home on Nov. 7 after not showing up at work for a week. She said he was taken to a hospital after police had to "break the front door to get into the house."

The Springfield City Council, which approves the hiring of permanent department directors but not the people who work under those directors, hasn't been informed by the mayor's administration about Doshi's arrest or family leave, Ward 6 Ald. Kristin DiCenso said.

"I think we should have been informed of this, at a minimum," DiCenso said. "Many on the council work with Ravi frequently, and we're baffled by his absence. I've been through a divorce. ... It's a private matter until something like this happens. I can understand

how emotions can run high, but this is a serious situation. That we were kept in the dark about it is concerning at best.

"Ravi has been the face of OPED,"
DiCenso said, noting that it's her
understanding Doshi has been away from work
for about a month. "We should have been
notified he was on leave, at the very least."

When asked why Langfelder didn't inform the council, he told *Illinois Times* that it was a "personnel matter. ... I don't know how that normally works."

Ward 8 Ald. Erin Conley, who, along with DiCenso has been a critic of Langfelder, told *Illinois Times* the lack of information from the administration is frustrating. "They don't tell us anything about anything," she said.

Conley said she "has some concerns" about Doshi returning in the wake of the misdemeanor charge.

"There needs to be some thoughtful conversations" about "where and how he works," Conley said. "It's a very public-facing office. When you're paid by tax dollars, you should be held to a higher standard." Ward 2 Ald. Shawn Gregory said he was aware Doshi wasn't at work but didn't know that Doshi had been arrested. At the council's committee of the whole meeting Jan. 31, Gregory commended Doshi's work in administering the city's first round of business grants in 2022 that were funded by the city's share of taxes from the sale of recreational cannabis.

Gregory said the "whole team" in the economic development office – a department of about 10 people – "does a great job."

After the meeting, Gregory said he looks forward to Doshi returning.

"The type of energy that that young man brings is what we need in economic development," Gregory said. "He was a bright mind, we bounced things off each other. He would go out into the community, go sit down with the people, help them with their paperwork, meet with different stakeholders. He was really, really doing a great job.

"I'm going to support him," Gregory said. "I've made plenty of mistakes." □

# **Debt disagreement**

Mayoral candidate wants to publicize list of businesses, individuals who have had debt forgiven

Springfield City Treasurer Misty Buscher, who is running for mayor, is calling for greater transparency when the city forgives debts or waives fines.

She contends that her opponent, incumbent Mayor Jim Langfelder, is unilaterally writing off debts without informing the council or the public. The mayor responded that is not the case.

"I'm not saying he's doing anything illegal. I'm just saying it's not a good way for the city to operate," she said. Buscher is calling for passing an ordinance that requires greater disclosure of forgiven debts and would require Springfield City Council approval before larger amounts are written off.

She noted that \$243,068 in utility charges owed the city by the owner of the Wyndham Springfield City Centre were written off by the mayor without first getting the approval of the City Council.

But Langfelder said the matter was discussed in closed session with the entire City Council before a compromise was reached with the hotelier who owed City Water, Light & Power.

"The consensus was to get as much as possible. The hotel potentially might go into a foreclosure or worse," said Corporation Counsel Jim Zerkle.

Langfelder said the hotel fell on hard times because of reduced occupancy during the COVID pandemic.

Some of what was owed the city was written off, but the city was able to recoup about \$1.2 million, Zerkle said. He said after the mayor and City Council members reached a consensus on how to proceed, city staff negotiated with the developer.

Zerkle said it would not be accurate to say the mayor acted alone.

But Buscher said there are other examples where substantial amounts of money owed the city have been waived without the knowledge or consent of council members. She cited two cases in the last year where property owners with poorly maintained buildings had \$42,000 and \$45,265 in fines waived.

But Zerkle said in the case of housing violations, city staff will often use the threat of the accrued fines as a means of

encouraging property owners to make the necessary repairs. Once the property is up to code, the fines are often waived, he said.

Langfelder said he does not personally involve himself in such cases.

Buscher said she would like to reveal the names of those who have had what they owed the city written off, but she has been told by Zerkle not to do so. A Freedom of Information Act request filed by Illinois Times for a list of all people and businesses with debts forgiven by the city in 2022 had not yet been responded to by press time.

Buscher said she believes the public has the right to know the identities of those catching fiscal breaks from the city. But Zerkle said he believes this sometimes could be interpreted by the courts as an unwarranted disclosure of private information.

He added he believes names can only be revealed if the matter has been litigated in court. Buscher said she disagrees.

Buscher said she has spoken to several council members about introducing an ordinance modeled after one in Bloomington that would require a monthly report disclosing all litigation settlements as well as waivers of claims or collections.

The report would not only be available to elected officials but the general public,

Langfelder said he would not be opposed to such an ordinance but said there is nothing to keep Buscher's office from generating such a report now.

Buscher disagreed, saying that she does not have access to all settlement information from the corporation counsel

She believes no debt greater than \$10,000 should be forgiven by the city without first being approved by the City

"It should be transparent whose debt is forgiven," she said. "As a taxpayer, I don't think this is right. Some of my friends, who are business owners, have been really upset that this kind of debt was forgiven for a business owner." □

# City council ponders a ban on electric surfboards

Matt Scherer got a loan from the city to start a new business. Now some city council members are trying to ban it.

A group of Springfield city council members are looking to foil the hydrofoil.

The hydrofoil in question is owned by Matt Scherer, an entrepreneur who wants to offer electric surfboard lessons on Lake Springfield.

Scherer said he took out a \$27,000 loan from the city of Springfield to start the business but now the city's council members are eyeing outlawing the watercraft at the city's lake.

According to *Surfer Today*, electric surfboards are specially designed boards powered by lithium-ion batteries that allow riders to glide across any water body at high speeds. They are equipped with an electric jet-propulsion system activated by a wireless handheld remote control and don't rely solely on the energy of waves to gain speed.

Scherer, who is a city firefighter, purchased the surfboard and began offering lessons last summer on Lake Springfield as well as lakes in Decatur and Clinton.

In order to drum up interest in the endeavor, he said he rode the watercraft throughout Lake Springfield, and this apparently angered folks with homes on the lake as well as nearby clubs.

"I guess this all started on the California coast or something, but it's a new product for Illinois," said Ward 1 Ald. Chuck Redpath, who is sponsoring the ordinance to ban such devices. "So here in Illinois, they're not even on their radar yet. Our CWLP people did some research and found out that there is a high capacity of accidents and things like that.

"And we're pretty concerned with the safety of them. We've had a lot of calls from homeowners and from homeowners' associations who are obviously opposed to them. I've also had calls from people that are in the council of clubs out at the lake who believe this is a too dangerous situation."

City Water, Light and Power administers Lake Springfield.

The ordinance banning electric surfboards was to be voted on Jan. 30, but Redpath temporarily pulled it from the agenda and expects it to return for a vote this month.

Scherer said he has repeatedly sought to discuss the matter with Redpath but said the alderman has not returned any of his calls.

He said he is willing to work with members of the city council to restrict the use of the electric surfboards to certain coves or to make other compromises.

He added some of the information provided to council members about the personal watercraft is inaccurate. The accidents that they have been informed about involve surfboards pulled behind motorboats — not self-powered ones like he uses, Scherer

Scherer said he remains perplexed as to why the city would have provided him with a low-interest loan to start the business if it did not want him to operate the watercraft on the lake.

"Well, I was perplexed by it, too," Redpath said. "We had no idea the mayor did this. He has spending authority up to \$50,000 that he can use without city council approval. And I don't know that the mayor realized the whole extent of this vehicle that he wants to put on the lake. I have brought it to his attention and CWLP has talked to the mayor about it, too. So, I think it slipped through cracks." □

# Opening doors to home ownership

Down payment assistance helps renters become buyers

Down payment assistance is on its way to low-income homebuyers through the Illinois Housing Development Authority. The program will be part of \$75 million in federal funds designated for IHDA by the Illinois General Assembly in legislation which went into effect Jan. 24. The money will allow IHDA to resume the popular "Opening Doors" program, which provides a forgivable down payment loan of up to \$6,000 to qualified buyers. The loan is forgiven over the course of five years.

The program is rooted in the concept that increased home ownership leads to healthier neighborhoods and healthier neighbors.

In a 2018 study for the U.S. Census Bureau, professors William M. Rohe and Mark Lindblad at the University of North Carolina Chapel Hill found that high rates of home ownership lead to lower crime rates, greater involvement in civic activities, better psychological health and better performance by children in school. The study also found that low home ownership rates correlate with low marriage rates.

Fred Weber, a mortgage broker at Flat Branch Home Loans in Springfield, sees a lot of renters who want to become homeowners. He spends much of his time educating renters about how they can change from paying a landlord's mortgage to paying their own.

"Many people who qualify for mortgages don't realize that they do," he says. "In fact, many renters face stricter financial requirements from landlords than they would from a mortgage lender." He emphasizes that potential buyers don't need perfect credit, they don't need a lot of money for a down payment, and they don't need to be in the same job for an extended period of time. "We have a policy



of never saying 'no' to someone who wants to buy a home. If they don't qualify today, we give them guidance about what they need to do in order to qualify in the future." Weber says he's closed many loans for clients who didn't qualify initially.

One of the biggest benefits of home ownership is the ability to pass along generational wealth. The Federal Reserve Board concluded in a 2019 report that for most families, a home is by far the most valuable asset that they own. On average, equity in the home amounts to about 90% of family wealth for those households with a mortgage and less than \$100,000 in income. As a result, the median net worth of renters nationwide is \$6,300 while the median for homeowners is \$255,000. This disparity disproportionately affects communities of color. According to the 2019 report, the median net worth of white families was \$188,200 in 2019, while black families, who are about 60 percent as likely to own a home, have a median net worth of

\$24,100

The United States Census Bureau pegs average rent in Springfield at \$861 per month, a monthly payment that will support a 30-year, fixed-rate mortgage at 7.0% for about \$90,000, taxes and insurance included, with about \$120 a month set aside for maintenance. Most days there are dozens of homes available in Sangamon County at this price or less. Many renters have the financial means to service a mortgage, but lack a down payment.

IHDA (https://www.ihda.org/lenders-realtors/lending-programs) manages a number of programs that include loans and grants up to \$10,000 with the goal to "finance the creation and preservation of affordable housing in Illinois." They also provide home ownership counseling to potential borrowers, since for many, home ownership is a new experience.

The city of Springfield also offers programs to help rehabilitate homes through Community Development Block Grant Funds from the U.S. Department of Housing and Urban

Development. The money is available to correct "building code deficiencies and other minor repairs of single-family, owner-occupied dwellings" such as "condemned furnaces, faulty wiring or actively leaking roofs." Money is also available to low- to moderate-income families for major home repairs in the form of zero percent loans (https://www.springfield. il.us/Departments/OPED/Documents/HmOwnerRehabProgram.pdf).

Down payment assistance is fundamentally different from the mortgage interest deduction, which allows homeowners to deduct mortgage interest payments from their taxable income. The interest deduction is only available to taxpayers who itemize deductions, and the biggest chunk of that benefit goes to high-income taxpayers with large mortgages. It doesn't benefit low-income first-time buyers, and in 2019 the Federal Reserve Board estimated that taxpayers subsidized these loans to higher-income taxpayers with an estimated \$196 billion in tax deductions.

In order to qualify for IHDA down payment assistance, borrowers must have decent credit and meet income and purchase price limits. IHDA states that almost 10% of all first-time homebuyers in Illinois receive down payment assistance. For Weber, that number is bigger. "I think about 15% of our borrowers receive IHDA down payment assistance. I'm glad the program has received funding again." □

#### **PURSUE SUSTAINABLE POWER**

After reading Dr. Brandon Derman's recent editorial "This year CWLP needs a new, community-led Integrated Resource Plan," (Jan. 5), I would like to encourage Springfield Power to the People on their efforts to shape CWLP's future energy policies into more sustainable means.

I applaud Dr. Derman's request to local energy policy leaders to "plan for a just and speedy clean energy transition." Additionally, I would like to encourage them to have the foresight to include the potential public health consequences of ongoing reliance on fossil fuels, particularly on the counties' vulnerable populations.

Sangamon County has specific health concerns linked to fossil fuel emissions. In just one example, the most recent Sangamon County Community Health Needs Assessment prioritized emergency room usage for asthma and cardiovascular disease, particularly in Black populations, as an area of concern. Facts like this should be considered in a future IRP.

As a solution to the same problem, Louisville, Kentucky, recently converted an electrical power plant from coal and found a profound and sustained decrease in pediatric acute asthma cases (the kind that require emergency room usage).

In Illinois, natural gas has recently been found to have more negative health consequences compared to all other fossil fuels combined. Natural gas contains very small particles that have been linked to many health problems, such as asthma attacks and hospital visits.

It is noteworthy that a growing number of forward-thinking communities are seeking healthier options to both coal and natural gas with cheaper Clean Energy Portfolios (CEPs), a combination of wind, solar, energy efficiency, demand response and battery energy storage.

I find it encouraging that there are members of our community who have the vision to realize that Springfield has the potential to become exemplary in transitioning to clean energy. Our state has chosen to take the lead on climate justice and equity, so the potential is here for Springfield to follow by considering healthier alternatives to fossil fuels.

# Illinois faces hurdles with auto manufacturers

The Rockford Register-Star reported last week that the state of Illinois "has submitted what could be its best offer to keep the Belvidere Assembly Plant operating and save what could be thousands of jobs."

Stellantis announced in December it would idle its Jeep Cherokee assembly plant in February. So, there appears to be a glimmer of hope that the state can finally notch a victory with a carmaker after years of trying.

And Jalopnik recently reported that Virginia Gov. Glenn Youngkin told the Ford Motor Co. that he didn't want their \$3.5 billion electric vehicle battery plant which would employ 2,500 workers because the company had partnered with China.

Ford already has a big assembly plant in Chicago. Maybe the state could capitalize on this Virginia thing?

But something else happened in December which highlighted why Illinois has had so much trouble closing deals with the automotive industry, even with a couple of lucrative subsidy laws passed within the last

Volkswagen filed a federal lawsuit in December that described a bill which overwhelmingly passed both Illinois legislative chambers and was signed into law in 2021 as, "crony capitalism at work: redistributive legislation that takes hundreds of millions of dollars from some (but not all) motor vehicle manufacturers and, for no public purpose, deposits that money directly into the pockets of politically favored Illinois [car] dealers." The automaker claims the law is costing it an extra \$10 million a year.

The bill in question (HB3940) was hotly opposed by automotive manufacturers. The law forces manufacturers to reimburse car dealers at a much higher rate (the auto industry says it's a 50% higher rate) for warranty repairs. The bill came about after a labor dispute between dealerships and a mechanics union. They apparently decided to let the carmakers pay to resolve their monetary dispute, although the mechanics ended up on strike anyway because the dealers allegedly kept the new windfall initially instead of passing it through.

Just about every state legislator has multiple auto dealers in their districts and Democrats have been eagerly allying themselves ever closer with organized labor in past years, so the bill hit a sweet spot with both parties and cleared the House 85-24 and then passed the Senate without a single dissenting vote a few weeks later.

The manufacturers say the law is costing

the industry \$240 million a year. Yes, you read that right. \$240 million. Per year. They claim Illinois has the highest warranty repair costs in the nation. By far.

The manufacturers were furious and remain so. And since the cost of doing business in a state is a main factor in deciding where to locate a new plant or keep a plant open, the law is not helping Illinois overcome automaker objections.

The subsidies the state can offer simply don't compare with the gigantic annual cost of that 2021 law. Couple that with our high local property taxes (these electric vehicle plants take up huge amounts of space) and other costs and hurdles (Ohio, like Illinois, is not a "right to work" state, but has a new concierge system to quickly clear red tape), and you can see why the state hasn't yet convinced a national or international corporation to construct an electric vehicle-related facility

It's no secret that Illinois has reputational issues. People love to run Illinois down. It seems to be a major sport everywhere. When Gov. JB Pritzker recently appeared on CNBC while he was at the World Economic Forum in Davos, Switzerland, the first question he faced was how he would attract businesses when so many existing businesses want to

That 2021 law merely added to the state's reputational problems. Manufacturers say that the bipartisan eagerness to quickly throw them under the bus is something they hadn't ever witnessed before here. The substance was bad enough, but the process was outrageous, they say. One industry lobbyist called the process a "radical departure" from the past. The whole thing is understandably given them quite a bit of pause.

Even so, a key labor leader says unions haven't yet been approached to repeal or modify the law (manufacturers disagree) and an official with the governor's office says they are unaware that this remains a big issue with carmakers.

I suppose we'll see what happens with the Stellantis Belvidere plant in the coming days. If Pritzker does cut a deal and convinces the company to stay and even expand, he'll have overcome some gargantuan hurdles. □

# No badge, no problem

Police board chair has gun permit reserved for real cops

The chair of the Illinois Police Training and Standards Board has a permit to carry a concealed firearm by virtue of being a retired police officer, even though he never was a sworn officer with arrest powers.

In his 2019 application for a permit to carry a concealed firearm via a program for retired law enforcement officers, Sean M. Smoot, under penalty of perjury, signed a form stating that he had been employed as a law enforcement officer for 10 years, had the power to make arrests and "was authorized to engage in or supervise the prevention, detection, investigation, prosecution or incarceration of any person for any violation of law." He told Illinois Retired Officer Concealed Carry, the agency that issues permits, that Leland Grove had employed him as a police commissioner.

Under state and federal law, only bona fide cops who have retired can obtain permits to carry concealed firearms through a program that began in 2004. Once granted by a state, the power to pack heat extends nationwide.

But Smoot never worked a beat in Leland Grove, where he was an alderman for a dozen years. The city has no personnel file for Smoot, nor any police reports prepared by him. Several online biographies, including one issued in December, when Gov. JB Pritzker announced that Smoot would become chair of the board tasked with training police, contain no mention of Smoot ever being a police officer.

In addition to training police, the board can revoke certifications to work as law enforcement officers and can investigate or review misconduct complaints against cops, a power recently granted to the board by the General Assembly. Pritzker appointed Smoot to the board in 2020.

"Throughout his career, Sean Smoot has prioritized making Illinois safer, sometimes in extraordinarily difficult circumstances," Pritzker said in a December press release. "I can think of no one who is more qualified for this position, and I wish him the very best of luck as he begins his term."

Smoot, an attorney who is director and chief legal counsel for the Police Benevolent and Protective association, a police officers' union, did not return phone calls or an email. Leland Grove police chief

Dan Ryan, who signed a form stating, under penalty of perjury, that Smoot was a retired cop who met requirements to obtain a concealed weapons permit under the program for retired police officers, also could not be reached for comment.


In 2021, the Police Training and Standards Board fired Brent Fischer, the agency's executive director, after the state inspector general determined that he had wrongly certified Howard Buffett, son of investor Warren Buffett, as a law enforcement officer after the younger Buffett donated money to law-enforcement causes, including a \$15 million donation to the board in 2016 and a \$10,000 donation for a police dog recertification program three years later. All told, Buffett's donations to various law enforcement organizations totaled more \$143 million, the inspector general reported.

"Certification of law enforcement officer status, especially considering the significant public interest in maintaining integrity in that process, should not be minimized, nor should it be provided based on someone's ability to financially contribute, regardless of how great that assistance is, to the law enforcement community," the inspector general wrote in a 2021 report that found Buffett had not completed basic law enforcement training courses.

Since obtaining his concealed weapon permit from Illinois Retired Officer Concealed Carry, Smoot has renewed it three times, most recently last summer, when Kenton Manning, program manager for Illinois Retired Officer Concealed Carry, was rangemaster and certified that all 30 rounds fired from distances ranging from five to 15 yards found their mark.

Manning says that his agency does not verify information included in written forms signed by applicants and representatives of departments who certify that applicants meet standards. About 9,000 retired cops in Illinois have permits issued by his organization, he says.

"I wouldn't knowingly let someone who I knew wasn't a sworn officer into the program," Manning says. □

# **Helping the homeless**

For seven years, Julie Benson has been serving Springfield's poorest. Doing small things with great love.

Last week Julie Bartlett Benson got a 79-year-old Vietnam veteran into a hotel, where he could stay until Feb. 2, when his check comes in. She got a pregnant woman off the street for a week. The woman is trying to get into rehab, but she has a dog so couldn't get into a shelter. The night before I met with her, Benson was able to get propane to a woman in New Berlin who's living in a small travel trailer with her disabled son. Her work is unpaid, but even as a volunteer she rarely takes a day off, because "people don't have problems just Monday through Friday, 9 to 5."

"People reach out to me for all kinds of stuff," she said. "I wake up in the morning and people are calling me and instantmessaging me. I haven't even got my feet on the ground yet, and I've already got six things to do. Everybody knows how to get ahold of me." She says many have her phone number memorized, useful if they're in jail, or if they don't have a phone and need to call her from someone else's phone. She wears her number on her shirt: "Helping the Homeless in Springfield, Illinois, 217-652-1307."

Benson enjoys her life and her work, but it isn't easy to work amid so much pain. "It's heart-wrenching to hear some of the stories. But I don't cry in front of anybody. I go home and cry. Because they're looking to me to be a source of strength, and the last thing they want is somebody wimping. I've had grown men cry on my shoulder, saying, 'My mom was my strength and she's gone.' Some of them call me Mama."

For this work she needs a thick skin. "You know, you can do 20 things for people, and

if you don't do the 21<sup>st</sup> thing, you're no good. You're not the person they thought you were. Then a week later they're calling me and asking me for something. And it's over."

Being well known and, mostly, loved, is far different from when she started in January seven years ago after a whisper from God. "I was on my way to church that morning and I got a whisper that said, 'You're going to help the homeless people." She started out small, gathering donations of hats, gloves and scarves from church members, then went to the parking lot of an established Springfield homeless shelter, opened her trunk and started handing things out. The homeless people who gathered around were skeptical, wanting to know how much she was charging. And the shelter told her, "You need to conduct your business off the property. We don't need your help." After that she started parking across the street for her weekly handouts.

Her street ministry grew when her employer, Henson Robinson, gave her a used van in 2018 as a retirement gift, then she got a building where she and volunteers sort donations. She incorporated Helping the Homeless as a 501(c)3 nonprofit so donations are deductible, but she resisted growing her organization much beyond that. Helping the Homeless doesn't receive government grants, just private donations, and she doesn't solicit donations by mail. "I don't want to just manage people. I want to go out and meet the people. I've had people want to ride with me to help me. But I don't need anybody to open up the van door and hand out socks."

Even today she occasionally gets the feeling

from Springfield's established homelesshelping organizations that her help isn't needed. "They don't call me anymore." But you're not a threat to them? "They act like I am. They said I'm enabling people. But you know, giving somebody a sleeping bag is not enabling somebody. It's trying to keep them from freezing to death."


She's pleased that the proposed new Helping Hands homeless shelter to be built on the eastern edge of Springfield plans to offer a wide range of services. But she worries that, even though there are plans to provide transportation, it's too far away from downtown for the people it serves. She scoffs at the long-range planning to reduce homelessness currently underway: "It's taking too long," Benson said. "They keep doing studies. But how many studies do you need in order to know that we don't have enough affordable, decent housing in this community?"

With housing in mind, in recent months she's launched a new business venture, called "Home Sweet Home sober-living LLC," which she owns by herself and for which she receives no grants. Last Oct. 4 with a bank loan she acquired a house on South Fifth Street. "I almost filled the house that night. And I thought, I've got a waiting list, I could fill another house. So I'm driving down Fourth Street and I see this 'For Sale' sign." On Jan. 5 she became the owner of a second building, with room to house more men. She plans to be strict about collecting rent. "People tend to be more responsible if they have to help pay for something." And she's serious about sober living, with plans to do random drug tests. "They have to be sober to live in the house. But if they test dirty, we will work on getting them the help they need. I'm not just going to boot somebody out the door." □

# **Shawnee National Park?**

A move to make southern Illinois' Shawnee National Forest a national park and climate preserve

When a tree falls in this forest, the sound it makes is definitely being heard.

A grassroots proposal fueled by opponents of logging and other concerns is gaining traction to transform the 289,000-acre Shawnee National Forest in southern Illinois into a national park and the nation's first climate preserve.

Proponents argue the designation would protect a valuable, incredibly diverse major ecosystem from destruction by logging and mining interests. They contend the current government agency that oversees the Shawnee, the U.S. Forest Service, sees the forest only for its trees as a lumber source.

But the proposal has many skeptics who

say the U.S. Forest Service has gotten better at managing the Shawnee. They argue that if the national park and climate preserve plan is approved, unchecked invasive species growth could destroy what is currently a vital recreational and economic resource for the

In 1996 environmental activists won a 17year injunction against commercial logging, ATV use and oil and gas development in the Shawnee National Forest. But the U.S. Forest Service produced a new management plan aimed at addressing several of the concerns listed in the 1996 ruling, and in 2013 U.S. District Court Judge J. Phil Gilbert lifted the injunction.

Timber harvesting currently occurs on a few hundred acres each year in the Shawnee. Backers of national park and climate preserve status want that permanently reduced to zero. Everyone seems to agree that the Shawnee must be preserved. The big question remains: How can that best be accomplished?

Southern Illinois residents Les and Judy Winkeler took a trip several years ago to the Great Smoky Mountains National Park in Tennessee and the Congaree National Park in South Carolina. The Winkelers are big fans of natural areas and were impressed with the

flora and fauna they saw, until they put it in perspective with what they had almost in their own back yard.

"There is a four-acre area in LaRue-Pine Hills, part of the Shawnee National Forest, that has more species of plants than all of the Great Smoky Mountain National Park," Les Winkeler said. "As we drove back home we discussed that the Shawnee is about five times larger than Congaree and it's so much more diverse. I mean my God, why isn't Shawnee a national

About the same time, the Winkelers saw a documentary about the 1990s effort to save the Shawnee National Forest from logging, and lengthy discussions ensued.

"Friends who are environmental activists were some of the principals in the documentary, and we had dinner one night and decided, 'Hey, let's try this,'" Winkeler said.

Winkeler is the retired sports editor of *The Southern Illinoisan* newspaper, headquartered in Carbondale, and still does outdoor writing on contract for the paper. He wrote a column based on that dinner conversation, suggesting that the Shawnee become part of the National Park Service. The column also put forth the idea that the Shawnee be designated the nation's first official climate preserve, an intact ecosystem that would remain untouched to help sequester and store greenhouse gases to stabilize atmospheric carbon dioxide levels.

Pope County, Illinois, resident John Wallace was one of the group of friends who came up with the national park and climate preserve idea

"The mission of the Park Service is to preserve unimpaired the natural and cultural resources for current and future generations. It's a better agency for actually caring for our public lands," Wallace said. "The Forest Service has 'productivity' in their mandate. They fall under the Department of Agriculture, agriculture produces products, and the biggest product that the Forest Service has is trees."

Wallace is perhaps the most well-known environmental activist in the Shawnee. For more than 34 years he has fought against logging and development in the forest, even going to jail once after he chained himself to a piece of logging machinery.


"I've seen the devastating impacts to wildlife, to natural communities, from their commercial-industrial log extraction programs. I am aware of how unjust it is," Wallace said. "Eastern deciduous forests like the Shawnee are quite good at sequestering carbon, often better than some of the old-growth forests out west. The best thing we can do is to leave those forests intact.

"We hope this starts a movement around the country, especially in the Midwest, of creating more preserves out of our public land," Wallace said. "We need to take drastic action, not subtle action, not politically viable action, not moderate action, to reduce our carbon production. Otherwise we face ecological collapse."

## "It's imperative that those types of activities remain permitted."

The city of Carbondale, which sits at the northern tip of the Shawnee National Forest, passed a resolution Dec. 13, 2022, supporting the creation of the Shawnee National Park and Climate Preserve.

"The city is intrigued by the possibility of this designation because the focus then would be on conservation and preservation, and we could see a boon to tourism," said Carbondale City Manager Gary Williams. "We have a lot of hotel rooms and Airbnbs, we have 13

wineries on the Shawnee Hills Wine Trail, so there is evidence to suggest that the creation of a national park will help facilitate additional tourism visits."

Carbondale adopted a sustainability action plan last year and Williams said the city council feels that having a climate preserve is a way to utilize the forest to achieve some of their long-term sustainability goals. He said the designation wouldn't affect traditional Shawnee recreational activities.

"Local residents in particular hunt, fish and trap in the Shawnee, so it's imperative that those types of activities remain permitted," Williams said. "Under a preserve you can define all of those activities and ensure that local residents can continue to enjoy the Shawnee as they have before."

The Illinois Audubon Society, based in Springfield, also passed a December 2022 resolution supporting the national park and climate preserve proposal.

"Our mission is preserving the plants and

animals of Illinois, and the proposal is in line with that, so we supported it," said Illinois Audubon Society Executive Director Joanne Fessett

The Southernmost Illinois Tourism Bureau promotes the area as Shawnee Forest Country and considers the forest to be a key draw for the region, but remains neutral on the national park and climate preserve proposal.

"There certainly could be some benefit that a national park would bring, but we work well right now with the Forest Service, and of course, if that were to happen, would continue to work with the National Park Service," said Bureau Executive Director Carol Hoffman. "We love promoting the area in any way we can with whatever agencies are appropriate."

The first step toward changing Shawnee's designation would be to convince Congress to authorize a feasibility study by the National Park Service. The land in question is already owned by the federal government so there would be no large land purchase expenditure.

The office of Congressman Mike Bost, whose 12<sup>th</sup> Congressional District includes the Shawnee, did not respond to a request for a comment on the proposal.

## "Some of the finest land management in the nation."

Tim Pohlman is the U.S. Forest Service Ranger for the Shawnee National Forest. He acknowledged that the Forest Service had gone through a dearth of management several decades ago in the Shawnee, but is proud of the progress the agency has made in recent years.

"It is disconcerting that all of our harvests are reported to be clear cuts and that's not the case. We are being told that we're not meeting our objectives and that's not the case either," Pohlman said. "There's some thinking that if you leave all of the trees standing, then that stores carbon. But just thinking that all we ever have to do is never cut another tree, well, the situation is more complex than that."

Pohlman said the Forest Service authorizes

approximately 150 to 200 acres of timber harvest per year and those harvests are "partial cuts" where "we go in and take about half of what is there, maybe a little less, and leave the rest of it there for several years," he said.

Pohlman said that most of the harvesting occurs among the 40,000 acres of non-native pine trees that were planted in the early 20th century to help guarantee a steady supply of timber for the United States. Timber management also occurs in areas of the forest that contain oak and hickory, but Pohlman said the management in those areas is intended to bolster those desirable, original hardwood tree

"Oak and hickory don't tend to do well in shade, they get out-competed by other species like maple, beech, elm and tulip poplar," Pohlman said. "To maintain oak and hickory in the forest you have to work at it a little bit and create some gaps in the canopy so the light can get down to the forest floor"

The Forest Service partners with several organizations, particularly The Nature Conservancy, to eradicate the nearly overwhelming amount of invasive plants that are choking out life on the Shawnee forest floor, particularly plants like bush honeysuckle and autumn olive. The partners conduct prescribed burnings on 10,000 acres each year and use mechanical removal and herbicides where appropriate to remove the invasive plants.

"Invasive species are so pervasive across the forest and it's our concern that if the Shawnee shifts to a different agency that the focus won't be as much on management, like invasive species control and prescribed fire," said Tharran Hobson, the Southern Illinois program director for The Nature Conservancy. "Without management they're going to become a real problem, and some of the areas that folks love because of the scenic beauty are going to be lost over time."

"The Forest Service is doing a much better job now," Hobson said. "There was a lot of criticism in the 1980s and 1990s but it's a completely different Forest Service. The amount of planning and professionalism that goes into a lot of their projects is completely different."

The Illinois Forestry Association is an organization of those who support conserving and managing Illinois' five million acres of forest, including those with commercial interests. The association is a strong supporter of the way the U.S. Forest Service currently manages the Shawnee.

"We think it offers a perfect balance of carbon sequestration, recreation, wilderness and forest management, it really is a climate reserve as it sits," said Illinois Forestry Association President Paul Deizman. "We think the forest leadership there practices some of the finest land management in the nation."

Deizman said creating a national park in the Shawnee would be difficult because of the "checkerboard" nature of the current national forest footprint, which contains nearly as many parcels of private as federal land. He also said a national park designation would prevent responsible stewardship of the forest.

"Logging is certainly something that is part of a managed forest at some point," Deizman said. "If nobody touches a forest, stands of trees die and that also gets attention."

The Sierra Club usually falls on the side of environmentalists on issues, and is behind the idea to eliminate logging, drilling and

mining in the Shawnee. But the transfer of the Shawnee to the National Park Service is another matter.

"We have seen firsthand how the number and amount of invasive plants has exploded in the last 10 to 15 years, and we are concerned that areas in Shawnee National Forest will not be managed to protect these areas from being taken over by invasives," said Barbara McKasson of the Shawnee Group, Sierra Club Illinois. "We also know the Forest Service has been working on timber restoration in several high-quality natural areas, and they have been able to increase the amount of management

with help from groups such as The Nature Conservancy and the Sierra Club.'

#### "Nature keeps moving."

President Theodore Roosevelt created the U.S. Forest Service in 1905 to help ensure a steady supply of construction timber for the United States, and famed conservationist Gifford Pinchot was the agency's first Chief Forester. The Forest Service currently administers 154 national forests

Pine trees were often planted on national forest land to keep the lumber supply going, particularly on marginal agricultural land such as was done in the Shawnee. But the Shawnee has not been a major source of construction timber for some time, according to Barry Johnson, the executive director of the Illinois Lumber and Material Dealers Association

"Most of the supply of lumber that we use to build homes is pine and comes either from Canada or the southern United States," Johnson said. "The supply we use to build homes with is soft wood, and what you're talking about in Shawnee is primarily hard

So, should the Shawnee be a hands-off or a hands-on resource for the region, state and

"The Shawnee should stay with the U.S. Forest Service, and the Forest Service needs to be a little more assertive and not cower to every little group that wants to change something," said consulting forester Bill Calvert from Breese, who has worked in the region for many

"The idea is sustainable forestry. As the big trees get old you cut those before they die, then you perpetuate the forest by letting the smaller trees grow, and young trees sequester a lot more carbon than older trees because they grow faster," Calvert said. "Some of the environmental groups don't want them doing anything, not one tree, not one bush, nothing. You can't do that, nature keeps moving. So if you want to try to keep it as natural as possible, you've got to manage it."

Les Winkeler knows that the creation of a hands-off Shawnee National Park and Climate Preserve faces an uphill battle, but there are several factors that give him hope.

Winkeler notes that there's the current focus on the global climate and efforts to utilize trees to sequester as much carbon as possible. There are no national parks in Illinois and a lack of Midwest national parks in general, with the closest, besides St. Louis' Gateway Arch, being Mammoth Cave in Kentucky and Indiana Dunes along the Great Lakes.

Winkeler is realistic, but optimistic, about the grassroots Shawnee effort.

"I think the ultimate chance of success is pretty good," Winkeler said. "I'm 68 years old and I would love to see it in my lifetime. I think that's realistic."

# Student artists compete in 100th Scholastic Art Awards

This year is the 100<sup>th</sup> Scholastic Art Awards, the premier art competition in the United States for students in 7<sup>th</sup>-12<sup>th</sup> grades. Regional winners will be honored Feb. 5 at Springfield High School (SHS), and their artwork will be exhibited at the Springfield Art Association (SAA) February 5 23

Many passionate individuals make this competition possible. Rosemary Buffington is one. She co-chairs the regional competition. The SAA is an enthusiastic partner. "It is so important for all to see that strong visual art programs still exist, and local students are excelling in them," said Betsy Dollar, SAA executive director. "I believe that some of the most imaginative works that we exhibit each year are in that show."

The Mid-Central Illinois Region covers

33 Illinois counties and was started by Rod Buffington in 1984. Students from this region submitted more than 600 entries. Art educators are crucial to the process. Beth Pianezza is one of 45 educators enabling their students to apply. "My role as a teacher is to foster an environment for students to feel encouraged to create artwork that conveys their personal worldview," said Pianezza, SHS art educator. She guides students in selecting artwork and helps them photograph and submit their work. Amy Lynn, Glenwood High School art teacher, says one of her most important roles is to inspire her students. She believes one of the best ways to do that is to encourage them to enter their creative artwork in the Scholastic art competition.

Panels of judges consist of local artists and former art teachers who select the winners

in multiple categories, such as photography, painting and drawing, sculpture and more. Jurors select works that exemplify the award program's core values of originality, skill and the emergence of a personal vision.

Gold Key awards represent the highest levels of achievement in originality, personal vision and technical skill. American Visions Nominees are Gold Key winners, considered best of show. Three of the five selected American Visions nominees are from Sangamon County – Jenna Robeen (Rochester High School), Katherine Minch (Springfield High School) and Sophia Corredato (Williamsville High School).

Of the 47 Gold Key award winners, 20 are Sangamon County students from Glenwood, Rochester, Springfield, Springfield Southeast and Williamsville High Schools; Franklin Middle School; Lincoln Magnet School; and Rochester and Williamsville Junior High schools. Winners of Gold Key awards and American Visions Nominees are automatically entered in the national competition. National jurors will select one nominee from each region for the American Visions Award. The Mid-Central Illinois Region also bestowed 68 Silver Key awards and 124 Honorable Mentions.

The regional awards ceremony is Feb. 5 at 1 p.m. at SHS, the first in-person event in three years. Mayor Jim Langfelder will present the Mayor's Choice Award. Lincoln Land Community College will present a \$1,000 scholarship to a student with an outstanding portfolio who plans to attend LLCC. Other monetary and gift card awards will also be presented, thanks to sponsors and other partners.

Feb. 5 is also opening day for the SAA exhibition (700 N. Fourth St., 11 a.m.-3 p.m.). The exhibition includes all of the entries receiving Gold Key and Silver Key awards and American Visions Nominees. Honorable Mention artworks will be projected on the wall of the gallery. The exhibition will be open Feb. 5-23 (Monday-Friday, 9 a.m.-5 p.m.; Saturday 10 a.m.-3 p.m.).

The SAA will also host an Honors Day on Feb. 24 for students and their teachers. All Gold Key recipients are invited, and each teacher may bring two students who entered the competition. "The students are released from their regular classes and come to the SAA for two workshops, one in the morning and one in the afternoon," said Dollar. "In some cases, they are exposed to media and processes that their schools don't offer. In other cases, it is a chance to work with a professional artist for a couple of hours and gain a new perspective."

The students' creativity will also be showcased throughout the community. Artwork will be displayed on a digital billboard on Chatham Road near Wabash Ave. during March and April. Organizers are working with Ace Sign Company to feature student art on bus benches this spring.

Top regional winners across the country are entered in the juried national competition and also considered for scholarships. National medalists and scholarship recipients are honored at a ceremony in New York City in June. National winners are also featured in an exhibition in Washington, D.C., and traveling exhibitions.

Teachers proclaim the benefits of this program. "Scholastics is a wonderful way for young artists to see what kind of art is being created in our region," said Amy Lynn. "The Scholastic Art Awards competition provides students the opportunity to gain recognition for their artwork locally and nationally, empowers them to trust that their voice is important and celebrates their creative endeavors," said Beth Pianezza. □

# Okonomiyaki – the Japanese vegetable pancake

Tonight's shift in the restaurant is over. I clocked in over 10 hours today and I've only been able to get off my feet for my half-hour family meal break. I'm very tired and my back and feet hurt. Even though I still have three more shifts ahead of me before my next day off, I know that I'll be too wound up to fall asleep unless I decompress. Most nights I am awake past 1 a.m.

On my short walk home, I pass Xiao Bao, a very stylish Asian restaurant and lounge that's open late. It's only been open a few months and has gotten rave reviews. I take a seat at the bar, order a cocktail and peruse the food menu. I've learned that having food in your stomach helps slow down the absorption of alcohol into the bloodstream and helps avoid a hangover. I ask the bartender: "What's good here?" She responds: "My favorite is the okonomiyaki. It's a Japanese hash-brown pancake that the owners learned to make while on their honeymoon in Japan."

Xiao Bao is the love child of Josh Walker and Duolin Li. After quitting their jobs in New York City, they embarked on a sevenmonth honeymoon throughout Asia, where they worked on a rice farm outside Osaka and learned Japanese cooking techniques. After returning to the United States, the couple settled in Charleston, South Carolina, where they started a series of pan-Asian pop-ups before opening a brick-and-mortar restaurant in 2011. After opening a second location in Charleston, they expanded to an East Nashville location, where I am now sipping my cocktail and unwinding from my restaurant shift.

The plate placed in front of me is an explosion of color and reminds me of Jackson Pollack's famous painting *Convergence*. It looks like a cross between a pancake and a frittata, garnished with a lattice of mayonnaise and sweet soy sauce drizzles, and topped with a dusting of seaweed powder and dried, smoked, fermented tuna flakes which are wiggling as if alive. I cut into it and find shredded cabbage, kale, carrot and scallion that have been mixed into the batter and fried to a hash brown texture. I take a bite and taste something that is sweet, spicy, smoky, and savory. I am hooked!

Okonomiyaki are made with a wheat flour batter and cooked on a griddle or teppan. They first appeared in Osaka during the 1930s and increased in popularity during World War II when rice became harder to come by. The name is derived from *okonomi* which translates to "how you want it," and *yaki*, meaning "cooked over direct heat."

Restaurants specializing in okonomiyaki

will have menus with several options to choose from, much like an American pizzeria. Common add-ins include octopus, shrimp, pork belly, Chinese sausage, yam or kimchi. You pick your ingredients which are then mixed together in a batter. The batter is then poured onto a hot griddle known as a teppan and shaped into a circle with short metal spatulas. Once one side of the okonomiyaki has been cooked enough to hold together, it is flipped onto the other side. When both sides of the okonomiyaki are cooked, the toppings are added. Okonomiyaki sauce, which resembles Worcestershire sauce, and Kewpie mayonnaise are drizzled all over in zigzagging lines. Small flakes of dried seaweed are then sprinkled over. Often paper-thin shavings of katsuobushi are added, which because of the heat, move and dance as if alive. The okonomiyaki is then divided into quarters and left on the griddle so that every bite is eaten "fresh off the grill."

Making your own okonomiyaki in a home

kitchen is relatively easy. It is essentially a vegetable fritter in the form of a pancake. It is a very adaptable recipe and is a good way to put to use the leftover vegetables that are hanging out in your fridge's produce drawers. If you have any pickled sushi ginger, add it in. Fry up a couple pieces of diced bacon to mix into the batter. If your batter seems too runny, you can add a little panko. If you have any microgreens or sprouts, put them on top. The only tricky part is flipping it over. But don't stress. If it comes apart, just piece it back together, and cover your mishap with the toppings.

# Okonomiyaki (Japanese vegetable pancake)

Serves 1-2, depending on hunger

#### Ingredients:

½ small cabbage, very thinly sliced (preferably using a mandoline), about 4 packed cups – 300 grams

1 medium carrot, peeled into thin ribbons using a vegetable peeler, and cut into matchsticks
2 Lacinato kale leaves – ribs removed and

2 Lacinato kale leaves – ribs removed and discarded; leaves stacked, rolled into a cylinder, and thinly sliced crosswise

2 scallions, very thinly sliced on a bias 1 large egg, lightly beaten 3/4 cup cold water, more if needed 1 cup all-purpose flour, more if needed

Garnishes (see note below): Bull-Dog sauce, for serving Kewpie mayonnaise Furikake seasoning Katsuobushi flakes (optional)

1 tablespoon canola oil

Note: Look for Bull-Dog sauce, Kewpie mayonnaise, furikake, and katsuobushi flakes in the Asian section of your grocery store, at an Asian market, or Amazon. If you can't find Bull-Dog, mix equal parts ketchup and Worcestershire sauce with a few dashes of soy sauce. Kewpie mayonnaise is a Japanese sweet mayonnaise sold in a red-capped squeeze bottle. You can substitute Hellmann's. Furikake is a Japanese condiment containing dried seaweed. You can substitute finely shredded nori.

#### Preparation:

In a large bowl, add the cabbage, carrots, kale and scallions. Stir in the egg and water. Sprinkle in the flour and stir to combine using chopsticks, if you have them. Depending on the water content of your shredded vegetables, you may need to add more water or flour to achieve a thick batter. The batter will be more like a potato pancake or hashbrown.

Heat the canola oil in a 10-inch nonstick skillet until shimmering. Add the okonomiyaki batter, and using the back of a metal spoon, spread the thick batter into a circle about ½- to ¾-inch thick, smoothing the top and gently pressing the pancake together. Cook until the edges of the pancake begin to brown, about 5 minutes. Once the edges brown, wait for 30 seconds before flipping the pancake over. Cover the skillet with a flat lid or dinner plate, and with a towel or pot holder, hold the lid firmly against the skillet and flip over, then carefully slide back into the pan.

Cook the other side until the edges brown, 3 to 5 minutes, then cook an extra 30 seconds before sliding the pancake onto a plate.

Drizzle with Bull-Dog sauce and Kewpie mayonnaise and sprinkle with furikake and some katsuobushi flakes, if using. Serve warm. □






