









Insurance reform proposal fails

Legislation intended to protect patients harmed by BCBS contract dispute with Springfield Clinic

State Rep. Sue Scherer asked fellow lawmakers April 6 to vote for legislation she said would protect patients harmed by the contract dispute between Blue Cross and Blue Shield of Illinois and Springfield Clinic.

Scherer, D-Decatur, whose 96th House district includes parts of Springfield's east side and eastern Sangamon County, was unsuccessful in securing passage of House Bill 1463, even though she portrayed the vote as a test of lawmakers' character.

"I hope to goodness people in this room have the courage to stand up to the 'bad guys,' because it's quite clear tomorrow if I want to answer who's owned by the insurance companies, guess what? I'm handing them a roll-call vote," Scherer said, her voice cracking with emotion at the end of 45 minutes of debate on the measure.

The roll call showed 40 House members voting "yes," 21 voting "no," seven voting "present" and 46 not voting — meant the bill failed because it didn't receive the required 60 or more votes to pass and move to the Senate.

Those not voting included Republicans and members of Scherer's own party, who control the House and Senate. Joining Scherer in support of the legislation were Reps. Tim Butler and Sandy Hamilton, both Springfield Republicans; and House Speaker Emanuel "Chris" Welch, D-Hillside.

Those not voting included Rep. CD Davidsmeyer, R-Jacksonville, and House Minority Leader Jim Durkin, R-Western Springs.

Scherer said she doesn't know whether she will try to pass the legislation in the future. The bill was supported by Gov. JB Pritzker, a Democrat, and the Pritzker administration's Illinois Department of Insurance.

Scherer told *Illinois Times* she will continue to speak out about the need to hold

health insurance providers more accountable.

"My bill was called to bring transparency and accountability to big insurance companies," she said. "I care deeply about providing affordable, accessible health care to the residents of my district, and I will continue to work towards that goal and fight for my constituents, as always."

HB 1463 covers 102 pages and would tweak the state's Network Adequacy and Transparency Act, which was passed in 2017 and began affecting insurance plans in 2019.

The bill would allow state officials to confirm the existence of investigations of insurance companies. The bill also would create more stringent standards for insurance providers to maintain accurate online listings of doctors in their networks and more quickly adopt annual federal recommendations on the number of specialty doctors needed for "network adequacy."

A news release from the state insurance department said the bill would give the department "the authority to put in place more stringent time/distance standards than current federal requirements for many specialties to ensure consumers can access in-network providers close to home."

Scherer, the bill's sponsor, said the state insurance department proposed the bill late in the spring legislative session because of regulatory gaps highlighted during Blue Cross' year-long contract dispute with Springfield Clinic.

Scherer arranged for a hearing on the contract dispute in front of a House committee on March 30 in hopes of pushing both sides to a settlement. But she said the bill wasn't intended to get in the way of a private contract negotiation.

Rep. Thaddeus Jones, D-Calumet City, chairman of the House Insurance

Committee, criticized Scherer's bill in debate on the House floor, saying she should have brought the bill to his committee for vetting instead of another House committee.

He also said Scherer didn't do enough to get agreement on the bill from the insurance industry. Scherer said she tried to get the industry and other organizations involved, but not everyone responded to her invitations.

Jones said Scherer was "untruthful" in her description of the bill negotiation process, a claim Scherer denied.

"This bill is not only overkill, but this bill doesn't solve the problem that you are seeking to resolve," he said.

He noted that the Department of Insurance says it would cost the department \$836,500 annually to carry out the legislation through the hiring of additional state workers, plus software and contractual costs.

Jones — who has received more than \$24,000 in campaign contributions from the Illinois insurance industry since early 2018, according to the nonprofit Reform for Illinois organization — didn't return a phone call from *Illinois Times*.

The insurance industry opposed the bill. Laura Minzer, president of the Illinois Life and Health Insurance Council, said her organization would support some parts of

the bill, including making insurance plan investigations public, but not other parts of the bill. The council would be willing to negotiate future legislation with Scherer, Minzer said.

Jones and other lawmakers opposing HB 1463 said the legislation wouldn't result in a contract settlement between Blue Cross and Springfield Clinic, but Scherer said that wasn't her goal with the legislation.

Other lawmakers questioned the need for the bill when administrative rules to clarify parts of the current Network Adequacy and Transparency Act were proposed by the insurance department recently and could go into effect in several months.

But Scherer said her bill would complement the proposed rules.

She said on the House floor that passage of the bill would allow lawmakers to know they "stood up for" their constituents and "had the courage to stand up to the insurance lobbyists, and we all know that's not a small thing."

The dispute between Blue Cross and Springfield Clinic has resulted in thousands of central Illinois residents losing in-network access to their doctors, physician assistants, advanced-practice nurses and other providers.

Springfield Clinic officials said last year that the dispute threatened to disrupt the care of more than 100,000 patients. Blue Cross officials disputed that number and said about 55,000 Springfield Clinic patients, at the most, were affected by the change.

Since then, some employers have switched insurance carriers to retain the clinic as an in-network provider and protect employees from higher out-of-pocket costs when they seek care from clinic providers.

The dispute hasn't been resolved.

Chicago-based Blue Cross, the biggest insurance company in the state, recently agreed to pay a \$339,000 fine to the Department of Insurance for delaying the filing of documents backing up Blue Cross' claim that it has an adequate network even with the loss of more than 600 Springfield Clinic providers.

The department continues to evaluate Blue Cross' "network adequacy" filing, department spokeswoman Caron Brookens said. □

Charlie Kirk coming to Springfield

Turning Point USA founder to speak at annual Lincoln Day Dinner

The Sangamon County Republican Central Committee hopes to follow up on record-breaking attendance at last year's Lincoln Day Dinner with this year's April 19 event featuring national conservative political activist Charlie Kirk.

Kirk, 28, a Chicago-area native and Eagle Scout, has said he is dedicated to "win the American culture war."

Raised in Wheeling, Kirk is known for his support of former President Donald Trump, his doubt about the value of masks during the COVID-19 pandemic, his skepticism of human contributions to climate change, and his criticism of transgender individuals and gymnast Simone Biles for her decision to withdraw from the team competition during the 2020 Summer Olympic Games.

Last year's Lincoln Day Dinner benefited from a lull in COVID-19 cases before the delta and omicron variant surges, as well as the popularity of conservative commentator Candace Owens as keynote speaker, when the event attracted more than 1,500 people, central committee chairwoman Dianne Barghouti Hardwick said.

Sangamon County Republican officials checked with some of their younger members for guidance on whom to invite to speak at this year's \$100-per-person fundraiser at the Bank of Springfield Center, she told *Illinois Times*.

"We gave them a choice of a couple of different people, and they like Charlie Kirk, so we said, 'OK, we'll go with Charlie Kirk,'" Barghouti Hardwick said.

Kirk founded Turning Point USA in 2012 and is chairman of Students for Trump. He didn't respond to a request for an interview but says on his website that Turning Point is the "largest and fastest-growing conservative youth activist organization in the country with over 250,000 student members, over 450 full- and part-time staff, and a presence on over 2,000 high school and college campuses nationwide."

Kirk says Turning Point, based in Phoenix, is "a national student movement dedicated to empowering young people to promote the principles of free markets and limited government."

The tax-exempt organization posted \$28.5 million in revenues in the fiscal year ending in June 2019, according to the group's most recent IRS form 990. Kirk's compensation that year totaled \$292,423, according to the tax document, which is available online at bit.ly/TurningPoint990.

Kirk doesn't have a college degree but

reportedly attended New York's King College and Harper College in Palatine.

Former Republican Gov. Bruce Rauner and his wife, Diana, gave Turning Point \$100,000 in 2014 and \$50,000 in 2015. In 2017, Kirk called Rauner a "disappointment, somewhat," as governor.

The New York Times reported in 2021 that Liberty University in fall 2020 opted not to renew Kirk's contract as founder of the Falkirk Center — named after Kirk and Jerry Falwell Jr. According to the *Times*, the center had become the "de facto headquarters of evangelical Trumpism."

The Virginia university's decision came shortly after Falwell, the son of Liberty's founder, resigned as university president amid allegations of sexual impropriety.

Kirk has been prolific on Twitter and in March was suspended after he used a tweet to address Assistant Secretary of Health and Human Services Rachel Levine as a male. She is a transgender woman.

Kirk wrote that Levine "spent 54 years of his life as a man. He had a wife and family. He 'transitioned' to being a woman in 2011, Joe Biden appointed Levine to be a 4-Star Admiral and now *USA Today* has named 'Rachel' Levin as 'Woman of the Year.' Where are the feminists??"

That same month, Kirk tweeted that Vice President Kamala Harris and recently confirmed U.S. Supreme Court Justice Ketanji Brown Jackson were "Affirmative Action" picks for those jobs.

And in July 2021, Kirk called Biles a "selfish sociopath" after she withdrew from the women's Olympic gymnastics team final in Tokyo, citing mental health issues.

"We are raising a generation of weak people like Simone Biles," Kirk said on his podcast, "The Charlie Kirk Show." "What kind of person skips the gold medal match?"

Kirk said people with mental health problems should opt not to compete in the Olympics. He said Biles is "an incredible athlete ... She's probably the greatest gymnast of all time. She's also very selfish, she's immature, and she is a shame to the country."

Candace Davis and Kirk may represent the far-right end of the Republican Party, but Barghouti Hardwick said that doesn't mean their views don't deserve an audience. Sangamon County Republicans tend to be moderate politically, though the presence of many Catholics plays a role in their firm pro-life stance on abortion, Barghouti Hardwick said.

The county GOP brings in speakers primarily as a draw to raise money for the support of local candidates, she said.

Previous Lincoln Day speakers included singer, hunter and gun-rights advocate Ted Nugent, former Judge Jeanine Pirro, former Presidents George H.W. Bush and George W. Bush, former Congressman Jason Chaffetz of Utah and former U.S. Department of Housing and Urban Development Secretary Dr. Ben Carson.

As for Kirk, Barghouti Hardwick said, "I don't think he's as controversial as maybe some people would like to make out."

Kyle Stauder, president of the College Republicans at University of Illinois Springfield, said he doesn't agree with Kirk on all the issues but admires him for "getting young people energized about the political process."

Stauder, 20, a junior from Shelbyville who is majoring in political science, wouldn't say which of Kirk's views he disagrees with. But Stauder said Kirk's work to build Turning Point is impressive.

Kirk is among conservative activists who go to college campuses to provide an alternate viewpoint to "liberal ideology" and "fight back against the propaganda that's put out," Stauder said. □

A journalist and a political candidate

Terry Martin seeks the Republican nomination for the 13th District

After decades of covering candidates for public office, journalist Terry Martin has decided to become one.

Martin, executive director of the Illinois Channel, is seeking the Republican nomination for the 13th Congressional District.

The district, which snakes its way from East St. Louis through Chatham, Springfield and Decatur to Champaign-Urbana was drawn by state lawmakers to favor Democrats, but Martin said he believes this year will favor Republicans.

"I don't know that Democrats figured that gas would be hitting \$4.50 a gallon and hamburger would be \$7 a pound," Martin said of those who drew the district boundaries.

Although supportive of gay rights, most of Martin's positions are standard Republican fare: drill more oil wells, build more petroleum pipelines, make abortion illegal, fight gun control measures and create a voucher system to enable youngsters to attend public or private schools with taxpayer dollars.

Martin said he doesn't believe elective abortions should be legal in most instances.

"When people say, 'Well, it's my body.' It's like, well, when you come out of the abortion clinic, are you missing arms and legs? That's the whole point. Unfortunately, we destroy the body that you don't want to have."

Martin, 67, heads the Illinois Channel, which offers C-Span-type programming of legislative deliberations, public affairs issues across the state and in-depth, long-form interviews with policy makers and political insiders. He has held the job for 20 years.

Before joining the Illinois Channel, he was a reporter for WAND TV in Decatur. But he began his career as a small business owner. His father, who owned a printing business in the St. Louis area, died while Martin was in college. He took over the business and brought it back into solvency.

"I didn't know the first thing about printing. I never wanted to be there. I was like Jimmy Stewart taking over the savings and loan," he said. "But just through sheer determination, I learned it on my own—without a mentor—and turned the business around, returned it to prosperity and then sold it in 1989."

"Now why does that matter? Because I remember what it was like to be a small businessman. I remember saying to myself, 'People don't know how hard it is to run a small business and that you're walking on a tightrope.'"

Martin lives in Chatham, is divorced and the father of three adult sons, who he said he raised



as a single parent.

Martin said he will continue to lead the Illinois Channel during his bid for Congress.

He said he does not believe this poses a conflict of interest for him as a journalist, noting that former U.S. Senator Paul Simon and former state Treasurer Judy Baar Topinka both owned newspapers while holding public office.

Retired University of Illinois Springfield journalism professor Charles Wheeler III said he doesn't see an ethical problem with the arrangement—as long as Martin is transparent about the two roles.

Martin said he has had one person decline to be interviewed by him because he is running for Congress.

Former state Rep. Jeanne Ives, R-Wheaton, said Martin is one of the most well-versed journalists she has met on public policy issues.

"The thing that immediately comes to mind with Terry is that he is media savvy. I think that's a benefit, but first and foremost, he's an ethical guy. I mean, the guy is just so honest. He would hold a position in the highest esteem. He would never cross any ethical lines. ... He has a vast policy knowledge on a

multitude of subjects. It's really important to have an informed voice in a debate rather than somebody who's just picked up talking points from somebody else."

Sangamon County Clerk Paul Palazzolo added that Martin's role with the Illinois Channel has made him well-known to the most politically engaged people in the district, which may prove to benefit his candidacy.

There are three other GOP hopefuls seeking the party's nod. Regan Deering, a Decatur community activist; Matt Hausman, a Champaign engineer; and Jessie Reising, a Decatur lawyer.

On the Democratic side, Nikki Budzinski, of Springfield, is widely considered the favorite to win the nomination. Budzinski served as chief of staff in the Office of Management & Budget in President Joe Biden's administration. She also is a former advisor to Gov. JB Pritzker.

David Palmer, a Champaign insurance broker, and Ellis Taylor, a minimum-wage worker from Decatur, are also on the Democratic ballot. □

Progress for Pillsbury site

Moving Pillsbury Forward acquires property, begins cleanup

The site of the former Pillsbury factory on Springfield's northeast side could be leveled and developed for future residential, industrial or commercial use – maybe even become a solar farm – in the next five years or more.

Those are among the hopes of Moving Pillsbury Forward, a Springfield nonprofit that recently acquired the 18-acre site from P-Mills LLC after years of both legal and illegal scrap removal since then-owner Cargill shut the site down in 2001.

But first, MPF, which bought the site at 1525 Phillips Ave. for \$1, plans to hire the Fehr Graham Engineering & Environmental firm to evaluate the soil, groundwater and remaining 500,000 square feet of buildings.

The firm's report, expected by the end of the summer, will guide decisions related to future development and hone cost estimates of demolition and cleanup ranging from \$8 million to \$12 million.

"That environmental work will tell us how contaminated the soil is and what we can do at this site," said Chris Richmond, a Springfield resident and retired firefighter who is president of MPF and helped launch the group in 2019.

State and federal grants would fund most of the site preparation and development, he said. Depending on what the environmental study reveals, the site could be ripe for development, Richmond said. It's already near major electrical, rail and water lines, he said.

The group wants to hear more from Springfield residents about their preferences. MPF plans to hold a public hearing on the issue from 6 to 8 p.m. April 27 in the commons area at Lanphier High School.

The group says on its website that it wants to "redevelop the largest single blighted property in our city." Debris and overgrown weeds and brush already are starting to be removed by volunteers.

Richmond, whose father worked at Pillsbury, said MPF, supported by financial and in-kind contributions from volunteers, wanted to have control over the site.

"We felt that as a local not-for-profit that had a stake in the community, we would have the best chance of having the outcome the community would like to see," he said.

Pillsbury Co., which was acquired in 2001 by Minneapolis-based General Mills, built the Springfield plant throughout the 1920s and opened for business in 1929, Richmond said.

The rows of 100-foot-tall bins on either side of the 14-story "head house" held as

many as 3 million bushels of wheat brought to the site by trucks and rail cars, he said. The plant at first ground the grain into flour that was shipped to general stores and other users in 100-pound sacks, Richmond said.

After World War II, Pillsbury expanded its production to cake mixes and eventually brownie mixes, and flour began to be packaged for sale in five-pound bags. Pillsbury products produced in Springfield were sold throughout the country.

The neighborhood surrounding the site grew along with employment at Pillsbury, which peaked at more than 1,500 in the 1950s, Richmond said.

The neighborhood grew and prospered along with the plant, but it also declined along with the plant's fortunes, according to Polly Poskin, a member of MPF's executive board and vice chair of the steering committee for Springfield Inner City Older Neighborhoods.

Pillsbury sold the site to Cargill in 1991 for \$19 million, according to Sangamon County property records. Cargill ran the plant as a 3 million-bushel grain storage facility for about 10 years and the facility then sat vacant until 2008, when the site was sold to the first of a series of owners who removed scrap metal.

Illegal removal of asbestos from copper

pipes led to a court injunction filed by the Illinois Environmental Protection Agency in 2015, and the U.S. EPA paid for \$3.2 million worth of asbestos cleanup in 2017. During those years, around half of the original 850,000 square feet of building space were demolished and removed, Richmond said.

Moving Pillsbury Forward still deals with "thrill-seekers" and "scrappers" who have snuck in through holes in the perimeter fence, he said. No one has been seriously injured, but the group is looking forward to seeing the site razed, he said.

"The structures are in a state of partial demolition currently, and they're in a state of serious disrepair," Richmond said. "Basically, the structures are all very dangerous at this point."

Clearing the site of the hulking cluster of steel-and-concrete buildings that extend as tall as 14 stories would provide an emotional and economic reset for the city and especially for residents of the struggling neighborhood, Poskin said.

The Pillsbury site represents the decline in heavy manufacturing and the good-paying jobs that went with it, that Springfield and many other communities in Rust Belt states have endured, she said.

"People would like to see the site cleared of these abandoned buildings," Poskin said. "They're unsafe. They're an eyesore. And I think they're also a painful reminder of what was – an economic driver in this city."

And though the smell of baking bread with Pillsbury's Best flour is long gone from the property, Poskin said the demolition of its buildings "will change the vista on the northeast side of Springfield."

Poskin, who lives in the Harvard Park neighborhood, said "gentrification" is not one of MPF's goals for the Pillsbury site and surrounding neighborhood. Basic improvements and a halt in economic decline are what Springfield's older neighborhoods need, she said.

"I think our city has long neglected the north and east and southeast ends of the community, and this is a chance to change the focus," she said. "If we're going to maintain a viable city, then we've got to ensure the residential integrity of all aspects of our community." □

While stories like the author used are very real, this is not only grouping all of the patients into a category they don’t deserve, it is also giving false information to people who may really need help.

We need more workers, not more walls

Is the current inflationary crisis due to the policies of President Joe Biden, or are they in part the result of four years of anti-immigration policies enacted by former President Donald Trump?

Economists tell us that one prominent factor fueling current inflationary pressures on the economy is a lack of workers.

Unemployment is low. There are not enough workers for manufacturing so fewer goods are produced with high demand and higher prices. There are not enough workers to transport goods, causing supply chain problems. The lack of workers in all sectors of the economy results in competition for the workers with higher salary offerings. That cost is passed on to consumers.

According to current Bureau of Labor Statistics, the national unemployment rate is 4%, or about 6.5 million people. In December 2019 there were 10.9 million unfilled jobs. That is a gap of 4.4 million jobs without potential workers.

Of course some reader is going to say: "Well, just get people off of welfare and tell them to go to work." Let's look at that.

Currently about 59 million people receive public aid. According to a Center on Budget and Policy Priorities study (2010), about 53% are elderly, 20% are disabled adults and 18% are adults who are working. They often are working in minimum wage jobs that pay so little that the family still qualifies for assistance.

Another 7% goes for benefits for things like Social Security survivor benefits for children and spouses of deceased workers. If you assume – a questionable assumption – the remaining 2% are able-bodied potential workers, that would translate to another 1.1 million workers. That would still leave a gap of 4.3 million workers.

So why the gap?

For decades it has been forecast that when Baby Boomers hit retirement age there was a potential for a workforce shortage. According to the Pew Research Center, the number of boomers retiring each year has been increasing by 2.5-1.5 million per year until in 2019 about 25.4 million retired. The number increased to 28.6 million (a 3.2% rise) in 2020 as workers were laid off due to pandemic closures and many older workers decided to opt for retirement. When data is available for 2021 we may find this trend has accelerated.

The U.S. has not been replacing retiring boomers with potential new workers.

The National Center for Health Statistics



reported in 2020 the U.S. hit a record low annual fertility rate, and it was the sixth year in a row that the birth rate has declined. Currently, our birth rates have been far below the rate needed to keep a stable population.

Now a naysayer to this last statement would point out that while the growth of the U.S. population has slowed greatly from 1960 to now, the U.S. population has never dropped.

That is where the Trump/Republican immigration policies come into play.

Immigration into the U.S. helped offset the drop in the U.S. birth rate. The latest census data shows that 14.1% of the U.S. population is made up of immigrants. However, the rate of immigration took a sharp drop in 2016 as the Trump immigration policies were enacted. As a result, the U.S. population growth was only 0.12% from July 2020 to July 2021.

In 2020, immigrant men were more likely to be employed (76.6%) compared to native-born U.S. men (65.9%), while women in both groups had rates in the mid-50th percentile, according to the Bureau of Labor Statistics.

By excessively cutting immigration, the Trump administration cut the pipeline of needed immigrants who were coming to the

U.S. to seek work.

The ultimate impact of this on the economy and inflation may have been delayed by the marked decrease in demand for workers that occurred because of the 2020 COVID-related shutdowns. Once the economy began to recover as widespread vaccination occurred in the first year of the Biden administration, the impact of this decreased flow of eager immigrant workers became a factor.

The solution? The Biden administration has taken some steps to open up legitimate immigration while still protecting the integrity of our borders. But the impact of such efforts will be delayed.

Meanwhile, Republicans in an election year are ramping up the get-tough-on-immigration rhetoric that builds on voters' fears or prejudices.

This year we need to elect individuals who support moderate immigration reform to help get our economy back on an even keel. We don't need more walls built against legitimate immigration.

No transparency for state budget process

Illinois politicians talk a lot about transparency but rarely practice it – even amongst themselves.

State budgets are negotiated behind closed doors between whomever is governor and legislative leaders. Sometimes members of the minority party are included, but other times, such as this year, not so much.

This month, once a budget agreement was reached behind those locked doors, lawmakers found themselves voting on a 3,400-page, \$46.5 billion operating budget a few hours later.

Think any of them knew exactly what they were voting on? No way. Is this unusual in Springfield? No. But it has never served the public well.

Whether the governor's last name happens to be Pritzker, Rauner, Quinn, Blagojevich or Ryan, the secrecy persists.

I first began covering the General Assembly in 1988. I can say both Republicans and Democrats are guilty of this practice. "Good-government-type" politicians and political hacks are equally guilty, too.

"They didn't talk to Republicans during the budgeting process at all, and they don't need to," state Sen. Neil Anderson, R-Andalusia, said. "Why would they? This is kind of the result you get: a closed-door budget to make sure everybody in their caucus is happy."


In politics, knowledge is power.

Taxpayers and bondholders deserve to know how our money is being spent. But the budget document is so opaque it is often hard to discern whether major new initiatives have been slipped into the spending plan – even if those voting on it had adequate time to review it.

For example, back in 2005, the General Assembly rejected spending state money on stem-cell research. Gov. Rod Blagojevich, who favored the measure, snuck \$10 million in stem-cell research spending into the budget by labeling it "scientific research."

Lawmakers were understandably angry when they figured out they had been tricked into voting for something they had opposed. Blagojevich shrugged and said the end justified the means.

And there is the rub. Deception is often the key to legislative success. The closed-door process benefits political insiders, legislative power brokers and a host of special interests.

But it rarely benefits voters.

It shows contempt not just for the minority party but also for the rank-and-file lawmakers of the majority party, who are derisively referred to as "mushrooms" because they are kept in the dark and fed a lot of ... er, um, manure.

The budget was hurriedly debated and voted on during an all-night session. Why? Well, if they act fast – before lawmakers and constituents have reviewed the spending plan's contents – they can beat any possible new opposition.

"You're trying to track everything and there's a lot of last-minute changes, because amendments get filed at the last possible moment," state Rep. Tim Butler, R-Springfield, said. "And it does make it very difficult to know exactly what's in there. I'm sure we'll see things coming out over the next several weeks about things that were tucked in there or mistakes that were made."

His view was echoed by state Rep. Sandy Hamilton, R-Springfield. "We can do better than this to improve transparency. After all, the budget is spending taxpayers' money. The people of Illinois should have far more input." □

Growing your own food is like nature's magic show

Gardening and canning both saw a resurgence in spring 2020 when families were home due to the pandemic and looking for activities to keep themselves busy. Gardening and canning had such a revival that seed suppliers were selling out and canning supplies were in high demand. The last time there had been a shortage of canning supplies was in 1975.

Gardening, once done for survival, is now utilized for a multitude of reasons – the mere satisfaction of connecting with the earth, knowing the food you're consuming is organic, contains no GMOs and no high-fructose corn syrup. Or maybe you make a mean salsa and therefore you dedicate your garden to growing salsa ingredients only. And if you just want the pure pleasure of tasting homegrown vegetables throughout the winter, you can plan a garden specifically for canning.

Although we are still experiencing some cold days, this is actually the best time to begin planning your garden. First, make a list of the produce your family likes best and then make a list of the vegetables you buy most during the winter. Compare those two lists and where they overlap becomes the list of vegetables you will plant in your garden.

Now that you know what you want to plant, next you'll need to plan out what seeds are planted first, which seeds can be started in the house and transferred outside and some other details. You can keep this simple with an outline sketch, or you can go high-tech and purchase software. I recommend keeping it simple and searching the web for some old-school worksheets that will help move you through the process. Search for: planting calendar, planting dates, crop amount worksheet and seed order worksheet, for



starters. You can get some real math involved and calculate the amount of garden space you'll need, or if you have a limited amount of space, then that's what you'll work with.

Speaking of output, the internet has resources to help you calculate yield from vegetables and fruit. If you're thinking of planting a couple of tomato plants, you'll be surprised to learn that it takes three pounds of tomatoes to yield one quart of canned tomatoes. Search for: yield of pounds to quarts and Google will pull up a nice list for you.

If you do not have enough real estate for a garden large enough to produce the pounds of vegetables to can, don't despair; see if there is a community garden near your home, or install

one or two raised garden beds, or plant some veggies in terra cotta pots on your back patio and look into freezing your produce. You can still embrace farm-to-table, just on a smaller scale.

If you are so new to canning that you have never witnessed the process, you will need to do plenty of research before diving in the deep end. Not only does it require some equipment and dedication, but not canning food properly can cause botulism poisoning. Foodborne botulism is often found in home-canned foods that are low in acid, such as fruits, vegetables and fish. Canning in a pressure-canner ensures that food reaches a temperature of 240-250 degrees over a period of time that kills the

toxin produced by the bacterium *Clostridium botulinum*. People who get this type of food poisoning get very ill; in rare cases it can be fatal. (That's a buzz kill, but safety first. Don't give up your dreams of canning just yet.)

This is a good time to mention the excellent resource we have in our local University of Illinois Extension office. There are knowledgeable educators on staff for the purpose of teaching us how to grow our own food, how to handle food safely and how to preserve food by canning it properly so we can feed our families through the winter. Learn more at extension.illinois.edu.

In addition, the nurseries in the Springfield area have staff who know just as much about growing food as they know about growing flowers.

Before the seeds are in the ground, do your research and know how you want to fertilize the soil and how you want to keep the bugs from eating your vegetables before you do. Once the seeds are planted, water your garden as it needs, celebrate the rainfall and enjoy watching the green sprouts pop up through the rich soil. While your garden is growing, make sure your canning jars are sterilized and that you have plenty of lids and rings on hand. The satisfaction felt from growing your own food is a feeling like none other.



Plastic spider rings. The nozzle part of a spray bottle. An old cellphone. A glow stick that has lost its glow. An old flash drive. A lucky coin gifted by a loving family member but pretty much useless to your child since it's a Euro. Life seems to pile up, one toy or treasure at a time. May I offer some quick tips on how to declutter kids' items and restore the peace in your home this spring?

The 100-item pickup

Feeling overwhelmed by clutter, but not ready for the complete overhaul that is decluttering your entire house? Try the 100-item pickup. Grab a box or a bag and pick just 100 items that you can recycle, place in a donation bin or throw away *right now*. A lot of families will be surprised how quickly they get to 100 items – think old magazines, outdated kids' artwork or a lonesome sock with no match. A bonus of this strategy is that your young children get to practice counting to 100, a kindergarten favorite.

Sell it

Consider offering lightly used items for consignment or resale. You may find that your older kids have some buy-in in picking items to sell, particularly if you offer them a percentage of your overall sale, or tell them that you'll use the proceeds toward a family trip or outing. Local spots to sell or consign kids' items include Once Upon A Child, Just Kids and Underdog Sports, Memorabilia & Games in Springfield, Remarkable Resale in Rochester and Sweet Pea Consignment in Chatham.

Donate it

Donate used items to a good cause. Springfield's Hope Thrift Center, Salvation Army, Goodwill and Habitat for Humanity are just a few local organizations that accept gently used donations of kids' items. Don't forget to contact libraries, schools, community-based or faith-based organizations in your network to inquire about whether they would benefit from a specific donation. Be prepared to explain exactly what it is that you are offering so that program leadership knows whether they can use it.

What about that puzzle missing a piece, a board game without all the parts, leftover craft and art supplies or other random things you run across? While your first inclination may be to toss it in the trash, a relatively new nonprofit called Creative Reuse Marketplace diverts material away from landfills to be reused by artists, teachers, students and community groups. Check out their website (creativereusemarketplace.org) for a room-to-room guide of items accepted and to make an



appointment for drop-off.

And remember: Once something goes into a donation box, make an immediate plan about where it is going, lest it sit in the corner of your toddler's room for a month (looking at myself here). Some organizations such as Hope and Salvation Army will even come to your home to pick up donations if you make arrangements ahead of time. Habitat for Humanity will pick up large items, such as furniture and home décor that are donated to the ReStore.

Get your kids involved...

One rainy day, take the time to sort through toys and games alongside your kids in order to weed out broken or missing pieces. Kids are very good at categorizing items – Legos with Legos, Tinkertoys with Tinkertoys, etc. Nine times out of 10, once I've started a decluttering or organizing project alongside my boys, they find some gem that they haven't played with in a little while, allowing us all the benefit of some new and novel independent play.

...Or not

If you aren't getting anywhere with your children by your side, sort through kids' things when they are out of the house. I know, I know. This has the potential to go badly if your child's room is full of beloved treasures, but I've found that taking a stab at the clutter on my own can oftentimes be the key to productive organization. Nervous about accidentally removing something precious? Break the above rule about moving donations out of the house immediately, and put a box or bin of less used but "not ready to get rid of" items somewhere out of sight. Let your child know that their items are still in the house and to simply ask if they are missing something. Chances are good that you'll be able to donate most of the things you moved after some time has passed. □

Planting a pollinator garden

A fun project for the whole family

One out of every three bites of our food, including fruits, vegetables, chocolate, coffee, nuts and spices, is created with the help of pollinators, according to the U.S. Department of Agriculture. Pollinators include not just bees, but birds, beetles, butterflies, moths, bats and more, and are an important piece of food creation around the world.

Unfortunately, the U.S. Department of Agriculture reports that dwindling habitats, diseases, parasites and environmental contaminants have contributed significantly to a drop in pollinator species across the world. Illinois' state insect, the monarch butterfly, has seen its population drop from one billion to only 34 million in the past 25 years. This spring, consider installing a small pollinator patch, sometimes called a butterfly garden, for the sake of the monarchs and more.

According to Patty Brockmeyer, owner of Designer Landscapes in Farmersville, some perennial flowers that attract butterflies and other pollinators include aster, sedum, false sunflower, Joe Pye weed and swamp milkweed. Joe Pye weed and swamp milkweed both boast a vanilla scent that butterflies and hummingbirds find irresistible.

Butterfly weed is another popular perennial pollinator, and its tangerine orange

blooms are favored by monarch butterflies. Annual flowers that attract butterflies and bees are numerous and include zinnias, lantana, petunias, cosmos and marigolds. Brockmeyer also recommends herbs such as dill and parsley for inviting pollinators to your garden.

According to the Illinois Department of Natural Resources, the requirements for a successful butterfly garden include six or more hours of sunshine per day, a flat or slightly sloped location that is protected from wind and loose, well-drained soil. Once native plants have grown into their space, they need very little watering. As far as arranging your plants, pollinators prefer you to plant in clumps, rather than in rows or spread out. This is because butterflies and other pollinators are most attracted to concentrated color and scent.

If you don't have much space to install a garden, containers work wonderfully for this sort of project. Choose containers of varying heights to add visual interest and to allow different plants to grow into their spaces. Larger containers will allow your plants to grow larger root systems and prevent potting soil from drying out quickly. Be sure there are drainage holes in the bottom of your containers so that your plants' roots don't rot.

While you are dreaming up your garden,

invite the entire family to help out. The proven benefits of gardening with children include healthier eating, boosted confidence, increased planning and analytical abilities, lowered stress and improved mood. Gardening with children also allows your kids the time and space to consider and ask questions about everything from the water cycle to the cycle of life. Allowing kids to get their hands dirty will help instill in them a love of nature and the outdoors that will last a lifetime.

Brockmeyer's tips for planting a butterfly garden with young children are to teach a respect for nature and make it fun. Bring your children along to choose plants or seeds, and involve your kids in planting, watering and fertilizing their sprouts. Get your children involved in painting rocks or building birdhouses to decorate your garden space. And as for the bees your garden will undoubtedly attract, Brockmeyer recommends simply teaching your children to respect them, to never pick them up or swat at them, and to enlighten kids on the usefulness of bees for our environment. □

Growing fruit for the home gardener

While farmers markets bring us fresh, local fruit in season, and grocery stores bring us everything else, nothing beats the taste – or the carbon footprint – of a freshly plucked fruit from the backyard.

Growing fruit in the backyard is easy, even for those without a green thumb. First things first, what do you like to eat? Locate a sunny spot in your yard, and let's get planning and planting.

Some fruits are tropical, and no matter how much you like oranges, it's not possible to grow them outdoors in Illinois. We are in USDA Plant Hardiness Zone 5b/6a, so make sure whatever fruits you choose can grow here.

Fruits grow on trees, bushes, vines, brambles and as small plants. After you choose your favorites, locate a sunny spot in your yard that gets at least six to eight hours of sunlight daily. Typically, the more sun, the sweeter the fruit.

Many backyard growers prefer dwarf or semi-dwarf trees. The advantages of using smaller trees are that they tend to produce fruits sooner than standard-size trees, and they stay smaller so picking is easier. However, these smaller trees may need to be staked or supported and have a much shorter life span than standard trees, usually 10-15 years. If you have the space, a good compromise can be to plant dwarf trees for your children and standard trees for your grandchildren.

For those with very limited space, fruit trees can be espaliered, which is a pruning style that approximates a 2-D or "flat" tree. These are usually grown against a wall or fencing. Most fruit trees, vines and brambles benefit from a yearly pruning.

Fruit trees that grow well in Illinois include pear, apple, persimmon, serviceberry (Juneberry), plum, mulberry, apricot, cherry, peach, paw paw



and nectarine.

Blueberries grow in acidic soil not found in Illinois, so amending the soil with something like pine needle mulch is necessary. Currants and gooseberries are not commonly eaten anymore, but grow well here. Goji berries may seem exotic, but grow well in our zone, as do honeyberries.

Fruit vines typically need to be supported with trellising. A trellis can be easily constructed using T-posts and heavy-gauge wire, but can be as elaborate and beautiful as desired. Grapes are the most common fruit vines, but hardy kiwi and passion fruits also grow here.

Brambles, or cane fruits, can be trellised for easy maintenance and picking, or be allowed to grow wild in a patch. Brambles multiply easily, some putting down roots from any contact with the soil, typically from the tips. Raspberries, black

raspberries and blackberries are the most common brambles, though thornless cultivars are available.

Small plants like strawberries are one of the most delicious and easy fruits to grow. Ground cherries are not perennials, but tend to self-seed.

Any of these backyard fruits can enrich your life not only through the taste explosion, but also the health benefits. Americans on the whole do not eat enough fruit, and being able to snack while in the backyard supports our health.

The nice thing about perennial fruits is that they are planted once, given minimal yearly maintenance and produce fruits for years. The biggest commitment is financial. Fruit trees and plants can be sourced through local or online nurseries or big box stores. Plus, fruit trees and plants can be purchased using EBT funds, commonly known as food stamps, wherever EBT

is accepted.

Backyard gardens aren't the only places fruits are being planted in Springfield. Michael Clark, founder of the nonprofit Ecofluent, is working hard to "help the community by providing sustainable food for easy access for anyone looking for a bite to eat."

Funds received from the Springfield Jaycees, Springfield Park District and more have enabled Clark to install trees at a variety of community gardens, including the Washington Middle School Community Garden, Enos Park Neighborhood Gardens and Motherland Community Garden Project, as well as schools such as Feitshans Elementary School and a number of local parks, including Jefferson, Comer Cox, Jaycees and more.

Clark encourages anyone interested in assisting Ecofluent in their mission to get in touch through Facebook as both volunteers and monetary donations are appreciated.

Neighborhoods are also getting in on the action. The Enos Park neighborhood has a community orchard that includes apples, pears, plums and mulberries. The Enos Park Neighborhood Gardens has established a free U-pick strawberry patch, as well as a plethora of other fruits. Both are free and open to the public in season.

For Clark, fruit trees are a part of the solution to food insecurity. "Sustainable agriculture is the main thing. We're trying to bring awareness to how many options there are for solutions to problems that burden us regularly in society." □

Gumbo z'herbes

Gumbo of greens for Good Friday

Fat Tuesday marks the last night of eating rich, fatty foods before beginning the Lenten ritual of self-sacrifice and fasting. In South Louisiana, Catholics go to Mass on Ash Wednesday, give up meat on Fridays and make small sacrifices until Easter to signify their piety and atone for the excesses of Mardi Gras revelry.

The word “Lent” comes from the Old English “lencten,” which means springtime, a time of renewal, and cleansing. Fasting and self-denial were meant to restore simplicity and renew spiritual growth. The practice of the Lenten fast began in the fourth century, when all meat products, except for fish and seafood, were forbidden. Nowadays, many people consume meat sparingly during the Lenten season leading up to Easter.

In New Orleans and the Cajun country of Southwest Louisiana, it's a Good Friday tradition to serve a plant-based gumbo known as gumbo z'herbes (meaning a “gumbo of herbs”) as a meatless alternative. The Cajuns pronounce it “gumbo zab,” and it's soup made with several types of greens, always an odd number, and usually containing seven or nine different varieties. An even number of greens is believed to bring bad luck. It is also believed that the number of greens your gumbo z'herbes contains will be equal to the number of new friends you will make in the coming year.

There are three theories of the origin of gumbo z'herbes. The Cajuns were descendants of the French Acadians and gumbo z'herbes resembles the French *potage aux herbes* or herb soup. A green stew called *callaloo* came over from West Africa with the slaves. Germans who emigrated to the area brought their tradition of serving a dish of seven or nine different greens, called Grünerdonnerstagsuppe (Green Thursday soup), on the Thursday before Easter.

Regardless of religious beliefs, this is a time of transition from winter to spring, from freeze to thaw, from austerity to abundance, from dormancy to new life. After a winter of heavy foods and sedentary living, gumbo z'herbes is the heady spring tonic that the body is needing. The aroma of fresh greens simmering on a stovetop is heavenly.

This is a dark roux-infused gumbo. A roux is a mixture of flour and fat that is used to thicken sauces. Roux is made by heating a fat (lard, butter or vegetable oil) on a stove top, incorporating an equal weight of flour, and cooking until the desired color and consistency is achieved. A roux can range in color from white to dark brown; the longer it's cooked, the darker it becomes. Lighter roux are commonly used to thicken sauces but add little flavor. A darker roux imparts more flavor but is less thickening. The practice of using a dark roux in

Cajun and Creole cookery probably developed as a way of masking the gamey flavors of such meats as squirrel, opossum and racoon.

Gumbo z'herbes

This gumbo is traditionally made on Maundy Thursday to be consumed on Good Friday. The gumbo is actually better the day after it's made. Serve over rice or just enjoy as a soup. It's also good with cornbread.

Serves 6-8

Equipment

6-8 quart heavy-bottomed stock pot, whisk, wooden spoon and a small ladle

Ingredients

3 thyme sprigs
2 bay leaves
4 whole allspice
6 whole black peppercorns
9 tablespoons canola oil (120 g)
1 cup all-purpose flour (120 g)

1 cup diced yellow onion
1 cup diced green bell pepper
2 ribs celery, finely diced
2 tablespoons minced garlic
2 quarts vegetable stock

Assorted greens (see note below)
½ small head green cabbage
1 bunch collard greens
1 bunch kale
1 bunch turnip greens
1 bunch mustard greens
1 bunch Swiss chard
1 or 2 heads green leaf lettuce
1 (5-ounce) bag baby spinach
1 (5-ounce) bag arugula
1 medium zucchini, chopped
Kosher salt and freshly ground black pepper
2 tablespoons tomato paste
Cajun Seasoning Blend, to taste
A few dashes Worcestershire (optional)
6 cups cooked long-grain white rice
1 cup diced green onion tops

Filé powder (look for in the spice section of your grocery or natural foods store)

Note: You may substitute other types of greens such as: dandelion greens, beet greens, carrot tops, bok choy, watercress or flat-leaf parsley

Preparation

In a piece of cheesecloth, make a sachet with the thyme sprigs, bay leaves, allspice, peppercorns, and tie off with a piece of kitchen string.

Wash the greens in several changes of water and trim away any hard stems. Chop greens into large pieces.

In the stockpot set over medium-high heat, heat the oil until just smoking. Turn off the burner and add the flour to the hot oil, sprinkling it in gradually to avoid splattering (it's called Cajun napalm for a reason), and stir with a wooden spoon. Turn the heat back on to medium, and continue cooking and stirring.

Once flour starts to brown, in about four to five minutes, reduce the heat down to low and stir slowly, until the roux is the color of milk chocolate, as much as 45 minutes longer, depending on your heat source.

Add the onion, bell pepper and celery, and stir to coat the vegetables in the roux. Increase the heat to medium and cook until the vegetables sweat well and turn soft, another six to eight minutes.

Stir in the garlic, turn off the heat, and allow the roux to rest off the heat for 10 minutes for the flavors to meld.

Deglaze the pot with half of the vegetable stock and simmer until everything is incorporated, about 5 minutes. It will get very thick. Add the remaining stock, bring to a boil, add the herb sachet and reduce to a simmer.

Add the greens in batches, adding the next handful after the previous is wilted and soft, stirring well before and after each addition. Once all greens are added and have wilted, add the zucchini, tomato paste and 2 teaspoons of the salt, stir the pot well, reduce to a simmer and simmer for one hour uncovered, stirring regularly. Skim off and discard any fat that rises to the top, using a small ladle. After an hour, remove the herb sachet, add the Cajun seasoning to your taste, more salt and black pepper to your taste, and Worcestershire if desired.

Serve over hot rice and top with the green onions and a light dusting of filé powder.



If you can't find something to your liking this weekend, well I don't know what to say, other than, wait until next week because there's probably going to be even more.

Let's get started with Friday, as that's most certainly a fine and logical place to commence our live music adventures for the weekend. Also, there's so much going on on this one night, it's truly a wacky and wonderful sight to behold. This week is a treat when guitarist extraordinaire David Lumsden comes with a load of jazz licks, along with a good bunch from jazz's older sibling, the blues. Be sure to ask Dave about his latest CD, *Rooted in the Blues*, and don't go home without one. You Springfield music-mates will know the regular and guest musicians on this locally produced and played recording, which includes a beautiful rendition of a Greg Pasko song called "Your Memory," where David is accompanied by Andon Davis. That's a triumvirate of Springfield-bred guitarists if ever there was one. Now where were we, on Friday night still, and only one gig mentioned?

How about this double bill of Unchained and BuK at the Curve or the mighty mash-ups of Fun DMC at Motorheads? Perhaps your fancy would be tickled with the Big Suns at Weebles or Captain Quirk at Long Bridge, or you might mosey on down to the Keg for Punk Night or travel to Boondocks for the cool country of Whitey Morgan and the 78s.

Downtown gives us Mississippi Leghound at Whiskey Jack's and Devin Williams at Buzz Bomb, plus Sam Crain and Jose Gobo (double-trouble jazz guitar-ing) at Anchor's Away. Some familiar names back in the saddle again include Cactus Ranch at George Ranks, JackAsh at the Blue Grouch and Angel Brown at Lime Street. Add in West End Boogie Project at the Northend VFW, Rod Grant Acoustic at Locals in Pawnee and Schroeder's DJ Service (hi Brad) doing the Dew Does Karaoke at the North Grand location and, hello my friends, that's a Friday night to remember.

On Saturday afternoon, Elvis Himself returns to the Hoogland for a 3 p.m. matinee as Rick Dunham completes his Elvis Top 40 shows with this third and final installment. The concert covers all of Presley's Top 40 hits from 1968 on, including many of the King's most familiar tunes, plus some very unusual cuts, so come to be entertained and educated. Interestingly, the latest addition, that old chestnut "Blue Christmas," entered the Top 40 in 1919 after first being released in 1957, so it just recently made the list.

Saturday night from 7 to 11, Mowie's Cue, all set up with a stage area specifically for live music (thank you very much), hosts the fifth Positively 4th Street anniversary party with the original P4S group joined by Murder of Crows and The Down Homies. The amazing and versatile (and in demand) Geoff Ryan plays bass in all three groups, keeping him out of trouble for the night. With Tom Beverly as the P4S ringleader, there will be lots of good times as this intertwined group of longtime friends come together for a night of unforgettable music making.
