

Legislation would support local journalism

"We are living through seismic changes in how people consume news."

The number of journalism jobs at Illinois newspapers has dropped 86% since 2005, but press advocates see signs of hope in proposed college scholarships, state tax credits, scholarships and other subsidies to benefit local news outlets.

"I'm cautiously optimistic we will see something," Sam Fisher, former president of the Illinois Press Association, said as the scheduled May 24 adjournment of the Illinois General Assembly's spring session approaches.

The package of legislation has "raised awareness of the local news crisis that we have," he said.

Senate Bill 3592, dubbed the Strengthening Community Media Act, passed the Democratic-controlled Senate 43-13, mostly along partisan lines, on April 17, and headed to the House floor after passing a House committee May 1 on an 18-8 vote.

The legislation would create state-funded college scholarships for students pledging to work at local news organizations in Illinois for at least two years after graduation and require 120 days prior notice before local newspapers can be sold to out-of-state companies.

Senate Bill 3591, titled the Journalism Preservation Act, would require online platforms such as Google and Meta, the parent company of Facebook, to pay fees to newspapers and other media organizations when linking to, displaying or otherwise presenting digital news content.

That legislation, which would provide a steady stream of revenue to news organizations, is being considered in several states.

Legislation adopted by Canada late

in 2023 is expected to funnel up to \$100 million in Canadian dollars to media companies in that country each year.

SB 3591 hadn't received any votes in the House or Senate as of May 7, but still could be considered in the waning days of the session, according to bill sponsor Steve Stadelman, a Democrat from the suburban Rockford community of Loves Park.

Tim Franklin, an associate dean and director of the Medill School of Journalism at Northwestern University, said the internet subsidies "could be a game-changer for a lot of local news organizations," and the tax credits and scholarship program would be a big help for a struggling industry.

It's "too early to tell" whether the legislation in Illinois and other states will save local journalism, Franklin said, but "it couldn't hurt."

"This is a time of both great peril for local news and a time of great possibility," he told *Illinois Times*. "We are living through seismic changes in how people consume news."

The legislative proposals emerged from the Illinois Local Journalism Task Force report, released in January 2024. Participants on the task force included Fisher; Franklin; former state Rep. Tim Butler, R-Springfield; NPR Illinois General Manager Randy Eccles; Allison Petty, Lee Enterprises central Illinois executive editor, representing the Illinois Legislative Correspondents Association; and Jason Piscia, director of the Public Affairs Reporting Program at University of Illinois Springfield.

Stadelman said the proposed scholarship program is designed to create a pipeline of prospective journalists. And he said

prior notification will give nonprofits and local business entities more time to buy newspapers that are up for sale and maintain local control.

Preserving local ownership is critical now more than ever, Stadelman said, because newspapers have lost advertisers to the internet and hedge funds. Publicly traded companies such as Gannett and Lee Enterprises have been buying local newspapers and then gutting newsroom staffs to boost corporate profits and satisfy shareholders, he said.

"Let's give opportunities for local entities," Stadelman said during debate on the Senate

But Sen. Jason Plummer, R-Edwardsville, who voted against SB 3592, said advance notice would lead to more hedge-fund and out-of-town purchases of local newspapers because those entities could outbid local groups.

Stadelman, a former Rockford television news reporter, said Plummer's scenario was unlikely.

Republican senators voting in favor of the bill included task force member Donald DeWitte of St. Charles; Steve McClure of Springfield; Sue Rezin of Morris; and Chapin Rose of Mahomet. Democrats voting in favor included Doris Turner of Springfield.

Republican Sally Turner of Beason voted against the bill.

Stadelman said he believes more Republicans will support the bill when they are educated about the problems facing local media

SB 3592 originally included refundable tax credits for news organizations for each reporter hired or retained – or up to \$25,000 per "qualifying journalist" each year. Also included was a provision to give small businesses up to a \$2,500 state tax credit when they advertise with local newspapers or broadcasters.

Stadelman removed those credits before the bill passed the Senate. He said he hopes to pass them in a separate bill.

He had no estimate of the cost to the state for the tax credits or the scholarship program. He said he will try to get money for those purposes included in end-of-session legislation to fund the upcoming fiscal 2025 state budget.

New York Gov. Kathy Hochul recently signed a 2025 state budget that included \$90

million in tax credits for local media outlets over a three-year period. Advocates of those credits worked for several years to pass them into law, Stadelman said.

He noted that New York's budget is larger than Illinois', and this is the first year he is pushing legislation to preserve local journalism in Illinois.

Publicly traded companies aren't eligible for the new tax credits in New York. Such companies would be eligible for the proposed Illinois tax credits, but there would be caps for each newsroom and corporation.

A Stadelman aide said the legislation is tailored to ensure any financial benefits to news organizations are invested in local coverage rather than used to boost corporate profits and benefit company officials already earning multimillion-dollar salaries.

Franklin said Illinois' newspaper journalism job losses are proportionately the largest in the country. That may be because Gannett, and its predecessor, GateHouse, owns or owned more than 20 papers in the state and have aggressively reduced the number of journalists employed, he said.

Lee Enterprises has eliminated many jobs at its downstate newspapers, and there have been "huge job losses" at the *Chicago Tribune* since 2005, Franklin said. Alden Global Capital, a New York-based hedge fund known for slashing newspaper budgets, bought the *Tribune* in 2021.

"These are staggering losses, and the implications are profound," Franklin said. "This has an impact on civic engagement. There's research that shows that in 'news deserts' and low-information communities turnout in local elections drops, the number of candidates seeking office drops and straight-ticket voting increases ... so there's more partisanship in how people vote."

Research also shows a lack of watchdogs in communities results in increases in government borrowing costs, he said.

Education of lawmakers and the public is key to turning the situation around, Franklin said.

"The challenge is that the vast majority of the public doesn't know there's a crisis in local news," he said. □

Editor's note

The Lincoln Presidential Foundation brought preeminent Lincoln scholar Harold Holzer to Springfield this week to expound on his new book, *Brought Forth on this Continent: Abraham Lincoln and American Immigration*, and the role Springfield played in shaping his emerging views. Petersburg man pleads guilty to child porn charges

Some victims were teenage boys from the area

A 30-year-old Petersburg musician, music teacher and former volunteer in Springfield-area theater productions could go to federal prison for at least 15 years after pleading guilty May 3 to 34 counts of producing, receiving and possessing child pornography.

Adam L. Power is scheduled to be sentenced by U.S. District Court Judge Colleen Lawless on Sept. 5. He has been in federal custody since June 30, 2023, and is being held at the Sangamon County Jail after first being charged in Menard County Circuit Court in March 2023 with eight felony child pornography charges.

Federal prosecutors said in a news release that Power used online chatting applications such as Snapchat and Kik to portray himself as an underage female to convince adolescent boys to produce pornographic images of themselves. The charges said the unlawful activity took place between July 2022 and March 2023.

Prosecutors wouldn't comment beyond the news release, but court documents indicated at least some of the victims were from the Springfield area.

It's unclear whether any of the victims were youth involved in area theater productions and programs and were part of a 2018 investigation conducted by Springfield police in coordination with the Illinois Department of Children and Family Services.

Power was the focus of parents' complaints to the Springfield Theatre Centre Board that year. Community theater supporters Johnny Molson and Kari Bedford told the board that their daughter was among those who received inappropriate text messages from Power when she was a minor and acting in local productions.

Power was vocal director of an STC musical, *Annie Get Your Gun*, in late 2019. *Illinois Times* reported in April 2023 that complaints from parents prompted the STC board to remove Power from the show, and the Hoogland Center for the Arts banned Power from the building.

Power never faced criminal charges in connection with that investigation into his alleged inappropriate online comments and text messages to minors he met as both a volunteer and paid staff member in STC programs and productions. A DCFS spokesperson told *Illinois Times* the state agency determined the 2018 allegations to be

"unfounded."

After learning of Power's guilty plea, Molson, a marketing consultant, told *Illinois Times*: "It's been a long time coming, and I'm certainly grateful that federal authorities came in. This is something that could have been nipped in the bud earlier if people had listened to the victims."

Bill Bauser Jr., also of Petersburg, a former volunteer member of the STC executive board, was the person who asked Power to be vocal director of *Annie Get Your Gun* when Bauser, 57, was the STC board's volunteer executive director and treasurer.

The STC board later asked for, and received, Bauser's resignation from the board in December 2019.

Bauser, who has not been criminally charged, resigned from the board of Springfield Municipal Opera in early April 2023 after being appointed in December 2022. The resignation came after youth and parents involved in area community theater groups complained on public websites that Bauser hadn't done enough to protect

children from Power.

Before Bauser resigned, the Muni hired former federal prosecutor John Milhiser – prior to his reappointment as Sangamon County state's attorney – to conduct an investigation that would help Muni officials decide whether Bauser should remain on the board and continue to volunteer running concessions and performing other tasks at the outdoor venue at 815 E. Lake Shore Drive.

Milhiser completed his investigation into Muni internal policies, according to Dennis O'Brien, chairperson of the Muni Trustees. O'Brien wouldn't disclose the results of the investigation to *Illinois Times*.

Bauser was fired from his \$43,860-a-year job as Rochester Community Unit School District 3A's auditorium and fine arts director on April 19, 2023. The School Board's resolution to fire Bauser, which passed unanimously, said Bauer allegedly made "sexually suggestive" comments to Rochester High School students and violated the district's code of professional conduct by bullying, intimidation and harassment.

Power, who had no prior convictions, initially was indicted by a federal grand jury on 10 counts in July 2023. The number increased to 34 in an updated indictment in January.

Menard County State's Attorney Gabe Grosboll said he agreed to drop the local charges because of the federal government's expertise in investigating and prosecuting a case such as Power's.

Power pleaded guilty to the seven most serious counts – production of child pornography, also known as sexual exploitation of a child – as well as eight counts of distribution, 18 counts of receipt and one count of possession of child pornography. Each count of production of child porn carries a penalty of at least 15 and up to 30 years in prison.

Power's attorney, Daniel Fultz of Springfield, declined comment.

Court documents indicated Power used various "internet protocol" addresses and various cellphones and other computer devices to pose as various females with different chat account user names.

One of the boys targeted by Power was 14 when he began chats with Power, according to the documents. Authorities said they learned that the boy and his brother, also a

minor, attended church with Power, and the boy's brother received music lessons from Power.

Another victim, who was 15 when the chats with Power's aliases began, attended an area high school, according to court documents.

The documents recounted a chat with one of the boys in which Power relentlessly asked to be sent nude photos and called the boy "chicken" and a "wimp" when he refused. Among the videos that Power obtained was a sexually explicit video of the same boy.

Power was first arrested in March 2023 while living with his grandmother in Petersburg,

Power previously was employed at Our Savior Catholic School and Routt Catholic School, both in Jacksonville, and he worked as a substitute teacher at Petersburg PORTA High School, from which he graduated in 2012.

Court documents said he formerly was a choir director at Central Christian Church in Jacksonville and worked at Nelson Oil.

In the wake of the controversies involving Power and Bauser, representatives of area performing arts groups gathered at the Hoogland on May 13, 2023, to hear a presentation of how child abusers groom their victims, according to Hoogland Executive Director Gus Gordon.

The meeting "started that dialogue" to prevent future incidents, he said.

Many arts groups have improved their screening and monitoring procedures to protect children and other volunteers and staff from abuse, Gordon said.

"There's no good reason for any adult to contact a child privately," he said.

Former Muni Opera president Mac Warren, who remains on the Muni board, said the meeting last May was a "good start," but more needs to be done to protect children throughout the arts community.

Molson said he was disappointed with the relative lack of follow-up work by the arts community to prevent more abuse.

"Without a concerted effort, the door is open for it to happen again," he said. □

Future of Logan Correctional Center uncertain

Governor says Lincoln can't rely on prison for economic development

Gov. JB Pritzker says it's time to look beyond prisons when promoting economic development in rural Illinois, but that's little consolation for the 500 workers at Logan Correctional Center who fear losing their jobs.

The state is eying shutting down the prison in Lincoln and rebuilding Illinois' main prison for women elsewhere.

One possibility under consideration is rebuilding the women's prison in Will County near Stateville Correctional Center, a maximumsecurity prison for men, in Crest Hill.

The price tag for doing this would be about \$935 million, Alex Gough, a spokesman for Pritzker said.

State Rep. Bill Hauter, R-Morton, said this estimate likely understates the cost of building a prison in the Chicago suburbs.

"The labor is going to be more expensive, the construction costs will be more," he said.

He noted that Lincoln, a city of 13,300, already is facing economic headwinds with both Lincoln Christian University and Lincoln College shutting down in the last two years. Losing another major employer would devastate the community, he said.

"Economic activity will be reduced if they move the prison away from Logan County. And in Will County, at Stateville, it's probably not even a blip. People up there don't even know that this is an issue. They could care less," Hauter said.

While in Bloomington on May 7, Pritzker told reporters, "We should all be paying attention to how can we get more economic development into the area, into Logan County and make sure that in Lincoln in particular, that we're attracting great new private sector jobs. I don't know where

the facility will end up."

State. Sen. Sally Turner, R-Lincoln, said she is working to make sure the prison is rebuilt in her community.

"We want them to continue at Logan Correctional Center there in Lincoln, Illinois," she said. "One of our big things to consider is that 54% of individuals incarcerated are from downstate. So, this is a central area for their loved ones – their family, their friends – to be able to visit the folks in those facilities. And that's really important for them to grow and to get better in the situation that they're in."

One thing that there is little disagreement over is that Logan Correctional Center is in a grave state of disrepair. More than \$100 million in needed maintenance and renovations have been

put off at the prison, Hauter said.

Gary Davis, who leads a volunteer ministry at the prison and recently stepped down as the head of the Logan County Democratic Party, said the conditions are abysmal.

"The living conditions are awful. It's just not a clean place, and there's a lot of unnecessary disease, a lot of mental illness that doesn't get treated," he said. "The place is a mess and it needs to be closed. The people that live there are being subjected to inhumane living conditions. There have been all kinds of organizations that have come out there and certified that."

While he personally doesn't want to see the prison continue in Lincoln, most of the inmates he has spoken with want to keep it in that small town. Davis said.

"I have yet to find somebody that wants to see it rebuilt in the Joliet area or near Chicago. This is really odd. And it runs counter to much of what I've been told," Davis said. "These COs – the guards – they're typical Midwestern nice guys. They're just decent people. I think for some of these prisoners, it's the first time they've ever interacted with normal, nice people."

Despite this, Davis said economic development is a poor reason for maintaining the women's prison in Lincoln.

"It's too bad they're going to lose their jobs, but I have a hard time defending the organization's continued existence, given the fact that it's contributing virtually nothing to the state. It's sucking up about \$70 million a year. ... I could think of a lot better ways to spend \$70 million than to (have it) go into a spot that has 40-year-old or 80-year-old buildings that are falling apart and that are unhealthy and condemned by all kinds of authority figures – just to give these guys and gals a job."

During his Bloomington press availability, Pritzker also said, "I'm excited about the prospect of attracting new businesses to the area just like we're doing here in Bloomington. And I think that really is the future for most places across the state, to not rely upon a state-run facility that's a prison. That can't be a great economic growth strategy for the area."

Turner does not fully share the governor's view.

"It just feels like this is kicking us when we're down," she said. \Box

The end of the rainbow

Rail project displaces five halfway houses, owner says he won't relocate House of the Rainbow

Despite a past pledge to reopen his halfway houses for men being released from prison, Dave Kettelkamp said that he is calling it quits after his venture, House of the Rainbow, was displaced by the high-speed rail project.

Ironically, Kettlelkamp said he is getting out of the lucrative business of housing former Department of Corrections prisoners because the caliber of inmates being released is worse now than when he operated the homes, which closed in 2020.

"The inmates coming out of prison now just have an attitude – they are hard to work with. The quality is a lot less than it used to be," he said.

Parolees were housed in five single-family homes at the corner of North $10^{\rm th}$ and Enterprise streets, and city officials have said House of the Rainbow operated without proper zoning for a nearly decade before a homicide committed by one of the residents called attention to the homes.

In 2013, Mark A. Brown, 50, a parolee staying at House of the Rainbow, killed 47-year-old Rebecca Cleaton at a home in the 900 block of North Ninth Street. Cleaton, who was homeless at the time, was beaten to death. Brown had cut his ankle monitor off and was arrested in Champaign. He is serving a 27-year prison sentence for the murder.

Kettelkamp then filed a zoning request to bring the properties into compliance. A former resident, Jermaine Davis, gave a speech to the Springfield City Council supporting House of the Rainbow.

"I got out of prison. I learned and I moved on. How many times can we do that, get out of a terrible situation, learn from the situation and really move on? There's not too many times or situations we can do that. Small or big," he told members of the council at a January 2014 meeting.

The City Council rejected the zoning petition, but Kettelkamp's attorney, Tom Immel, filed an appeal and the homes were allowed to continue to operate for the time being.

Six weeks after the council meeting, Davis and another former resident, Sancho Mitchell, were arrested and charged with a double homicide that had occurred while both were residents of House of the Rainbow.

On Dec. 31, 2012, Larry Grice and Andrea Pocklington were killed in Pocklington's home at 924 N. Ninth Street. Police contended that Davis shot Grice in the back of the head and

Mitchell stabbed Pocklington, who was pregnant, in the neck and abdomen. Davis is serving a life sentence for the murder and Mitchell is serving 35 years.

Kettlekamp said his decision to call it quits had nothing to do with the three homicides.

"You know things like that happen, no matter where you are," he said of the murders. "Just because they came out of prison, came to my house, don't mean that they were bad persons. They just made a bad choice when they came back to my house. ... They just ain't doing anything with (inmates) in prison other than just letting them be there to do their time and getting them out."

He said it was this lack of rehabilitation – not the violent crimes committed by his past residents – that prompted him to slam the door shut on future halfway-house endeavors.

In 2020, the high-speed rail project

displaced the houses operated by the House of the Rainbow.

"It was just a blessing that the railroad took me out," Kettelkamp said. "That's all I could sav."

The Department of Corrections was paying Kettelkamp more than \$300,000 a year to house the newly released inmates. At the time that the railroad project displaced the homes, Kettelkamp had said he planned to relocate House of the Rainbow to somewhere else in Springfield.

Kettelkamp, who now works as a laborer for Woodside Township, said he has since changed his mind

"I just got tired of it, man. I got tired of the guys. The guys coming out of prison these days are a whole 'nother generation, man," he said.

John Keller, president of the Pillsbury Mills Neighborhood Association, said he is pleased that the area is rid of the halfway houses.

"Some of (the former inmates) were standoffish and kept to themselves, and a couple of them were actually decent people who had problems with their life and tried to follow the rules. ... I won't condemn everybody that was there, because there were a few people there that tried to be decent," he said.

Nonetheless, Keller said House of the Rainbow was an impediment to redeveloping the neighborhood. He said neighbors found it difficult to sell their houses.

"I don't think anybody would have wanted to sell their house, because I don't believe they would have had too many takers for it," he said. \(\Pi\)

A state tax on services?

Governor signals he is open to the idea as legislators seek funding for mass transit **POLITICS** | Rich Miller

Gov. JB Pritzker unexpectedly moved away last week from his long-standing opposition to taxing services, saying he didn't want to start taking ideas off the table as lawmakers search for ways to fund and reform the Chicago region's mass transit system. A major business group predictably pushed back.

As you may know, Chicagoland's mass transit agencies are facing a \$730 million "fiscal cliff" in 2026. The federal government's COVID-era subsidies will expire that year. Also, ridership has declined as service worsens, operating costs have increased and average fare prices have fallen

According to a report last year from the Chicago Metropolitan Agency for Planning (CMAP), imposing a service tax could be part of the solution. The CMAP report claimed adding a service tax to the state's existing 6.25% state tax rate could generate \$1.1 to \$1.9 billion in 2026. Some legislators are proposing a \$1.5 billion annual funding increase for transit as part of a consolidation effort.

So, my associate Isabel Miller (who contributed to this column) asked Pritzker during an unrelated event if he wanted to take any state taxes off the table before the talks heat up, including the service tax.

"I have never been in favor of that before," Pritzker said of the service tax. He has indeed opposed the tax all the way back to his first 2018 gubernatorial campaign, often calling it regressive.

"There may need to be a source of revenue here," Pritzker said, "but that's not something that I have favored in the past."

As far as specifically ruling out a service tax, however, the governor said: "I really don't want to start saying, 'We're not going to do this, we're not going to do that.' At this point, there are just so many pieces of this that we have to look at before we're going to pay for what's necessary here as we come off of support from the federal government and making sure we're restoring transit services."

Some legislative Democrats pushing transit agency consolidation and reform welcomed the news of the governor's new openness to a service tax, which seems to be evidence that the governor is serious about finding a fix.

"I appreciate the governor being open to it, and I appreciate him recognizing this is a complicated matter," Rep. Eva Dina Delgado, D-Chicago, told me. Delgado introduced legislation (HB5828) last week to provide the systems an annual \$1.5 billion state appropriation once the mass transit system is consolidated.

Rep. Kam Buckner, D-Chicago, whose House Bill 5823 would create a consolidated transit agency, told me he's also opposed a service tax in the past. But Buckner said he is open to it now and said he appreciates that the governor is keeping an open mind.

Pritzker also reiterated last week that he's not yet endorsing any particular mass transit reform proposal, but insisted that "change is going to have to come."

That change in direction will be a complex endeavor, the governor said.

"We've got to look at cuts that need to be made, along with, you know, are there changes in fares for certain types of riders that need to be made," Pritzker said.

A Pritzker spokesperson later explained that when the governor said "cuts," he meant efficiencies to save money, like consolidating the regional transit system, but not service cuts.

A spokesperson for the Illinois Chamber told me the organization hopes the governor remains ambivalent about a service tax.

"From our position, taxing Illinois' service businesses – especially our smallest businesses – to close a budget gap is a non-starter. The tax would negatively impact the smallest of businesses: service-based small businesses and startups – especially businesses in counties that border other states as customers can save just by crossing the state line," the Chamber spokesperson said

One issue with a service tax is that implementing it would take time. Many of the businesses that would be covered are not currently set up to pay sales taxes, for example. The Chamber predicted it could take "several years" to implement a service tax, so it won't solve "short-term gaps."

"As the voice of Illinois business, we would welcome sitting down with the governor's team to discuss pragmatic ways to address the budget gap, but taxing services is not one of them," the Chamber spokesperson said. □



Turmoil at senior housing complex

Meadow View residents claim they're being bullied by managers. Managers says it's the other way around.

Senior citizen residents and the new management of a Springfield west end apartment complex have been at odds for several months over what some residents say is a concerted effort to intimidate them into moving out. The management, however, alleges that the problem is just a handful of residents who don't want change and who are using bullying tactics to get their way.

Meadow View Landing on Montaluma Drive is a three-story, 160-unit apartment complex that was purchased last October by the Highlands Vista Group of Denver, Colorado, which owns similar complexes in several states. Meadow View Landing consists primarily of residents 55 years of age and over, and while the Highlands Vista Group said it intends to keep that demographic when they purchased the complex, as leases have expired the company has begun renting units to younger tenants.

Several of the residents claim that opening up the complex to non-senior citizens has changed the atmosphere and cite an increased police presence, thefts in common areas and a much higher level of comings and goings as proof that things just aren't what they used to be at Meadow View Landing. Some of the residents also say they fear the two on-site managers, while those same managers allege they are being bullied by some of the residents.

The Springfield Police Department responded to the complex 21 times between January 1 and mid-April this year for a variety of issues, including welfare checks, disturbances and follow-up investigations. But it's not always the residents who are calling the police. Meadow View Landing managers called the cops earlier this year on 85-year-old resident Nancy Laird.

"I was arguing with the manager, I was up in her face, and she called the police," Laird said. "When the police came they asked if I was waving my hands around while we were arguing, and I said that if I was, I will take accountability. I was in her space, and I was too close to her face. I'm sure she told the police that I tried to hit her."

Laird was upset at the time about an issue that was echoed by several other residents. During the past several months those residents say they have had form letters delivered to their doors with the heading "Final Eviction Notice." The letters state that "there is a current delinquent rent amount due" and "you

are further notified that payment of said sum is hereby demanded of you" or the resident must "vacate the leased premises." The form letters, several copies of which were obtained by *Illinois Times*, do not list the name of the resident, the apartment number, the amount past due, or any other identifying information.

"I know I'm not delinquent and I can prove I'm not delinquent," Laird said. "The woman from corporate said she would look into it and I said don't bother, I'm reporting you for elder abuse."

Seventy-eight-year-old resident Linda Hardy had a similar experience.

"I got an eviction notice saying that I hadn't paid my rent, which is \$1,080. It turns out they made a mistake and only put \$80 on the

computer, so I was given 24 hours to vacate," Hardy said. "I went down to the office and I said, 'You have copies of my check right on the desk.'

"Why would they do that? What's their end game here? Why do they want us out? Do they want to bring somebody else in?" Hardy said. "I told corporate that I dread going to that office again."

John Krews is an 82-year-old resident who has lived at Meadow View Landing for seven years, and he also received one of the "Final Eviction Notice" form letters, even though he had paid his rent.

"I was told the check had been destroyed by the office's check-processing machine. So I went and wrote another check as a replacement for the original, and then I heard that check got destroyed as well," Krews said. "I keep a running notebook every time I deal with the management now because I get one story one time and discover it's different another time."

Seventy-eight-year-old resident Barbara Pitchford hasn't received a rent overdue notice yet, but she's uneasy about the situations her friends and fellow residents have encountered.

"What I'm scared of is the managers down there, they have all of our pertinent information, Social Security numbers, dates of birth, everything about us. They could do a lot of damage to us financially." Pitchford said. "Instead of being professional and treating residents with respect, they've intimidated and aroused people, and we are scared."

Jerry Ceglinski is a 70-year-old resident who has lived at Meadow View Landing for three years and he also received a form letter about overdue rent, which he claimed was due to the office misplacing his check. Ceglinski also started receiving separate bills for utilities, an expense that is supposed to be included in his rent, and got another past-due notice when he did not pay the utility bill.

"I took the bill to the office and they told me to disregard it because it wasn't legal and they assured me they would take care of it.

Then two weeks later I got another eviction notice saying I hadn't paid my utility bill so I had to vacate," Ceglinski said. "When I write rent checks I take a picture of my check and a video of it being dropped in the box so I have

Haley Wilson, communications director for the city of Springfield, said, "It is against city code and CWLP policy for landlords to resell, sub-meter or otherwise separately bill tenants for water or electric service." Wilson urged residents to come forward with copies of those bills so the matter could be addressed with the property owner.

Sheryl Stoffregen is the director of regional management for the Highlands Vista Group. She said the company "is not perfect, we do make mistakes," and added that, "Our goal is to help the residents there. We put a lot of money into the property and we've made some good changes there."

Stoffregen said she could not comment on many of the specifics regarding the concerns raised by individual residents, due to landlord-tenant confidentiality laws. But she said some of the confusion over rent payments has to do with funds that were not transferred six months ago when Highlands Vista Group took over Meadow View Landing from the old management company. Stoffregen said that when the company is made aware of mistakes in crediting rent payments, those errors are corrected.

But Stoffregen said a handful of residents "are refusing to pay for whatever reason" and when rent is owed and it is not paid, those residents must be notified in accordance with the Fair Housing Act. The notices that were shown to Illinois Times are not eviction notices despite their heading, she said, because an eviction notice is a legal document with the apartment number and the resident's full name listed, and "I don't have any evictions filed on that property."

The main problem is "six or fewer residents that are really adamant that we need to terminate our manager, and they did the same thing with our past manager," Stoffregen said. "Are you going to report the blatant racism that's been shown to my employees at that

Stoffregen said the first manager hired by

her firm for Meadow View Landing was a Black man and, "They harassed him from the day he walked on that property. They said they were scared of him." When the next manager, a Black woman, was hired, "The same thing happened, they're scared of her," Stoffregen said. "When I asked why they were scared, they told me they didn't like the way she looked at them."

Stoffregen said the residents have posted personal information about the former and current managers in common areas of the complex, including "false accusations" about their backgrounds, and have shared images of the managers, without their permission, as the managers have performed their daily tasks at the complex. The residents interviewed for this story gave *Illinois Times* a copy of one such posting that purports to show the background of a current manager.

"They first started calling and telling me that my manager and assistant manager, who are both Black, were mother and daughter, which is not true," Stoffregen said. "Then they told me my regional manager was the sister of the manager and assistant manager. She's from Atlanta, she has no relatives in Springfield. The only reason they think she's their sister is because she's Black."

"They're literally harassing my manager eight hours a day that she's on that property," Stoffregen said. "It seems unfair that somebody can get by with doing that."

Stoffregen shared a note she received from a Meadow View Landing resident, who asked to remain anonymous for this story, about the situation in the building: "The apartments that are causing major issues are bullies in the building and run over everyone. Why can't Tonya (the manager) and Octavia (the assistant manager) do their office jobs without the tattletales? Pay your rent, mind your business, let the managers manage the building, not the people. We are begging you to stop this."

Meanwhile, Stoffregen said there are no such issues at Meadow View Place, an adjacent apartment complex that Highlands Vista Group purchased at the same time as Meadow View Landing.

Rosanna Pulido (See "The Anti-Welcome Lady," April 5, 2018 *Illinois Times.*), is a 68-year-old Meadow View Landing resident who selected the complex because "it was peaceful and I chose to live around seniors because we're all on the same page," she said. "I wanted a place where I felt safe and secure. Most of us are paying nearly \$1,000 in rent, so we are not charity cases. I must give customer service where I work or I'm going to be out the door."


Pulido, a frequent and vocal participant in Springfield City Council meetings, has brought her concerns about Meadow View Landing to city officials, including Ward 7 Alderman Brad Carlson.

"I'm concerned about the situation because I think people need to have a safe environment to live. Nobody should wake up in the morning and go to bed at night concerned about what's going to happen the next day," Carlson said. "I had a productive meeting with the on-site manager to hear her side of the story. We both agreed to communicate back-and-forth when we hear different concerns or issues from the residents."

The city's Office of Community Relations "has investigated the situation developing at Meadow View Landing to gain a comprehensive understanding of the concerns of residents," said Wilson, the city spokesperson.

Regardless of which side in the Meadow View Landing situation the city and the public believe, resident Barbara Pitchford said people should pay attention to what is going on at the complex.

"The people that live around here on the west side of town in their nice houses, their property values will go down because of this," Pitchford said. "I love the location, I would still like to be here for the rest of my life, but things are making me kind of nervous about staying here." □

Greek cuisine among world's healthiest

Cookbook on Greek food a manual for living a long, happy life


NPR's *Morning Edition* recently reported on a study published in *The British Medical Journal* that concluded that eating ultra-processed foods harms our health. The study, which was based on data compiled from more than 9 million people, found "consistent evidence" that people who consume high amounts of ultra-processed foods have an increased risk of anxiety, depression, obesity, metabolic syndrome, colorectal cancer and premature death. This information should be a loud wake-up call, considering that more than 70% of the food supply in the U.S. is made up of ultra-processed foods and that manufactured foods comprise two-thirds of the food we feed our children and 60% of an adult's diet.

Ultra-processed foods are packaged foods and beverages that are made flavorful and enticing by the addition of chemically manipulated ingredients such as high-fructose corn syrup, artificial emulsifiers and thickeners, artificial colors and flavors, saturated fats, protein isolates and preservatives. These so-called food products usually contain high amounts of salt and little real whole food. Ultra-processed foods exist because they are convenient, affordable and accessible to people who don't have the time or resources to prepare meals from scratch using fresh foods. And deplorably, they are aggressively marketed to children.

The dramatic rise in chronic diseases and the increasing pervasion of ultra-processed foods into our modern diets have prompted many to attempt to "find a way back" by studying ancestral (pre-industrialized) diets and examining the diets of people living in "Blue Zones." Blue Zones are regions in the world where people live much longer than the average. The name is derived from a demographic study in which the researchers used a blue pen to encircle areas on a map with the highest concentrations of people who have lived to at least 100.

One of the five Blue Zones is the Greek island of Ikaria, the subject of a new cookbook by Diane Kochilas, the host of the television series "My Greek Table." More than just a book of recipes, *The Ikaria Way: 100 Delicious Plant-Based Recipes Inspired by My Homeland, the Greek Island of Longevity* is a manual for living a long and happy life. It is believed that the longevity of Ikarian inhabitants (more than one-third live past 90) is due to strong social and family ties, exercise integrated into daily life, frequent napping, and, of course, the foods they eat.

Greek cuisine is considered one of the healthiest in the world. Kochilas explains that the traditional Greek diet is predominately plant-based, though most Greeks would not consider themselves vegetarians. Animal protein is consumed in smaller quantities and often plays a supporting role in a dish, rather than being the main ingredient. Red meat, especially lamb, tends to be eaten just a few times a month and on special occasions. Instead, Greeks eat more vegetables, fresh or dried fruits, nuts, and legumes such as fava beans, lentils, chickpeas and split peas. They use olive oil instead of butter, honey rather than sugar, fermented dairy (cheese and yogurt) rather than milk, and sourdough bread rather than pasta. This way of eating has been shown to lower risk factors for



health conditions such as heart disease, stroke, diabetes, high cholesterol, obesity and high blood pressure.

The recipes in *The Ikaria Way* are simple, almost entirely plant-based, and do not require any processed ingredients. Some of the dishes contain surprising pairings, such as the asparagus and strawberry salad, yogurt cucumber soup with walnuts, and orzo pilaf with pistachios and currants. I recommend *The Ikaria Way* for anyone interested in learning the longevity secrets of one of the world's healthiest and longest living cultures or for those that wish to incorporate more plant-based dishes into their diets.

Kochilas writes, "Food equals pleasure, and cooking is the vehicle for delivering that. In the spirit of Ikaria, that means sharing a plate or two with friends, drinking some wine, creating a ritual around the table that involves simply sitting down, taking a breath, and respecting the meal in front of us enough to put away our gadgets and focus on what we're eating."

The Ikaria Way's Chickpea stew

With Honey-roasted Cauliflower and Root Vegetables Serves 6

Ingredients for the sheet-pan vegetables: Fresh strained juice of 1 orange ½ cup extra-virgin Greek olive oil

2 teaspoons Dijon mustard

1 tablespoon Greek pine honey, or more to taste

2 heaping teaspoons ground cumin

1 pinch freshly grated nutmeg

1 heaping teaspoon turmeric powder

2 teaspoons ground ginger

1 teaspoon smoked paprika

½ teaspoon cayenne or hot paprika, or more to taste

Sea salt and freshly ground black pepper to taste

1 medium head cauliflower, trimmed and cut into small florets

2 carrots, pared, halved lengthwise, and cut into 2-inch pieces

2 large red onions, peeled and quartered

Ingredients for the chickpeas:

2 tablespoons extra-virgin Greek olive oil, plus more for drizzling

1 large red or yellow onion, chopped

4 garlic cloves, chopped

4 cups cooked chickpeas (good-quality canned are fine), rinsed and drained

1 heaping tablespoon tomato paste

1 small seedless orange, preferably organic, cut into 4 wedges

2 fresh rosemary sprigs

2 to 4 cups hot vegetable broth or water, or more as needed

1 tablespoon balsamic vinegar

Preparation:

Preheat the oven to 400°F. Line a sheet pan with parchment paper.

In a large mixing bowl, whisk together the orange juice, olive oil, mustard, honey and all of the spices including the salt and pepper. Toss the vegetables in this mixture to coat evenly. Spread the vegetables in one layer onto the sheet pan. Roast until tender and lightly charred, about 20 minutes, removing vegetables as they cook to avoid burning them. Set aside to cool and then cut into smaller pieces, a little larger than the chickpeas.

In the meantime, prepare the chickpeas: Heat the olive oil in a large wide pot and sauté the onion until translucent. Stir in the garlic. Add the chickpeas and stir. Stir in the tomato paste. Squeeze the orange wedges into the chickpeas to get out their juice and add the wedges, peel and all, to the pot. Add the rosemary and 2 cups of hot broth or water. Season to taste with salt and pepper, partially cover the pot and cook the chickpeas on low for the flavors to meld – about 15 or 20 minutes. If you want the mixture to be thick and creamy, you can mash a handful of chickpeas against the side of the pot.

Add the root vegetables to chickpeas, heat all together for about 5 minutes, stir in the balsamic vinegar, and serve. \square






