County coroner's office opens in former SJ-R building

New morgue will serve as a regional hub for forensic investigations

Coroners speak for the dead. In doing so, they play a key role in bringing accountability to the living.

That's why Sangamon County Coroner Jim Allmon was emotional when he spoke at a ribbon-cutting ceremony for his recently opened regional morgue in the former State Journal-Register building in Springfield.

"We're in a position now to better help people, and that's really what our mission is," said Allmon, 51, a Republican and coroner's office employee since 2003. He has been the elected coroner since 2020. "We've been looking forward to this day for a long time. This facility is built with our loved and our lost in mind. We ensure every case is handled with professionalism, care and compassion."

It was Allmon's dream for Sangamon County to have its own freestanding morgue, replacing the county's longtime use of facilities inside Springfield Memorial Hospital for autopsies and refrigerated storage space for bodies at both Springfield Memorial and HSHS St. John's Hospital.

The new morgue and coroner's office will result in more effective and efficient operations, Allmon said. Included are larger and more convenient spaces for autopsies, as well as private spaces for families of the

deceased and police and other officials investigating suspicious or undetermined deaths.

And the office's expansion over the past year to make its services more attractive to county coroners in central and southern Illinois will reduce Sangamon County taxpayers' burden for supporting the office and make professional death investigations more convenient to access, Allmon said.

The National Academy of Sciences in 2009 recommended many changes to the patchwork of coroner, medical examiner and death-investigation systems across the country to institute more professionalism, consistency and accuracy. But few improvements have resulted.

A 2011 investigation by the PBS program "Frontline" stated, "Blunders by doctors in America's morgues have put innocent people in prison cells, allowed the guilty to go free, and left some cases so muddled that prosecutors could do nothing."

Morgan County Coroner Marcy Patterson said the regional morgue in Springfield is a positive step forward in this part of Illinois.

"It's an incredible opportunity for the region," she told *Illinois Times*. "This gives everyone involved a state-of-the-art facility

that will help us provide a consistently accurate cause and manner of death."

The \$6 million in renovations at the three-story building now known as Sangamon South, 300 S. Ninth St., allowed the coroner's office to consolidate vehicles, equipment and personnel from four locations to one.

More than \$4 million of the renovations for the coroner's office, and for evidence-storage areas elsewhere in the building used by the sheriff's department, came from federal COVID-19 relief funds. State funding is covering the rest of the cost of renovations.

The county bought the 135,000-square-foot SJ-R building, originally constructed in the early 1980s, from the newspaper's parent company, Gannett, at auction for \$1.25 million in 2021. The newspaper's staff, vastly downsized since the building's construction, currently is based in office space at 2144 S. MacArthur Blvd. in Springfield.

The largest refrigerated forensic storage space in Illinois south of Interstate 80 will be a relief for the coroner's staff, Allmon said. The staff no longer will have to scramble to avoid decomposition of remains and transfer bodies between locations when space used to fill up at Springfield Memorial and St. John's, he said.

Each hospital had refrigerated space for 12 to 14 bodies and no freezer space for longer-term storage. The new morgue has refrigerated space for 60 bodies, including freezer space for 12 bodies.

The new morgue, in the basement of the building only steps away from where the newspaper's press used to roar every night, includes a sealed area for autopsies on bodies involving advanced decomposition or insect infestation.

Rapid air circulation in that area will reduce the spread of smells and other disruptions for staff members not involved in those cases, Allmon said.

With the newly renovated and more spacious facilities, along with office space for the county's board-certified forensic

pathologist, Dr. Nathaniel Patterson – no relation to Marcy Patterson – the new morgue will offer the region easier access for central and southern Illinois counties needing autopsy and related testing services, Allmon said.

Some of those counties will save money by paying Sangamon County for autopsies rather than flying in forensic pathologists from out of state – sometimes as far away as Kentucky – or having to travel and transport bodies for autopsies in Bloomington-Normal or Peoria, Allmon said.

The new fees that Sangamon County will receive for morgue services, money that otherwise would go to the two Springfield hospitals, will help reduce the need for county tax revenue to support the coroner's office's approximately \$1 million annual budget, Allmon said.

Allmon's office also will incur a savings by no longer needing to pay Springfield Memorial and HSHS St. John's in rental fees and related costs, he said. That's not to say the county isn't grateful to the hospitals.

"They really rolled out the red carpet for us for years, and we can't thank them enough," Allmon said, adding that Springfield Memorial donated \$200,000 worth of equipment from its own morgue for the new facility.

Allmon's office handles more than 600 cases involving the death of people in Sangamon County each year, everything from homicides, suicide and drug overdoses to natural deaths that initially are undetermined as to the cause and manner.

In 2024, the office performed 235 autopsies on people who died in Sangamon County and more than 300 autopsies from people who died outside the county through arrangements with coroners' offices in other counties. □

Thousands facing eviction get free assistance

Since 2020, around 4% of Illinois residents – 560,000 – have acquired legal assistance from the Eviction Help Illinois Program. Eviction Help Illinois is a state program funded through a partnership between the Illinois Department of Human Services and the Illinois Equal Justice Foundation (IEJF). The program helps low-income Illinoisans get free legal representation if they are threatened with getting evicted from their homes.

State funding is given to a network of 16 legal providers throughout Illinois and these legal providers offer free legal assistance. One of these legal providers, Land of Lincoln Legal Aid, covers 65 counties in central and southern Illinois and offers legal advice and/or court representation in about 3,000 cases each year, according to Andrew Weaver, deputy director of Land of Lincoln Legal Aid.

“Each legal provider that is awarded funds by the IEJF helps people in the counties that they serve, with some counties being covered by multiple providers,” Weaver said in an interview. This allows people in need all over Illinois to be able to find help near them,

rather than having to drive to a big city far away. For example, Land of Lincoln Legal Aid alone has regional offices in nine locations all over southern and central Illinois, including one in Springfield. Land of Lincoln also has a hotline, the Legal Advice and Referral Center (LARC), that processes applicants via telephone or online application.

“The first step for applicants living in the Land of Lincoln region is to contact LARC through Land of Lincoln’s Eviction Hotline at 855-601-9474,” Weaver said. “The hotline will decide if someone is eligible for legal assistance, and if so, they will be assigned an attorney to be given advice, and/or directed to other resources.”

The hotline will also direct the applicant to a regional office near them. The regional office is where the recently accepted person will go to further discuss their case with their attorney.

Land of Lincoln has around 70 lawyers who provide legal assistance. About half do eviction work, among other kinds of law, and any of them may be assigned to an

applicant’s case after they have been accepted into the program. The help given by these attorneys could be as little as giving advice to their clients or, as much as representing them in court. For example, if a person were about to get evicted and got a lawyer through Eviction Help Illinois, the lawyer could make a compromise between the person and the landlord, so that they could remain peaceful and the tenant could stay in the residence.

According to a press release, of the 560,000 people who have been given legal assistance from Eviction Help Illinois, around 1,500 were helped in Sangamon County. The numbers show not only the significance this program has had on Illinois, but also locally. Even though the program has only been in operation for five years, one in 25 people in Illinois have already been helped with their housing situations.

Great Race coming to Springfield

Capital city is a stop this year, will kick off next year's vintage auto event

Springfield traffic court is usually a very crowded place, as the city has a well-known reputation for being tough on speeders. On June 23, a lot of old cars will come speeding into town, but perhaps in their cases, the radar guns will be more forgiving for going 50 in a 35 that day around the state Capitol building.

That's because, for the first time, Springfield will be an overnight stop for drivers in the Hemmings Motor News Great Race, an event that began in 1983 and this year starts in St. Paul, Minnesota, on June 21 and finishes in Irmo, South Carolina, on June 29. The pit stop in Springfield will be on Monday, June 23, when drivers will display their 1974-and-older vintage automobiles to anyone who wants to see them. They'll also mingle to discuss what it's like to race more than 2,000 miles in cars that, in some cases, date to when William Howard Taft was president (1909-13).

While Springfield is a stop along the way this year, next year the state capital will serve as the host city for the race. Instead of just one night, being the host city means a week-long series of events that will be paradise for the many gearheads who populate Sangamon County. That will coincide nicely with the city's many planned activities next year for the 100th anniversary of Route 66.

"We're not only the state capital, but we're the car capital of Illinois," said Scott Dahl, director of the Springfield Convention and Visitors Bureau. "We host a lot of cruises, car shows and the International Route 66 Mother Road Festival. So, I think this fits Springfield really well."

Kankakee's Teri and Jeff Fredette are just the kind of people attracted to the Great Race. While both are at the retirement ages of 66 and 67, respectively, their idea of great fun is to saddle up in their 1933 Ford pickup, complete with a standard 21-stud flathead V8 engine, and hit the open road. It has no AC, no GPS and no room for more than two people in the truck. All contestants have is a daily set of clues on a multi-page, hand-drawn map for the next destination, not given out until that morning.

"It's a really cool deal," said Teri, who works in sales for a media site, Blox Digital. "We're big believers in 'there's always something to do, places to go, people to see.' That's what keeps you young – keep moving and keep learning."

While there is \$160,000 in prize money, including \$50,000 to the winner, participants are in it more for the adventure than the money. The course changes every year, and entrants such as the Fredettes can't wait for the next slice of American road they might not have seen before.

"You're on these roads that nobody's on. It's backstreet America. It's way cool," said Jeff Fredette, who will drive the '33 Ford while his wife will be there "for support." Jeff's 34-year-old son, Eric, will be the navigator. Jeff and Eric won the 2018 Hemmings Great Race, which spanned from Buffalo, New York, to Halifax, Nova Scotia.

Said Teri: "It's a big social thing among the racers, too. There are people I can't wait to see again, who compete every year."

It's not cheap to take part in the Great

Race. Entrance fees go up to \$7,500, and participants are responsible for all their costs along the way, such as hotels, gas, and food – although many are put up for the night by family, friends or sudden acquaintances met along the way. It's a race as much of time as of speed, as competitors are tasked with arriving in each city at predetermined times. They get points added or subtracted for how precisely they arrive at the checkpoints.

A 1933 Ford pickup of the kind the Fredettes own usually runs about \$25,000, if it can be found in running condition. Jeff said when he bought his, it was not in running condition. His late father, a former participant in the Great Race, bought it in Idaho, transported it back to Illinois and rebuilt the entire engine. Now, it "purrs like a kitten," Jeff said.

Jeff inherited not only his father's love for driving vintage cars, but interest in how they work. He can rebuild an engine in a few hours, his wife says, and takes with him a spare engine in a follow car that Teri will probably be in most of the time while Jeff and his son are in the Ford. Jeff is also a champion motorbike racer who holds many records in the Six Days Enduro, considered the Olympics of endurance motorbike racing.

"One of my dad's final wishes about 10 years ago was for us in the family to keep running the race," Jeff said. "It wasn't a hard sell." □

Massey Commission continues pursuit of reform

Group approaches anniversary of Sonya Massey's death

Anticipating the July 6 one-year anniversary of Sonya Massey's death, the Massey Commission met Monday, June 16, to discuss memorial initiatives and further reform efforts in the form of community policing changes and recovery-focused support.

The commission began by proposing memorial initiatives, which include wearing purple clothing throughout July and planting purple flowers in remembrance and solidarity.

Additionally, the commission announced a planned memorial concert for July 10 at the upcoming Levitt Amp festival, as well as proposing that a permanent symbol of Massey be added to the county building.

Speakers invited to present findings, data and suggestions for community improvement were the Springfield branch of the American Civil Liberties Union (ACLU) and the Recovery Oriented Systems of Care (ROSC) network. Each organization had different yet complementary approaches to preventing future events like Sonya Massey's death.

ROSC, a community-focused addiction recovery network founded by the Illinois Department of Human Services (IDHS) in 2018, was introduced as a change from a short-term attitude toward substance recovery to a continuous, long-term attitude of recovery. ROSC's recent community survey, which spanned December 2024 to February 2025, revealed significant gaps in community services, particularly for youth and those exiting incarceration.

Whitney Devine, Sangamon County ROSC program manager, said, "Respondents were aware of few resources and services for youth compared to adult services. In general, awareness of mental health-related services was lower than the awareness of substance use-related services."

Austin Dambacher, ROSC coordinator, added that nearly half of respondents weren't aware of resources for people exiting incarceration with substance use needs, and a majority were unaware of mental health resources for this population.

Major barriers included waitlists, cost, stigma, lack of insurance and transportation. However, Naloxone awareness and usage were

surprisingly high. The survey highlighted three major gaps: youth services, family support, and services for the incarcerated/formerly incarcerated.

The lack of youth services was particularly concerning to ROSC, citing limited outpatient substance use treatment for adolescents and zero adolescent residential treatment providers in the county. "The awareness and existence of resources related to supporting people currently incarcerated or exiting incarceration is low," Dambacher said.

ROSC proposed increasing youth services, adding preventative measures and peer support groups, improved interagency communication, resource bundles for those leaving incarceration – including basic supplies and job/housing resources – and expanding access to peer recovery specialists.

Devine emphasized the need for more youth support groups. "It's helpful to have

support groups, especially when you're among your peers...to have support groups with people that are also going through the same thing." Commission members expressed interest in collaborating with ROSC to address these gaps and incorporate its recommendations into their final report.

On the matter of reforming the community in another way, ACLU president Ken Page and communications director Ed Yohnka focused more on the reformation of policing practices, while ROSC focused on the community itself.

Presenting traffic stop data from the Illinois Department of Transportation and the seven police departments within the Sangamon area, the ACLU found consistent discrepancies across Illinois police data, which showed a far higher stop and search rate for Black and brown individuals than for most others.

According to the United States Census Bureau, only 19.8% of Springfield residents are Black, but they're being pulled over at higher rates. Data from the Illinois Department of Transportation shows Black motorists were 5.7 times more likely to be pulled over than their counterparts.

Page further commented on these discrepancies, noting that while around 90% of people currently on the road are actively committing some form of traffic violation, the discrepancies in stops and searches between races have remained mostly the same for the past 20 years.

One solution already being implemented by the Springfield Police Department is a "lights-on voucher program," which aims to address repeated stops for minor vehicle violations. The program works by offering vehicle repair vouchers at participating businesses instead of tickets.

Page noted that most traffic stops boil down to mechanical violations, which often disproportionately affect low-income individuals who cannot afford to fix their vehicle's issue easily and eventually lead to subsequent stops down the road and traffic tickets, which make it harder to deal with an already expensive situation.

The ACLU representatives also suggested regular community meetings with police departments as another way to build community trust. Page says that giving an opportunity for direct, two-way communication would help communities express their needs and grievances while allowing local police to receive feedback on practices and explain themselves constructively.

The rule of law is king

The hundreds of thousands of Americans who took part in the “No Kings” protests across the country on Saturday, June 14, were asserting a demand that the current president and his minions comply with the rule of law.

Elections do have consequences. It is the American way to oppose policies and programs of a president and administration. However, regardless of one’s political philosophy or partisanship, Americans are governed by the rule of law as it exists in the U.S. Constitution, laws enacted by Congress and signed by a president, and rulings by courts of law. One can also argue that common law and practices are also precedents that are a natural part of the rule of law.

Now we are witnessing, not just changes in policy, but an anarchical disregard for the legal process for changes in policy. The Illinois State Bar Association summarized the breach in its February 2025 statement in support of the rule of law and an impartial and independent judiciary: “Embodied in the U.S. Constitution, for 236 years these foundational principles have contributed significantly to an ordered society, the preservation of individual rights, checks and balances on excessive

government actions, and a firm confidence by the public that access to equal justice is available to all.”

As ABA president Bill Bay stated: “We have seen attempts at wholesale dismantling of departments and entities created by Congress without seeking the required congressional approval to change the law. There are efforts to dismiss employees with little regard for the law and protections they merit, and social media announcements that disparage and appear to be motivated by a desire to inflame without any stated factual basis.”

In Illinois, we see continuing threats to the rule of law by Department of Homeland Security and its anti-immigration posse with increasing seamy attacks on residents from outside the U.S. moving toward actions parallel to the military invasion of Los Angeles. Treatment of those seized, legally or not, is inhumane treatment in violation of the rule of law.

Nationally, as of June 13, there have been 187 court actions successfully delaying or preventing the administration’s illegal, unconstitutional acts. Historically, no presidential administration has acted so

egregiously. This administration’s response has been to attack, attack, attack. Anyone acting against “the king’s” directives is the enemy and subject to juvenile-level abuse. He calls judges America-hating and seeks their removal – even of those who were appointed by the first version of this administration.

It returns us to the imperial presidency, complete with the unconstitutional concept of the “unified executive.” Quoting Richard Nixon – “When the president does it, it is not illegal.” In contrast, Thomas Paine wrote in *Common Sense*: “For as in absolute governments the king is law, so in free

countries the law ought to be king; and there ought to be no other.”

Whatever other messages may have been sent by the “No Kings” protest, the key is objection to the disregard of the Constitution, congressional acts and judicial rulings. Rule of law should be our guiding beacon, as it has been for over 200 years. □

Chicago on list for ICE raids

Multiple news outlets have reported that the Immigrations and Customs Enforcement agency is preparing to deploy its Special Response Teams to five major U.S. cities, including Chicago, in the very near future.

Chicago Mayor Brandon Johnson's chief of staff Cristina Pacione-Zayas told reporters last week: "There will be tactical teams, mini-tanks, other tools they use in which they plan to do raids, as we saw in Los Angeles."

Last Thursday, Department of Homeland Security Secretary Kristi Noem explained to reporters in Los Angeles the reasoning behind the massive federal response to sporadic violent protests against ICE in that city: "We are not going away," Noem said. "We are staying here to liberate the city from the socialists and the burdensome leadership that this governor and that this mayor have placed on this country and what they have tried to insert into the city."

In other words, according to Noem, the federal government intends to "liberate" those Americans from their own duly elected state and local governments.

Immediately after Secretary Noem said that, California U.S. Senator Alex Padilla was forcibly dragged out of her media event by federal police and handcuffed when he identified himself and attempted to address Noem.

Thursday night, a three-judge federal appeals panel put on hold an order by a district court judge hours earlier that would've forced the federal government to relinquish control over 4,000 National Guard troops deployed to Los Angeles.

Federal law allows the president to federalize state national guards whenever he is "unable with the regular forces to execute the

laws of the United States."

A hearing was scheduled on the lower court ruling, but it's possible, perhaps even probable that we can expect the same attempt at federalizing our Illinois National Guard troops.

Gov. JB Pritzker said during a congressional committee hearing last Thursday that he would "stand in the way" of Trump border adviser Tom Homan, "going after people who don't deserve to be frightened in their communities, who don't deserve to be threatened, terrorized. I would rather that he came and arrested me than do that to the people of my state."

But there may not be a whole lot the governor can do when push literally comes to shove. And not just this governor.

Because of ICE's heightened presence in California, the National Guard issue and even the deployment of U.S. Marines, Gov. Gavin Newsom is the first line of defense for sanctuary states like Illinois, New York, etc.

Newsom filed the lawsuit to stop the federalizing of National Guard troops in his state. The governor and the Los Angeles mayor have both claimed that sending in the National Guard has inflamed the local situation. But, if President Donald Trump can maneuver himself into anything which he can convince himself is a "win," then this tactic will surely continue.

"They don't get (that governing is) not like the black and white of campaigning" said one person close to Pritzker about the Trump White House. "They are living on election night. And now they are creating a whole lot of chaos and lighting themselves on fire on an issue they had an advantage on."

But, holding out hope that Newsom will

be an effective firewall against this expansion of traditional presidential powers has its perils.

Political writers love writing about the guy, probably because he's good-looking and a bit of a showboating goofball. Newsom makes for great copy and visuals, but his methods aren't always sound.

Earlier this month, Newsom suggested via social media that the state could withhold \$80 billion in federal payments – equal to the difference between what the state receives

from the federal government and what its taxpayers send to D.C. It's a great soundbite, but it simply can't be done. State governments don't give money to the feds, taxpayers do.

This is the same Democratic governor who fawned over President Trump after the devastating southern California fires only to be denied federal help.

He's the same guy who President Trump said ought to be arrested last week.

That's some firewall. □

The college crisis

Regional universities struggle to attract students amid funding challenges, changing demographics

When University of Illinois Springfield recently was designated Illinois' top regional state university, it was a dose of good news on a campus that has seen its enrollment drop by 1,000 students during the last decade.

UIS is reviewing programs and pondering whether they continue to serve student needs, Chancellor Janet Gooch told *Illinois Times*. It's a situation almost all of the state's regional institutions find themselves in.

There is no precise definition for what constitutes a "regional university" or a "flagship" institution, said Cecilia Orphan, an associate professor of higher education at University of Denver who studies regional universities.

"A good but imprecise rule of thumb is regional schools are the state universities with

either a direction or a city in their name," she said.

In Illinois, University of Illinois campuses in Champaign-Urbana and Chicago are generally considered flagships. The remaining 10 state universities are often labeled as regional institutions.

And it is at these regional institutions that a crisis is brewing. In 2010, a combined 112,200 students attended those schools. But today, that number has dropped to 71,600 — a 36% decrease. During the same period, enrollment at University of Illinois' flagship campuses soared from 71,700 to 90,100 — a 26% increase.

These changes have left college towns such as Macomb, Carbondale and Charleston struggling.

A front-page *Wall Street Journal* article last month painted Western Illinois University and Macomb in almost post-apocalyptic terms:

"At Western Illinois University, an empty dorm that once held 800 students is now a police training ground, where active-shooter drills have left behind overturned furniture, rubber-tipped bullets and paintball casings.

"Nearby dorms have been razed to weedy fields. Two more dorms are set to close this summer. Frat houses and homes once filled with student renters are empty lots. City streets used to be so crowded during the semester that cars moved at a crawl. No more."

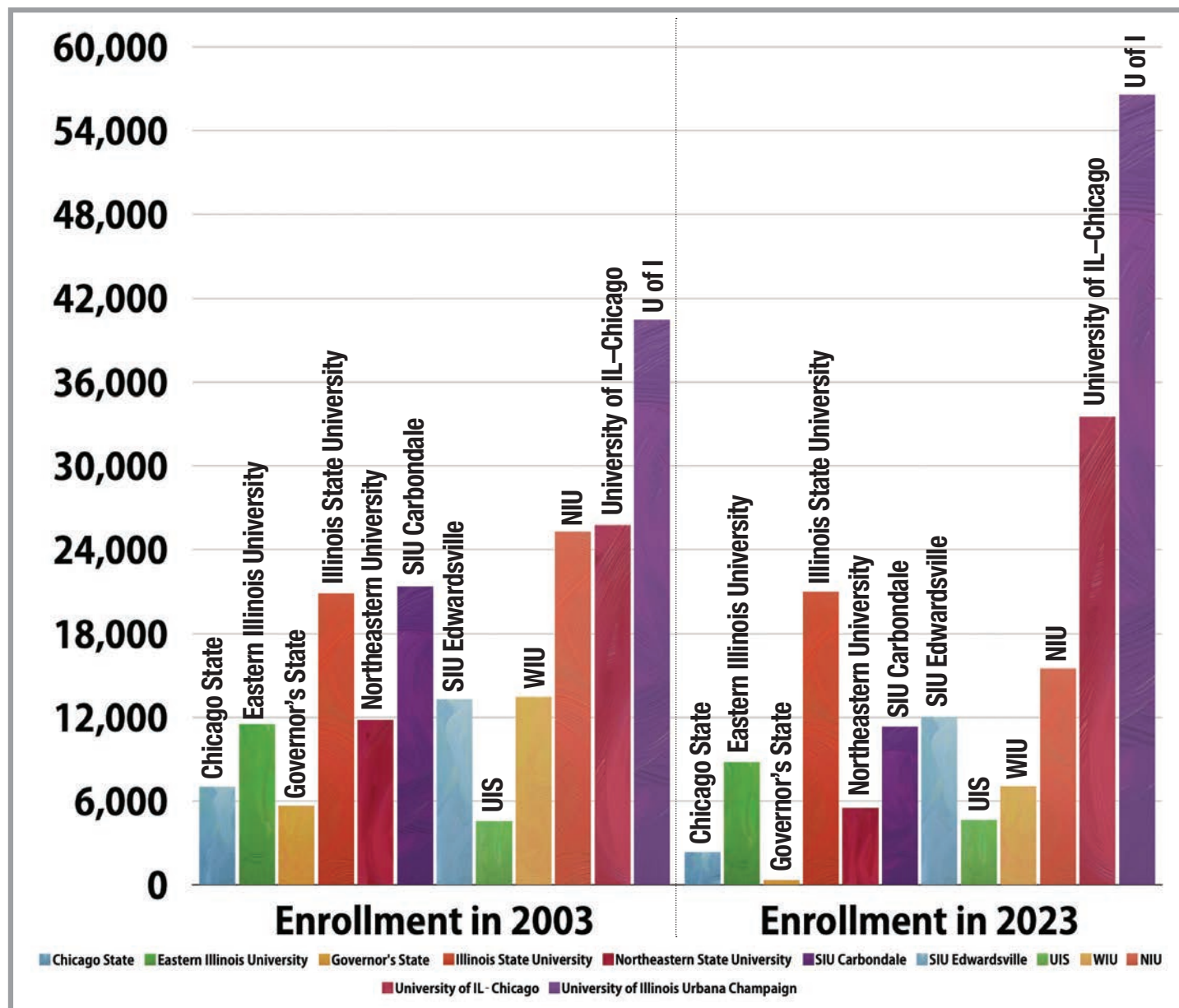
Much the same could be said of Southern Illinois University's Carbondale campus, said Jim Nowlan, a retired professor who writes

extensively about higher education.

"They have gone from a high of 22,000 students to about 11,000, and that includes online students. Carbondale is a long way from anywhere," he said.

But Kirk Dillard, a former state senator from the Chicago suburbs and a member of WIU's board of trustees, noted that Macomb and Carbondale are no more remote today than they were when their enrollments were at their peaks. And other regional schools such as Chicago State and Northeastern, which are in the heart of the state's largest metropolitan area, are struggling as much as or more than their rural counterparts.

Chicago State's enrollment has dropped from 7,040 in 2003 to 2,328. At Northeastern, which is also in Chicago,

enrollment dropped from 11,825 to 5,504 during that same time period.

Dillard, who was a Republican state senator for 21 years, said other factors are contributing to the decline of almost all of Illinois' regional universities. Among the causes he cited are:

- Decades of state underfunding has forced universities to escalate tuition, pricing out many students.
- Enrollment growth at University of Illinois' Chicago and Champaign-Urbana campuses has been at the expense of other state universities.
- There are fewer high school students today, which makes for a shallower pool from which universities can draw.
- Colleges in neighboring states are aggressively recruiting Illinois high school students.
- More students are choosing to forgo college and enter the workforce directly or join a vocational training program.

Dillard said of all these factors, the most

devastating has been decades of underfunding by the state.

State underfunds higher education

Nowlan noted that when adjusted for inflation, state funding for higher education is less than half the level it was in 2000.

Illinois State University President Aondover Tarhule said, "The cost of running a university depends on how much you get from the state and how much parents and students pay. In Illinois, we have been disinvesting – in terms of the amount of money the state gives to the universities – over the last two, three decades. Other states have not disinvested to the same degree."

Tarhule noted that in the 1970s, Illinois taxpayers paid 70% of the cost of educating a state university student. Today, taxpayers are covering only 20% of the cost, he said.

When the state contributes less, students and their parents are expected to make up the difference with higher tuition bills. This makes Illinois schools less competitive with state

universities in neighboring states, he said.

Nowlan agreed, saying, "There has been a dramatic increase over the past 20 years in the numbers of Illinois high school graduates going out of state. Other states saw an opportunity because of the high tuition (in Illinois) and said, 'Look, come to Iowa. Come to Iowa State. We'll give you a package that costs less than Illinois schools.' These schools have good brand names: Iowa, Iowa State, the University of Wisconsin. They very consciously are poaching Illinois students."

Tarhule noted that Illinois ranks near the top in the nation for the number of students who leave to attend colleges elsewhere.

"We are a net exporter of students. We are No. 2 in the whole country in terms of states that export students to other states," he said. "New Jersey is No. 1. We are No. 2. So, we are losing a lot of our future tax base and our talent base. From a policy point of view, it makes no sense at all that the state is allowing this to continue."

Changing demographics

Southern Illinois University President Dan Mahoney said demographic changes are also making it more difficult to recruit students.

"Illinois is not any different than what you see in a lot of states across the country, with a few exceptions where they've had huge growth in high school seniors – places like Florida and Texas," he said. "But in most states, regional universities have lost enrollment over the last 10 to 15 years."

Don Sevens, who was a senior executive with the Illinois Board of Higher Education and later lobbied for Northern Illinois University, said students today are more focused on job training, at which not all of the state's universities have excelled.

"I think a lot of young people are looking for credentials, rather than a broad-based

liberal arts education,” he said. “And it’s taken the public universities a long time to understand that and accept it. And maybe some haven’t even accepted it yet. People are finding that they want value for their dollar, and in most cases – in their mind – that translates to job credentials.”

Tarhule noted Illinois State University is the only regional university where enrollment has held steady over the decades. He credits the school’s focus on workforce development.

“We are being very thoughtful about what we offer students,” he said. “We’re looking at what we think students are asking for and trying to provide that. So, we created a new college of engineering, a data science program, created a master’s in public health. These are all things we’ve done in just the last few years.”

Zack Stamp, a former Springfield resident and lobbyist who once chaired the WIU board of trustees, said the Macomb school may need to focus on the academic areas where it has traditionally excelled.

“If it wants to remain alive, which I think it does, they may want to become a specialized

school where they say, ‘Look, these are the six things that we are specializing in,’ Stamp said. “I am not saying that these are the right ones, but we’re going to educate teachers, we’re going to do law enforcement, we’re going to do agriculture, we’re going to do nursing. We’re not going to be everything to everybody. You’re not going to come here and get a degree in accounting. You’re not going to come here and get a degree in philosophy. You’re not going to come here and get a degree in political science.”

WIU president Kristi Mindrup said with the declining number of students graduating from Illinois high schools, the university needs to rethink whom it serves.

“Universities in general, not just Western Illinois University, have been focused on that high school population,” she said. “And so, this change presents us with an opportunity to cast a wider net and start to think more broadly about the type of students we can attract to our institutions. (We need to) think about adult student populations, working students.”

Western isn’t alone among regional universities in pondering where to focus. Gooch said UIS is also reviewing its program offerings.

“We are currently undertaking an initiative – an academic program portfolio review,” she said. “We’re looking at the programs that we offer to determine whether they are in line with market demand, student demand. That is something that we need to be sure of, that we are offering programs that are attractive to students.”

Nowlan said another factor contributing to the enrollment decline at regional universities is the growth at the University of Illinois Chicago and Urbana-Champaign campuses.

Ross Hodel, who was director of ISU’s Education Policy Center, said the current leadership at University of Illinois appears less concerned than previous university administrations about maintaining healthy state universities throughout Illinois.

Nowlan noted that the U of I has a smaller endowment than many other major research universities. So, it has brought in more money by expanding its student body, he said.

“The U of I has a rather modest endowment of a few billion dollars, whereas Harvard has \$60 billion or \$70 billion, and the Texas universities have similar amounts. So, it has to support the university and its research mission in part with numbers of undergraduate and graduate students. It’s clear they have goosed enrollment.

“It has been successful at this because it has a better brand name than regional universities. And it has strong programs in the top areas such as computer science, engineering and the sciences. They’re making the U of I very attractive and working hard to recruit the students who might have once gone to ISU. ... Western, Northern or Eastern.

Competition from community colleges

Gov. JB Pritzker unsuccessfully pushed legislation this past session that would have enabled community colleges to offer four-year bachelor’s degrees.

While the measure has yet to pass, lawmakers call it a perennial issue that will

certainly be considered again. If it were to pass, some believe it would further devastate enrollment at regional universities.

“It would be a devastating thing for a place like here in Springfield with a community college and the four-year regional (university) right next to each other,” said Dathan Powell, chapter president of the union representing tenured faculty at UIS.

“It doesn’t make sense for property taxes that pay for the community college to be increased just to offer another program that’s already being offered just down the road,” he said.

Powell contends Pritzker supports allowing community colleges to offer four-year degrees because the funding would come from local property taxes rather than the state budget that he is trying to balance.

But when Pritzker proposed in March having community colleges offer bachelor’s degrees he said, “We have some really terrific four-year institutions that are a vital part of the higher education system in Illinois, but we need to recognize that there are geographic, financial and accessibility constraints that close off too many students from attending those schools. With lower tuition rates and a greater presence across the state – especially in rural areas – community colleges provide the flexibility and affordability for students to pursue a quality education that works for them.”

Sevener said such a measure would be detrimental to regional universities.

“If somebody can get a bachelor’s degree from the College of Lake County, they’re not going to go to Western or even Illinois State. They’re going to stay home. And that would be a factor in accelerating the decline in enrollment,” Sevener said.

Nowlan said community colleges are pushing for this because they, too, are seeing their enrollments dropping.

“Regional universities have so many challenges,” Hodel, formerly of ISU, said. “Unless these are very narrow programs (at community colleges) it can’t be helpful. It’s another negative for the Easterns, Westerns and Southern of the world.” □

Major higher education policy bills stall in General Assembly

Despite victories, funding overhaul, community college baccalaureates not brought up for votes

Gov. JB Pritzker got some of what he requested from the General Assembly in the area of higher education, but his biggest requests fell short.

Pritzker’s wins include a \$10 million increase in need-based student financial aid and passage of a direct admission program to make it easier for eligible Illinois high school and community college students to apply to public

universities.

But lawmakers did not approve the overall funding increase for universities that Pritzker requested at the start of the session, settling on a 1% bump in their operational budgets instead of the 3% the governor proposed, Pritzker’s office, however, has said there are contingencies to provide an additional 2% in the event of

significant cuts in federal funding.

They also did not pass other major higher education policy initiatives, including Pritzker’s plan to allow community colleges to offer four-year bachelor’s degrees in certain high-demand career fields, and a long-sought overhaul in the way Illinois funds its public universities.

“You don’t get everything done in one

year,” Pritzker said during a post-session news conference when asked about several of his initiatives that failed to pass this year.

“Sometimes they (lawmakers) spend two years, four years, six years, trying to get something big done.”

Community college proposal

In his State of the State address in February, Pritzker called for allowing community colleges to offer baccalaureate degrees as a way of expanding access to those programs, especially for older, nontraditional students who may not live close to a four-year university.

"With lower tuition rates and a greater presence across the state – especially in rural areas – community colleges provide the flexibility and affordability students need," Pritzker told the General Assembly. "This is a consumer-driven, student-centered proposal that will help fill the needs of regional employers in high-need sectors and create a pathway to stable, quality jobs for more Illinoisans."

In the legislature, however, the proposal ran into stiff opposition from several sources, including universities that said the plan lacked sufficient safeguards to prevent community colleges from offering duplicative programs that would siphon prospective students away from their campuses.

Amid that opposition, House Bill 3717, which was carried by Rep. Tracy Katz-Muhl, D-Northbrook, failed to advance out of a key committee before a mid-session deadline in March. And even after amendments were negotiated that led to universities dropping their opposition and the bill was reassigned to a different committee, it still failed to gain enough traction to advance to the House floor.

That was mainly due to opposition from the Legislative Black Caucus, whose members said it still posed a threat to the three universities in Illinois that serve primarily Black and Latino students – Chicago State University; Governors State University; and Northeastern Illinois University – which are all located in the Chicago metropolitan area alongside multiple community colleges.

"Chicago State is hemorrhaging," Rep. Curtis Tarver, D-Chicago, said during a May 23 House Executive Committee hearing. "And you all, as an administration, are handing them Band-Aids and they need stitches. And then you come in and you provide a bill that's going to be even worse for them, with 11 community colleges within 25 miles of them. And I'm saying as we sit here that the Black Caucus has an issue with the bill."

Funding overhaul

Another proposal that failed to advance called for establishing a new formula for funding public universities.

The Adequate and Equitable Public University Funding Act called for establishing a funding structure like the Evidence-Based Funding formula used for K-12 education.

That formula would use objective standards to determine an adequate level of funding for each university. The bills then called for adding as much as \$1.7 billion in new funding for universities over the next 10-15 years, with most of the funding going toward schools furthest

away from their adequacy target.

The proposal grew out of a commission formed in 2021 within the Illinois Board of Higher Education. That commission worked for nearly three years to develop a proposal and issued its report and recommendations to the General Assembly in March 2024.

Under the proposed formula, Western Illinois University in Macomb would have earned top priority for new funding because it is currently funded at only 46% of its adequacy target. Northeastern Illinois University and Southern Illinois University-Edwardsville, at 47% of adequacy, would have been next in line.

But the state's flagship institution, the University of Illinois Urbana-Champaign, currently at 89% of adequacy, would rank at the bottom of the priority list. For that reason, the U of I System opposed the plan.

"The University of Illinois System is absolutely dedicated to expanding equitable access, enhancing student success and promoting statewide economic growth," Nick Jones, executive vice president and vice president of academic affairs for the U of I System, told a Senate committee in April. "The proposed legislation penalizes institutions that provide the most support for underrepresented and rural students while failing to ensure long-term access."

Senate Majority Leader Kimberly Lightford, D-Westchester, who sponsored the Senate bill and was a cochair of the study commission, said she was disappointed it did not pass this year, but vowed working for a more equitable funding formula.

"While it is far past time to pass an equitable funding model, I am reminded that many of the comprehensive plans I've passed have taken years of research, input and negotiations," she said in an email statement. "This legislation is no different."

Robin Steans, president of the education advocacy group Advance Illinois, who also served on the commission, said in a separate statement that she expects lawmakers to continue discussing the bill over the summer. Action could come during the fall veto session or early in the 2026 regular session, she said.

"Eventual adoption of the Adequate & Equitable Funding bill represents a significant change, one that requires new investment by our state in what remains the surest path to greater mobility and opportunity for Illinois families," she said. "The questions and comments made during legislative committee meetings indicate that Illinois lawmakers get that, and powerful testimony from the state's university leaders drove home the urgency of this issue." □

Slab pies, perfect for summer

Picture an enormous Pop-Tart, bursting with juicy summer berries and encased in a flaky scratch-made crust. Perhaps it has a drizzle of lemon laced icing if you're feeling fancy. This is slab pie at its finest – a rustic and ever-changeable creation that feeds a crowd with minimal fuss. Baked in a rimmed 10-inch by 14-inch jelly roll pan, slab pies happily accommodate whatever fruit is ripe and ready. June – strawberry and sour cherry season here in central Illinois – is replaced in the blink of an eye by blueberries, peaches and green summer apples.

Slab pies can even shoulder the entire meal when they're filled with savory ingredients such as creamy chicken and spinach or heirloom tomatoes and sharp cheese. Whether sweet or savory, round or rectangular, a couple key techniques will ensure that the finished pie has a flaky, crispy crust and perfectly set, cuttable filling.

In spite of the old adage “easy as pie,” making homemade pie crust can be an intimidating prospect for many home bakers. For those with a food processor, preparing the dough takes just seconds, but it can also be easily produced using a box grater. Be sure the butter is thoroughly chilled and have all of the crust ingredients ready to go, especially if it's a hot day. Crust is made flaky as a result of the little pockets of cold butter suddenly melting

when they hit the hot oven, so it's critical to keep all the ingredients cold until the very last minute. Rolling a perfect rectangle of dough can be enough to stress even an experienced baker, but thankfully the dough can be easily pieced together and patched up into whatever shape it needs to be.

When it comes to the fruit, its juiciness, which is indeed one of fruit's main attributes, often presents a soggy problem. For firm fruits such as apples or even savory players like zucchini, this can be mitigated by briefly roasting at a high temperature (400 degrees) to remove excess moisture. For juicy fruits like cherries, peaches and tomatoes, draining the excess juice in a colander helps to remove excess liquid and keeps the filling thick and dense when cutting into the finished pie. As a bonus, the strained liquid can be mixed with sugar to taste and brought to a quick simmer in a saucepan. Once thoroughly chilled, it can be used in cocktails, Italian sodas or over ice cream.

Berry slab pie

For the crust:

5 cups all-purpose flour (or use 1 cup whole wheat flour and 4 cups all purpose)
2 teaspoons each salt and sugar
1 pound cold butter, cut into pats

2 tablespoons vodka
14 tablespoons cold water

For the filling:

8 cups berries (drained if juicy)
1 to 1 ½ cups sugar, to taste
⅓ cup cornstarch
1 teaspoon lemon zest
A drop of almond extract, optional
1 teaspoon of vanilla or brandy, optional
A pinch of salt
Cream or milk for glazing, optional

For the glaze (optional):

4 ounces cream cheese, softened
1 tablespoon butter, softened
Zest and juice of one lemon
1 cup sifted powdered sugar

First, make the crust. Combine the flour, salt and sugar in the bowl of a food processor. Add the cold butter. Turn on the machine and immediately add the cold water and vodka. Process for 30–45 seconds until the dough comes together into a ball. Do not overmix. Divide the dough in half, shape into ½-inch thick rectangles and wrap in plastic wrap. Refrigerate for at least 30 minutes.

While the dough is chilling, combine the filling ingredients and mix thoroughly.

Preheat the oven to 400 degrees. On a

clean, floured surface, roll the dough into a 12-inch by 16-inch rectangle. Don't worry if it's not perfect. Use a tiny amount of water on a pastry brush to patch cracks or glue misshapen pieces together. Do avoid excessively kneading and re-rolling the dough as this will yield a tough, rather than flaky, crust. Roll the crust lightly around the rolling pin to pick it up and lay it over a 10-inch by 14-inch jelly roll pan. Roll out the second piece of dough into a slightly smaller rectangle. Pour the filling into the dough-lined pan, then top with the second rectangle of dough. Fold the overhanging edge from the bottom crust over the top crust, then pinch the edges to seal. Brush the crust with cream if desired and cut a few slits in the top to allow steam to escape.

Bake the pie in a preheated 400-degree oven for 15 minutes, then reduce the heat to 350 degrees and bake 45 minutes more, until the crust is golden and the juices are bubbling up through the slits in the crust. Set aside to cool. While the pie is cooling, make the glaze by whisking together the cream cheese, butter, powdered sugar and lemon zest/juice. Add cream or water as needed to create a thick, pourable glaze. Drizzle over the cooled pie and serve. □

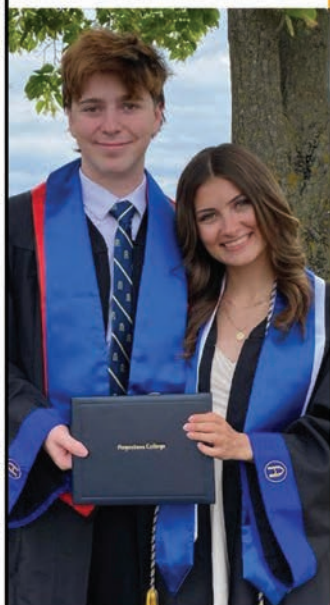

A petition for reclassification of property upon annexation from R-1, Single Family Residence District, Section 155.016, to I-1, Light Industrial District, Section 155.040, and for Variances of Sections: 155.001, Definitions, "Lot" and "Use"; 155.040, I-1 Light Industrial District; 155.063(a) & (b), Required Yards for Lots Adjoining Residential Districts ; 155.050, Screening; 155.111, Access to Off-Street Parking Facilities; 155.112, Surfacing; 155.113, Screening; 155.131, Required Off-Street Loading Spaces: Wholesale , Manufacturing, and Industrial Plants ; 155.214, Application for amendments and variances; 155.480(d),(h),(k),and (i), Landscape Screening and Lighting Regulations, of the Springfield Zoning
