Black leaders outline solutions for economic inequity

Black residents of Springfield face income disparity that is greater than any other metro area in the U.S., according to an investigation on segregation conducted by *Governing* magazine and published in January 2019. Springfield is also among the most segregated third of U.S. metro areas between Black and white people, the investigation said. The *Governing* investigation cited data released by the U.S. Census Bureau in 2017.

But it should not take hearing those statistics to believe Black people's experiences, said Rikeesha Phelon, executive director of marketing, communication and engagement at SIU School of Medicine, who moderated a Citizens Club event held July 28 at the Hoogland Center for the Arts titled "Moving Towards Equity in Local Economic Access."

The forum's three panelists were Tiffany Hightower, executive director of the Illinois Legislative Black Caucus Foundation; Gina Lathan, CEO of Lathan Harris, Inc.; and Dominic Watson, president and CEO of the Springfield Black Chamber of Commerce.

"If it took the numbers for you to pay attention to it, then we need to challenge ourselves to look at our community differently," Phelon said. "And we need to challenge ourselves to believe the stories of people of color when they're presenting them to us, or when they're speaking at city council. There are many ways that this data shows up. And sometimes, it's just in believing the story of your neighbor."

Hightower said that the pandemic and police killing of George Floyd have amplified disparities that Black people face. "The only way to address these inequitable and unjustifiable actions was for the Illinois Legislative Black Caucus (ILBCF) to

introduce policies and legislation that seek to eradicate systemic racism in the state of Illinois," Hightower said.

The ILBCF introduced four pillars of

education and workforce development; the third was economic access, opportunity and equity; and the fourth was health care and human services, Hightower said.



reform that correspond to areas of inequity faced by Black people. The first pillar was criminal justice reform, violence reduction and police accountability; the second was Although the ILBCF was successful in passing legislation, creating tangible change may be more difficult than a reform bill becoming law. "The ILBCF recognizes that there has been legislation put in place to address the concerns of the African American constituents of Illinois. However, once the bills pass, either they lose legislative intent or are not executed," Hightower said.

Legislation such as the ILBCF's reform package aims to correct the generational wealth gap between Black and white households. Hightower said some of the opportunities available to increase wealth in Black communities are to readdress the war on drugs, promote apprenticeship programs in green technology, IT coding

and urban farming, and to work toward true homeownership. She also emphasized investing in small Black businesses and entrepreneurship programs.

Springfield Black Chamber CEO Watson said that there are five primary barriers to prospective Black entrepreneurs: being taken seriously: access to capital, defying social expectations, supportive networks and discussing accomplishments.

Phelon noted that Black business owners face challenges that are not limited to securing funding and finding space. Not being taken seriously is an intersectional issue that can especially affect Black women, Phelon said.

Lathan identified the effects of redlining as another barrier to Black economic success. "Over the years of working in public health, I know that we can look at ZIP codes, we can look at income, and we can identify who's going to die early, who's going to get disease and illness, who is going to go to prison. That is closely tied to economics," she said.

Another economic solution the panelists promoted was the R3 initiative: restore, reinvest, renew. R3 grants, which are funded by the state using revenue from adult-use cannabis sales, fund programs in the areas of civil legal aid, economic development, reentry, violence prevention and youth development. The Pritzker administration announced on July 15 that 21 grants, totaling \$3.5 million, have already been distributed in efforts to provide young people with positive social activities to reduce violence.

The event was hosted with the goal of increasing awareness of disparities in Springfield and encouraging discussion and action to combat the inequity. It was jointly organized by the Citizens Club of Springfield and University of Illinois Springfield as the second installment of a series, "Confronting Inequities in Springfield." The Citizens Club of Springfield is a nonprofit and nonpartisan organization that aims to promote public, civic and cultural welfare.

Brian Charles and Mike Maciag. "The truth is that segregation isn't limited to the South, or to large cities. America's racial divide, in fact, runs right through the Heartland." Shelter delays

\$1.2 million plan for homeless "overflow" center still unclear

Frustration is rising as plans for a proposed homeless shelter in Springfield continue to stall. At its July 27 meeting, the Springfield city council voted to put off a decision regarding a plan for a homeless shelter at the former Salvation Army building at 221 N. 11th St.

While considering an ordinance to put in place a two-year shelter plan, estimated to cost more than \$1 million, the council heard testimony from Josh Sabo, coordinator of the Heartland Continuum of Care, which has been attempting to broker a cooperative operational agreement between the city of Springfield and the Salvation Army in regards to the facility. While the building is used on a limited basis as a cooling center, it has sat largely unused since April. Those seeking shelter erected a tent city around the facility.

At the committee meeting, Sabo urged the council to delay adoption of the ordinance so the continuum could finalize details of the plan. Speaking with Illinois Times afterward, Sabo said the continuum, the body designated by the U.S. Department of Housing and Urban Development to create and implement plans addressing homelessness in Springfield, had not had an opportunity to review the plan before the July 27 meeting. He told the council that he wants more time to speak with the Salvation Army about shelter needs and the needs in the continuum's wider crisisresponse plan. Sabo said that he still hopes to secure approval for a fully fleshed-out agreement sometime in August.

"From that point, hiring and training staff would be the biggest obstacles to overcome to prepare the way for opening," Sabo said.

On July 30, Mayor Jim Langfelder said the council could act to consider an amended ordinance for emergency passage as soon as Aug. 17, but said it is more likely to receive a vote in September. How quickly the council can act hinges upon whether an amendment that fulfills all parties' wishes can be filed, and how quickly.

Sabo said the continuum's short-term strategy includes an overflow shelter to make up for insufficient space at the city's other shelters, a location which could help people get connected with the various services that are already available in the Springfield area. Supportive housing has to be another compo-

nent, Sabo said. The former Salvation Army location would ideally serve as that overflow shelter.

"If we really want to end homelessness as a community, we have to invest in supportive housing alongside emergency shelter," Sabo said.

Ward 2 Ald. Shawn Gregory voted to delay adoption of the plan in accordance with Sabo's recommendations, but expressed impatience at the committee meeting. Gregory told *Illinois Times* he wants to see comprehensive services that help homeless people at the emergency shelter when it reopens.

Gregory said he wants to see a long-term plan that will support people beyond a stay at the proposed overflow shelter, located in his ward. "I want to see what services will be wrapped around this thing," he said. "If I don't see those things, I am not going to be for it."

In order for an ordinance to be considered for emergency passage, it must be filed

with the city clerk two business days prior to the upcoming council meeting. Langfelder said the timeline for ultimate passage of any ordinance will depend on whether the continuum's changes can be easily reflected in an amendment. He said his priority remains how to address people who are living on the streets.

Gregory said the residents of his ward are frustrated at what they perceive to be the city's continued inaction.

"I've always maintained that I'm in full support of rapid rehousing and anything we can do to get people in sustainable housing and in some form of independence. For whatever reason, we in government and these providers ... we just can't get our act together to help people," Gregory said. "That is why I'm frustrated. While we don't get things done, we have people on the streets."


Artists sing and dance to promote vaccinations

Artists throughout Illinois are using their creative talents to encourage people to get vaccinated. Through an initiative of Arts Alliance Illinois, invited artists of all genres are receiving stipends to design powerful messages in unique formats. The Springfield Area Arts Council (SAAC), a member of Arts Alliance Illinois, is a local partner. Sheila Walk, SAAC executive director, chose to reach out to local performing artists. "Performing arts venues were the first to close under COVID and the last to open," says Walk.

Julio Barrenzuela, known locally as the Ambassador of Salsa, organized a salsa dance party and family picnic on July 19 in a neighborhood with many immigrants from Spanish-speaking countries. The Sangamon County Health Department vaccinated 17 people at the fun event. The musical duo Idle Oath (Mark Beanblossom and Ren Nickerson) wrote and performed an original song to promote receiving the immunization and presented a live premiere at Dumb Records on Saturday, July 17, Record Store Day. They partnered with a visual artist to animate the lyrics and create an engaging video https:// youtu.be/Mfve_B9wDlU. Reggie Guyton, actor and director, currently is working with others to create spoken-word pieces that address some common concerns about the vaccination, while highlighting the benefits.

The mission of SAAC is to enrich the community through the arts, and the arts sector is eager to return to the work of bringing communities together. Artists were deeply affected by the pandemic, but they never stopped being creative. Artists have a vested interest in being able to get out and perform. They are now using their talents to be a part of the solution and help encourage widespread vaccination. "If people want to hear live music, those sitting in the audience need to shoulder some responsibility," says Walk. "I hope these artist-designed messages encourage people to be immunized." Statewide COVID-19 ICU bed usage jumps 15 percent overnight

Hospitalizations for COVID-19 jumped by more than 13 percent from Sunday to Monday night, Aug. 2, while intensive care bed usage jumped 15 percent as the delta variant of the virus continued to cause a surge nationwide.

According to the Illinois Department of Public Health, 1,107 individuals with COVID-19-like illness were hospitalized as of Monday night, an increase of 130 from the night before. ICU bed usage for COVID-19 jumped to 243 from 212, and ventilators jumped 18 percent, to 103 from

While those numbers were below previous spikes in disease spread, they represented a rapid increase from recent pandemic lows.

Ventilators were up nearly four times from the 28 in use by COVID-19 patients as of a July 15 pandemic low. Hospitalizations were three times more than their July 4 pandemic low of 380, while ICU bed usage increased by three times since that date as well.

The one-day hospitalization totals were the highest they've been since late May and early June.

According to IDPH, only about 2.4 percent of the COVID-19 deaths since January have occurred in vaccinated individuals. IDPH's weekly report showed 169 COVID-19-related deaths in people who had received the vaccine since January while 644 vaccinated individuals have been hospitalized at some point this calendar year.

Capitol News Illinois reached out to the Illinois Department of Public Health as to what percentage of individuals who had contracted, been hospitalized or died of COVID-19 were unvaccinated during the June and July surge, but did not receive a response as of this publication.

WCIA-TV Champaign's Mark Maxwell

reported last week that IDPH said 87 percent of the June COVID-19 cases and hospitalizations were in unvaccinated individuals, along with 92 percent of COVID-19-related deaths.

Approximately 51 percent of the state's population is fully vaccinated, or about 6.5 million people. The vaccination pace has accelerated amid the surge, with 28,250 vaccine doses administered daily on average over the past seven days. That's up from a pace of 16,423 on July 9, but down from a pace of more than 130,000 in April.

Over the past week, 44 individuals testing positive for COVID-19 were reported by IDPH to have died, bringing the state's death toll to 23,458, with another 2,482 probable COVID-19 deaths reported.

For southern Illinois' Region 5 of the state's mitigation plan, there were 15 of 85 ICU beds that were unoccupied as of Monday night, or 18 percent of the total supply in the region. There were 28 unoccupied ICU beds out of 108 in Region 4, the Metro East area on the Missouri border, or 26 percent of the total supply.

But it wasn't just southern Illinois that had scarcities, as Region 1, in the northwest corner of the state, had 18 percent of ICU beds, or just 32 of 181, available.

The state's rolling seven-day average case positivity rate increased to 4.4 percent, matching the mid-April peak of the most recent virus surge. Since June 2020, the highest positivity rate recorded was 13.2 percent, logged in November.

The state reported 2,682 new cases of COVID-19 Aug. 3, a high since May 7. □



CITYWIDE INTERNET NEEDED

I live in Jacksonville, and the city partnered with i3 Broadband to bring network access to every household and business in the city ("City surveys residents to determine internet needs," July 29). The network will be complete by the end of this year. That includes the northeast side of the city and other low-income areas. The lowest-priced package is \$50 a month for 200 Mbps down, 50 Mbps up. If you get public assistance in any form, such as WIC or free school lunches, you can get the same

service for about half price.

My connection is stable and service has been impeccable. The city of Jacksonville used funds from gaming terminals to partner with i3 Broadband to build the full network. Otherwise, the company probably would have just cherry-picked the wealthier areas where it could be assured of getting back its investment.

Maybe the city of Springfield can do the same, or work with CWLP to build a fiber network that any company could lease to provide service to homeowners? Jacksonville's population is going to make the city's investment back in 2-5 years, versus the cost of doing nothing and paying higher bills to legacy providers for slower speeds and less service.

There are lots of options, and I encourage Springfield to make sure all areas of the city have good choices for internet service.

Why we don't need another replica historic place

The recent announcement that the Abraham Lincoln Association (ALA) wants to reconstruct the original one-story version of the Lincoln home needs a more thorough vetting than the publicity coming from the ALA. It's time to put some perspective to the need for another replica building to tell the Lincoln story.

Springfield already has the most authentic Lincoln sites – his home as well as his tomb and a modern museum. Another replica Lincoln site does not advance the story of Lincoln's life and represents community resources that would be better used in preserving authentic places, which Springfield does rather poorly. Despite the best of intentions, an "authentic reconstruction" is just another word for a fake with a veneer of respectability.

Springfield already has Lincoln sites with questionable authenticity. For example, The "Lincoln Depot" failed to meet the Lincoln authenticity test of the National Register of Historic Places during many years of community misrepresentation. The depot was added to the National Register of Historic Places in 2014, not as the Lincoln Depot, but as the Great Western Railroad Depot, significant for the railroad history of Springfield.

The premise of this idea is faulty.

The ALA has stated that the reason behind recreating the first version of the Lincoln home is that current visitors to the house get the impression that Lincoln was a successful lawyer with a very nice house. Somehow or other, they have turned this to be a negative that his success prevents people from knowing that he started from more humble origins. This logic is faulty.

The American public has grown up with the story that Lincoln was born in a log cabin. The New Salem historic site more than adequately tells this story. The NPS already has a display with models of the Lincoln home showing its evolution. This was a wonderful method of telling the story of Lincoln's success as a lawyer and the home improvements that came with this success.

Build it and they won't come.

There is a huge crisis facing America's house museums. The public interest in this type of cultural attraction is waning and virtually none of them are self-supporting. The ALA has accurately calculated that a historic house museum won't pay for itself in admission charges and therefore needs a perpetual funding source for its long-term care.

The ALA has made a political plea for the property to be "given" to the National Park Service, and therefore the American taxpayers. They have falsely stated that the NPS desires an expanded campus, when they already have more properties than they need. The NPS does and should have high standards for acquisitions and already has enough fake Lincoln sites. The Lincoln birthplace site in Kentucky is already known to be a fake. The Lincoln home site already has a fake version of the home in which the Lincolns married.

The NPS professionals who are the stewards of our collective legacy should not be burdened with more replicas. It's demeaning to the professionalism of the NPS and a misuse of the political capital of Sen. Dick Durbin and U.S. Rep. Rodney Davis. The NPS also has no need

for the Iles House, which was included in the potential "donation" to the them. This property is a piece of community history and is not essential to telling Lincoln's story.

There are other options.

If the Abraham Lincoln Association wants to do something new to better explain Lincoln's life through the places that represent him, there are better ways to do this than recreating the early version of the Lincoln home. The use of virtual recreations through modern architectural rendering tools and information software could put the ALA at the forefront of virtual historic interpretation. There are many examples of this for ancient sites, but this option has not been used nearly as well in America. If this group is still considering a physical recreation, they need to build and maintain it themselves, and not

"give" it to the NPS.

Recreations do have the advantage that they can be used for modern activities that are not appropriate for authentic historic sites. An Abraham Lincoln Airbnb where a modern visitor could stay in a "Lincoln Home" might be a new model for a replica historic house that could actually pay for itself. Building it knowing that enough people won't support it is the first mistake. Making this a "gift" to the National Park Service only compounds the error. \square

Running as refuge

Before you can fully understand why Randall came to run 50 miles in honor of 50 lives lost, you must first know how she came to be a runner. In 2014, she stopped drinking alcohol. "I was just sick and tired of being sick and tired. And I wasn't getting to my full potential because alcohol was in the way," said Randall. "I know a lot of people may feel weak by saying that, but I actually feel very strong for admitting what was wrong with me – what I could not control. And what I can control is not drinking, and I can control what I'm doing now."

Before getting sober, "I hated working out," said Randall. "And it wasn't until my third or fourth year in sobriety that I was like, I'm going to try something new." A friend suggested she try running. Randall found the practice both humbling and therapeutic. "When you go outside and run, you notice things," she said. "I hadn't noticed how the leaves change colors in the fall until I started running. I knew they change colors, but I never saw the beauty of it until I started running. And I was like, there is so much I've been missing in this world because I've been drinking, and I haven't been paying attention."

Before long the impact of her new hobby

was tangible. Randall started participating in races. She was losing weight and feeling better. She decided to make a short video that would share her story of getting more healthy through sobriety and running. "I wanted to celebrate the average American being able to lose weight and then run a marathon." But then her mom suggested that Randall go further and make a documentary. With her mom's financial and moral support, Randall decided to go for it. She was scheduled to run a 50-mile race in April of 2020 that would be the focus of the documentary film. But the pandemic and the civil rights uprising shifted her trajectory.

Film for a cause

Running became an increasingly important mental health outlet for Randall during the pandemic. It was something she felt safe and healthy doing in a world where being in public came with risk. On June 1, 2020, Randall attended her first-ever protest. She had been worried in the past that protests might involve looting or riots. But she felt compelled to get involved. During her first protest, a week after Floyd was murdered, Randall looked for leaders. "There were all these people. But no one was in the middle and no one was saying anything. We were all just standing there. And I walked up there in the middle of this sea of people, and I just started singing."



Randall sang a hymn. "And then from there, people started coming up and speaking."

Protesting became a daily occurrence for Randall. "A lot of times people would look at me like - 'Oh, she's the leader of this' ... that's when I started organizing my own protests and then started coordinating with other organizers in New York City." Randall said her worries about violence were quickly put to rest. "I never once was at a protest where people were rioting or looting." She said the most contention came from outsiders who took issue with what demonstrators were trying to say.

As Randall got more involved in social justice work, the calling to make a film kept nagging at her. And then it was her mother's voice in her ear, telling her the film still needed to be made, its topic just needed to change. Instead of it just being a film about Randall and her health journey, it would also be a film about police violence. After assembling a crew and raising extra funds for the film, on Nov. 1, 2020, Randall geared up to run 50 miles through NYC. Each mile she dedicated to a person who had been killed by police.

From Springfield to NYC

Randall put together a film crew of about 10 people to make the film and the run a reality. She got other cities, like LA and Houston, involved. She researched to find the names of Black and brown people killed by police. Randall ran for Breonna Taylor, George Floyd and Ahmaud Arbery. "But then I also wanted to run for the names we don't know – names people forget about." During the run, Randall made nine stops for small rallies. The families of people like Sean Bell and Delrawn Small came out to share their words.

Her friend Jessica Cornelio, from northern Illinois, co-directed the film. And two central Illinois natives, Elijah Settles from Springfield and Luke Welchel from Lincoln, helped film, produce and edit the documentary. The two









have a production company called Mecoclub. Settles knew Randall through their families and church. "It was incredible to see just how sturdy and steady she was through everything going on," Settles said about working with Randall. He and Welchel flew to NYC to film the run. They arrived days before the presidential election. "There was a lot of tension," Welchel said of the environment. The city was relatively empty. The two had to prove they were going for work to even travel there. The day of the run was rainy. It wasn't clear whether Randall would be able to finish the run. Along the way, Settles would hop out of a van that was following Randall and film from his skateboard.

The documentary is a short film – about 20 minutes in length. It was recently completed but has yet to be released to the public. Both Settles and Welchel consider the project, which includes interviews with the family members of victims of police brutality, to be one of the most impactful they've ever worked on. "We were stunned by the content, honestly, and really moved by it. We even had a conversation that we thought we might not ever make anything that is more important than this, and definitely

haven't before," said Welchel. Settles admitted fighting back tears while working on the film.

In talking to people back home in Spring-field about it, Settles said he gets questioned about how he pulled off filming a 50-mile run, partially from his skateboard. But it was Randall who accomplished the most impressive feat, he said. She was joined along the way by supporters who ran alongside her.

Settles and Welchel said they also realize that the message of the film might land differently in downstate Illinois than it will in a place like NYC. "I do believe this film is accessible. I don't think that we push a certain agenda or a political idea," he said. "Ultimately I think one of our huge prayers is that this documentary is used as a tool for empathy."

Walking home


Randall's mother, Tinnie Randall, was the person who most cheered on her idea for the film, both financially and through moral support. And at the same time Randall was running for the film, Tinnie was back home fighting a COVID-19 infection. She was first diagnosed in October 2020. "The first few weeks, she

was fine," said Randall. But eventually the infection progressed to the point that Tinnie was hospitalized. She stayed in the hospital for about two months. Randall would not have been allowed to visit her mother in the hospital, so she stayed in NYC. She didn't want to get the virus herself while traveling and infect other family members.

Over video calls, Randall would keep her mother company and sing her hymns. "She went through hell," Randall said of her mother's fight with COVID. Tinnie died on Dec. 17, 2020. Her condition had improved for a while, she was almost taken off a ventilator. But then she got a secondary infection, "and within a day she was gone," said Randall. Tinnie was 63 years old. "She won her battle. She's with the

Randall relies on her faith to get her through. It's what she learned from her mother, who served in pastor positions at both Faith Temple African Methodist Episcopal (AME) Church in Springfield and Allen Chapel AME Church in Taylorville. "She was funny, loud and very rambunctious," Randall said of her


mother, who was her best friend. "She was a go-getter and energized, she was one of the best people. She's where I get my servant heart from. She helped a lot of people behind closed doors that I don't even know about."

Tinnie is survived by her husband, Nathaniel Randall, a pastor at Faith Temple and Allen Chapel, and three daughters. Randall recently returned to Springfield for her mother's memorial service, which had been postponed due to the pandemic. Tinnie used to walk through impoverished Springfield neighborhoods and pray for healing. So part of the way Tinnie's family and friends honored her was with a prayer walk.

Randall said the past year or so has come with nearly insurmountable challenges. Throughout the way, she has gained a new lease on life. "I started volunteering at homeless shelters, I started giving away all my worldly possessions." Randall said now more than ever, "I want to be Christ-like, and I'm not ashamed to say that. Yes, I'm going to mess up. Yes, I'm going to stumble. But at the same time, I'm also trying to be like him in the sense of helping people and doing all I can for them." Randall's documentary film is titled The Race Against Race. It is dedicated to Tinnie and the 50 people whose lives Randall honored with her run.



Salt can transform summer produce

Salt can do more than add flavor and sparkle to recipes and fresh summer produce. Thanks to the power of osmosis, salting and draining fruits like cucumber, zucchini or tomatoes can have a transformative effect on the finished product. Foods with a high water content often benefit from an extended period of salting because it draws out significant quantities of liquid in an effort to balance the levels of salinity around it. This is helpful if you're looking to prepare a crisp cucumber salad or grill succulent slices of summer squash. Salting is also an ideal step to take when putting up tomatoes for the freezer because it helps prevent the plant cell walls from rupturing from the water inside expanding as it freezes, resulting in a meaty rather than mushy product with concentrated flavor. Prepared in this way, frozen tomatoes maintain much of their fresh texture and still taste like summer even after months in the freezer.

As a bonus, the liquid that is drained off the salted produce is an ingredient worth having in its own right. Use drained zucchini or tomato water to cook pasta or use in place of vegetable stock, or to make a surprisingly light and bright Bloody Mary. When we prepare large batches of chili sauce or ratatouille, I'll chop up and drain gallons of tomatoes, resulting in many quarts of drained tomato water which I package like broth and store in the freezer. It's a staple ingredient in my kids' favorite Spanish-style brown rice and a smart nutritional combination as well. Brown rice is rich in iron, which is more easily absorbed by our bodies when it's combined with foods rich in vitamin C, such as tomatoes.

Use a teaspoon of salt per quart of prepared produce and mix it well before placing it in a nonreactive colander set over a bowl. Refrigerate for several hours or, ideally, overnight, stirring once or twice, until the product will have reduced by about half. For quick weeknight applications, salted veggies can be spread out on a paper towel for 30-40 minutes to pull out water before sautéing or roasting. It's important to remember when using salted produce to adjust or omit any additional salt in the recipe as necessary. This process can be applied to sweet as well as savory applications. Sugar draws out water just like salt, so tossing cut peaches or berries

with a little sugar and a pinch of salt and then draining is a great way to concentrate flavor when making a cobbler or fruit pie. The drained fruit juice can be reduced in a pan over the stovetop and added back into the recipe, or left as is and used in cocktails or other fruity drinks.

Combine the above ingredients and mix well then pour into a tall glass filled with ice. Garnish and serve.

Zucchini and Rice Noodle Stir-Fry 2 medium zucchini cut into ½-inch dice

Tomato water makes a light and bright Bloody Mary.

Tomato Water Bloody Mary

6 ounces tomato water

2 ounces vodka or tequila

1 tablespoon fresh lemon juice

1 tablespoon dill pickle juice

Grated horseradish, celery salt, Worcestershire,

and Tabasco to taste

Fresh herbs to garnish

1/2 to 1 teaspoon salt

4 ounces wide rice noodles

2 tablespoons neutral oil

1 red bell pepper, diced

1 bunch scallions, sliced into ½-inch lengths

2 cloves garlic, minced

1 tablespoon grated ginger

1 tablespoon sesame oil

2 tablespoons low-sodium soy sauce Herbs such as Thai basil, cilantro and mint

Sprinkle the zucchini with salt. Arrange on a paper towel and allow to drain for 30-40 minutes. Meanwhile soak the rice noodles in a bowl of warm water for 30 minutes to soften, then drain and set aside. Stir-fry the drained zucchini with the bell pepper and the oil over high heat in a wok or skillet until they begin to soften, then add the scallions. Cook one minute, then add the garlic and ginger and cook one minute more until they just begin to sizzle, then add the sesame oil and soy sauce. Stir to combine, then add the drained noodles and mix well. Top with fresh herbs and serve.

Fresh Tomato Risotto with Bacon and Cheddar

2 ½ cups chopped tomatoes (peeling optional)

1 ½ teaspoons salt

3 ounces bacon, diced

1 medium onion

1 cup Arborio rice

3 cups water

4 ounces best quality white cheddar, grated 1/4 cup minced scallions or chives

Mix the tomatoes with the salt and allow to drain in a colander set over a bowl, refrigerated, for several hours or overnight. Be sure to save the drained liquid.

Heat the water and reserved tomato liquid in a small saucepan on a back burner. Place a heavy-bottomed nonreactive saucepan over medium-high heat. Fry the chopped bacon until crisp, then remove it from the pan with a slotted spoon and set it aside to drain on a paper towel. Add the rice to the hot fat in the pan and cook until the rice becomes opaque and just begins to brown. Add the diced onion and a tiny sprinkle of salt and continue to cook until the onions just begin to soften. Add 1 cup of hot tomato water to the rice mixture, stirring continuously, and cook until the water has been fully absorbed. Add another cup of tomato water and repeat the process until most of the water has been used up and the rice is just al dente (avoid overcooking). Turn off the heat and add the drained tomatoes and cheddar, stirring until the tomatoes are warmed through. Stir in the chopped bacon just before serving and top with the minced scallions and additional cheese if desired. Serve immediately. □

First health fair for food workers

Luminary Kitchen and Provisions hosted its first restaurant industry health and wellness fair July 26 at Luminary restaurant. The event brought food service and hospitality workers together with health care providers and representatives from various branches of Memorial Health Systems as well as Flow Yoga and the American Cancer Society. This was an effort to spark conversations and create opportunities for food service workers to get the health care many desperately need.

Aurora Coffey, the chef and co-owner of Luminary with her husband, Jordan, explained that she wanted to create a forum to connect restaurant workers with the resources they needed to care for their well-being.

"I've been doing this work my whole adult life, and I don't think I've ever met anvone in this industry who had health insurance," Coffey explained. "It's always been this thing that we joke about, that as restaurant people we're so tough and show up, and show up even when we don't feel good, and push through it. It was never really OK, but I think since COVID, health has taken on a new importance for a lot of people. Recently one of our employees wasn't feeling well. He was really worried, but he was still refusing to go to a doctor because he didn't know how he would pay for it. So we did what we always do and banded together to figure out where he could go to get help. It's become a running thing with us and our staff that if somebody's sick we try to figure out who we know who can help them out. We're in an incredibly privileged position to have those kind of contacts, but that's not the case

Coffey explained that many restaurant workers go years without basic medical care. "I've known people who haven't seen a gynecologist in decades or don't get teeth fixed or ignore mental health problems because they don't think they have a choice. People just assume that it'll be way too expensive to deal with but there's actually a lot of community resources out there and folks that'll work out flexible payment options if you know how to access them."

On hand for this first event was Amber Olson, LCSW, director of Behavioral Therapy services at Memorial Behavioral Health with information about the range of services they offer, including the Living Room. "It's open Monday through Friday, noon to 8 p.m.," Olson explained, "and is available to anyone, whether they're insured or not. It's completely free. If folks are stressed and need someone to talk to in the moment, there's someone

available to talk to them. We can also help people access resources like the food pantry or how to apply for Medicaid."

Additional providers from Memorial Health System in attendance included nurses and social workers, as well as Dr. Nicole Florence from Memorial Weight Loss and Wellness Center with information about nutrition, sleep hygiene, diabetes risk factors and the various ways that individuals can improve their health through food lifestyle changes. "One thing about COVID is that now a lot of people are finally ready to address major health issues like obesity or diabetes and we have a wide range of support options available," Florence said.

Flow Yoga studio was at the event as well, with information about their accessible schedules and the importance of mindfulness and meditation, especially for restaurant workers. "It was my goal to have a studio that was community-focused and affordable, and we try to offer class times that make sense for people who work nontraditional hours, including restaurant folks," explained owner Ashley Krstulovich.

Coffey hopes that this first event will help shed light on what she believes is a huge and largely ignored issue. "We'd like to see this become a recurring event, not always at Luminary, but try to get it going in different restaurants in other parts of town. Especially now that restaurants have super minimal staffing it's even more important that the folks who are there working are taking care of themselves and have resources for when they get sick. There's nothing tough about neglecting yourself."
