

St. Patrick's wants tax credits to continue

Invest In Kids Scholarship program will expire without action during fall veto session **EDUCATION | Dean Olsen**

Three of Jasmine Bland's five children have been able to attend St. Patrick's Catholic School, and she hopes state lawmakers continue to help lowincome families like hers afford high-quality educational options.

"The culture there is more like family, which I prefer," said Bland, a single parent who lives with her children on Springfield's east side, works a minimum-wage job and recently began a second job waiting tables.

Bland, 41, said she wants to make sure her children have access to Catholic schools even though she and her kids aren't Catholic because she has seen her children face more distractions in public schools.

Officials from St. Patrick's – a prekindergarten through fifth-grade school and a stable presence in its east side Springfield neighborhood since 1910 – hope the Illinois General Assembly listens to Bland and other parents like her.

They said the Invest In Kids Scholarship Tax Credit Program has helped put the private school at 1800 South Grand Ave. E. on the road to financial stability after years of struggle. They are worried because the program, created in 2017, is scheduled to end in January 2024 unless Capitol lawmakers take action during the fall veto session in October and November.

"I'm very concerned about it," said Sister Marilyn Jean Runkel, a member of the Dominican order and a longtime St. Patrick's board member who previously was director of Catholic education for the Diocese of Springfield.

St. Patrick's needs Invest In Kids to ensure its long-term stability, she said, though she knows some advocates of public education, including teachers unions, oppose the program and contend it potentially diverts state funding away from public schools. Opponents of the program also note that private schools can choose not to provide special-education and other services public schools must provide.

"I understand there's not enough money for public education," Runkel said. "But it's a very small percentage of the budget."

Invest In Kids offers a 75% state income tax credit to individuals and businesses that contribute to qualified "scholarship granting organizations" that, in turn, provide scholarships to students whose families meet income requirements and attend qualified private schools and technical academies in Illinois.

Donors can specify that their money should be used for scholarships at certain schools.

Created in 2017 through the same bipartisan legislation that reformed the school funding formula, Invest In Kids was signed into law by former Republican Gov. Bruce Rauner. The current governor, Chicago Democrat JB Pritzker, has made statements indicating he would be willing to renew the program with tweaks that include a reduction in the state tax credit percentage.

The Democratic-controlled legislature didn't include renewal in the state fiscal 2024 budget it sent to Pritzker's desk and he signed into law. No Republicans voted for the budget, though some would have voted for it if Invest In Kids – a priority item for Republicans – were included, according to Senate Minority Leader John Curran, R-Downers Grove.

The program is assisting more than 9,000 students across the state, and even more could benefit if the program were continued, Curran

said. Current law caps annual maximum donations at \$100 million, resulting in up to \$75 million in tax credits.

Donations haven't reached the caps thus far. There were \$76 million in contributions made, and \$57 million in tax credits given, in 2022.

"We are in full support of extending the program," Curran said of his Senate Republican caucus.

He took issue with the notion that Democratic lawmakers would allocate more to public education if Invest In Kids were allowed to expire.

Curran said he is optimistic about the program's chances in the veto session. Families that live in Democrat-represented legislative districts and see the program as key to their kids' educational futures have been knocking on lawmakers' doors, he said.

An initial report from the Illinois State Board of Education on the academic impact of Invest In Kids on the students receiving scholarships is in the works but hasn't been released yet.

Curran said recent news that the president of the Chicago Teachers Union decided to send one of her children to a private high school highlights the need for low- and moderateincome families to have access to the same educational opportunities for their kids that people with more money enjoy.

More than two-thirds of students receiving scholarships through Invest In Kids in the 2022-23 school year were from families with incomes less than 185% of the federal poverty level, or less than \$55,500 a year for a family of four, according to an Illinois Department of Revenue report. Forty percent of the families had incomes below the poverty line.

In Sangamon County, 179 students are receiving Invest In Kids scholarships, and 261 are on a waiting list for a scholarship, based on information from Empower Illinois, one of the nonprofits administering scholarships.

Almost all of St. Patrick's 45 students in kindergarten through fifth grade have qualified for full or partial Invest In Kids scholarships in the 2023-24 academic year, according to Kris Cavanagh, the school's advancement director.

Any students who fail to qualify for the scholarship won't have to pay anything other than a \$40 annual registration fee because the shortfall will be covered by private donations from individuals and area organizations, Cavanagh said.

The support through Invest In Kids will end after this school year if the program isn't extended, Cavanagh said.

St. Patrick's Principal Michael Carlson believes the school would be able to continue operating with private donations if the program went away. But Runkel said the school needs the Invest In Kids money so St. Patrick's, which has an annual budget of about \$800,000, doesn't have to constantly worry about survival.

When St. Patrick's first opened 113 years ago, it primarily served white Irish Catholics, Carlson said. Almost all of its current students are African American or of mixed-race heritage, and only a few are Catholic.

But Carlson said families who send their children to St. Patrick's see the value of a Christian education and classes of 15 or fewer students in a school with Christian standards of "respect, responsibility and safety, and also praying for each other."

"Our story at St. Pat's from the beginning through today is about adapting to the needs of this community," he said. "The neighborhood changed, but there's a need for an affordable education for working-class families, and that's what we're responding to."

The school was affiliated with St. Patrick's Parish until January 2001, when that parish merged with Sacred Heart Parish to form St. Katherine Drexel Parish. Later that year, the school became an independent entity governed by a nonprofit organization and a board.

The school property continues to be owned by the Springfield diocese, and the bishop has a say over the school's mission and philosophy, Runkel said. The school, which almost closed in 2010 because of financial difficulties, receives donations from the diocese, parishes, private organizations and individuals, Cavanagh said.

Teresa Mattsson, 63, retired earlier this year after a 21-year career in Springfield District 186, but she wasn't done with teaching. She decided to return to the field to teach a St. Patrick's classroom with third- and fourthgraders this school year.

"We have a great curriculum and great instruction," Mattsson said.

She said the smaller class sizes at St. Patrick's help her meet her students' needs, and teachers have more freedom in carrying out the curriculum than they do in District 186.

"I don't have the stress that I used to have, and my demeanor is more relaxed," she said. "I'm smiling more." \Box

Battery manufacturing plant coming to Illinois

Lithium-ion plant in Manteno part of state's effort to court EV manufacturing ELECTRIC VEHICLES | Andrew Adams, Capitol News Illinois

A new battery manufacturing plant is set to open in northern Illinois next year after the state offered more than \$330 million in tax incentives to make it happen.

Gotion, a Chinese battery manufacturing and development company, announced Sept. 8 that it will build a lithium-ion battery manufacturing facility in Manteno, about 50 miles south of Chicago.

The roughly \$2 billion project is set to create 2,600 jobs and begin production in 2024. The plant will produce battery cells, battery packs like the kinds used in electric vehicles and large-scale energy storage systems.

Gov. JB Pritzker on Sept. 5 called the development "the most significant new manufacturing investment in Illinois in decades."

In total, the state and local governments offered Gotion more than \$536 million in incentives and tax breaks, according to Pritzker's office.

The company is the fifth to make a deal with the state under the two-year-old Reimagining Energy and Vehicles, or REV, program. Under the deal finalized last week, the state will provide \$213 million in tax credits to the company over the next 30 years – nearly nine times more than the previous four deals combined. Gotion's agreement is contingent on a minimum investment of \$1.9 billion, among other stipulations.

Gotion is also set to receive \$125 million for capital funds from a \$400 million pot of money overseen by Pritzker's office that is sometimes referred to as a "closing fund." This discretionary fund was approved by lawmakers for the current budget year, giving Pritzker the authority to offer businesses incentives to relocate to Illinois beyond those offered in other state programs.

A Pritzker spokesperson said the negotiations between the state and Gotion started approximately two years ago.

The company also worked out a deal with Kankakee County to cap the taxes paid on the approximately 150-acre property at \$2 million per year for the next 30 years, according to Kankakee County Board Chair Andrew Wheeler.


The chairman of Gotion's parent company in a statement said that the group was drawn to Illinois because of "an enabling business environment" and "a supportive state government."

The company produces lithium iron phosphate cells for groups like Volkswagen. The German automotive manufacturer is the largest single shareholder in Gotion's parent company, Gotion High-tech, and the two companies share a strategic framework for developing battery cells, according to Volkswagen's 2022 annual report.

Gotion is also in the process of setting up a plant in Michigan. This has sparked controversy from Republicans in that state, who cite concerns about the company's

Chinese ownership.

Illinois Senate President Don Harmon, D-Oak Park, used the Sept. 8 announcement ceremony to advertise Illinois to other companies looking to select locations for new developments, declaring that "Illinois is open for business."

"We are a leader in the Midwest of clean energy job creation, putting us at the forefront of a rapidly expanding industry," Harmon said.

Another player in the deal was Intersect

Illinois, a public-private partnership set up by former governor Bruce Rauner to attract businesses to Illinois. The group's CEO, Dan Seals, said his organization helped Gotion with site selection for its Manteno project.

"This is the biggest project I've seen in my years of economic development," he told Capitol News Illinois. "It's a big deal for the electric vehicle industry, it's a big deal for Manteno, it's a big deal for Illinois."

Seals said the Manteno project's central location in the U.S. is a key selling point for EV companies.

"Batteries have strategic value to the electric vehicle industry," Seals said. "Batteries are heavy. Auto manufacturers don't want to be too far and have to ship them."

Earlier this summer, Canadian manufacturer Lion Electric opened a 900,000-square-foot factory in Joliet. The plant will focus on building electric buses and trucks and the company says it will eventually have a production capacity of 20,000 vehicles per year.

But the state has also had some misses when it comes to battery manufacturing. U.S. Sen. Dick Durbin, a Democrat from Springfield, told reporters in 2021 that there were talks with Samsung to bring a battery manufacturing plant to Bloomington-Normal.


But that plant, a partnership between Samsung and automotive company Stellantis, eventually went to central Indiana. Stellantis later "idled" its Jeep manufacturing plant in Belvidere, citing the rising costs of EV manufacturing as a contributing factor.

In addition to state efforts to court manufacturers, consumers in Illinois are increasingly turning to EVs and other batterypowered cars.

Since 2018, more than 186,000 EVs and hybrid vehicles have been licensed in Illinois, according to data from the secretary of state's office. There were about 80,000 fully electric cars on Illinois roads as of Aug. 15, about eight times as many as there were at the same time in 2018.

The state of Illinois offers support on the consumer side of the EV equation as well. As part of the 2021 Climate and Equitable Jobs Act, the state gives \$4,000 tax rebates for EVs and \$1,500 on electric motorcycles. □



Mayor says she didn't meet with other library director candidates LIBRARY | Dean Olsen

The woman who likely will become the next director of Springfield's public library is a longtime employee of the Illinois State Library and worked at Lincoln Library for 16 years at the beginning of her career.

Gwendolyn Harrison of Springfield was Mayor Misty Buscher's top choice among candidates to replace Summer Beck-Griffith, an appointee of the previous mayor whom Buscher fired shortly after taking office.

Beck-Griffith was appointed by former Mayor Jim Langfelder, who was defeated by Buscher in the April election, after Langfelder fired former library director Rochelle Hartman in January 2022.

When asked why she terminated Beck-Griffith, Buscher said she kept only a few of Langfelder's department directors and picked new directors based on "who I thought would fit ... my personality, my views, my goals (and) my initiatives."

The mayor wouldn't say whether Beck-Griffith, whom she didn't talk with before firing, wasn't a good fit. "I just wanted to set up my own team," Buscher said.

Buscher told the news media after the Sept. 5 Springfield City Council meeting that Harrison "stood out amongst all of them" because of her experience and her previous work for Lincoln Library.

"The other applicants had not worked for a library as large as ours," Buscher said.

Harrison, 61, who couldn't be reached for comment, could start as early as Oct. 2, the mayor said. Harrison would become the library's first African American permanent director.

The beginning of Harrison's tenure would overlap for a week with the end of interim library director Kathryn Harris' term to allow for a smooth transition, Buscher said.

If approved by the City Council at its Sept. 19 meeting, Harrison would be paid \$115,000 annually. Beck-Griffith's salary was about \$96,000. Buscher said Harrison deserves to be paid more than Beck-Griffith because of Harrison's master's degree in library science.

Beck-Griffith was the city's first library director without a library degree, though she told *Illinois Times* after her appointment that it's not uncommon for big-city libraries to have a director without one. Beck-Griffth had bachelor's and master's degrees in communications, both from University of Illinois Springfield. The library, 326 S. Seventh St., a wing of city government, operates with a staff of about 40 employees and a \$5 million annual budget.

According to a copy of Harrison's resume provided by Buscher's office, Harrison has been a library program specialist at the Illinois State Library since 2005, a reference librarian there from 2000 to 2005, and chief librarian for the Illinois Department of Children and Family Services from 1999 to 2000.

She is being paid \$96,000 per year in her job at the state library, which is part of the Illinois Secretary of State's Office and serves library systems throughout Illinois as well as state agencies.

Harrison was a library assistant at Lincoln Library from 1983 to 1999, managing the library's now-closed Southeast Branch.

She completed her master's degree in library and information science in 1997 from the University of Illinois at Urbana-Champaign. She earned a bachelor's degree in library science in 1984 from Illinois State University.

Harrison has been active in the Illinois Library Association and the Illinois Association of Minorities in Government. She was lead plaintiff in a 2014 lawsuit filed by members and retirees from several unions in state government that resulted in the Illinois Supreme Court striking down the landmark 2013 state pension reform law as unconstitutional.

Buscher said there were five applicants for the director's job, and one of the applicants later withdrew from the process. The mayor didn't reveal the other applicants' identities.

Based on Harris' recommendation, Harrison was the only person who was interviewed for the position, Buscher said.

"I do not interview people I have no intention of hiring," Buscher said. "I think it's disrespectful to spend someone's time and give them false hope."

Harris, former division manager of library services at the Abraham Lincoln Presidential Library and Museum, was acquainted with Harrison, the mayor said.

Harris told *Illinois Times* she has known Harrison personally and professionally for years. Harris said the fact that Harrison is a Springfield native, her contacts with other library professionals in the area and statewide, and her familiarity with Lincoln Library made her stand out. "I am very confident that she will be a good director for the public library," Harris said.

Buscher said she allowed the Lincoln Library Board of Trustees, an unpaid advisory panel appointed by the mayor, to interview Harrison. Buscher said she didn't know whether the board agreed with her hiring decision.

The board members wanted to look at the other candidates' resumes and interview them, the mayor said, but she didn't grant that request.

"I find it disrespectful for a professional to be interviewed by a nonpaid board when the person hiring them isn't going to interview them," Buscher said. "That doesn't make any sense to me."

The library board complained in a July 18 statement to the council about the trend of first Langfelder, and then Buscher, ignoring the board's bylaws and city code, both of which call for the board to be involved in interviews, hirings and firings of directors.

"The position of library director should not be a political one," the statement said.

The library board issued another statement, this one dated Sept. 6, after Buscher's preference for Harrison was announced and after the board had interviewed Harrison. The statement said Harrison is qualified for the position but that the board "is not in a position either to recommend that she be hired over the other candidates or to recommend that she not be hired."

The Sept. 6 statement said Harris, the interim director, "believes that Ms. Harrison would be a successful executive director" but "the board was not given the chance to interview any other candidates."

The board, made up mostly of Langfelder appointees, said Buscher may be correct "in her conclusion that Ms. Harrison was the most qualified applicant; however, the board did not have the information to reach that conclusion."

Buscher said Harrison didn't need any assurance of job security amid the recent turnover in the director position. "She was very excited to do it," Buscher said. □

Coming back to Mass

Catholic students will lose subsidies if parents don't attend regularly EDUCATION | Scott Reeder

This month, priests began taking attendance to make sure parents of students enrolled in Springfield's Catholic schools are attending worship services – and the families who aren't regularly attending could lose tuition breaks worth thousands of dollars. Perhaps not surprisingly, attendance at Catholic Masses has soared since the new policy went into effect.

"We've noticed that a lot of our parish or school families were not showing up in church, which is kind of normal across the country," said Father Dan Bergbower, priest for St. Agnes parish. "Anywhere from maybe 20% to 30% at most have been showing up at church. But they're obviously showing up at school."

"Five (priests) with the Catholic schools got together and said, 'Well, how can we encourage our people to be back at Mass?"

The plan developed by the pastors from Little Flower, Christ the King, St. Aloysius, Blessed Sacrament and St. Agnes parishes requires parents to attend at least 51% of church services in order to receive the subsidy, or scholarship, provided by the local congregation.

"It's just helping people to do what they already know they're supposed to do," Bergbower said. "Part and parcel of a Catholic education is our Catholic faith. Our intention is to try to gently encourage them to come back to Mass. Obviously, what we've been doing for the last 20 or 30 years is not working. So, we decided to try something a little different."

Since the new policy went into effect, church attendance has spiked. For example, Bergbower said at St. Agnes Church, attendance has risen from about 600 people a weekend to 800.

"We're hearing crying children again. We're seeing young families at Mass," he said.

Tuition varies a bit among the city's Catholic schools but Bergbower explained the math behind the situation this way:


A practicing Catholic with one student pays an annual tuition of about \$4,500, but the actual cost of educating the child is \$7,500. The local congregation pays the difference, which is \$3,000. For families with more than one student enrolled, tuition per child goes down and the subsidy from the parish goes up. And with lowerincome families, the subsidy may be even greater.

"A family may end up paying \$9,000, which sounds like a lot of money, because it is. But it's a lot of money for the parish, too," he said.

However, Berghower said the goal of the new policy is not to cut parish expenses but to increase Mass attendance.

"It's not about a money thing. It's just about a faith thing," he said.

The new policy does not affect Sacred Heart-Griffin High School, president Bill

Moredock said. Financial aid at the Catholic high school, which is partially funded by the Dominican Sisters, is provided based on need, but not religious affiliation, he said.

At Lutheran High School, students whose families are active in one of the area's

Missouri Synod Lutheran congregations receive a \$1,000 discount on their tuition, said Principal Zack Klug. Each year, a pastor from the church a family attends must write a letter to the school affirming that they remain "active."

It's left to individual congregations to define what "active" means, Klug said.

Pastor Matt Schneider, of Good Shepherd Lutheran Church in Sherman, said he considers how involved a family is in the church's ministries and how regularly they attend services when determining whether they have "active" status. But he added he does not have a specific rule for how many Sunday services a family must attend.

Calvary Academy gives a 10% tuition discount to students whose families are active in Calvary Church, superintendent Jay Hinckley said.

"We call it an active member discount," Hinckley said. "What that constitutes is a little open-ended. We look at attendance, whether they are involved in ministries and whether they have gone through membership class."

Jeremiah Auble, superintendent of Springfield Christian School, did not immediately respond to interview requests from *Illinois Times*.

Or will it continue to drive a wedge between the haves and the have-nots, destroy our YMCA and recreational leagues, continue to push our community resources further away from the need and harpoon the very things that it purports to bring – growth

ENOUGH WATER

The City of Springfield applied for and was granted U.S. Army Corps of Engineers permits and Illinois Pollution Control Board variances in 1988, 1993, 2000 and 2006 to construct temporary dams on the Sangamon River and South Fork River to supply CWLP with supplemental water during previous droughts ("Say no to Hunter Lake," Aug. 24). The 2006 permit and variance expired in 2011. Since 2011, CWLP customers have been vulnerable to drought with only the Springfield Drought Management Plan to rely on. There was no backup water supply during the 2012 drought, but it was not an emergency, so the drought management plan was not implemented.

The permits and variances granted previously were never used and the drought management plan has never been implemented since its inception. With renewal of the Sangamon River permit and variance, Springfield will always have enough water. *Donald D. Davis Pleasant Plains*

Why China's economy is tottering

A Springfield professor on the paradox of President Xi's power

President Xi Jinping has taken policy actions which cripple the Chinese economy. Why? Let's look at Deng's previous successful policies, what Xi has done since 2012 and the resulting political and economic consequences and discover why Xi has not acted to cure the current economic malaise in China. Last month the stock price of Evergrande in China fell 87%; it is the largest housing development bank in the world.

The good ol' days

After the helter skelter following Mao's death in 1976, Deng Xiaoping emerged as the leader who created the opening, free-market policies that brought over 600 million Chinese from dire poverty to lower-middle-class lives, while making China a world power. Mao's previous tight government control of economic activity had been disastrous. However, Deng's admonition that "profits are glorious" unleashed the enormous creativity and zeal of the Chinese people and the rest is history. For decades the economy grew at 11% per year as China became the factory of the world.

Xi's policies

Xi Jinping was elected president in 2012 by the Communist Party Congress. He assured his continuing leadership by purging corrupt and rival officials. He infused party members into the governing boards of private and government-owned businesses, while proclaiming that China was now a major world power to be reckoned with. He asserted control over the South China Sea and launched his abrasive World Warrior foreign policy to intimidate foreign countries to kowtow to China's wishes. He announced that for the good of China he would serve a third term.



In October of 2022, Xi was elected for an unprecedented (since Mao) third term as president and also head of the party and the military.

He toppled major business leaders like Jack Ma of Tencent, using fake legal charges to ensure that business leaders did not become too powerful. With the government playing its wild card of control throughout the economy, business planning and predictability became difficult, while risk shot up.

In addition, he carried out a harsh and lengthy COVID lockdown which caused great public resentment and suffering. When he finally unlocked the lockdown in November of 2022, COVID hit the population hard. His action led to mass protests against Xi's policies, a rarity in China. Finally, Xi constructed an immense surveillance program using cameras, computers and police to keep track of the movements and behavior of 1.4 billion Chinese citizens. Called the Social Credit program, it created a numeric score of the behavior of each citizen. The previous era of freedom of movement appears golden to citizens who now see their space of freedom shrinking and shrinking.

Consequences

These social and economic consequences of Xi's repressive policies have created a crisis of confidence among the Chinese people, along with major damage to the economy. The damage includes high youth unemployment, slowing of consumer demand, excessive debt (especially among developers in the housing market), falling home and apartment building prices (where half of consumers' savings are invested), weak private and foreign investment, falling exports and increased uncertainty, leading to precautionary moves all round. Economic growth has fallen to under 5% per year and is now probably closer to zero. The expected strong upswing after the harmful COVID lockdown is now sputtering. Xi's move away from a market-based

economic policy to a government- and partydirected approach has caused the dangerous current situation. A recession or worse in China would weaken the entire world economy. Political collapse would cause mayhem.

Why did President Xi intentionally switch from successful economic policies to command-and-control policies?

First, previous world recessions have been averted by China through massive government investment in infrastructure, which created excess housing and transportation capacity. The resulting excessive debt has caused sharp declines in stock and bond prices along with defaults among banks. This precludes using this stimulus method again.

Second, Xi is ideologically opposed to providing cash to citizens to spur consumption because this Western-type solution is wrong for China.

Third, and probably most important, Xi is unwilling to loosen his tight party control of China because of his "Comprehensive National Security Policy." He has declared that China can succeed only if the party guides China forward under his control. Therefore, security of the party and Xi are paramount. Political scientists note that leaders who acquire increasing political power also increasingly acquire fear that they will be overthrown. They call this the "power paradox." As Xi climbed the mountain of power through purges and killings he created his future enemies. The power paradox has gripped him, and he is unlikely to loosen his policies. □

Teachers' union president under fire

Sending son to private Catholic school

The last two Chicago mayors took some news media heat for not sending their kids to public schools, as did Chicagoan Barack Obama when he pushed for education reforms. So, this particular issue is obviously not out of bounds in that city and nobody in public life there should expect otherwise.

Chicago Teachers Union president Stacy Davis Gates has in the past pointed with pride to the fact that all three of her kids attended public schools. While others often chafed at reporters' questions about their children, Davis Gates did just the opposite, centering her children as part of who she is as a progressive activist.

"I'm also a mother," President Davis Gates said on March 6, 2022, according to NBC 5 Chicago. "My children go to Chicago Public Schools. These are the things that legitimize my space within the coalition."

"I can't advocate on behalf of public education and the children of this city and educators in this city without it taking root in my own household," she told *Chicago Magazine* a month later.

Davis Gates has also been a fiery and longtime opponent of "school choice." Last August, after a retired Chicago firefighter posted on social media: "School choice is the civil rights struggle of our generation. Keeping poor children of color trapped in failing public schools is inherently racist," Davis Gates fired back: "School choice was actually the choice of racists. It was created to avoid integrating schools with Black children."

And then it came out last week that Davis Gates was sending one of her kids to a private Catholic school.

She had to have known this would blow up in the news media. The CTU has held protests outside of elected officials' private residences, so Davis Gates couldn't possibly expect a privacy pass. And you don't just walk in a day before school starts and register your kid for a private high school, so she had plenty of time to contemplate her response.

If Davis Gates had simply defended her family's decision by saying something like her son really had his heart set on going to that school, then I don't think anyone could really disagree with her choice.

Instead, the union president initially stonewalled when faced with questions and then offered up an explanation to a local public radio station which threw the South and West sides under the bus and, more importantly, just weren't true.

President Davis Gates said basically three things last week to a WBEZ reporter: 1) Course offerings for high schools on the South Side and West Side "are very marginal and limited"; 2) Selective enrollment and magnet public high schools were just too far away and would've forced her son to, according to the article, "spend hours traveling"; 3) A public high school with a good soccer program (a sport played by her son) and strong extracurriculars are just not available close by, or are in Latino neighborhoods that were too far away.

Look, there's no doubt whatsoever that problems exist in public schools on the South and West sides. But that doesn't mean the areas are completely bereft, no matter what Internet trolls scream online.

Just as a small sampling, Davis Gates lives only three miles from Gwendolyn Brooks College Prep, a high-quality selective enrollment high school which has a soccer team and extracurricular activities.

Lindblom Math and Science Academy in the West Englewood neighborhood has a pretty darned good soccer team and is six miles from the union president's home.

the other hand, is almost nine miles from Davis Gates' home.

Not to mention the area's charter schools, which are taxpayer-funded and privately operated.

Davis Gates' public explanation just doesn't hold up to scrutiny.

Remembering Bill Black

Bill Black was a lawmaker who alternated between being outraged and outrageous.

The former Danville high school history teacher died Sept. 9. He was one of my favorite people in the Illinois General Assembly. Black was a Republican member of the Illinois House of Representatives from 1986-2011, representing the 104th district, which stretches from Champaign to Danville.

Humor was a big part of how Black legislated.

When he sponsored the legislation that ultimately outlawed bestiality, he told me: "I'm from farm country. I've heard all the jokes: 'Honest, officer, I was just trying to help the sheep over the fence.' But until recently, I didn't know that this stuff actually goes on. But I've seen police reports that show that dogs and cats have died while having sex with humans."

He later added, "I think it is the type of behavior that would be very hard for someone to say, 'What I do in the privacy of my own pasture is only my business."

Another time during a House debate on a bill to allow alcohol to be served for formal events in the Abraham Lincoln Presidential Library and Museum, he suggested that men would be staggering back into the replica of the Lincoln log cabin to urinate.

Former state Rep. Tom Ryder, who now lives in Springfield, said Black was his guiding star.

"I got there in August of '83. Bill came a few years later. We matured through the General Assembly together. He eventually became the floor spokesman. His responsibility was to tell (Republican members) on the floor about each and every bill, ask questions where appropriate and sometimes to slow down the process to keep things from moving along.

"He loved to give speeches. Sometimes they were fiery and sometimes they were eloquent. But he always knew what he was doing – even in his worst moments – like when he threw a Kleenex box at the speaker, which, by the way, didn't go more than about two rows. He had the worst pitching arm in the General Assembly."

Despite being of different political parties and having had a Kleenex box hurled at him, Black maintained a friendship with longtime House Speaker Michael Madigan.

"I can say pretty safely that of all the folks on the Republican side with whom I've served, Bill Black was the only one who was welcomed into Mike Madigan's office whenever he wanted to talk to him," Ryder recalled.

In the hyper-partisan environment of

Springfield, such friendships are becoming increasingly rare. And Black paid a political price for breaking with his party on a significant bill.

In 2010, House Republican Leader Tom Cross demoted Black from his leadership position after Black voted for a Democraticbacked pension borrowing measure.

It was not only the ultimate slap in the face that a leader could give a subordinate, it also was a significant cut in pay.

Black was no fool. He knew the consequences of voting against his party's leadership. But he considered his boss to be the voters of east-central Illinois, not some caucus leader in a fancy Statehouse office.

"Sometimes he'd get mad and he'd say, 'I'm done with this and head back for Danville, and we have to talk him out of it,' Ryder recalled. "But he was my rock. He was my North Star. I did appropriations for over a decade, which meant I was off the floor (during debates) a lot.

"And occasionally they'd call us back to the floor on a particular vote. I always looked to see how Bill Black was voting, because I knew he knew the issues. And most of the time, if Bill was voting that way, that's the way my vote should be as well. There were a few occasions in which he said to me, 'I gotta be this way, but you should be the other way."

In an environment where politicians are often obsessed with position, Black was ambivalent.

After serving 25 years in the House, he returned to Danville where he again held elective office, first as an alderman and later as a Danville Area Community College Trustee.

Neither was as prestigious as serving in the legislature from which he resigned. But Black valued service more than status.

Former Gov. Jim Edgar added, "We all have egos in this business. But he had his under control. He liked to be in the middle of things, but he always wanted to get something done. There are some people who like power for power's sake. There are others who like power to be able to get things done. And he liked to get things done."

Edgar added that the political process is producing fewer politicians like Black today.

"I think today we've got a lot of legislators who would just rather be right in their own minds than to get things done for their district. Bill had strong opinions and he'd voice them. But at the end of the day, he knew he had to work with other people if he was going to get anything for his people. Unfortunately, that is not as abundant in Springfield as it used to be." \Box

Tree health and maintenance

Preparing for the next storm **HOME | Karen Ackerman Witter**

This summer's derecho caused massive damage to trees. Now is the time to be proactive and learn about tree management and how best to maintain a resilient urban tree canopy. In the aftermath of storms, there are many unscrupulous people and others with good intentions looking to make money who lack skills and training. When branches are cut from limbs still attached to trees, energy is released, creating a significant safety hazard when branches move unpredictably. Hanging branches are called widow-makers.

If someone knocks on your door offering to help, ask for proof of insurance and credentials related to chainsaw safety and tree management. Qualified individuals should have credentials and proof of insurance handy.

"Talk to a certified arborist, not someone with a chainsaw," advises Guy Sternberg, certified arborist and owner of Starhill Forest Arboretum. The day after a storm is not the time to locate a certified arborist for the first time. Christopher Enroth, horticulture educator with University of Illinois Extension, recommends developing a relationship with a certified arborist who can assess tree health and provide advice on appropriate tree management.

Healthy trees with a strong structure are more resilient to storms. Proper pruning and removing dead wood contribute to tree health. "Consider it like a doctor's checkup," says Enroth. He recommends an annual evaluation of your trees. Enroth explains that trees don't heal – they seal and wall off damage. Wounds are carried with them and may take a long time to manifest. Most homeowners don't look high up into the canopy and lack a trained eye to see potential problems. Certified arborists trained in tree health can identify issues that need addressing. They are also trained to evaluate the level of risk and what is at risk.

Solastalgia

If you are mourning the loss of trees as a result of the derecho, it's a real thing. Australian philosopher Glenn Albrecht coined the word "solastalgia," meaning the mental, emotional or spiritual reaction of an individual, group or community to the negative transformation of their environment." There is even a book on this topic: *Solastalgia: An Anthology of Emotion in a Disappearing World*, edited by Paul Bogard.

What to plant, where to plant, how to plant

Many people will plant new trees this fall to replace those lost in the derecho. What type of tree to plant, where to plant and how to plant properly are important considerations.

Species diversity is critical. "Overplanting one species invites trouble," says Sternberg. There are many examples. Dutch elm disease devasted elm trees. More recently, the emerald ash borer destroyed tens of millions of ash trees. In many places red maples now comprise 50% of the urban tree canopy, setting up another potential disaster, and are not recommended.

A long-established guideline to reduce the risk of catastrophic tree loss due to pests is for the urban tree population to include no more than 10% of any one species, 20% of any one genus or 30% of any family. Dr. Frank Santamour, U.S. National Arboretum, published this guidance in 1990.

Christopher Evans, forestry extension and research specialist with the University of Illinois Department of Natural Resources & Environmental Sciences, recommends walking through your neighborhood and planting something different than what is already there. Consider native species and trees with wildlife and ecological benefits. Oaks and tupelo/sour gum/black gum are some examples. When selecting a nursery, avoid those promoting primarily red maples and selling trees no longer recommended (such as Callary pear, which is invasive and has a weak structure).

Look for trees with a healthy central leader. Enroth has observed trees in garden stores where the top has been cut to promote branching and make them look fuller. Without a strong central branch, the tree structure is weak and more likely to suffer storm damage. Enroth says a tree that looks like a skinny whip is better than a small, bushy tree.

Sternberg advises paying attention to the surroundings and finding the appropriate tree for the soil and location. Be aware of buried and overhead utilities, proximity to structures, the size of tree at maturity and soil conditions. Proper planting is also critical, as sometimes trees are planted too deeply.

Evans says good tree health starts with the roots. There should be enough space and appropriate soil for the root system to develop. Prune or remove circling roots when taking trees out of plastic pots. It can take three years for newly planted trees to become established. Larger trees can take longer and require more watering. Mulch around the tree, leaving a twoinch gap between the mulch and trunk. "Mulch like a bagel, rather than a muffin," says Enroth. Poor watering and lawnmower damage are the biggest killers of newly planted trees. "Prevention is the best medicine," says Emily Swihart, Illinois Extension horticulture educator. While the trees are young, proper maintenance can help develop well-formed, structurally-sound trees. Evans says there should be a good flare at the base and not look like a telephone pole in the ground. Pay attention to changes in your trees over time. Take pictures seasonally and track changes which may be a warning sign. Alterations to sidewalks, driveways or landscaping can impact trees, and results may not be seen immediately.

Periodic cicadas coming next summer

Two broods of periodic cicadas will emerge concurrently early next summer for the first time since 1803. The 13-year and 17-year broods will emerge in May in central Illinois. Newly planted trees in areas with more mature trees will be most vulnerable. Females use their ovipositors to cut slits in the branches and lay their eggs. The nymphs fall down, burrow in the ground and feed on the roots. The slits in the branches damage the tree. Pesticides are not a control option. Be proactive next spring and place fine mesh netting over young trees. □

Planning for spring

Get a head start with this fall lawn and flower garden checklist

If you're thinking of spring and can't wait to see beautiful flowers and a lush lawn next year, consider the following checklist of action items to do now:

Fertilize

September is the best time to fertilize the lawn and get the root system ready for winter, according to Joan Buckles of Pleasant Nursery, 4234 W. Wabash Ave. Fall is all about the roots.

If you weren't the person who planted the grass, take the time to identify it before applying fertilizer. The wrong fertilizer can poison your lawn. Take a photo of your lawn to Buckles, or visit the Illinois Extension website (https://extension.illinois.edu)to identify the type of grass in your yard.

Plant grass seed

September is also the time to plant grass seed on bare areas and overseed the existing lawn. Overseeding is adding seed to an existing lawn without turning the soil. With less weed competition, grass seed can germinate and establish roots before winter. If you plan to aerate the lawn to break up compaction and allow air movement in the soil, do so before overseeding.

Plant trees, shrubs and perennials

If your favorite tree is on sale, then give yourself the green light to buy, because planting can be done through October. As the air cools, the ground remains warm, which creates perfect growing conditions for roots to take hold.

Divide existing perennials

Perennials are flowers, vines and ornamental grasses that are planted once and return each year. If your perennial garden is getting



crowded, fall is a great time to divide and transplant.

Dividing is a simple process. Dig up the plant to be divided and use a shovel or sharp knife to divide the root ball into smaller units. Return one portion of the plant back to the original hole. Make sure all roots are covered with soil and mulch, and give it a drink of water.

Take the divisions to their new place, dig a hole slightly larger than the root ball, add water, place roots in the hole and cover with soil and mulch. Cut back remaining foliage to reduce stress on the plant and assure that all nutrients go to the new root system. Water every couple of days while temperatures are high. Water less often as temperatures cool. The new transplants may be given a slow-release fertilizer, but be careful not to burn new roots with too much fertilizer. If you're unsure, stick with water and sunshine.

Plant bulbs

For early spring color, Candi Scheuermann, garden center manager at Green View, 3000 W. Jefferson St., recommends planting bulbs from September through the end of November. When planting large bulbs such as daffodils and tulips, place them eight inches deep and two to three bulbs per square foot. For smaller bulbs such as crocus, put them about five inches deep and three to five bulbs per square foot. Plant all bulbs with the pointed end up. To get bulbs of the same type to bloom at the same time, plant them at the same depth.

Bring delicate bulbs inside for protection

Some plants such as cannas, dahlia or gladiolus will die if allowed to freeze. Buckles recommends that once frost is in the forecast, cut back the foliage of the plant and dig up the bulbs to store in a cool, dry place over the winter. Bulbs can be stored in a box and covered with sawdust. If you have a refrigerator in the garage, Scheuermann said this is a perfect place to store these bulbs so they won't sprout too early.

Winter interest

No need to cut back all that is green before winter arrives. Buckles suggested leaving the ornamental onions, roses, butterfly bushes and hydrangeas behind for winter interest. These can be trimmed in the spring.

Create a protective covering and food source

Scheuermann advises leaving the leaves (or putting them in the compost bin) for birds and beneficial insects such as the praying mantis and lady beetle (not to be confused with the beetles that are prolific in fall and bite). Birds need leaves for protective cover and material to build nests. Bees and other pollinators appreciate late fall blooms for nectar and pollen grains.

If you are inspired to select perennials that will continue to bloom until late fall and other plants for winter interest, both Buckles and Scheuermann are happy to provide you with options and guidance. It's never too early to think spring. \Box

A blueprint for fall gardening

The end of summer does not mean the end of gardening. In fact, fall provides opportunities for planting vegetables, as well as bulbs and hostas that will ensure a colorful and beautiful garden come spring. Mary Hinkle and Patty Lloyd, who serve as the horticulture committee chairs for the Springfield Civic Garden Club, share their thoughts on fall gardening.

Start by developing a plan. Decide what you want to plant and where. You will need to be sure your garden beds offer the space, soil and sun exposure to accommodate what you wish to grow.

Fall vegetables

Hinkle, who is a designated master gardener, advises clearing away old plant material before planting vegetable seeds. She says an all-purpose fertilizer or organic compost can be added to the soil. Once seeds are planted, she recommends keeping the top half inch of soil moist to help with seed germination and root development.

Some vegetable seeds need to be planted by early September. If you wait too much later in the month, your choices of vegetables to plant will be more limited due to the timing of the first frost. "The average date of the first frost in central Illinois is around Oct. 15," said Hinkle.

About the Springfield Civic Garden Club

The SCGC was established in 1929 and supports area groups in their horticultural, educational and environmental efforts. With 250 members, it is the largest garden club in Illinois. The group meets on the first Monday of most months to hear guest speakers or visit local gardens. Guests are welcome. For more information, visit scgc-il.org.

"Anything that will be harmed by frost should be harvested by then."

However, Hinkle notes, some veggies, such as kohlrabi, leaf lettuce, mustard and turnip greens, spinach and spring radish can survive a light frost. She also says you can extend the harvest season by covering crops with an old sheet and removing it each morning.

Flower bulbs

Fall is a great time to plant bulbs such as tulips, daffodils, hyacinth and crocus so you can enjoy pops of color in the early spring. Look for highquality bulbs that are firm and plump with no spots or mold. And be sure they haven't already started sprouting.

The Illinois Extension advises planting bulbs four to six weeks before the first frost so the roots can start to grow. Bulbs grow best in well-drained soil with full or partial sun.

Bulb packaging will tell you how deep to plant the bulbs. A general rule of thumb is to bury them two to three times as deep as the bulb is tall. Place bulbs with the pointed-side up and the roots down. Give bulbs a healthy watering after planting and cover the soil with mulch.

Hostas

Many people love hostas because they are resilient and survive winters by going into dormancy. They are great for ground cover in shady areas, but some do well in sunny or partially sunny areas. Plant them in early fall after the heat of summer subsides. There are many varieties of hostas that vary by size, leaf shape, color and texture.

When planting hostas, the Old Farmer's Almanac advises digging a hole that is twice the size of the root ball. Use a well-balanced, slowrelease fertilizer after planting. Keep the soil

moist, but not soaked.

Hostas are toxic to pets so keep that in mind when deciding where to plant them.

Garden cleanup and maintenance

There are two schools of thought on fall garden cleanup, says Hinkle. "You can cut it all down and make it neat before winter, or leave most of it for nesting and developing pollinators over the winter." Lloyd adds that it is helpful to leave places for beneficial insects to hide over winter.

"Perennials such as hostas, peonies and iris should be trimmed up and the waste removed from the flower beds to avoid plant diseases like fungus," says Hinkle.

YOU SAID TOMORROW

Lloyd says that fall is a good time to divide perennials, except for fall-blooming perennials such as chrysanthemums and asters. The divided flowers and hostas can be replanted elsewhere or shared with friends.

A final tip for gardeners is to make notes of what worked or didn't work so well in your fall garden, as well as make a list of things you want to consider for next year.

Get your family organized

It's happening. The kids are back to school, the temperature is dropping slowly but surely, and I see mums and the occasional pumpkin popping up on people's front stoops. Whether you are a fall lover like me, or are more like my partner, who considers fall the end of all things living as we slide toward winter, we can no longer deny that it's coming.

Along with the change in weather comes the busiest time of the year for many families. Early mornings getting ready for the day bump up against after-school activities, and all of a sudden, it's time for dinner and homework and bedtime routines, only to rise and do it all again the next day. And somewhere looming in the not-so-far distance is the massive lift of HalloThankMas and all the tasks and business of the upcoming holidays.

Even for a fall lover, it can feel a little bit overwhelming. Luckily, there are a few small things we can do once to help our families feel a bit more organized and prepared for the busy days ahead.

Hang it

Install some hooks for your kids' hoodies and jackets in order to keep these items from getting lost and to keep them off of the floor. This doesn't have to be anything fancy; in fact, I find that big Command hooks work great for kids' items because they are adjustable and durable.

Contain it

Consider where kids will stick backpacks and lunchboxes at the end of the school day. You may have storage in an entryway or a mudroom. The entrance to our home dumps right into our kitchen, so no such luck, but we have baskets in the dining room in order to keep backpacks, lunchboxes, school iPads and library books all together and easily accessible day to day.

Archive it

It is perfectly understandable to slide some of these graded papers right into the recycling bin, but in the case of items you'd like to preserve or keep, you'll need a system. Some families opt for digital storage, and there are no shortage of apps and sites to choose from. The analog option is a large file box or file folder tucked away someplace hidden but convenient. Resist the urge to keep everything, and clean it out



from time to time as you may be surprised about what you've chosen to keep year to year.

Separate it (or them)

Multiple kids probably means multiple homework assignments. If your kids are younger, they may opt to do homework near a parent or caregiver so that they can ask for help. If your kids are sharing a dining room table, you may notice that they have more fun pestering one another than getting straight to it. Consider a tri-fold poster board as a temporary separation space for kids doing homework next to one another. Oktoberfest in September

Next to beer, currywurst are the best

Though it's only the middle of September, Oktoberfest officially begins this weekend. Over six million people will be attending Munich's annual beer bash which goes on for 18 days. Oktoberfest has spread across the globe, with major celebrations taking place in such diverse places as Brazil, Australia, China, Argentina, Japan, South Africa and Hong Kong, as well as in many cities across America.

The tradition of Oktoberfest began in 1810 as part of the wedding celebration of Princess Therese to Ludwig Karl August, the crown prince and future King of Bavaria. The citizens of Munich were invited to attend the fiveday wedding celebration of food, drink and music, which culminated in two-mile horse races. The event was held in a grassy field outside the Munich city gates dubbed Theresienwiese (Theresa Meadow), which has remained the site for the world's largest Oktoberfest celebrations, now in its 188th year.

Over the years, Oktoberfest has grown from five days to more than two weeks. The festival traditionally ended on the first Sunday of October, so the starting date was moved to mid-September to take advantage of the longer days and warmer temperatures.

Munich's Oktoberfest has become more a celebration of German beer and food than the marriage of a prince and princess. The festival kicks off with a 12-gun salute followed by the ceremonial tapping of the first keg of Oktoberfest beer. By the end of the fest, nearly 7.7 million liters of beer will have been consumed. And while the beer is certainly the center of attention, food is a very important part of the festivities. The festival's tents and food stalls serve up such things as spit-roasted chickens, beer-braised pork, pretzels and a wide variety of sausages. One of the most popular, and uniquely German street food treats, is the currywurst.

A currywurst is a grilled bratwurst cut into bite-sized pieces, topped with curry ketchup, and dusted with curry powder. Nearly a billion currywurst are sold each year. Its origin is attributed to Herta Heuwer, who was working as a trümmerfrau (rubble woman), helping to clear the destruction in the British military sector of Berlin after the Second World War. Somehow she managed to get ahold of curry powder and Worcestershire sauce from the British soldiers, and ketchup from the Americans. Seeking a flavorful alternative to bland post-war rations, she developed a spicy condiment that could be served over grilled pork sausages. Heuwer started selling the cheap but filling snack at her street stand, where it became wildly popular with construction workers rebuilding the war-torn city. At her peak, she was selling nearly 1,500 currywurst a day. She obtained a patent for her sauce under the name "Chillup." Under German patent law, she did not have to disclose the exact recipe, so she kept it secret and took it with her to her grave in 1999. Kraft Foods unsuccessfully tried to acquire the patent. An interesting bit of trivia: the Wolfsburg Volkswagen plant has an in-house butchery program that produces 7 million currywurst a year to feed its employees.

Today currywurst are available in food stalls and many

restaurants across Germany, served in a paper food tray with a little wooden currywurst fork. They are usually accompanied by fries or *brötchen*, small bread rolls. Currywurst can be enjoyed any time of day, but they are especially popular as late-night drunk food.

Curry Ketchup can be found in many international grocery stores or from Amazon, but making it from scratch is quite easy, and it spares you from all the unhealthy food additives and high-fructose corn syrup or refined sugar found in commercial versions.

German bratwurst are different from the bratwurst typically found in the Midwest. German bratwurst are a mild-flavored, fine-textured mixture of veal and pork and they are usually pre-cooked. Wisconsin bratwurst are made with more coarsely ground pork and are usually sold raw.

Currywurst

Herta Heuwer's original curry ketchup recipe remains a secret to this day. Copycat versions abound. This one is a good approximation.

Makes about 2 cups

For the curry ketchup

- Makes about 1 cup
- 1 tablespoon avocado or canola oil
- 1 small onion, diced
- 2 tablespoons yellow curry powder, plus more for dusting
- 1 tablespoon tomato paste
- 1 cup tomato passata or purée
- 1 tablespoon balsamic vinegar
- 1/2 tablespoon honey
- 1 teaspoon Worcestershire sauce
- 1 teaspoon kosher salt
- 2 tablespoons extra virgin olive oil

For the sausages

- 6 German-style bratwurst (See note below)
- 1 tablespoon avocado or canola oil (if pan-frying)

Preparation

Prepare the curry ketchup: Heat the olive oil over medium heat in a deep saucepan. Add the onion and sauté until softened, but not browned. Stir in the curry powder and tomato paste and cook briefly. Add the tomato passata or purée, balsamic vinegar, honey, Worcestershire sauce and salt. Bring to a simmer, stirring occasionally, until thickened, about 10 to 20 minutes. If it becomes too thick, thin with a little water.

Transfer the mixture to a blender and purée until smooth. Alternatively, purée with an immersion blender. Taste for seasoning and add salt, vinegar or honey as needed. Blend in 1 tablespoon of olive oil in a steady stream.

Prepare the sausages

With a sharp knife, make 8 shallow crosswise cuts about 3/4-inch apart along the length of each sausage to allow steam to escape as the sausages cook. Heat the oil in a skillet over medium heat. Lightly brown the sausages on all sides. Alternatively, direct-grill on a barbeque over charcoal or gas.

Following the cuts along the sausages, separate into bitesized pieces. Drizzle with the curry ketchup and sprinkle with additional curry powder.

Heroux said the show is a fundraiser for Victim Impact Speakers, a nonprofit organization that works to reduce the number of deaths because of drunken driving.




