# **Blight brigade**

City targeting east-central area for services, improvements

The city of Springfield is hosting a program Oct. 7 designed to target 55 neighborhood blocks deemed to be in need of extra attention from municipal departments.

The targeted area was identified using police data on where gunfire is most often detected and public works information on areas receiving the most complaints for problems such as dilapidated housing, said Sai Joshi, the city's Bloomberg Harvard fellow who is coordinating the initiative.

"So, we're using both of these data sets to overlay and then map out a geography," Joshi said. "Basically, it's an agglomeration of blocks within specific neighborhoods where we could go in and pool all these resources."

Last year, Springfield was one of seven U.S. cities selected to participate in the Bloomberg Harvard City Hall Fellowship program. Joshi is an architect, urbanist, researcher and a graduate of Harvard Graduate School of Design. She joined the city's Office of Planning and Economic Development in August 2022 for a two-year fellowship, and her focus has been on developing a "whole block restoration strategy" for Springfield.

The boundaries for the initiative are from North Grand Avenue to East Carpenter Street and North Ninth Street to North 19th Street. The area encompasses some of the city's highest concentrations of blighted homes, property crimes, violence, rental properties and housing and environmental code violations, she said.

Police officers and other city employees will knock on every door within the designated area and ask residents to identify

persistent problems in their neighborhoods such as illegal drug dealing, fly dumping, derelict houses and yards overgrown with weeds

The office of Public Works will be in the area for about three weeks following the Oct. 7 launch trimming trees, assessing sidewalks, performing alley cutbacks, sweeping streets, replacing signs and performing engineering

assessments. City inspectors will be assessing possible code violations and answering residents' questions.

Mayor Misty Buscher said this is her flagship initiative. She said she intends to have similar endeavors in other parts of the city during her time in office but they are starting in central and east Springfield because the need is perceived to be greater.

She said she will be among those knocking on doors and listening to concerns.

"The concerns could be about neighborhood cleanup. It could have to do with food needs. It could have to do with educational needs. We just will be really open and listening. Our volunteers will document where a household is and what their request is."

From 10 a.m. until 4 p.m. Oct. 7 there will be a gathering of various city department heads and representatives from various medical and social service agencies at Bunn Field, 1300 East Division Street. Firefighters and police officers will have child-friendly displays.

"Sometimes children, including children of color, can perceive police negatively because of only seeing police officers in negative situations," Haley Wilson, the city's director of communications, recently told the Springfield Downtown Kiwanis Club. She added that is why it is important to have children interact with officers in other settings.

Police Commander Joe Behl added, "We're just starting a conversation – a non-law-enforcement contact with the community members. It is always good to bridge that gap and break down those barriers. And that's our intention, to build back our community and make a safer, more healthy community."

Behl said between 20 and 25 police officers will participate in the project. Overtime expenses and expenses related to the project are being paid for through a \$500,000 state grant.

Ward 3 Ald. Roy Williams praised the program, which began last year under the name Community Connections. The initial outreach efforts in October 2022 focused on an area bounded by 11th to 18th streets and South Grand Avenue to Cook Street.

"I think it's a good program. If the citizens participate, it will take us a long way because it's putting the directors – people in powerful positions – right in the face of ordinary people from the neighborhood," he said. "In other words, instead of calling and making demands or calling the city and reporting a problem over and over, they're going to be able to talk directly to someone who can solve the problem."

Williams noted that much of the outreach area is within his ward.

"I'm from near east, and Pillsbury is a part of Ward 3, just like the rest of the east side. Pillsbury is dirt poor, and (there is) very, very primitive housing over there. ... If they do it right, (department heads) can see some examples of these houses that I have turned in over and over and over," he said. "I'm going to make the people show them instead of me showing them. Seeing these situations, they'll see these houses should have been gone years ago."

Williams later added, "It's outright disgusting that these places continue to exist. If the mayor's out there − I'm hearing rumors she's going to walk through there − I think she will see things that are much worse than she ever imagined." □

# Momentum after many delays

Construction begins on Scheels Sports Park, set to open in 2025

Ceremonial shovels turning over dirt Sept. 20 signaled the start of construction for a \$67 million sports complex that city officials said will make Springfield a popular destination for young people competing on traveling athletic teams from throughout the Midwest and beyond.

"This puts Springfield on the map for sports tourism," Springfield Mayor Misty Buscher said at a groundbreaking ceremony on the city's south side at the future site of the Scheels Sports Park at Legacy Pointe.

About 300 people from the area's business community and units of local government, as well as a handful of young soccer players and high school athletes, turned out for the groundbreaking ceremony, capping a multiyear effort to create a 95-acre indoor and outdoor site expected to open by the end of 2025.

Buscher, whose administration continued the work begun by former mayor Jim Langfelder's administration on the unique public-private partnership, said the sports park is expected to bring \$25 million a year in new spending to Springfield.

About 250,000 people from across the country are expected to visit Springfield each year to use the sports complex, increasing visitors overall by 10% to 15% after the first year of operation.

"You will have people coming to the community who have never been here and may never have come here," Buscher said.

Buscher, who took office in May after defeating Langfelder in his bid for a third consecutive term, asked residents to welcome athletes and their families and encourage them to eat at local restaurants, stay at Springfield hotels, visit historic sites and patronize local shops.

Ryan McCrady, president and chief executive officer of the nonprofit Springfield Sangamon Growth Alliance, helped to spearhead the project and said, "Sports tourism is a great way to separate people from their money, and we want to do it in Springfield to benefit our local businesses."

McCrady, who has acted as a spokesperson for landowners Steve Luker and Dirk

McCormick of Legacy Pointe Development, thanked Springfield-area elected officials who voted to take part in economic incentives to move the project forward.

He also thanked business people such as Luker and McCormick "who are not afraid to dream big, take risks and gather a lot of parties together to help bring things to reality.

"This project will change how Springfield sees Springfield," McCrady said. "It'll change how other people see Springfield. It's a sign that we can achieve big things in our community when we work together between the public sector, the private sector, all the large governmental bodies (and) the financial institutions."

Sales taxes and hotel-motel taxes paid in the city over a 23-year period are expected to pay for half of the complex's construction costs, totaling about \$33.5 million.

The rest will be financed by the developers, who McCrady said have received financing commitments from about a dozen area banks, including Bank of Springfield.

The Springfield City Council recently

dissolved the former South Central Business District to create a new one with a maximum 23-year lifespan that coincides with other economic incentives in the city's agreement with Legacy Pointe Development.

The business district, about double the size of the previous district, includes the sports complex and imposes an additional 1% sales tax on purchases at Scheels and other businesses in the district for use by the city for infrastructure improvements in the district.

The development agreement also calls for more than 70% of the city's portion of sales taxes in the business district, above a base of \$1.48 million annually, to be reimbursed to the sports complex, which will be owned and operated by Legacy Pointe Development.

Springfield city government, as well as Sangamon County government, District 186, the Springfield Park District, Lincoln Land Community College, Capital Township, Springfield Airport Authority and other governmental units agreed to not collect additional property taxes associated with

the construction for the life of the 23-year agreement.

All of the entities working together to get the project moving "really shows Springfield's strength – how we can pull together if everybody keeps their mind on the goal, and that should be what's in the best interest of the city and our residents moving forward," Langfelder told *Illinois Times* before the groundbreaking.

"This is a decades-long project that Springfield always yearned for ... and we appreciate all the partners that brought it to fruition," Langfelder said.

McCrady said the sports complex "will be the best youth sports destination in Illinois because of the outdoor and indoor facilities, its proximity to interstates and central location in Illinois to attract athletes from across the region."

The outdoor areas will include lighted turf fields for soccer, softball, rugby, lacrosse, football, baseball and other sports.

The site will include an air-supported, inflated and domed structure for year-round indoor use. It will cover 190,000 square feet and provide enough space for eight basketball courts, 16 volleyball courts, performance areas and turf training areas, McCrady said.

Compared with the nearby Scheels store, the domed structure will be at least as tall and twice as long, he said.

Some city officials have said the groundbreaking and banks' approval of financing for the sports park's developers was delayed somewhat by the fact that the city, under Langfelder's administration, didn't pursue creation of a new business district.

But Langfelder, in response to questions from *Illinois Times*, said there were several factors that contributed to the delay, including the opinion of Jim Zerkle, the city attorney appointed by Langfelder, that the City Council could take action to extend the life of the former business district so it coincided with bond-related borrowing to pay project costs.

Buscher said the legal advice she received after taking office pointed to the need for dissolving the old district and creating a new district. The council didn't have the power to extend the life of the former district, she said.

Langfelder said: "Few have fought harder for the sports complex than my administration — having to work through competing sports complex projects' interests, changing dynamics, creating a tax-incentive package and successfully getting it approved through City Council." □

## **Springfield Clinic to be major sponsor**

Springfield Clinic's name and logo will appear on the inflated dome of a 190,000-square-foot structure for indoor practices and competitions at Scheels Sports Park at Legacy Pointe.

That name recognition for the clinic, one of the largest multispecialty medical groups in Illinois, is just one part of its involvement as the park's official Health and Performance Partner, according to Cal Thomas, the clinic's chief development officer.

Though all the plans haven't been finalized, the clinic's "multimillion-dollar commitment over a 20-year period" will include construction of a brick-and-mortar building attached to the dome for sports-medicine, rehabilitation and performance-enhancing services for competitive and casual athletes in the region, he said.

Outside the park but still in the Legacy Pointe development, the clinic plans to build a walk-in clinic where patients will be able to receive services ranging from urgent and primary care to specialty care.

That clinic will cater to area residents as well as young athletes and their families who may be visiting Springfield for a

tournament, Thomas said.

The park, which is being constructed through a public-private partnership and expected to be completed by the end of 2025, could become a place where the clinic provides a central location where already-existing strength, conditioning and speed-enhancement businesses can offer services, Thomas said. The clinic, an 80-year-old, for-profit entity, is reaching out to those businesses to collaborate, he said.

"Instead of replicating what's (already) here, we want to be that central force that pulls all of those together and develops a true, integrated program that's offered here on this complex," Thomas said.

He said he didn't have specific estimates for the cost of the new buildings and for exercise and calisthenics stations that will be placed throughout the park.

He declined to say what the clinic will pay for naming rights that allow the clinic's brand to be placed on the dome. Park organizers said the dome, also known as an air structure, will be the largest of its kind in the world for youth sports and will be held up with air pressure and not columns.

Thomas said he did research on other partnerships between medical providers and youth sports complexes in Illinois and other parts of the country, but he found none quite like this.

"We think we can bring something unique to a project that's already unique in its own right. ... Nothing is really like this in the Midwest," he said.

"We're deeply committed to redefining the future of health care in our communities, so our support for this project goes beyond dollars and cents," Thomas said. "We see it as an opportunity to create a one-of-a-kind destination for performance and wellness that this region has never seen."

Ryan McCrady, chief executive officer of Springfield Sangamon Growth Alliance, said: "This investment by Springfield Clinic is a game-changing development for this project. It's a shining example of the strong sense of community that Springfield has always had, and I hope it encourages other homegrown organizations and businesses to get behind this effort that we will all benefit from."  $\square$



#### **Small counties struggle to implement SAFE-T Act**

Hannah Meisel's recent report for Capitol News Illinois included a line that jumped out at me: "Per state law — which hasn't been updated since 1949 — only counties with 35,000 or more residents are required to set up offices of public defender."

According to information posted on numerous websites (Illinois Demographics, Wikipedia and World Population Review), a majority of 62 out of 102 Illinois counties have fewer than 35,000 residents. Fifty counties have less than 25,000 residents. Another 31 have less than 15,000 inhabitants, 15 have less than 10,000 people and seven don't even have 5,000 residents. For perspective, a single Chicago ward contains about 54,000 people. Only 24 counties have at least that much population.

All counties in the state are required by the Illinois Constitution to have sheriffs, county clerks and treasurers. State statutes heap on many more responsibilities, as do local county ordinances.

We've long seen advocates calling for school district consolidation and township elimination. But the SAFE-T Act's implementation last week highlights how the state should probably start a conversation about how dozens of small Illinois counties can effectively govern in a modern society.

A recent WBEZ story noted that Cass County has "one attorney and one resident judge handling all the criminal cases." Cass is just northwest of Sangamon County and has a bit more than 13,000 residents.

Meisel's story profiled a public defender who does part-time work in two counties: Gallatin and Hamilton. The combined population of those two counties is about 13,000, according to her report.

The counties want more money from the state to implement the new law, which fully took effect Sept. 18. Public defenders outside of Cook County received \$10 million in this fiscal year's budget, which doesn't seem like much

I don't know what the answer is here, but I do know that local mandates are regularly approved at the Statehouse without taking the population of most Illinois counties into consideration.

And the lack of resources in Illinois' plethora of tiny counties is only one problem. There will be other problems with the new SAFE-T Act.

A prosecutor will decide not to ask a judge to keep someone in custody who has been busted for a detainable offense, or a judge will overrule a prosecutor who wants someone detained, or a loophole will be exploited and that suspect will then go out and commit another crime and maybe hurt someone, or worse

This sort of thing is not new, of course. A small minority, but still a significant number of people who bailed out of jail, wound up going back after committing more offenses. But that history may easily be lost in the debate as bad things happen under the new law.

Controversy arose on the very first day of the new law when WTTW reported that the Cook County state's attorney's office decided not to ask for the detention of the very first person given a hearing. The suspect was accused of pepper spraying four Chicago police officers and sending three of them to the hospital, and is facing four counts of aggravated battery to a police officer.

"This highlights the misplaced priorities of Illinois' criminal justice system when the prosecutor prioritizes the freedom of a violent offender over the safety of those police officers dedicated to protecting and serving our communities," said Senate Republican Leader John Curran in response.

Elsewhere, though, prosecutors used the new law to keep people behind bars who likely would've previously walked away.

McLean County State's Attorney Erika Reynolds has been a staunch critic of the new law, but her office persuaded a judge to keep a man locked up who was accused of possessing a gun as a felon, a consortium of Public Radio stations reported. The man was arrested before the SAFE-T Act officially took effect, and his public defender wanted him charged under the old statute so he could potentially bond out of custody. The judge disagreed and the man remained in custody.

Proponents just haven't focused on how the SAFE-T Act will make it easier in many cases to keep physically dangerous people locked up without bail.

But no mere law can eliminate human error or prevent all unforeseen circumstances. As those cases emerge, we can probably expect legislative fights over whether to expand the list of detainable offenses.

Those battles could wind up being the new version of the old legislative tradition of annually enhancing criminal penalties, which proceeded unabated for decades until more progressive members finally put a stop to it.  $\square$





# Dying and disabled Illinois prisoners

Hundreds who are medically incapacitated are kept behind bars, despite new medical release law INCARCERATION | Carlos Ballesteros of Injustice Watch, Shannon Heffernan of WBEZ, and Amy Qin, WBEZ

Phillip Merritt's dementia is so advanced he's lost the ability to speak. But with the help of his cellmates at Western Illinois Correctional Center, the 71-year-old still manages to get on the phone with his brother every few weeks.

"He has to have someone call me, and then I don't know what to say to him because he can't understand anything, so I'll just talk," said Merritt's brother, Michael Merritt, in an interview. "All he can say are two words. ... I mean, he's just gone."

Merritt's deteriorating condition makes him a prime candidate to get out of prison under the Joe Coleman Medical Release Act, a pivotal criminal justice reform bill touted by Gov. JB Pritzker and Illinois Democrats as an effective way to alleviate the state's decrepit prison health care system, reduce the "staggering" costs of caring for ailing people in prison, and reunite families with frail loved ones.

Under the act – named after a decorated Army veteran who died of prostate cancer while incarcerated – Illinois prisoners can request early release if they're terminally ill and expected to die within 18 months or if they're medically incapacitated and need help with more than one activity of daily living, such as eating or using the bathroom.

But a year-and-a-half since the Coleman Act went into effect, an investigation by Injustice Watch and WBEZ found far fewer prisoners have been released under the law than expected, as the medical release process has become mired in the charged politics of criminal justice reform in the post-George Floyd era.

Behind the lower-than-expected numbers is the Prisoner Review Board, a state body appointed by Pritzker and confirmed by the Illinois Senate with final say on medical release requests.

As of mid-August, the board had denied nearly two-thirds of medical release requests from dying and disabled prisoners who met the medical criteria to get out of prison under the Coleman Act – including Merritt.

"I couldn't believe it," his brother said.

"How could they deny him? He can't even talk!"

More than half of the 94 denied applicants were older than age 60, and half had spent at least 15 years behind bars, according to an analysis of state prison data. At least two died in prison, including an 81-year-old who had been incarcerated for more than three decades and was scheduled to be released in 2025. Another man died five days before the board denied his request.

Meanwhile, the Prisoner Review Board has only granted 52 medical releases – a rate of fewer than three releases per month on average since board members began voting on those requests, records show.

Advocates say the board is undermining the Coleman Act and forcing ill-equipped prison staff to care for dying and disabled prisoners, even those with families practically begging to take them off their hands.

"Our prison system is now completely overburdened by people who pose absolutely no risk to public safety but are tremendously expensive to care for," said Jennifer Soble, lead author of the Coleman Act and executive director of the Illinois Prison Project, a nonprofit legal group that represents dozens of medical release applicants.

"From a cost-saving perspective, from a government-efficiency perspective, and truly from a moral perspective, we need to be doing something differently here," she said.

Donald Shelton, chair of the Prisoner Review Board, declined an interview request, but he defended the board's record on medical release requests in an email sent through a spokesperson.

"Each case that comes before the board comes with its own set of circumstances to be studied and evaluated by members," he wrote. "Due diligence is given by the board to every person who sets a petition before them."

#### More medical releases could save taxpayers millions

It's unclear exactly how many of Illinois' nearly 30,000 prisoners could qualify for

medical release. Under the Coleman Act, the Illinois Department of Corrections is required to keep track of that number, but department officials said they don't have it yet. A department spokesperson said the data would be published by year's end.

What is clear, from years of scathing reports from an independent monitor appointed by a federal judge, is Illinois prisons are unfit to provide health care for the thousands of aging, disabled and incapacitated prisoners.

Half of the state's prison medical staff jobs are currently vacant. Prisoners with mobility issues suffer bed sores and frequent falls because no one is around to care for them. Some are even left sitting in their own waste, according to the monitor's reports.

"Prescriptions go unrenewed, cancers go undiagnosed. In the worst cases, as everyone here knows, people die painful deaths because of the lack of care," attorney Camille Bennett with the ACLU of Illinois said at a recent hearing on health care in state prisons.

Even this substandard care is expensive. Illinois paid \$250 million last fiscal year to Wexford Health Sources, a for-profit company contracted to provide health care to state prisoners, according to state records.

Wexford's 10-year contract expired in 2021, but the company continues providing care as Illinois seeks new bidders. Releasing more people under the Coleman Act could bring down the long-term cost of prison health care, said Alan Mills, executive director of the Uptown People's Law Center, a legal clinic in Chicago whose lawsuits against the state led to the appointment of the independent monitor.

"The more prisoners there are who are medically needy, the higher the cost of caring for them, and the higher the bids will be," Mills said.


Conversely, if the Prisoner Review Board approved more medical releases, the cost savings for taxpayers in the long term could be in the millions, Mills said.

Daniel Conn, chief executive of Wexford Health Sources, did not respond to an interview request. LaToya Hughes, acting director of the Illinois Department of Corrections, declined to comment.

There are other, more immediate savings for Illinois taxpayers if more ailing prisoners were released, Mills said.

A recent government report showed Illinois spends more than \$76,000 on average to incarcerate a single person for a year. Experts say terminally ill and incapacitated prisoners are much more expensive to care for. Prisoners whose medical needs can't be met in prison infirmaries are escorted to and from hospitals by guards. With prisons short-staffed, officers already routinely require overtime pay.

By refusing to release more ailing prisoners, the Prisoner Review Board is also making

it harder for prison medical staff to care for everyone else, Mills said.

"What limited resources we have are being devoted to people who are most seriously mentally or physically ill, and that doesn't leave any health care for anybody else at all," he said.

At the same time, the overburdened health care system is also blocking more prisoners from getting out under the Coleman Act.

Prisoners must be found qualified for

medical release by a prison doctor or nurse before the board votes on their case. But prisoners often wait weeks or months to know whether they'll qualify, records show. In one case, a prisoner at Illinois River Correctional Center waited 152 days before finding out he didn't qualify for release, records show.

Prison medical staff have said 240 prisoners who applied were unqualified for medical release. At least a handful of those prisoners lived in a prison infirmary, used wheelchairs, or had terminal diseases like end-stage liver disease; and at least three died in prison, records show.

There are other frail and disabled prisoners who don't see a doctor on a regular basis, "so there's no way for the doctors to know about their condition," Soble said.

Michael Merritt knows the limitations of the prison health care system all too well. His brother, Phillip Merritt, hasn't received proper medical treatment in prison for years, he said, and he's afraid of what could happen as his brother's dementia worsens.

He wishes the state would let his brother die at home, where his family can take turns caring for him, instead of a prison cell, where he's unsure whether there's anyone to properly look after him.

"I don't know what the problem is," Merritt said. "They know they can't take care of him in there the way he is supposed to be taken care of."

#### Medical release decisions dictated by politics

The Prisoner Review Board never told Merritt

why they denied his brother's medical release request. Their deliberations happen behind closed doors, and the law doesn't require them to provide an explanation.

Board chair Shelton said members weigh many factors when voting on medical release requests, but they primarily focus on an applicant's prior convictions, where they plan to live once they're released, and testimonies from the victims of their crimes.

An analysis of the board's decisions shows there's likely another factor at play: politics.

Under state law, the board is required to be roughly evenly split between Democrats and Republicans. The 12 current members include former law enforcement officials, educators, attorneys and counselors. Pritzker appoints all board members, who are then confirmed by the state Senate.

Medical release requests are decided by panels of three board members; at least two must agree to either approve or deny a request. Shelton said board members are "chosen randomly" for the panels.

But so far, Republicans have cast more votes in medical release cases than Democrats – and they are much more likely to vote to deny those requests, an analysis of voting data shows.

Three out of the four board members with the highest denial rates – Jared Bohland, Kenneth Tupy, and LeAnn Miller – are Republicans. Each of them voted to deny release in more than 70% of the cases they heard, and each voted on more than a third of all medical release requests, voting data shows.

Bohland and Tupy, along with Democrat

Matthew Coates, were on the panel that denied Phillip Merritt's medical release request in July. They voted to deny six out of seven requests that day, records show.

A month earlier, Bohland was part of another panel, this time with two other Democrats, when they heard the case of 82-year-old Saul Colbert.

Like Merritt, Colbert developed dementia while serving time for armed robbery. They both also had previous violent convictions, records show; Merritt had a conviction for attempted murder, while Colbert was convicted of murder.

Both had family ready to take them in, and both were represented by the same attorney with the Illinois Prison Project. But the board voted 2-1 to release Colbert, with Bohland voting against.

"The only difference between those cases was the panel," Soble said.

Through a spokesperson, Bohland, Tupy and Miller declined to answer questions about their voting records.

Lisa Daniels, a former board member and a restorative justice practitioner, said she believes some of her former colleagues are ideologically against letting anyone out of prison early.

They "simply believe that a person should complete the entirety of their sentence, no matter the circumstances they present in their petition, no matter how that person may have shown themselves to be redeemed, and no matter (if they're) no longer a threat to public safety," Daniels said.

Daniels resigned from the board in January, one of six Democrats to step down or fail to be appointed since 2021. In the past few years, the state GOP has turned the board into a new front in the ongoing debate over criminal justice reform.

Democrats, who have a supermajority in the state Senate, have failed to muster enough support among their ranks to get Pritzker's appointments through, leaving the board with three vacant seats.

In a statement, Pritzker acknowledged his administration has had a hard time recruiting potential board members because of the frayed political atmosphere around its work.

"In today's political climate where supporting commonsense criminal justice reform has become a lightning rod, the Coleman Act's initial success should be seen as major progress in the right direction," he said. See sidebar for more Pritzker reaction.

#### Coleman Act has 'failed to live up to its promise'

The day Pritzker signed the Coleman Act, its main sponsor, state Rep. Will Guzzardi, D-Chicago, said in a press release the law would transform Illinois' prison system and allow families to properly say goodbye to their loved ones.

"I'm sorry we couldn't afford this mercy to

Joe Coleman, but I'm proud that we'll be able to do so for hundreds of other Illinoisans," Guzzardi said.

Criminal justice reformers celebrated the Coleman Act as a model for other states to follow. In a report last year, FAMM, a prominent national advocacy group, said the Coleman Act was one of the strongest "compassionate release" laws in the country.

But so far, the act has "failed to live up to its promise," said Mary Price, FAMM's general counsel and the report's author.

Advocates want lawmakers to institute several changes to the Coleman Act to encourage the Prisoner Review Board to release more people.

Lawmakers should require board members to visit prison infirmaries to see firsthand the state of prison health care, advocates said. The board should also receive more training on how to evaluate the medical conditions of prisoners applying for release.

Advocates also want the state to provide prisoners who are applying for medical release with an attorney to argue their case. Guzzardi said he'll advocate for funding for that in the upcoming fall legislative session.

Lawmakers should also allow prisoners to reapply for medical release sooner than currently allowed, said William Nissen, an attorney who represents prisoners pro bono, including on medical release requests.

Prisoners denied medical release currently have to wait six months before they can reapply, unless they get a special exemption from the board. Shelton has only approved three out of 10 requests so far, according to figures provided by the board's chief legal counsel.

"If you're representing a terminally ill person, then a large part of their remaining life is gone before you can even apply again," Nissen said.

Nissen said lawmakers should also require the board to explain why they denied a medical release to "instill a certain amount of discipline in the decision-making process." If board members have to articulate their reason for denying someone release, maybe they'll reconsider the decision, he said.

Phillip Merritt's attorney is in the process of refiling his medical release request. His brother Michael doesn't know whether he'll get out this time. And he hasn't been able to reach Phillip in three weeks – the cellmate who had helped facilitate the calls was apparently transferred.

But he's certain he and his family can give Phillip a more humane send-off than any prison could.

"At least he could go peacefully," he said.  $\square$

# Pritzker defends denials of medical release requests

Illinois Gov. JB Pritzker defended the number of dying and disabled prisoners released under a landmark law that went into effect early last year at a news conference Aug. 31.

"The Coleman Act is, in fact, being carried out as it should be," Pritzker told reporters in response to an Injustice Watch and WBEZ investigation, which found only 52 prisoners had been granted release under the law – far below the hundreds of terminally ill and incapacitated prisoners advocates say could have been released by now.

The Prisoner Review Board – a state body whose members are appointed by Pritzker – denied nearly two-thirds of requests from ailing prisoners made under the law, known as the Joe Coleman Medical Release Act, as of mid-August.

Pritzker acknowledged some medical release applicants "really can't function" and are unlikely to commit another crime if released. But "just because the person is ill, doesn't mean that there aren't factors that are being considered and need to be considered about a case and whether somebody should be released or not," he said.

"I've encouraged the Prisoner Review Board to do the right thing, to encourage release wherever it's appropriate," Pritzker said. "But we're not just going to push everybody out the door just because there's somebody who complains that we haven't done it the way they would like it done."


But that outlook undermines the intent behind the Coleman Act, said Jennifer Soble, the act's main author and executive director of the Illinois Prison Project, a nonprofit legal group in Chicago that's represented dozens of medical release applicants.

"The eligibility conditions are extremely strict and narrowly tailored to apply to only the sickest and most expensive people in the prison health care system," she said. "With that in mind, almost every eligible person should be released if we are to realize the Coleman Act's purpose."

But Pritzker expressed confidence that board members "are people who care deeply about criminal justice reform (and) who care deeply about making sure that we're being fair to prisoners – and to the community in which we're releasing people."


In a statement sent in response to follow-up questions, Pritzker's spokesperson said the governor was expressing "frustration with the characterization that progress in the right direction isn't enough." But she also said "there are undoubtedly improvements that should be discussed among stakeholders and the General Assembly as the law continues to be implemented." □

### **Echoes of Yesteryear at Oak Ridge Cemetery**

Actors at graveside portray prominent citizens Oct. 1

The annual Echoes of Yesteryear Oak Ridge Cemetery walk, sponsored by the Sangamon County Historical Society, has become a popular Sunday event every October. This year the date is Oct. 1. Actors in period costume will portray seven prominent citizens from Springfield who are buried at the beautiful cemetery.

Park near the bell tower. Board a bus to the first site. Walk to each subsequent gravesite (total of ½ mile) and return by bus to the parking area.

Enjoy the stories of interesting and influential men and women who stand out for their contributions to Springfield and Sangamon County.

Edgar Shanklin (1877-1926) was cofounder of Shanklin Manufacturing. The company produced the Dropper carbide lamp which was invented by Springfield miner Frank Guy and used in coal mines from about 1913 until the 1930s. Shanklin Manufacturing factory became Park Sherman, maker of cigarette lighters, smoking accessories and other novelty items. Portrayed by Andy VanDeVoort.

Erma Garrison Templeman (1878-1974) was the first woman to practice law in Sangamon County. She and her husband, J.W. Templeman, took the bar exam on the same day. As Erma took the exam, her son sat on the floor next to her, and she held her infant in her lap. The couple opened their first law office together. She founded the Springfield Business and Professional Women's Club. Portrayed by Erica Smith.

Edna Dye Weaver (1877-1934) was the first woman to own an auto dealership in Springfield, Capital Motors, which was located at Seventh and Monroe streets in the 1930s. In fact, it is believed she was the only women in the United States to own a car dealership then. She was the wife of Ira Weaver, one of the brothers behind Weaver Manufacturing. Portrayed by Tracy Petro.

Nora Deuel (1890-1984) will share the story of her husband, Thorne, a former anthropologist and military aviator, who was appointed director of the Illinois State Museum by Governor Henry Horner in 1938. He served until 1963. He oversaw unprecedented expansion of the museum, along with its move into the present building. Portrayed by Mary Disseler.

Herbert Georg (1893-1964) was one of a family of local photographers who made their names elsewhere. Herbert worked as a photographer in Springfield for 50 years and helped develop a 35-millimeter sound system

for films. He was the official still photographer for Cecil B. DeMille's *The Greatest Show on Earth*. Portrayed by Pat Foster.

Vera Shoultz will talk about herself and her husband, Rev. Rudolph Shoultz (1918-2000). He was the pastor of Union Baptist Church for more than 30 years and was an influential leader in the Springfield African American community. He believed in helping his parishioners find jobs and gain better conditions and so lobbied with legislators and others to help his church expand its services. Portrayed by Willa Barger.

**Dr. Don Deal** (1879-1952) was a physician who performed the first blood transfusion in Sangamon County in the 1920s. He performed the transfusion at St. John's Hospital for a woman whose husband was the blood donor. Deal predicted that Springfield would become a strong medical center. Portrayed by Dave VanDeVoort.

#### **Details about the walk**

Oct. 1 Noon-4 p.m. (the last tour will be at 3:15). The event is free to the public, although donations are suggested. Parking will be available in designated areas of the cemetery. Refreshments will be available for purchase by the Sangamon County Historical Society.

Each year the Sangamon County Historical Society chooses people to be portrayed, making sure the time to walk to each site is easy and yet far enough apart so that actors and actresses are easily heard. Research is conducted to ensure accuracy of facts and information about each person.

Immediately after the day of the walk, the society begins plans for the next year, looking at an area of the cemetery that is walkable, easy to get to, and has several important people to portray. The popular cemetery walk was held annually for 12 years, beginning in 1996 and ending in 2008. It was brought back eight years ago by popular demand.

Established in 1961, the Sangamon County Historical Society is dedicated to preserving and promoting the history of the area through educational programs, tours, grants and special projects including providing support to the Sangamon Valley Collection of Springfield's Lincoln Library. Monthly programs feature topics of local historic interest and are open to the public.

## The Niceties, a campus clash of ideas onstage

Intimate drama in the UIS Studio Theatre black box

"It takes *work* to not be a bad person...you can't just be the least bad person in a lineup and call yourself good." That line, according to one of the actors, stands as a powerful summation of the struggle faced in a provocative new play currently running at the UIS Studio Theatre.

The two-act, two-character play involves a meeting in the office of "Janine Bosko" a tenured professor of American history at a prestigious university who is an accomplished author and expert on revolutions around the globe and throughout history. Her ambitious student, "Zoe Reed," has come to Janine's office for an early critique of her latest term paper. Zoe believes "a successful American Revolution was only possible because of the existence of slavery" and her paper presents this theory. The meeting with the unfiltered professor and her radical student features deft writing and sharp witty words that escalate into intense exchanges and a clash of ideas about race, privilege and social justice.

The play features Regina Ivy as "Zoe" and Meredith Vogel-Thomas as "Janine" and is co-directed and stage-managed by V. June Chappelle, produced and co-directed by Carly Shank. Scenic and lighting design by Sarah Brewer. I was able to sit down with the cast and co-directors before a rehearsal last week for a discussion about the play, its themes and why it's important people come to see it.

Q: What attracted you to the play/part?

Meredith: "I like to see more authentic representations onstage, characters from minority backgrounds telling underrepresented stories, where the plot doesn't hinge just on who the people are. I love that Janine is a whole person: messy and complicated. It takes guts to be that messy in front of a room of strangers and I've

always gravitated toward those kinds of characters.

Q: Why/when did you become interested in the play?

Regina (a current undergrad at UIS): "Carly gave it to me and I read it in one sitting. Zoe is very different than me. She's a little mean, but the more I read it, and the more I perform it, the more I came to understand and empathize with her."

Q: What questions do you think the story raises?

Meredith: "How it's a ruse and a trap in higher education to think that it's not a place for (learning) practical skills. It's easy to lie to yourself in the pursuit of excellence in higher ed because there's a myth of pushing narratives forward and not learning more about diverse people and things."

Q: What drew you to the project?

**June (co-director):** "I come from a place of understanding, as I have encountered many 'Janines' in my life. I understand Zoe a lot in how I was raised, what I encountered at school and at home. I can relate to her passion, what drives her and what she stands for."

Q: What have you gained or what has surprised going through this process?

**Regina:** "I find myself examining theories more and trying to understand what Zoe is saying. It's allowed me to look inward, as well as at parts of society. It's made me excited to do things that will help shape a better society and make it the way I want to see it."

**Meredith:** "It's so refreshing to play this character and be able to walk away each night

and know I'm not her. It pushes me to be uncomfortable, to get out of sometimes being a 'lazy white lady,' to be a better person. It's a great leaping off point to understanding privilege."

Q: Why this play, now?

Carly (co-director and producer): "The subject matter seems the right fit in the university setting, especially as so many have established DEI programs, and it's a good time to have this kind of discussion." There's the hope too of establishing the black-box-style Studio Theatre as one of *the* places to go for these kinds of intimate works. "Everyone I handed the play off to read it in a single sitting. I'm really excited to present it and talk about it at UIS. I've been pounding the pavement (here) because I think it is going to cause a lot of great discussion and I don't want people to end up saying, 'Oh, I wish I would have known about that."

The Niceties continues Thursday through Saturday, Sept. 28-30, at the UIS Studio Theatre; limited seating available. Tickets are \$20; UIS faculty/students/staff − \$15 with ID and can be purchased here: The Niceties By Eleanor Burgess − UIS Performing Arts Center. Curtain is at 7:30. This event is presented in partnership with the UIS Diversity Center and will include talk-backs at the end of each performance. □

# Cheeseburger in paradise

Heaven on earth with an onion slice

Cold weather is just around the corner, and I'll miss being able to cook outside. My favorite way to cook most foods is open-air grilling over wood or charcoal. Elizabeth Karmel agrees: "Grilling is the best way to cook, bar none. There is no other cooking technique that gives you this much flavor for your effort." Karmel is a nationally respected authority on grilling, barbecue and Southern food and the author of *Taming the Flame*. I don't presume to match her experience and expertise, but when it comes to burgers, I beg to differ. The best burger is a burger cooked on a cast iron pan or griddle, smashed thin and cooked crisp on its edges.

It's often said that "fat is flavor" and when you cook a burger on a grill grate, the fat that drips down onto the coals is lost flavor. Cooking in a cast-iron skillet traps the fat and prevents it from falling into the heat source. When you smash ground beef onto a hot cast-iron surface with a heavy object, it gives the beef greater contact with the heat source and creates a crispy crust with intensified flavor. This savory crust is a result of the *Maillard reaction* (pronounced my-YAR), a chemical reaction between amino acids and sugars, which creates compounds that give browned foods their distinctive flavor.

I converted to cooking burgers in a castiron skillet during my year working for Sean Brock. Brock is arguably the South's most prominent chef. He's won the James Beard Award for Best Chef, Southeast, and authored two best-selling cookbooks. He's been featured in the Emmy Award-winning television show *Mind of a Chef* and the popular Netflix show, *Chef's Table*. Brock operates three high-end fine-dining restaurants in Nashville. But when asked about his favorite thing to eat, he'll reply: "If I had to pick one thing that made me the happiest when I ate it, it would certainly be a cheeseburger.

"Everyone has their own idea of the perfect burger; mine was inspired by the drive-in that my family used to take me to when I was young. Robo's was the only real "restaurant" in my hometown, and my family just loved it. We would go there after my Little League baseball games. As the game wound down, I would be daydreaming about that burger, shake and crinkle-cut fries. It's probably the reason for some missed fly balls."

When Brock tastes something he likes, he laughs with joy. His lifelong obsession and passion for cheeseburgers led to his

opening Joyland, a fast-casual addition to his restaurant roster. Brock's goal with Joyland is to make other people laugh with joy when they take their first bite.

The signature item on Joyland's menu is the Crustburger, which he describes as "crispy crust, onions and Kraft American cheese, on flattened, buttered and inverted Martin's Potato Roll" with "fancy sauce on the side for dipping."

A Crustburger is basically a Smashburger set between two buns that have also been smashed paper-thin and griddled until crispy. The idea behind the Crustburger is that the entire burger is made up of crunchy bits of meat that are normally only found around the edges of a burger. Joyland's Crustburger is made from a custom-blended, dry-aged beef blend from Bear Creek Farm, a sustainable cattle and heritage hog farm. Brock is dogmatic about the choice of cheese. "I choose American cheese because it isn't really a cheese — it's more of a sauce when it melts, so you end up with a burger covered in

delicious cheese sauce." The buttered potato bun is griddled under a burger press on both sides and the cheeseburger is assembled with the cut side of the bun facing outward to create a crusty exterior, much like a good grilled cheese sandwich.

Last fall Nashville was featured in an episode of the Netflix travel documentary, *Somebody Feed Phil*, and Joyland was one of the eateries visited by Phil Rosenthal and his guest, country singer Brad Paisley. Paisley threw both hands in the air in approval after taking a bite of the Crustburger and exclaimed: "Oh my gosh! So inappropriate, the thoughts I'm having as I eat this... I'm not hearing anything you're saying right now!"

After the episode aired, Joyland became swamped and I was asked to work a few shifts there on my days off from my job in Brock's Fermentation Lab. I hadn't worked in a fast food restaurant since college and the experience was totally exhausting. But I learned the secrets of making a proper Crustburger.

#### **Joyland's Crustburger**

Serves 4

Equipment needed: Cast-iron skillet or griddle Thick metal spatula

Ingredients:

For the burger:

½ pound ground beef, preferably 70/30 grind 1 red onion, sliced into rings 1/8-inch thick.

4 slices Kraft American cheese

4 hamburger buns - preferably a potato bun

4 tablespoons butter

Salt and pepper, as needed

For the "fancy" sauce: 1 cup mayonnaise ½ cup ketchup 1 tablespoon hot sauce 1 teaspoon fish sauce Salt, as needed

Preparation:

Preheat a large cast-iron skillet in a 400°F oven.

Make the "fancy" sauce: Whisk all the sauce ingredients together and season to taste.

Gently measure out 4-ounce portions of the ground beef with an ice cream scoop or spoon, and form in loose balls about 2 inches high. Try not to handle too much.

Generously butter the tops and bottoms of the buns. Transfer the skillet to the stovetop with the burner set to medium-high. Place the buns in the skillet and flatten with a heavy spatula. Toast for about 30 seconds and flip. Press again and toast for another 15 seconds. Set the buns aside.

Increase the heat to high. Position the balls of beef in the skillet, leaving plenty of room between. Using the heavy spatula, press the meat very thin, moving the spatula in a circular motion while pressing to smear the meat even further, then season with salt and pepper.

Place a few rings of red onion on each patty and top with a piece of American cheese. Cook until the edges of the burgers have achieved a deep, burnished crust and the cheese is melty. This should take less than 2 minutes. Using the spatula, scrape the burger off the griddle. Place between the two flattened buns with the inside of the buns facing out and return the whole Crustburger to the skillet, toasting one more time, roughly 30 seconds per side.

Serve with fancy sauce on the side for dipping. □
