# Sangamon County could see first wind farm soon

German company seeks approval for first phase of three-county project

A German renewable energy company plans to file applications with Sangamon and Macoupin county officials early in 2024 for approval to construct the first phase of a multi-county, \$450 million wind farm development known as Grand Prairie Energy Park.

UKA Group's North American Affiliate, based in Stuart, Florida, would build about 60 wind turbines in Montgomery County and Sangamon County over the next several years. Transmission lines would run through Macoupin County.

The total project would eventually create 350 megawatts of electricity. That amount is equivalent to about half of Springfield's power needs, though the electricity would be sold on the local power grid, according to UKA North America Project Developer Adam Wilson.

Many rental agreements with landowners on which the wind turbines would sit already have been secured, and the company is working on the rest of the required rental pacts, Wilson told *Illinois Times*.

A state law that took effect in January 2023, largely removing the ability of local governments to block or severely restrict the development of wind and solar projects that meet state guidelines, will make it easier for UKA to operate in Illinois, Wilson said.

Grand Prairie would bring Sangamon County its first wind farms.

Wilson said UKA, which has operated overseas for 22 years and began operations in the United States six years ago, is committed to working with individual communities to boost economic development while helping Illinois reach its long-term goals for reducing climate change-causing fossil fuel emissions.

"We're not just coming in here to build something and then walk away from it," Wilson said. "We intend to be good neighbors. So it's important for us to let everybody know that we intend on being part of this community going forward."

UKA set up an office in the Montgomery County village of Farmersville in mid-2022 and already has taken part in community events in Raymond and Farmersville.

No significant or organized opposition has emerged at this early stage, but UKA officials said there's always the chance members of the public may raise concerns about potential disruption of the rural landscape, and possible humming and sunlight flickering that can be caused by the windmill blades.

Company officials said the distance the turbines would be placed from people and structures outside the project area would alleviate those concerns.

UKA says the project will be safe, quiet and won't pose significant harm to wildlife.

"Honestly, we're talking about such large tracts of land and such significant setbacks," Wilson said. "You really don't know the effect of a wind turbine in terms of sound unless you're standing under or close by one. The decibel level is not that big, primarily because they're so high up."

Wilson added: "The biggest complaint is the visuals. Some people think a wind turbine looks majestic. Others think they look awful."

The largest phase of the project – 17 to 23 wind turbines, mostly in Montgomery County and some in Sangamon County – would create 67 construction jobs that would last 12 to 18 months, and nine permanent jobs once the project is operating, Wilson

Annual lease payments to local landowners in this phase would likely be

more than \$1 million.

"This translates to reinvestments in local farms, spending more money on local businesses, continuing family legacies and more," a UKA fact sheet on the project said.

The first phase would likely generate more than \$1.05 million in total annual property taxes for Montgomery and Sangamon counties every year for more than 30 years – the expected life of the wind turbines, according to UKA.

"This means significant funds for schools, health care, tax relief – or freezes – infrastructure and more," the fact sheet said.

The wind turbines would be in unincorporated rural areas, and not in incorporated cities and villages.

The first phase of the development would cover the Virden area in Montgomery and Macoupin counties. That phase, involving the construction of 14 to 17 wind turbines and possibly some solar-power panels, would produce 100 megawatts and be connected to an electrical substation in that area. UKA hopes to complete this project in 2026.

The second and largest phase, involving wind turbines in Montgomery and Sangamon counties and transmission lines in Macoupin County, could be completed in 2027, UKA officials said. The turbines would connect to major power lines at City Water, Light and Power's Westchester substation on Springfield's west side.

The third phase, in the Pawnee area in Sangamon and Montgomery counties, would produce 100 megawatts with 14 to 17 wind turbines and possible solar arrays. That site would connect to a substation in the area and possibly be completed in 2027.

Some turbines from all three phases would be visible from the east and west to drivers along Interstate 55, UKA officials said.

Using the newest technology and construction innovation, the wind turbines in the project would be larger than most in central Illinois and the rest of the state, UKA officials said.

Each turbine would generate more power, as well, while taking up about the same amount of farmland – about one acre apiece, once completed, officials said.

Most wind turbines operating in Illinois generate two to three megawatts, while UKA's wind turbines each would generate between 6.5 and 7 megawatts, Wilson said.

UKA's wind turbines would be 377 feet tall at the "hub," or the center portion of the structure where the blades are attached. That's more than 40% taller than most earlier-generation wind turbines and taller than the Statue of Liberty.

The UKA wind turbines would extend 656 feet tall at the tip of the top blade, or about 55 stories high.

Rural Farmersville resident Tom Murphy, 72, a retired farmer whose brother farms the 320 acres Murphy owns in Montgomery County, said he would receive more than \$100,000 in annual rental income per year for the two UKA wind turbines the company plans to build on his land.

Murphy said he supports the project, noting that he generates about \$90,000 a year in rental income for all of his farm ground now.

Montgomery County chairperson Doug Donaldson, a Republican from rural Hillsboro, said he is "not a fan" of wind farms and didn't appreciate state lawmakers taking away most local control from county governments on wind and solar power developments.

He said Montgomery County officials have received numerous inquiries from alternative energy developers since the state law was passed, mostly along partisan lines, by the Democratic-controlled General Assembly.

Rural Chestnut resident Bobby Jackson, 56, who opposed a Top Hat wind farm that received Logan County Board approval in 2022, said state officials were "willing to ignore safety concerns" to further a cleanenergy agenda.

There is "room for questions" about the potential drawbacks of wind turbines, said Jackson, a computer software architect. "They're not as appealing as what it appears on the surface."

Some people in Montgomery County don't want wind turbines coming to the area, and some farmers don't welcome the prospect of having to farm around the structures, Murphy said.

"It seems to me the majority of people are for it," he said. "I see it overall as a good thing, not only for me, but for the community and the county tax-wise."

# Federal trial for Sam McCann postponed again

Decides to represent himself, pleads not guilty to charges of illegal campaign spending

Former Conservative Party gubernatorial candidate Sam McCann fired his latest court-appointed lawyer and decided moments before opening arguments in his federal trial Nov. 27 to represent himself against charges of illegal campaign fund spending that could land him in prison for 20 years or more.

McCann, 54, told reporters after his decision that he doesn't fear federal prosecutors armed with 70,000 pages of documents bolstering their case. A potential prison term doesn't bother him either, he said.

"I'm not nervous at all ... because I know God's got this," he said. "Whatever happens, God's got it."

By the end of the hearing in Springfield's U.S. District Court, East Peoria lawyer Charles Schierer had been dismissed, and a clearly annoyed Judge Colleen Lawless rescheduled McCann's bench trial in the almost three-year-old case for Feb. 5-9.

"This is a request that is absolutely untimely," Lawless said. "There will not be another continuance of this."

McCann, a former Republican state senator from the unincorporated community of Plainview in Macoupin County who lacks a college degree and has never studied the law, told Lawless he was unfamiliar with the federal court system's rules of evidence and rules of criminal procedure.

Lawless told McCann it would be "unwise" for him to act as his own attorney, even if she is able to grant his request for an experienced lawyer to act as a court-paid "standby counsel."

But McCann – who has pleaded not guilty to the seven counts of wire fraud, one count of money laundering and one count of tax evasion handed down by a federal grand jury in February 2021 – said he wanted to proceed and doesn't want to plead guilty, as some of his previous attorneys have advised.

"This is a very much politically motivated case," said McCann, who represented parts of Springfield and Sangamon County while representing the 49th Illinois Senate District from 2011 to 2013 and the redrawn 50th District from 2013 to January 2019. He was succeeded in the General Assembly by Sen. Steve McClure, R-Springfield.

Ostracized by Republican politicians and running under the Conservative Party banner, McCann lost his bid for governor in 2018, receiving about 192,500 votes, or 4.2% of the total. That was the year Democrat JB Pritzker received 2.47 million votes to win his first term as governor over incumbent Republican Gov. Bruce Rauner, who received 1.7 million votes.

The charges against McCann, who formerly operated a construction company, allege he engaged

in a scheme from May 2015 to June 2020 to illegally pay himself and make personal purchases totaling more than \$200,000 from contributions to his campaign committees.

McCann allegedly used more than \$60,000 in campaign funds to partially fund the purchase of a 2017 Ford Expedition in April 2017 and a 2018 Ford F-250 truck in July 2018 that he used for personal travel.

The charges also say McCann, who previously lived with his family in Carlinville, used campaign funds for loan payments on the truck, for fuel and insurance for both vehicles, two separate personal mortgage loans, a personal loan, about \$187,000 in direct payments to himself, \$52,300 in payments for payroll taxes, credit card payments for a family vacation in Colorado and other personal expense.

In April 2018, McCann allegedly used \$18,000 in campaign funds to buy a 2018 recreational travel trailer, and later that year used \$25,000 in campaign funds to buy a 2006 recreational motor home, both of which he titled in his name.

He allegedly established a recreational rental business in the state of Ohio, then portrayed himself as a renter and used campaign funds to pay rent to himself for the travel trailer and motor home in 2018.

McCann hasn't provided any explanation for the spending irregularities other than professing his innocence. He waived his right to a jury trial, opting instead to allow Lawless to issue a verdict.

Assistant U.S. Attorney Timothy Bass opposed

another delay in the case, noting Nov. 27 that witnesses for his case against McCann had already, or were planning to, travel from out of town to arrive in Springfield in the coming days to testify.

But McCann indicated to the court that he needed time to contact as many as 50 witnesses, some of whom he hasn't talked with in years, to prepare for his defense.

"I deserve that as an American citizen, and I need time to find them," he said.

McCann said he feels badly about inconveniencing the government's witnesses. But he said "my life and my family's life" are at stake.

Statements in court and court records indicated McCann filed his request for a new courtappointed attorney on Nov. 24, citing "inadequate representation." That was the day before he had a phone conference with Schierer in preparation for the trial

McCann apparently didn't mention his desire for a new lawyer to Schierer until Nov. 27. Schierer has represented McCann since February.

McCann said he didn't give Schierer all of the names of witnesses who could testify in his defense because McCann lacked faith in Schierer.

At one point this year, Schierer "looked at me and said, 'You're going to prison anyway,'" McCann told the judge.

Schierer told Lawless he never made the comments.

Schierer wouldn't comment outside the courtroom about McCann's statement except to

say, "I wish him all the best."

Schierer told the judge that the potential witnesses whose names McCann did give to Schierer and co-counsel Michael Sweis wouldn't be appropriate to use in McCann's defense. Their testimony could be used after a conviction to argue for a light sentence, Schierer said.

Bass said McCann was represented by four different federal public defenders before Schierer was appointed. But McCann said outside the courtroom that it wasn't his fault those lawyers either withdrew from the case or failed to put in the work to properly defend him.

McCann, who has three children and a grandchild, said he is being supported financially by his wife, Vicki McCann, a registered nurse. He said he can't afford to hire a private attorney.

"It's obvious that no one is going to take this seriously, certainly as seriously as I do," he said. "I guess you get what you pay for."

McCann wouldn't say whether he has leftover campaign funds that he could use for legal expenses – something Illinois law allows.

"I'm not going to talk about this active case," McCann said. "I'm not a trained attorney. I don't pretend to be. I don't want to get on the bad side of the Department of Justice any more than I already am, and I don't want to get on the bad side of this judge."

The last report filed with the Illinois State Board of Elections by McCann's "McCann for Illinois" campaign committee listed \$31,566.85 in remaining funds as of Jan. 15, 2021.

Because the committee hadn't filed any reports with the board for 12 months, the board terminated the committee and fined the committee \$9,250 for failure to file required reports on time.

If there's any money left in the committee's account, McCann could legally spend it only if he paid the fine and filed all required reports since January 2021, Illinois State Board of Elections spokesperson Matt Dietrich said.

McCann acknowledged to *Illinois Times* that the latest development in his court case is another chapter in his unconventional political career.

"God bless America," he said. "I don't fear those who can kill the flesh. I'm only worried about the one who can, and I know I'm right with Him.

"I'm not worried about these people because they cannot kill my soul. I look forward to presenting a case, and we'll let the judge sort it out."  $\Box$

# Liquor license dilemma

State commission overturns Rochester village president's denial of liquor license

The Illinois Liquor Control Commission is overruling the decision of Rochester's village president to deny a liquor license to a business owner who had recently evicted his son.

Village President Joe Suerdieck said Nov. 27 he hasn't decided yet whether to appeal the commission's ruling. He declined to speak further on the matter.

"I don't think it's any secret; it looks like he's getting even for how they treated his son," Village Trustee Chadd Carver said. "We want this just to go away. He has given a black eye to the village of Rochester. This has already cost Rochester too much. We are out six months of gaming and other tax revenue."

At issue is the future of the building at 320 E. Main St. in Rochester that once housed The Alibi, a bar and restaurant. The building's most recent tenant was Ben Suerdieck, who was evicted June 13 by a Sangamon County judge for failing to pay \$9,075 in rent.

The week after Ben Suerdieck was evicted, his former landlord, who sought to reopen a business in the building, had his application for a liquor license rejected. The decision was made by Village President Joe Suerdieck, who is also the municipality's liquor commissioner and the father of Ben.

Mark Clemens, a partner in Superior 3 Treasures LLC, which owns the building, told *Illinois Times* he plans to open a new bar and restaurant at the location and call it the Filling Station.

"This used to be a gas station years ago. I kind of told a few of the old-timers in the community, who have been here a long time, and they thought it was a great idea," Clemens said. "We

have remodeled quite a bit in here, made it look a little nicer, and it's going to be a good spot."

As to whether the village president appeals the commission's ruling, he added, "Nothing

surprises me anymore about this process. Whatever he does, he does. We have the truth on our side. So, if he appeals, then we'll fight him in that angle. And if he decides that he was wrong

and moves forward, then great. Either way, we're prepared."

In the wake of this controversy, the village board is forming a committee to make recommendations on revamping the village's liquor ordinances and reevaluate the authority given to the village president, Village Trustee Harry Hendrickson said.

Carver noted that the bar would have been an ideal place for folks to gather and watch Rochester High School win the recent state 4A football championship. But the village president's action prevented that from happening.


"People in the community are upset about this," he said. "People are so upset that they are going to be lining up to put \$100 bills down on the bar. They want to make up for how this guy has been treated."

Just when – or if – the bar will reopen remains to be seen.

Illinois Liquor Control Commission spokeswoman Nicole Sanders told *Illinois Times* that the commission reversed the decision Nov. 15 and will draft an order to that effect. But that does not necessarily mean the issue has been settled.

She said the Village of Rochester has 20 days to file a petition for a rehearing which, if filed, would be reviewed and decided by the commission at its next meeting, likely in January. If the commission denies the petition, the village may still ask for the matter to be reviewed in circuit court.



In late December 2022, a teenage boy with a broken arm was left to suffer alone in his cell at a youth lockup in rural southern Illinois. Staff were aware he'd been seriously injured; he told them he was in pain and asked to see a doctor. Two hours passed before staff took him to the hospital, during which they cooked and served dinner and took a group of kids for recreation, he claimed.

Almost everything had gone wrong that day, at a place where things went wrong a lot. Four months earlier, a state audit had called the Franklin County Juvenile Detention Center in rural Benton a "facility in crisis" because it was routinely keeping kids locked up for upwards of 24 hours at a time, a "significant violation" of state standards. It had failed to offer them much in the way of mental health or educational services, the audit said. An overwhelmed and undertrained staff routinely called on the sheriff's department to help keep the youth in line, even for seemingly minor behavioral disruptions, according to additional law enforcement records obtained by Capitol News Illinois.

All of that was evident on this particular day,

when the residents were told they'd get a rare treat, an hour or so inside the facility's gymnasium.

But once in the gym, the boy got into a shouting match with another youth, and staff ordered him back to his room. Devastated to lose his rare gym time, he refused to go. Deputies from the sheriff's office across the street rushed in – several men who were much bigger than the teen, according to sworn statements that several youth provided for a federal lawsuit the American Civil Liberties Union of Illinois filed against the detention center this summer.

The lawsuit alleges widespread failures, namely that the detention center had violated youths' constitutional rights by subjecting them to excessive forms of restraint and seclusion while denying them adequate education and mental health services. The children who are confined there are "uniquely vulnerable, many having already suffered harrowing abuse and trauma" — and instead of caring for them, the lawsuit claims, the facility subjected them to "inhumane conditions" known to cause lasting harm.

Melissa Morgan, chief judge of the 2nd Judicial

Circuit Court of Illinois, whose office is ultimately charged with running the facility, did not return phone calls seeking comment, though an assistant confirmed she had received the messages. In a court filing earlier this month, Illinois Attorney General Kwame Raoul, who is representing the chief judge and other senior facility staff sued in federal court, denied the allegations of poor care leveled against the facility. The attorney general's office declined further comment. In a separate filing on Nov. 6, Franklin County, which was also named in the lawsuit, denied the allegations as well.

Youth at the facility said in signed statements taken under oath that the deputies took the boy to the ground, breaking his arm in the process, a claim that is backed up by law enforcement records obtained by Capitol News Illinois and ProPublica.

"The officer asked me about my arm, and I said, 'You know it's broken. You heard it snap,'" said the youth who was injured, identified only by his initials, A.B., in his signed statement. A.B. is not a plaintiff in the suit, though his statement was included as evidence of the poor conditions alleged by the ACLU. The ACLU is seeking class-action status for the case, and that request is pending before a federal judge.

A month after the incident, the Illinois Department of Juvenile Justice (IDJJ) returned to the detention center to see whether the "facility in crisis" had corrected any of the deficiencies cited in the August 2022 audit. It had made "some improvements" but "several" deficiencies remained and new ones were identified, the auditor wrote in a report on the visit. He also made note of the broken arm, saying that he could find no proof that anyone at the facility had conducted a review to determine whether staff or the deputies had acted appropriately. Franklin County Sheriff Kyle Bacon, who was among the law enforcement officers who restrained the youth that day, defended his department's actions but said he could not speak to whether the facility had conducted an internal review because the sheriff's office is not involved in its administration. Nearly a year later, a spokesperson for IDJJ said the detention center has yet to provide one.

A new analysis by Capitol News Illinois and ProPublica suggests those failures were not unusual. A review of hundreds of pages of state audits, law enforcement records, a federal lawsuit and reports by oversight and advocacy bodies point to troubling conditions inside many of the state's 16 juvenile detention centers, which operate much like adult jails, detaining court-involved youth with open cases when a judge determines they are at risk of fleeing or reoffending. The facilities combined can house upwards of 1,200 youth as young as age 10, though they are rarely at capacity.

The records show that youth have been Tased, pepper-sprayed and roughed up by staff and law enforcement officers; forced into isolation for days at a time; denied access to their psychotropic medications and mental health treatment; and received little or no schooling, despite state and

federal laws mandating that the youth receive educational services while incarcerated. Nearly twothirds of those who are detained are Black teens.

Poor conditions in juvenile lockups across the country have recently made headlines, bringing renewed calls for reform. What makes Illinois different from many of its state peers is that no independent agency licenses or certifies the youth detention centers. Even in some states that have been heavily scrutinized for problematic conditions inside their youth facilities, such as Louisiana, Tennessee, Michigan and Pennsylvania, a licensing

action plans were developed with them to address deficiencies. Christopher Bonjean, a spokesperson for the Illinois Supreme Court, declined to provide the full reviews or any of the ongoing progress reports for facilities requiring action plans, saying that only its initial summary reports are made public. The judicial branch is not subject to the Illinois Freedom of Information Act.

Juvenile justice experts and advocates for incarcerated youth in Illinois say the weak oversight of these facilities needs the attention of lawmakers and policy experts.

a group of officers rushed in. They were much larger than me and they threw me around in a way that was way too rough. When they were throwing me to the ground they twisted my arm and there was a snap that everybody could hear. They still twisted my broken arm behind my back and it was extremely painful. process is in place that allows for sanctions, up to closure.

Under state law, the Illinois Department of Juvenile Justice sets standards for county detention facilities that hold youth in custody and conducts audits of them. While the department has repeatedly cited several centers for failing to meet its standards, under state law, IDJJ cannot mandate corrective action plans, issue fines or shut down detention centers found in repeated violation of the rules. Instead, the IDJJ reports are sent back to the county detention facilities' staff and to the chief judges of each judicial circuit, under whose authority they operate. Neither the staff nor the judges are obligated to respond.

IDJJ shares oversight of the youth detention centers with the Illinois Supreme Court. The high court's administrative arm implemented its own set of standards for facilities in 2022 and started conducting reviews later that year. In its initial review of the detention centers, the court found that about a third did not meet its standards, and

And it's the latest example the news organizations have revealed about the failures of Illinois officials to put an end to the poor treatment of vulnerable populations held in facilities, even when problems are well documented.

Capitol News Illinois spoke with six experts in the field of juvenile justice and youth development who said facilities that detain children should have robust oversight structures. This spring, Equip for Equality, Illinois' federally designated legal aid organization for people with disabilities, called on policymakers to reform the oversight system "given the longstanding, serious and pervasive problems" inside facilities statewide.

"Would you want nursing homes operated without any oversight? I don't want nursing homes operated without oversight. So to think we don't have any kind of oversight and quality improvement for kids that are in custody in a facility, I don't understand," said Hunter Hurst, director of the National Center for Juvenile Justice, the research arm of the National Council of Juvenile and Family

Court Judges.

IDJJ Director Heidi Mueller said in an interview that she agrees that the agency is limited in what it can do if a county's chief judge can't or won't enforce compliance.

"I think a lot of folks would say that that oversight mechanism isn't what you would call best practice," Mueller said. Only the Illinois General Assembly has the authority to change the oversight structure, she said. Mueller stopped short of making a call for lawmakers to do so, saying that's not her role as an agency leader.

#### Widespread problems

Oversight entities have identified numerous problems in facilities across the state. In a March report, Equip for Equality found widespread problems at Chicago's youth lockup – the state's largest – including that it had utilized "unjust and excessive use of physical restraints and seclusion, often as punishment, with a wanton disregard of state law."

In a letter addressed to Equip for Equality, Leonard Dixon, superintendent of the Chicago facility, rebutted the findings, saying that the youth facility follows state and federal laws, that the advocacy group's claims about unlawful restraints were "unsupported" and that physical restraints are "never used as punishment." Dixon noted to the news organizations in a statement that recent state audits found the facility to be in compliance with restraint standards.

Concerns about excessive use of force extended beyond Chicago. In April, a youth at the Mary Davis Home in Galesburg, in central Illinois, told an IDJJ auditor of a troubling physical restraint from the day before. After watching a video of the incident, the inspector was so alarmed that he reported it to the state's child abuse hotline, although ultimately the Department of Children and Family Services did not designate this as a case of abuse or neglect. No other governmental body is charged with reviewing whether administrative policies were properly followed in specific situations. The IDJJ audit noted that one of the staff members involved had not received the training the facility utilizes to teach staff proper restraint techniques.

Wendi Steck, superintendent of the Mary Davis Home, said the employee involved in the restraint incident no longer works there, but she declined to say whether his departure was related to this incident. "Any incidents of abuse of our clients are not tolerated and are dealt with swiftly," she said. "All staff are trained in Handle with Care restraint and cannot be involved in any restraints until successfully trained."

Perhaps nowhere are concerns as extensive as those documented at the 32-bed youth lockup in Benton, the only one that IDJJ labeled "in crisis." The facility is the state's southernmost detention center and houses youth from across 26 counties – the lower quarter of the state.

Among IDJJ's findings in its August 2022 audit: Youth were confined to their rooms for upwards of 24 hours for behavioral infractions, though state



standards limit the use of seclusion to four hours and allow it only if youths are at risk of harming themselves or others. In fact, because the facility was so short-staffed that IDJJ described the issue as "critical and unsustainable," youth were kept in their rooms for most of their days there, even if they had not acted out. The facility has a gym and outdoor recreation area, but youth had not utilized either area for two years. The facility had no process for assessing youth to determine if they were at risk of sexual assault or of sexually assaulting a peer, a requirement of the federal Prison Rape Elimination Act. Mental health services were "minimal" and "there was an obvious lack of training" among the staff

Staff at the Benton facility told the IDJJ auditor that at one time, it had utilized the Crisis Prevention Institute to train staff on how to try to calm situations before they escalate and how to properly use physical restraints if it can't be avoided. But a supervisor acknowledged to the IDJJ inspector that such training had not been conducted in several years and that some newer employees may have never received it. "This poses a high risk for potential liability for the county," IDJJ wrote in the audit.

Joseph A. Cervantez, the state's attorney in Jackson County, one of the counties from which youth go to the Benton facility, said he was so alarmed when he read the report that he immediately stopped sending youth there. Without better services, he said, "I might as well just keep them out on the street."

When IDJJ followed up in January, it found that many problems had not been corrected in the intervening five months. It also criticized the facility's handling of the broken arm incident. Detention center staff told the auditor that its video system was faulty and didn't record what happened. A senior official told the auditors that an internal review had been conducted but could produce no written record of it. While the standards do not stipulate the use of video cameras inside the facilities, any use of restraint or seclusion requires a full written report.

Bacon, the sheriff, said his office conducted an internal review consisting of a conversation between him and the chief deputy about what had transpired. "I was present and I was familiar with what was happening and the actions that we took, and there were no issues with those actions," he said.

While IDJJ's reports cited extensive problems, claims made by five youth who provided statements for evidence as part of the ACLU's lawsuit, filed in July, suggested even more dire conditions. The youth said they were locked inside "very small concrete boxes" covered in black mold and that they were forced to eat their meals alone in their cells next to their toilets and sleep on wet mattresses because the windows leaked. One youth said he was experiencing a mental health crisis and cut his arm

with a broken colored pencil. "Instead of getting me any mental health treatment, they just gave me a paper towel to clean up the blood," he said.

The presence of law enforcement officers inside the facility is common, several of them said. "The crazy thing is the police don't even just come in for fights or big things, they come in just when a kid doesn't want to move and they do things that the staff should be doing," said another youth.

Law enforcement records obtained by Capitol News Illinois showed that staff called on sheriff's deputies 21 times between September 2021 and August 2023. Some of the calls were for seemingly minor incidents. For instance, on Aug. 1, staff requested backup because a youth had "stuffed snacks down his pants and won't give them back."

In some cases, the arrival of deputies resulted in more aggressive restraint techniques than are typical for – or allowed in – juvenile detention centers. In October 2022, detention center staff called for backup because a different youth had refused to return to his cell. When the deputies tried to force him back to his room, the youth assumed a fighting position, the responding deputy wrote in a report, so the deputy fired his Taser.

Staff in juvenile lockups are not allowed to use stun guns on youth, according to IDJJ.

Bacon said he believes the staff call on the sheriff's deputies because of their ability to utilize tools, such as stun guns, that the facility staff cannot.

He said that he and his staff are trained in de-escalation techniques and use force only when necessary. "There are youth that can cause harm to you," Bacon said. "And we want to use the least amount of force necessary, but at the same time we have to protect ourselves from being injured as well as the youth. That's not our intention to hurt anyone." He also said that as he understands the law, his office is not bound by IDJJ standards, even when officers are responding to an incident inside a facility that is under those rules.

In a statement, IDJJ said it does not consider calling for outside law enforcement alone to be a violation of any standards, though "the standards would apply to how force, if any, is used."

The agency said it had not been aware of the stun gun incident until they were alerted to it when they returned for an audit in late September. That audit is not complete and has not yet been made public.

#### Oversight breakdown

Two years ago, IDJJ updated its standards for the operation of juvenile detention centers, incorporating language that emphasizes youths' education and mental health and stresses appropriate use of restraint and seclusion. Its reports, available online, became more robust. But while they have helped bring problems to light, said Rachel Shapiro, a managing attorney with Equip for Equality, her agency is still identifying some "horrific" conditions that never appear in IDJJ audits.

And although it can document problems it has identified, IDJJ's authority to ensure they are fixed is limited.

The law does allow the state agency to petition a court to order a facility into compliance if it hasn't fixed deficiencies within six months of receiving notice from IDJJ. But IDJJ said the agency is "not aware of any instances" of agency staff initiating such a process, in part because it would have to petition the very courts that run them.

The Illinois Supreme Court is also limited in what it can do. Its standards say that the

court "shall" withhold 10% of the salary reimbursements it provides to any facility that remains out of compliance 90 days after receiving notice, and another 10% monthly thereafter. But it has not financially sanctioned any facilities.

Instead, Bonjean said, a special unit within the Administrative Office of the Illinois Courts is closely monitoring any facilities that are still working through their corrective action plans.

The court spokesperson declined to provide the news organizations with the court's full review of the Benton facility, its action plans or its progress reports. He confirmed that it remains out of compliance 14 months after the review but said that it is "making progress." The county has approved funds for needed repairs and improvements to the facility, he said, but they will "take some time." Reducing funding, he said, "could be problematic and could hinder the progress we are trying to achieve."

John Albright, IDJJ's chief of performance and innovation, who conducts the audits for the agency, said he also tries to work closely with facility staff to help them understand the standards and how to meet them.

"Some facilities have been working very hard to make changes, and others maybe not as much," he said.

When the oversight entities don't compel action, the only option remaining for those who feel they were harmed by the system is a lawsuit, advocates say. Kevin Fee, an attorney with the ACLU of Illinois, said his organization is concerned about conditions across facilities. But those found in Benton were "far and away" the most troubling, he said.

"The Franklin County reports were pretty scathing, and we would have expected more action in response to those reports," Fee said of the IDJJ audits. "But we didn't see any, which is why we felt the need to bring the lawsuit."

Jennifer Vollen-Katz, executive director of the John Howard Association of Illinois, an independent watchdog organization, agreed that even with the improved standards, there are still shortcomings with "system transparency and concerns about the treatment and conditions youth experience while in detention."

The weak enforcement mechanisms are "a real deficiency in the state of Illinois," she said. "We have work to do so that we're not just inspecting these facilities and reporting on the issues. There has to be some way of holding the detention centers accountable and responsible for the treatment of youth in their custody short of litigation."



# At Home for the holidays

Give a cookbook that will actually get used



Five years ago, I attended a book-signing for the highly acclaimed Noma Guide to Fermentation. Noma is a three-Michelin-star restaurant in Copenhagen, considered by many to be one of the world's best. In his presentation prior to the book signing, Noma's chef, Rene Redzepi, criticized the restaurant's two previous cookbooks: Noma: Time and Place in Nordic Cuisine, and Noma 2.0: Vegetable, Forest, Ocean. Both are impressive tomes, but the recipes are complex, require obscure ingredients, and are totally inaccessible for home cooks. He remarked: "We've sold thousands, and no one who owns one has ever tried a recipe." I must confess that my Noma volumes reside in a corner of my bookcase next to my copies of *The* French Laundry Cookbook, Alinea, Fäviken, and A Day at elBulli, all unused and in mint condition.

There's a big difference between a cookbook whose goal is to impress, yet confuses and overwhelms the reader and one that helps the reader grow to become a better cook. If you want to give a gift to someone who is interested in improving home cooking skills, I highly recommend *At Home* by Gavin Kaysen. Unlike the volumes that are collecting dust on the corner of my bookshelf, *At Home* exists to educate rather than impress. Though its recipes are impressive, they are relatively easy to prepare and will look and taste like a meal from a high-end restaurant. I don't want to spoil anybody's surprise, but all the interested home cooks on my shopping list will be getting a copy of *At Home* for Christmas.

Gavin Kaysen is a James Beard award-winning chef based in Minneapolis, where I had the privilege of working for him for a year when his restaurants started reopening at the end of the COVID pandemic. During the shutdown, Chef Kaysen started "GK at Home," online cooking classes that originated in his home kitchen. The Zoom classes included an option of purchasing all the ingredients needed for preparing the meal, which provided work for his chefs, who would otherwise have been furloughed. His first class had 130 participants. By his third class, the number grew to over 1,000.

The success of this project prompted Kaysen to write and self-publish *At Home*, which features 112 recipes that he developed while teaching nearly 40 online cooking classes. "I've always loved teaching others how to cook, but it wasn't until I began livestreaming classes in 2020 that I learned how much beyond basic culinary techniques I have to offer. *At Home* is an extension of these classes." The experience of interacting online with home cooks, answering their questions and walking them through unfamiliar procedures,

showed Kaysen where extra help was needed. *At Home* addresses these common issues and serves as an effective tutorial.

Each recipe includes step-by-step photography as well as tips and insights that Kaysen has collected during his years of running fine-dining kitchens and cooking with some of the world's best chefs. Good cooking shouldn't be overly difficult; it's simply a matter of knowing what the steps are and paying attention as you work your way through them. Kaysen shows you how to organize your workspace and workflow like you would in a professional restaurant kitchen. He emphasizes cleaning as you go. On more than one occasion he had to kindly remind me: "A messy station is a messy mind."

At Home features a mix of recipes, ranging from his family favorites passed down from his

grandmother to dishes that Kaysen has developed over his years working in high-end restaurants. He credits his grandmother, Dorothy, for instilling in him his love of cooking and this collection of recipes merges his Midwestern roots with his classic French training. The recipes are organized by the season, and range from such French classics as Coq au vin and Cassoulet to Midwest classics such as Grandmother Dorothy's Chicken and Dumplings.

*At Home* is a cookbook you'll use. My copy is already christened with my greasy fingerprints.

# **Dorothy's Chicken and Dumplings** From *At Home*

This is one of the first dishes Kaysen's grandmother taught him how to make. It's a good dish to make for dinner parties because it can be made ahead. Serves 4 Ingredients

For the dumplings:

1 cup all-purpose flour

1 teaspoon baking powder

1 teaspoon fine sea salt

1 teaspoon freshly ground black pepper

34 cup buttermilk

For the stew:

1/4 cup avocado oil (or canola oil)

1 pound boneless, skinless chicken thighs and breasts, cut into 1-inch cubes

fine sea salt

Freshly ground black pepper

1 cup white pearl onions, peeled and halved

1 small carrot, peeled and diced

1 small rutabaga, peeled and diced

2 tablespoons unsalted butter

1/4 cup all-purpose flour

1-quart chicken stock 1/4 cup sour cream

1/4 cup finely chopped parsley

#### Preparation

For the dumplings: In a bowl, stir together flour, baking powder, salt and pepper. Make a well in the dry mixture. Slowly drizzle in buttermilk and stir gently with a fork; the batter should stick together but remain a bit wet. Use your hands to gather batter together into a dough. Cover with a wet towel and set aside.

For the stew: In a 4-quart Dutch oven, heat oil over medium-high heat. Season chicken with salt and pepper. Working in batches to avoid overcrowding, sear chicken on all sides until browned but not cooked through, about 5 minutes. Add onion, carrot and rutabaga, and season with salt. Cook until lightly browned, about 4 minutes.

Reduce heat and add butter and flour. Cook until flour is lightly browned and has a nutty fragrance, about 2 minutes. Add chicken stock and scrape the bottom of the pan to deglaze. Bring to a boil, then reduce to a simmer, season with salt and pepper, and cook for 10 minutes. Bring heat up to a gentle boil, add sour cream and whisk to combine.

Scoop a dollop of dumpling batter into the pot so it rests atop the liquid; repeat with the remaining batter. Cover, reduce heat to low, and cook for 5 minutes. Flip each dumpling, replace the lid, and cook 3 to 5 minutes longer. Dumplings will turn a shade whiter when finished. Season stew to taste with salt.

To serve, divide stew among bowls, sprinkle with parsley, and enjoy.




