










# Wrongful incarceration

Illinois Innocence Project helps free man who served 35 years

Brian Beals walked out of prison this month after serving 35 years for a murder he didn't commit.

He blames his wrongful incarceration on a corrupt legal system and credits his freedom to the Springfield-based Illinois Innocence Project.

"I got involved in the Innocence Project because my sister and my family petitioned them to take my case and I'm really glad she did," he told *Illinois Times*.

Lawyers from the Innocence Project visited him in prison, listened to his concerns and advocated for him in courtrooms.

A Cook County judge overturned the conviction Dec. 12 and dismissed all charges against Beals, marking the end of a legal ordeal that began in 1988 when he was falsely accused of murdering a 6-year-old boy in Chicago's Englewood neighborhood.

In 1988, Beals was a senior at Southern Illinois University and a college football player. He was visiting his Chicago home when he became the target of a local drug dealer's threats. Bullets aimed at Beals' fleeing vehicle struck 6-year-old Demetrius Campbell and his mother, Valerie Campbell. Demetrius died of his injuries.

During his trial, Beals was convicted in part on the testimony of Valerie Campbell, who identified him as the shooter despite not being shown any lineups or photographs. But newly surfaced evidence included statements from five additional witnesses showing that Beals was the intended target, not the perpetrator. Photographic enhancement of police images also revealed bullet holes in Beals' car, further bolstering his claims of innocence.

Chicago police detective Thomas Ptak, the lead investigator, has been linked to eight

other proven wrongful convictions.

"Brian was locked up for something he didn't do, and he missed out on so much, but I also firmly believe that we missed out on so much by not having him be a part of our world out here," IIP co-director Lauren Kaeseberg told *IT*. "He is so capable and so inspiring. There's so much good that he has inside of him to do in the world."

Ironically, at the time of the 1988 incident, Beals was studying to become a police officer.

According to IIP, Beals is the 521st individual to be exonerated in Illinois. He served the third-longest term of wrongful incarceration in the state's history.

Kaeseberg added, "I think a lot of times people look at cases of people who are wrongfully convicted and they think to themselves, 'Well, there must be a reason the police thought it was him.' Like, maybe he did something else or he had some other record, or he was a bad guy in another part of his life. And the truth is, wrongful convictions happen to everybody. Brian Beals was on a trajectory of not only success, but of service. He wanted to be a police officer."

Beals served time in some of Illinois' toughest prisons but he said the fear he experienced came from the institutions themselves – not fellow inmates.

"Prison can be a scary place," he said. "I think everybody there is a little afraid. I'm no exception to that. But I think the

misconception is, what are you afraid of? I was not afraid of the other prisoners. It was the system itself, the way we were targeted for certain things. ... trying to have a stable life in prison was difficult, not knowing what was going to happen next. There was wave after wave after wave. ... I don't know how many different directors I've experienced over the years, dozens and dozens of wardens, being transferred. Yeah, those were the scary things – the system itself."

The Illinois Innocence Project, which was formed in 2001 at University of Illinois-Springfield, provides free legal advocacy and guidance to those believed to have been wrongfully convicted in Illinois. It also educates law enforcement, students and the public about wrongful convictions. And it works with policymakers to change rules, laws and practices to minimize wrongful convictions. □

#### **Editor's note**

The Springfield Immigrant Action Network and its president, Veronica Espina, had the most helpful response to recently exposed divisive anti-immigrant rhetoric from Teresa Haley, Illinois NAACP president. "We need to stop using the lenses in which we see 'us' versus 'them,'" SIAN said in a statement. "What we need instead is an analysis in which we view communities as whole, fully human, deserving of our respect and assistance. ... When we lift one group, when we support and elevate communities, we are also lifting our neighbors and other marginalized peoples." We are all reminded to renew efforts to support the advancement of colored people, with an expanded definition that includes people of color immigrating from the Global South, as well as the rainbowdraped LGBTQ community. # **Problematic bug makes its way to Springfield**

Global warming leads kissing bug to migrate from Latin America

Dr. Meredith Mahoney, a zoologist for the Illinois State Museum, made a discovery in her Springfield home that could be a bellwether not only to global climate change but to a deadly disease making its way into the Midwest.

Perhaps the actual discovery should be attributed not to Mahoney but to her cat, Darcie.

"She was playing with something in my living room, and I've discovered it's best to find out what she's playing with. It was a bug," Mahoney said.

What Darcie was batting about was a triatominae, which is better known as a kissing bug.

The insect is a scourge in Latin America. It clamps onto people's faces while they sleep and sucks their blood. Worse yet, it is the vector for a parasite that causes Chagas disease

While the ailment can be mild, causing swelling and fever, it also can be long lasting and lead to congestive heart failure in infected humans and dogs.

Little did the cat – or the insect – know, but Mahoney's institution was working with a researcher at Saint Louis University tracking the northly migration of kissing bugs.

Ellen Santos, an epidemiologist at SLU, published an article this month in *Entomology Today* tracking the presence of kissing bugs in Illinois and Missouri. She said there has been at least one case of a Missouri resident believed to have been infected with Chagas disease in their local community.

Kissing bugs are black or dark brown, with red, orange or yellow stripes around the edge of their bodies. They can be up to an inch long.

Typically, U.S. physicians only find the disease among those who have immigrated from or visited Central or South America. Part of the reason for this is because kissing bugs thrive in warm climates.

But global warming may mean that the bugs are migrating farther north. Santos said the purpose of her study is to establish a baseline to track migration of the insect species as the planet continues to warm.

Already, the presence of kissing bugs in places like Sangamon and Champaign counties indicates that the creatures' range is much farther north than previously thought.

Dr. Becky Smith, a veterinarian and epidemiologist at the University of Illinois College of Veterinary Medicine in

Champaign-Urbana said global warming is a reasonable hypothesis for why insects not previously found in central Illinois are becoming more common.

"Vectors (disease carriers) are now more common and in our area. And I am concerned. I mostly work with ticks and we know that there are species of ticks that didn't used to be able to survive winters in Illinois that we have this far north. But now they are in Champaign County," she said. "There are mosquitoes that are surviving the winter, and now apparently these kissing bugs that can spread Chagas disease are also surviving the winters here."

In decades past, kissing bugs were occasionally found in northern Illinois, Smith said. Today, there appear to be established populations in central Illinois.

In Illinois, the mammals most likely to be infected with Chagas disease are racoons, she said.

Animals are more likely to be infected than humans because they sometimes eat bugs, Santos said.

But Smith added there are other factors that make canines more vulnerable,

"I think dogs are more vulnerable than humans in the U. S. because dogs are more likely to be exposed to the outside," she said. "Kissing bugs like to feed at night and they tend to not be able to get into our houses. But if the dog lives outside or lives in a kennel, then the kissing bugs might find a potential host for biting."

There is no vaccine or other preventive treatment for Chagas disease in dogs or humans, Smith said.

"Unfortunately, there's not much good treatment after infection," she said. "The treatment of Chagas disease in dogs is not very strong yet. And for prevention, it's all about vector control," she said. "Kissing bugs really like wooded areas, brush piles and wood piles. So, cleaning those up is one of the pieces of advice that people give. They are active at night and attracted to light – if you have a light outside your house, they may be attracted to it. So, you want to turn off those outdoor lights and clean up the brush and wood pile."

Dr. Vidya Sundareshan, a professor of infectious disease at Southern Illinois University School of Medicine in Springfield, said the primary concern for the spread of Chagas disease in the United States has been through blood transfusions and organ transplants from infected donors who contracted the disease in Central or South

She added that in Latin America, "It's most common in more rural areas where there are houses made of mud or straw. In those kinds of houses, the bugs hide and at nighttime they come out and then they bite people. After the blood meal, the bugs actually defecate and in their gut is the parasite Trypanosoma cruzii. ... The people that they bite will scratch and they can put it in their eye or other places."

Initial symptoms of infection can include diarrhea, nausea and labored breathing, she said. Sundareshan added there are some antiparasitic medications that can be used to treat infected patients.

But sometimes the disease is not detected early enough and permanent heart damage can result. She said area residents should not be unduly alarmed but there is reason for concern.

"Yes, when you're seeing these (insects), they're telling us something. So, we want to be careful and definitely track (their population migration.) So, surveillance is very, very, very important."

# Haley suspended by NAACP

Calling immigrants 'savages' and rapists creates uproar

The national NAACP has suspended Teresa Haley as president of the group's Illinois State Conference after the Springfield resident was recorded on video in October calling immigrants "savages" and saying they are "raping people" and attracting more sympathy than Black people with similar needs.

Haley's comments, made during an online monthly video call with NAACP leaders throughout Illinois, drew criticism from Gov. JB Pritzker, state and local groups advocating on behalf of immigrants and a call for her resignation from a former suburban Chicago NAACP leader.

Haley, who received the "activist of the year" award at the 2020 NAACP Image Awards, issued a written apology in a Dec. 14 news release from the Illinois NAACP.

The news release also said NAACP branch presidents from throughout Illinois met Dec. 13 and "unanimously supported Haley's quintessential leadership skills."

But the national NAACP, based in Baltimore, said in a statement Dec. 15 that it suspended Haley Dec. 13.

It's unclear whether national NAACP officials had communicated with Illinois branch presidents before the Illinois NAACP meeting. Champaign's NAACP branch president, Minnie Pearson, told *Illinois Times* on Dec. 15 that the suspension was a surprise to her. She declined further comment.

Haley initially scheduled a news conference Dec. 16 in Springfield, where she is president of the Springfield NAACP branch, but an emailed statement to the news media said the news conference was canceled "in accordance with the recent request from the national NAACP office. Ms. Haley stands by her heartfelt apology and will not provide any further comments at this juncture."

The Dec. 15 statement from the national NAACP, the nation's oldest and largest civil rights organization, said the nonprofit "stands firm in our commitment to advancing racial justice and cultivating a society where human dignity is respected."

The NAACP didn't respond to requests for more information or clarification, didn't say how long the suspension will last, whether the group will consider permanently removing Haley as statewide president or whether the suspension also applies to Haley's position as president of the Springfield NAACP branch.

"As an internal matter, there will be no additional comment at this time," the statement said, adding, "The NAACP will continue to

foster an environment that is reflective of our mission and respective of our membership."

Haley, 58, a retired state employee who was elected to her first two-year term as president of the Illinois NAACP in 2015, hasn't responded to *Illinois Times*' requests for an interview.

Television station ABC7 Chicago reported that Haley told one of its reporters in early December, in a phone call while she was on vacation in Dubai, that she didn't make the comments and that the video was fake and was created with artificial intelligence.

"With AI, anything is possible," Haley told the Chicago reporter.

Then, in the Dec. 14 Illinois State Conference news release, Haley reversed course without explanation.

"First and foremost," she said, "I express my sincere apologies to anyone who may have been hurt or offended by my comments. I love and value all members of our communities — including immigrants. I have worked tirelessly to advocate for the underserved and the voiceless. I remain focused on denouncing injustices, racism and discrimination.

"I am empathetic to the plight of all people, and I proudly serve as a beacon of hope to the hopeless. I embrace the mission of the NAACP, which is to 'Achieve equity, political rights and social inclusion by advancing policies and practices that expand human and civil rights, eliminate discrimination and accelerate the wellbeing, education and economic security of Black people and all persons of color."

Elbert Betts, 82, a retired principal of Southeast High School who is a member of the Springfield NAACP's executive committee, said Haley "has my support 100%."

Regarding Haley's comments on the video, Betts said, "I don't think she was lashing out at

Betts said he hopes the national NAACP "gives her due process" before making any final decision about her status.

Patrick Watson, 40, a small business owner in the Chicago suburb of Lisle, said he recorded the October statements by Haley when he was president of the NAACP's DuPage County branch.

Watson told *Illinois Times* he had complained to the national NAACP for months about what he called Haley's disregard for NAACP bylaws on acceptable business practices.

"She tends to create her own facts and creates her own reality," he said.

Watson also said Haley has engaged in "hate speech against the LGBTQ community."

He said Haley, in a November monthly video meeting with Illinois NAACP officials, questioned national NAACP officials' use of "they" and "them" pronouns preferred by certain staff members. According to Watson, Haley said, "What the hell is that?"

Watson said he resigned from his post on Dec. 12 in protest of Haley's conduct and requested her resignation. That same day, he notified the media about Haley's October comments and provided an approximately two-minute section of a recording of the two-hourlong video meeting.

"I could no longer be a part of the organization," he said. "Hate has no home in the organization."

Watson said he also notified the national NAACP and the media because Haley is campaigning to be named to the NAACP's national board of directors in an internal election taking place in December and culminating at the end of the month.

In the video clip, Haley talked about immigrants who have been bused to Chicago and other Northern cities from the U.S. border with Mexico.

Apparently in response to comments made by other people on the call, Haley said Peoria, Springfield and other cities should prepare for immigrants wanting services and noted that cities are being more eager and generous about finding immigrants safe housing than they have in serving low-income Black people.

"But Black people have been on the streets for ever and ever, and nobody cares because they say that we're drug addicts, we've got mental health issues. But these immigrants who come over here, they've been raping people, they've been breaking into homes, they're like savages as well. They don't speak the language, and they look at us like we were crazy because we were the only people in America who were brought over here against our wills and were slaves, sold into slavery.

"But everybody else who comes over here? We're so kind, we're so friendly. You need some clothes, you need a place to stay? We're gonna make it happen. So brother, I feel your pain. I'm right there with you. I'm trying not to be a (N-word), but you know I'm pro-Black."

Pritzker called Haley's comments on the video "reprehensible" and told the news media he hoped she would apologize.

The governor said "people should recognize that immigrants in this country are all around us" and "virtually all of us came here from somewhere else. So remarks like that are commentary on our entire society."

Watson said he doubted the sincerity of Haley's apology because she directed it to "anyone who may have been hurt or offended."

Watson called the national NAACP's suspension of Haley "a great first step to begin the healing of the community to show there's no hate in the organization."

Veronica Espina, founder and president of the Springfield Immigrant Advocacy Network, didn't comment on Haley's apology or suspension but said she was "sad and upset" after hearing Haley's taped comments.

"It's not just disappointing. It's hurtful," Espina said

"The NAACP has a history of supporting immigrants and refugees in this country," she said, adding that low-income Black people and immigrants often live in the same neighborhoods and share the same concerns and challenges.


"We need to stop using the lens of 'them vs. us," Espina said, adding that those who oppress marginalized groups benefit when those groups criticize each other.

"They divide and conquer," Espina said. "It's a way of thinking we need to reject. There are resources out there."

A joint statement from the network and the Illinois Coalition for Immigrant and Refugee Rights said the groups rejected Haley's comments on the video:

"Divisive rhetoric damages communities. It reinforced harmful stereotypes, which, in turn, hurt entire groups of people. Apologies must include strategies to begin dialogue, deliberate actions to repair relationships and commitment to share accurate information."

#### **NEED TRANSPARENCY**

This project is supposed to be a public/private initiative with each entity covering half of the total \$67 million cost ("Scheels Sports Park development on track," Dec. 14). According to Ryan McCrady, president and CEO of the Springfield Sangamon Growth Alliance, "Money from the banks isn't needed by the developers yet; drawing on funds that have been committed by the banks too soon would incur unnecessary interest charges."

Using this logic, the developer should not use any private funding until the city of Springfield has spent its share of the \$67 million in order to save unnecessary interest charges. It is time for the City Council to do their due diligence and not pay one dime until the developer can show proof of financing for their share of the project. The developer should be providing receipts for work already completed, and the council should insist on complete transparency on all transactions by this developer, including paying prevailing wage. *Bill Baskett*

#### **NEED SELECTIVITY**

Regarding the Scheels Sports Park, Ward 3 Ald. Roy Williams observed, "We do a whole lot for this developer that we don't do for other developers." He's right, and I think it's important to explore it further to determine value guidance for future developer requests.

A new grocery or hardware store mostly cannibalizes customers from established stores with little or no gain to the overall economy. Housing projects, especially downtown, are often risky with predictable downside and developers seek TIF dollars to cover their losses. Strip malls rarely bring in impact business. Nonprofits do not generate appreciable revenue.

Local business transacted in Springfield is money spent from resident to resident. Tax revenue and payroll dollars that chain stores leave behind also originates from residents. Conversely, state of Illinois payroll and manufacturing bring money here from elsewhere.

Scheels Sports Park will draw a steady stream of outsiders spending hundreds of dollars while visiting. Tax revenue from hotels, restaurants, gas stations and souvenir sales will boom. Wages from new jobs will expand. Locally owned businesses will share in the harvest of outside money.

That is the key to understanding why Scheels Sports Park is so valuable and why its

developer gets better consideration. Almost all the money spent at or near this expanded athletic facility will be new money – money brought here from somewhere else and left behind.

# This year's Top 10 underreported stories

"We have made the planet inhospitable to human life." That's what the lead researcher in Project Censored's No. 1 story this year said. He wasn't talking about the climate catastrophe. He was talking about so-called "forever chemicals," per- and polyfluoroalkyl substances (PFAS), linked to prostate, kidney and testicular cancer and additional health risks, and the study he led found unsafe levels in rainwater worldwide.

Even though this story received some corporate media attention – in USA Today and the Discovery Channel - the starkly shocking bottom line clearly didn't come through to the general public. Have you heard it before? Has it been the subject of any conversation you've had? No? Well, that, my friend, is the very essence of what Project Censored's signature top 10 list is all about: Exposing the suppression (active or passive) of vitally important information from the public, which renders the public unable to act in the way that a healthy democratic public is supposed to. They've been doing it since Carl Jensen began it with a single college class in 1976, inspired in part by the way the Watergate story got this same sort of treatment until well after the election cycle it was part of.

But there's a second story intertwined with the forever chemicals' pervasive presence: the revelation that companies responsible for them have known about their dangers for decades, but kept those dangers hidden - just like fossil fuel companies and climate catastrophe. The intersection of environmental/public health and corporate criminality is typical of how certain longstanding patterns of censored news weave together across the years, even decades, and how the spotlight Project Censored shines on them helps to make sense of much more than the individual stories it highlights, as vitally important as they are in themselves.

The themes in the No. 1 story – environmental harm and corporate abuse – so dominate the top 10 story list that they send another message as well, a message

about the fundamental mismatch between our needs as a species living on a finite planet and a rapacious economic system conceived in ignorance of that fact. The climate catastrophe is just the most extreme symptom of this mismatch, but it's far from the only one. Corporate abuse figures into every story in the list – though sometimes deep in the background, as with their decades-long efforts to destroy unions in story No. 6. Environmental harms 'only' show up in seven of the 10 stories.

There are still other patterns here, to be sure, and I encourage you to look for them yourself because seeing those patterns enriches your understanding of the world as it is, and as it's being hidden from you. But this dominant pattern touches us all. The evidence is right there, in the stories themselves.

# 1. "Forever chemicals" in rainwater a global threat



Rainwater is "no longer safe to drink anywhere on Earth," Morgan McFall-Johnsen reported in *Insider* in August 2022, summing up the results of a global

study of so-called "forever chemicals," or polyfluoroalkyl substances (PFAS), published in the journal *Environmental Science & Technology.* Researchers from Stockholm University and the Institute of Biogeochemistry and Pollutant Dynamics at ETH Zurich concluded that "in many areas inhabited by humans," PFAS contamination levels in rainwater, surface water and soil "often greatly exceed" the strictest international guidelines for acceptable levels of perfluoroalkyl acids.

They're called "forever chemicals" because they take so long to break down, "allowing them to build up in people, animals, and environments," *Insider* reported. Project Censored notes, "Prior research has linked

these chemicals to prostate, kidney and testicular cancer and additional health risks, including developmental delays in children, decreased fertility in women and men, reduced vaccine efficacy and high cholesterol."

## 2. Blurred lines between big tech and big brother



"Google – one of the largest and most influential organizations in the modern world – is filled with ex-CIA agents," Alan MacLeod reported for *MintPress News* in July 2022. "An inordinate number of these recruits work in

highly politically sensitive fields, wielding considerable control over how its products work and what the world sees on its screens and in its search results."

And more broadly, "a former CIA employee is working in almost every department at Google," Project Censored noted.

But Google isn't alone. Nor is the CIA. "Former employees of U.S. and Israeli intelligence agencies now hold senior positions at Google, Meta, Microsoft and other tech giants," Project Censored wrote. A second report focused on employees from Israel's Unit 8200, its equivalent of the CIA, which is "infamous for surveilling the indigenous Palestinian population," MacLeod wrote. Using LinkedIn, he identified hundreds of such individuals from both agencies, providing specific information about dozens of them.

"The problem with former CIA agents becoming the arbiters of what is true and what is false and what should be promoted and what should be deleted is that they cut their teeth at a notorious organization whose job it was to inject lies and false information into the public discourse to further the goals of the national security state," MacLeod wrote, citing the 1983

testimony of former CIA task force head John Stockwell, author of *In Search* of *Enemies*, in which he described the dissemination of propaganda as a "major function" of the agency.

Reinforcing that concern is big tech's history. "As journalist Nafeez Ahmed's investigation found, the CIA and the NSA were bankrolling Stanford Ph.D. student Sergey Brin's research – work that would later produce Google," MacLeod wrote. "Not only that but, in Ahmed's words, 'senior U.S. intelligence representatives, including a CIA official, oversaw the evolution of Google in this pre-launch phase, all the way until the company was ready to be officially founded."

This fits neatly within the larger framework of Silicon Valley's origin as a supplier of defense department technology.

## 3. Toxic chemicals continue to go unregulated



The United States is "a global laggard in chemical regulation," *ProPublica* reported in December 2022, a result of chemical industry influence and acquiescence by the Environmental

Protection Agency over a period of decades, according to reporters Neil Bedi, Sharon Lerner and Kathleen McGrory. A headline example: asbestos, one of the most widely-recognized toxic substances, is still legal in the U.S., more than 30 years after the EPA tried to have it banned.

"Through interviews with environmental experts and analysis of a half-century's worth of legislation, lawsuits, EPA documents, oral histories, chemical databases and regulatory records, *ProPublica* uncovered the longstanding institutional failure to protect Americans from toxic chemicals," Project Censored reported. *ProPublica* identified five main reasons for failure:

• The chemical industry helped write

#### the 1976 Toxic Substances Control

**Act.** The law "allowed more than 60,000 chemicals to stay on the market without a review of their health risks" and required the EPA to always choose the "least burdensome" regulations. "These two words would doom American chemical regulation for decades," *ProPublica* reported.

- The EPA lost its resolve. In 1989, after 10 years of work, the EPA was banning asbestos. But companies that used asbestos sued and won in 1991, based on a court ruling that they'd failed to prove it was the "least burdensome" option. However, "the judge did provide a road map for future bans, which would require the agency to do an analysis of other regulatory options ... to prove they wouldn't be adequate," but rather than follow through, the EPA simply gave up.
- Chemicals are considered innocent until proven guilty. For decades, the U.S. and EU used a "risk-based" approach to regulation, requiring the government to prove a chemical poses unreasonable health risks before restricting it, which can take years. In 2007, the EU switched to a "hazard-based" approach, putting the burden on companies when there's evidence of significant harm. As a result, *ProPublica* explained, "the EU has successfully banned or restricted more than 1,000 chemicals." A similar approach was proposed in the U.S. in 2005 by New Jersey Sen. Frank Lantenberg, but it was soundly defeated.
- The EPA mostly regulates chemicals one by one. In 2016, a new law amended the TSCA to cut the "least burdensome" language, and created a schedule "where a small list of high-priority chemicals would be reviewed every few years. The first 10 were selected, including asbestos," *ProPublica* reported. "The EPA would then have about three years to assess the chemicals and another two years to finalize regulations on them." But six years later, "the agency is behind on all such rules. So far, it has only proposed one ban, on asbestos, and the agency told

*ProPublica* it would still be almost a year before that is finalized." Industry fights the process at every step.

• The EPA employs industry-friendly scientists as regulators. "The EPA has a long history of hiring scientists and top officials from the companies they are supposed to regulate, allowing industry to sway the agency's science from the inside," *ProPublica* wrote. A prime example is Todd Stedeford. "A lawyer and toxicologist, Stedeford has been hired by the EPA on three separate occasions," *ProPublica* noted. "During his two most recent periods of employment at the agency – from 2011 to 2017 and from 2019 to 2021 – he was hired by corporate employers who use or manufacture chemicals the EPA regulates."

# 4. Stalkerware could be used to incriminate people violating abortion bans



Stalkerware – consisting of up to 200 surveillance apps and services that provide secret access to people's phones for a monthly fee – "could become

a significant legal threat to people seeking abortions, according to a pair of articles published in the wake of the U.S. Supreme Court's decision to overturn the constitutional right to abortion," Project Censored reports.

"Abortion medication is safe. But now that Roe is overturned, your data isn't," Rae Hodge wrote for the tech news site CNET just two days after the Dobbs decision. "Already, the digital trails of abortion seekers can become criminal evidence against them in some states where abortion[s] were previously prosecuted. And the legal dangers may extend to abortion seekers in even more states."

The next month, writing for *Slate*, University of Virginia law professor Danielle Keats Citron warned that "surveillance accomplished by individual privacy invaders will be a gold mine for prosecutors targeting both medical workers and pregnant people seeking abortions."

It's not just abortion, she explained, "Your phone's data, your social media accounts, your browsing and geolocation history, and your ISP's detailed records of your internet activity may all be used as evidence if you face state criminal or civil charges for a miscarriage."

And "abortion bounty hunter" provisions adopted by states like Texas and Oklahoma, add a financial incentive. "Given the inexpensive cost of readily available stores of personal data and how easily they can be deanonymized, savvy informants could use the information to identify abortion seekers and turn a profit," she noted.

"The law's response to intimate privacy violations is inadequate, lacking a clear conception of what intimate privacy is, why its violation is wrongful and how it inflicts serious harm upon individuals, groups, and society," Citron explained. "Until federal regulations and legislation establish a set of digital privacy laws, abortion-seekers are caught in the position of having to create their own patchwork of digital defenses, from often complicated and expensive privacy tools," Hodge warned. While the bipartisan American Data Privacy and Protection Act is still "slowly inching through Congress" it "is widely thought toothless," she wrote.

## 5. Certified rainforest carbon offsets mostly "worthless"



"The forest carbon offsets approved by the world's leading certifier and used by Disney, Shell, Gucci and other big

corporations are largely worthless and could make global heating worse, according to a new investigation," the *Guardian* reported on Jan. 23, as part of a joint nine-month reporting project with SourceMaterial, and *Die Zeit*.

"About 90% of rainforest carbon offsets

certified by Verra, the world's largest offset certifier, do not reflect real reductions in emissions," Project Censored summed up.

Specifically, "The investigation of 29 Verra rainforest offset projects found that 21 had no climate benefit, seven had significantly less climate benefit than claimed (by margins of 52% to 98% less), while one project yielded 80% more climate benefit than claimed. Overall, the study concluded that 94% of the credits approved by these projects were 'worthless' and never should have been approved."

"Rainforest protection credits are the most common type on the market at the moment. And it's exploding, so these findings really matter," said Barbara Haya, director of the Berkeley Carbon Trading Project, who's researched carbon credits for 20 years. "But these problems are not just limited to this credit type. These problems exist with nearly every kind of credit," she told the *Guardian*. "We need an alternative process. The offset market is broken."

### 6. Unions won more than 70% of their elections in 2022



Unions won more than 70% of their certification elections in 2022, according to reporting by NPR and The Conversation, and workers of color were

responsible for 100% of union growth, according to an analysis by the Economic Policy Institute reported by Payday Report and the *New Republic*.

The National Labor Relations Board reported 2,510 petitions for union representation filed in fiscal year 2022, up 53% from F 2021. Seventy-two percent of the 1,249 certification elections were held voted to certify a union as their collective bargaining agent. "The entire increase in unionization in 2022 was among workers of color – workers of color saw an increase of 231,000, while







white workers saw a decrease of 31,000," EPI wrote in a February 2023 press release.

EPI also noted that "Survey data show that nearly half of nonunion workers (48%) would vote to unionize their workplace if they could. That means that more than 60 million workers wanted to join a union, but couldn't. The Protecting the Right to Organize Act and the Public Service Freedom to Negotiate Act provide crucial reforms that would strengthen workers' rights to form a union and engage in collective bargaining." It passed the House in 2020 and 2021 but died in the Senate, where it needed 60 votes to pass because of the filibuster.

"Corporate media coverage of the labor resurgence of 2022 was highly selective and, in some ways, misleading," Project Censored reported. There've been hundreds of articles on union organizing at Starbucks and Amazon and among graduate students, "Yet corporate coverage of current labor organizing often fails to address the outsized role played by workers of color in union growth." Nor has it placed recent union successes in the historical context of prolonged decline, largely due to private employers' heavy-handed efforts to undermine organizing campaigns and labor laws that strongly favor employers.

# 7. Fossil fuel investors sue governments to block climate regulations



"Litigation terrorism" is what Nobel Prizewinning economist Joseph Stiglitz called the practice of fossil fuel companies and investors suing governments in secretive private

tribunals to thwart climate change policies. Litigants claim climate change laws undermine their profits, and thus they must be compensated under what's known as "investor-state dispute settlement" legal actions, Rishika Pardikar reported for *The Lever* in June 2022, following a paper in *Science* by lead author Kyla Tienhaara the month before. It found that "Global action on climate change could generate upward of \$340 billion in legal claims from oil and gas investors," which, "is more than the total level of public climate finance globally in 2020 (\$321 billion)."

A good portion threatens the Global South. "The five countries with the greatest potential losses from ISDS are Mozambique (\$7-31 billion), Guyana (\$5-21 billion), Venezuela (\$3-21 billion), Russia (\$2-16 billion) and the United Kingdom (\$3-14 billion)," Tienhaara reported. What's more, "If countries decide to also cancel oil and gas projects that are currently under

development, this could introduce substantial additional financial losses from ISDS claims."

"Such [litigation] moves could have a chilling effect on countries' ability to take climate action because of the fear and uncertainty they cause," Pardikar noted. "New Zealand, for example, recently said that it could not join the Beyond Oil and Gas Alliance, an international consortium of governments working to phase out fossil fuels, because doing so 'would have run afoul of investor-state settlements," Lois Parshley reported for *Grist* in January 2023.

Project Censored also cited Lea Di Salvatore's December 2021 report that fossil fuel "investors succeeded in 72% of all cases," winning an average over \$600 million, "almost five times the amount awarded in non-fossil fuel cases." In addition, secrecy is the rule. "54% of the concluded fossil fuel cases are confidential – while their existence is known, no case-related documents, such as awards or decisions, have been made public."

# 8. Proximity to oil and gas extraction sites linked to health risks



"Two epidemiological studies, from 2021 and 2022, provide new evidence that living near oil and gas extraction sites is hazardous to human health," Project Censored

reports, "especially for pregnant mothers and children, as reported by Nick Cunningham for DeSmog and Tom Perkins for the *Guardian*."

Based on 1996-2009 data for more than 2.8 million pregnant women in Texas, researchers from Oregon State University found that "for those pregnant women within one kilometer of drilling there's about a 5% increase in odds of gestational hypertension and 26% increase in odds of eclampsia," researcher Mary Willis told DeSmog. "So, it's this really close range where we are seeing a potential impact right on women's health." Eclampsia is a rare but serious condition where high blood pressure results in seizures during pregnancy.

"Notably, the data in the OSU study predate the widespread development of 'fracking,' or hydraulic fracturing, the process of extracting gas and oil from shale beds by injecting fluids at high pressure," Project Censored pointed out. The second study, from Yale, did study fracking. It found that "Young children living near fracking wells at birth (approximately 1.2 miles) are up to three times more likely to later develop leukemia," according to an August 2022 Guardian story. The study, based on 2009-

2017 data from Pennsylvania, compared 405 children aged 2-7 diagnosed with acute lymphoblastic leukemia with an additional 2,080 children, matched on birth year, who didn't have leukemia.

The findings aligned with others, as DeSmog discussed. "One consistent takeaway from so many health studies related to fracking is that proximity is key," they reported. "The allowable setback in Pennsylvania, where our study was conducted, is 500 feet," Yale researcher Cassandra Clark told them. "Our findings ... in conjunction with evidence from numerous other studies, suggest that existing setback distances are insufficiently protective of children's health."

State and local governments have tried to create health buffer zones, but "The oil industry has consistently fought hard to block setback distance requirements," DeSmog reported. For example, "In 2018, the oil industry spent upwards of \$40 million to defeat a Colorado ballot measure that would have imposed 2,500-foot setback requirements for drillers." Regulations are so weak that "In Texas, drilling sites can be as close as 45 meters from residences," Willis told them.

## 9. Deadly decade for environmental activists



At least 1,733 environmental activists were murdered between 2012 and 2021 – nearly one every two days across 10 years – according to the Global Witness study, *Decade of Defiance*. They were "killed by hitmen, organized crime groups and their own governments,"

Patrick Greenfield reported for the *Guardian*, "with Brazil, Colombia, the Philippines, Mexico and Honduras the deadliest countries." Half the attacks took place in the first three countries, each reporting around 300 killings.

"The killing of environmental activists has been concentrated in the Global South," and "Indigenous land defenders are disproportionately impacted," Project Censored warned. "*The Guardian* reported that 39% of those killed were from Indigenous communities, despite that group constituting only 5% of the global population."

"This is about land inequality, in that defenders are fighting for their land, and in this increasing race to get more land to acquire and exploit resources, the victims are indigenous communities, local communities, whose voices are being suppressed," the BBC summed up.

But, "campaigners are hopeful that progress is being made," the BBC reported, citing the sentencing of a former energy executive to 22 years in prison in Honduras for the murder of world-renowned activist Berta Cáceres in 2016, as well as promising international agreements. The Escazú agreement, the first environmental and human rights treaty for Latin America and the Caribbean "commits countries to prevent and investigate attacks on environmental defenders," and went into force in 2021. Mexico has ratified it, but "others including Brazil and Colombia have not" so far, the BBC said. There are also plans by the European Union to pass laws making companies responsible for human rights abuses in their supply chains.

"These are game-changing decisions that could make a real positive impact for environmental defenders," Shruti Suresh told the BBC. "We should be optimistic. But it is going to be a difficult and challenging road ahead."

#### 10. Corporate profits hit record high





"Corporate profits in the U.S. surged to an all-time record of \$2 trillion in the second quarter of 2022 as companies continued jacking up prices,

pushing inflation to a 40-year high to the detriment of workers and consumers," Jake Johnson reported for Common Dreams in August 2022. "Astronomical corporate profits confirm what corporate executives have been telling us on earnings calls over and over again: They're making a lot of money by charging people more, and they don't plan on bringing prices down anytime soon," the Groundwork Collaborative's chief economist, Rakeen Mabud, said.

This followed Johnson's reporting in March that the average bonus for Wall Street employees rose an astounding 1,743% between 1985 and 2021, according to an analysis by Inequality.org of New York State Comptroller data. Then, in December 2022, he reported that "earnings inequality in the United States has risen dramatically over the past four decades and continues to accelerate, with the top 0.1% seeing wage growth of 465% between 1979 and 2021 while the bottom 90% experienced just 29% growth during that same period," according to research by the Economic Policy Institute. As a result, the average incomes of the top 0.1% rose from 20 times that of the bottom 90% in 1979 to more than 90 times as much in 2021. □

# Eggnog, the divisive drink

Love it or hate it, here's how to make it

Of all quintessential holiday flavors, eggnog might be one of the most divisive. Folks either love it or hate it, however it's hard to argue that this richly spiced and strongly spiked holiday beverage has left an indelible mark on the American holiday tradition. Eggnog is widely believed to be a descendant of posset, a medieval British recipe that consisted of warm milk that had been curdled with alcohol such as wine or ale and infused with spices. It was considered a restorative beverage with medicinal benefits. Monks are said to have added the egg component and sweetened the mixture with dried fruits. Serving eggnog came to be seen as a sign of wealth, thanks to the costly nature of the ingredients, which at that time often included sherry or Madeira.

The popularity of eggnog swelled in the American colonies, where eggs and cream were plentiful and rum from the Caribbean was inexpensive. Variations of the drink grew along with the nation, making use of the different combinations of spices and liquor that waves of new Americans brought with them. George Washington himself was known to make a mean nog that included brandy, rye whiskey, Jamaica rum, sherry and a dozen egg yolks, along with milk and cream.

The commercial eggnog that most of us know and love, or hate, is practically unrecognizable from its origins. I realized this when I tasted the real thing last Christmas. Travis Booth is an award-winning home brewer who lives in Springfield, and when he brought his "Aged-Eggnog" to my house last Christmas I was skeptical. However I quickly pushed all my Scroogey notions aside when I tasted the delicious concoction. Creamy but not thick, it had a texture more akin to a cream liqueur like Baileys, rather than melted ice cream like the eggnog I was used to. And thanks to the high alcohol content, the product, when refrigerated, is safe to drink. Safe enough that, according to an article in Popular Science, microbiologists at Rockefeller University's Laboratory of Bacterial Pathogenesis and Immunology have been making a batch of aged eggnog every Thanksgiving for five decades to serve at their Holiday Party in December (https:// www.popsci.com/blog-network/our-modernplagues/why-you-shouldnt-fear-eggnog/).

Booth's eggnog is a combination of recipes from Alton Brown and other historic sources, including George Washington's recipe. Booth ages his eggnog for at least 30 days. "I usually do mine in August to have it ready in December." It improves with age, he



said. "I have bottles from 2015 thru 2020 in my refrigerator. I usually make five gallons at a time and bottle it to give as Christmas presents."

I live in a blended family of prepared eggnog lovers. My husband and eldest daughter love the stuff and, while I like the flavor, I can't handle the viscous texture. This eggnog French toast bake is a great compromise and perfect for Christmas morning. Prepared the night before, it makes for a hands-off holiday breakfast, perfect alongside crispy bacon and a festive fruit salad.

#### **Travis's Aged Eggnog**

This will last indefinitely in the refrigerator, says Booth. Make sure to shake it vigorously if you've aged it over a year.

6 cups raw milk with the cream, or 3 cups whole milk and 3 cups heavy cream 3 cups bourbon 3/4 cup cognac

½ cup dark rum

12 eggs, separated

2 cups sugar

1 teaspoon each nutmeg and cinnamon

1 tablespoon vanilla extract

1/4 teaspoon salt

Whisk the egg whites until creamy but not quite peak-forming. Beat the yolks with the sugar and spiced in a large mixing bowl until it is light in color and falls off the whisk in a solid ribbon. Combine the two egg mixtures slowly and mix well. Combine the remaining ingredients and mix/swirl in a large container. Refrigerate and age for at least 30 days. Shake or swirl once a week. Shake before serving.

#### **Baked Eggnog French Toast**

½ cup butter

1 loaf day-old challah or French bread, sliced ½-inch thick

2 1/2 cups storebought eggnog

8 large eggs

2 tablespoons rum or bourbon, optional

½ teaspoon each freshly grated nutmeg and cinnamon

 $\frac{1}{4}$  cup turbinado sugar, optional

Whipped cream and maple syrup, to serve

The night before you want to serve it, melt the butter and pour into a 9-inch by 13-inch casserole dish, tilting the dish to coat the bottom and sides with melted butter. Arrange the bread in the buttered dish, slightly overlapping the slices.

Whisk together the eggnog, eggs, booze if using, and spices, then pour this mixture over the bread. Wrap tightly with plastic wrap and refrigerate overnight.

In the morning, preheat the oven to 350 degrees. Remove the plastic wrap and sprinkle the turbinado sugar over the top of the soaked bread, then cover with foil. Place the casserole in the oven and bake for 45 minutes, then remove the foil and bake 10 minutes more, or until the top is golden. Let rest for 20 minutes before serving with whipped cream and maple syrup.  $\square$ 

# **Holiday memories of downtown Springfield**

For some, a big family Christmas dinner is how they celebrate, while for others, it is baking cookies, singing carols or remembering family members who have passed away. Sangamon Experience asked several individuals to share their special holiday memories of growing up in Springfield.

For those whose memories go back far enough, nothing will ever compare to the era when downtown was the heart of retail and crowds thronged its sidewalks during the holiday season. In the past, the streets of downtown Springfield were decorated for Christmas before Thanksgiving, the holiday season's opening. Children could stop by Santa's house on the Old State Capitol grounds in the 1940s to tell him what they wanted for Christmas.

Myers Brothers, Sears, Bressmer's, Herndon and several other national retailers, including Montgomery Ward, were spaced out within an eight-block area. You could go to every type of retail operation, from small dress shops and shoe stores, to full-size department stores.

John Simpson grew up in Taylorville in the 1950s. He stated that most of his memories of Christmas shopping were in Springfield, considering it was the closest place to shop.

"Our holiday shopping in Springfield was usually on a weekday night. [One of] my sisters was in nurses' training at Memorial Hospital. The student nurses lived at the hospital. Both my parents worked; Sunday was for church, and Christmas shopping in downtown Springfield was so crowded (on Saturdays) that my parents avoided that. So as soon as my parents were home from work after 5 p.m., we would drive to Springfield to pick up my sister at Memorial, and the shoparthon was on," Simpson said.

"The first floors of Myers and Bressmer's were overwhelming to a kid. The smell from the perfume counters near the door nearly knocked you over. Dozens, hundreds of people milling around the cosmetic and ladies' accessory counters on the first floor were a maze to find your way through. When headed upstairs to the clothing and furniture floors, you rode in the elevators. All the floors were covered in holiday decorations and trees, and young women in elf costumes directed the customers.

"If the gift was more upscale clothing for a woman relative or friend, you went to Roland's or Herndon's. Sometimes I would get dragged in there by my sister or mother. Inside was a completely baffling multitude of dresses, skirts and blouses. I do recall that Herndon's

had elevator operators who sat by the buttons and levers and guided you up and down. And they always seemed to have another suggestion – the operators had excellent merchandising

"Often, my father and I would escape the clothing stores and head over to Fishman's at Sixth and Washington streets. We both fished, hunted and camped. The place was a multistory jumble of everything outdoors. I do not recall any particular order to the store. You just wandered around, which was actually perfect from the store's perspective, because you always found something you wanted. If a particular item was desired, you spoke to one of the ancient clerks, and they shuffled their way through piles and stacks and invariably found the exact item.

"Of course, the Old Capitol square was also surrounded by many specialty shops – The Hub for men's clothing; B & F and a number of shoe stores; candy stores, small restaurants, florists, drug stores and many others. Downtown even had a barber college. Several barbers were around the square, and most had a shoeshine stand.

"Finally, exhausted from shopping, my parents' wallets depleted (no one had credit cards), we would head home and drop my sister off. But one more stop was on the agenda. At South Grand and Ninth stood The Georgian restaurant. We might get a sandwich and a drink, but we always got banana cream pie. Sitting by the windows looking out on the street, maybe snow falling, the booths hung with pine garlands, a Christmas tree up at the hostess stand, a sprig of spruce in a tiny vase on the table, we would enjoy our pie, imagine what we'd open on Christmas and whether Aunt Bea would like her gift. I suppose my parents would count up the evening's financial toll. But I didn't worry about that."

Steve Myers started working in his family's business in the late 1970s. He worked in

the warehouse and distribution center for Myers Brothers at 118 S. Fourth St. At the time, the company had 10 department stores throughout central Illinois. "All of the 18-wheelers would pull down that alley between Fourth and Fifth streets, and they would offload goods to be tagged with price tags," Myers said. "We distributed out the merchandise... Some would go across the alley into the main building, and then the rest would be distributed to the other stores for products that would go out on the floor for sale, but Christmas was always the magical time of the year."

According to Myers, display windows were the key to attracting attention to the products and hopefully motivating people to walk into the store.

"There were about seven or eight different windows that went around Washington and Fifth streets," he said. "When you look at recounts on social media of people's favorite memories of the holiday season while shopping downtown, many recall walking by those stores and seeing what was in the display windows."

While working at the family department store, Myers would enter not through the front doors on Fifth Street, but the door right at the corner of Fourth and Washington. It was across the street from the parking ramp, and many people parked in that parking ramp at that time.

"You walked in, and guess what? The first department that you walked into was cards and candy, and it smelled like peppermint and roasting nuts," Myers said. "It made you want to buy something and eat it right then and, on the way, out, you got that smell too, and you had to buy it before you walked out. Santa was there during business hours, and the decorations throughout the store were orchestrated to set a mood, a tone and a feeling. There was no way you could not get that feeling when you strolled through the store, so the activity and the bustling nature of the holiday season is something that can translate every year. Our key now is to recreate that feeling (in downtown Springfield)."

A magical Christmas experience awaits all interested in making memories that will last a lifetime.  $\Box$






