Two health insurers leave Illinois market

Fewer insurance providers, tax credits raise concern around higher premiums

Only two health insurance companies are slated to offer marketplace health plans in central Illinois next year, halving the amount of insurance issuers the region currently has as Aetna and Health Alliance announced they will be exiting the insurance marketplace in 2026. In addition, health policy nonprofit KFF estimates the average cost of monthly premiums for central Illinoisans will increase by at least 65% as a result of federal tax credits expiring.

All the while, Blue Cross Blue Shield of Illinois – the only company that covers the entire state – is proposing to raise rates at the highest clip of any health insurer in Illinois.

Health Alliance, which is based in Urbana and issues the second-largest share of all health insurance plans in Springfield, stated it would be discontinuing group health insurance plans next year as it “struggled to achieve operational and financial efficiency” amid rising costs of health care, marking the end of an Illinois insurer that has been in business for nearly 35 years.

Aetna already exited the marketplace once before in 2017, a few years before CVS Health’s \$69 billion purchase of the insurer was finalized. The American Medical Association continuously protested the merger, alleging it would violate federal antitrust law and “likely harm patients.”

The National Association of Benefits and Insurance Professionals, or NABIP, noted in a May press release this is now “the second time in a decade” Aetna has exited the insurance marketplace “and will leave nearly 1 million enrollees seeking new health insurance



options” across the country. Although NABIP acknowledged the decision was a part of “broader market headwinds,” the trade organization “warns of the cascading impact this move could have on health care access.”

Tax credits introduced with the Affordable Care Act, which were then expanded and extended by the Biden administration in 2021, are set to expire at the end of 2025. Such credits have been recognized as making marketplace health insurance reasonably affordable for more than 90% of recipients, according to the Center on Budget and Policy Priorities. Cuts to Medicaid could result in fewer options for care – regardless of a patient’s insurance status – as health care providers that rely on Medicaid reimbursement could cut staff, decrease service

hours or even close clinics.

Brokers from the Illinois chapter of the National Association of Benefits and Insurance Professionals, or NABIP-IL, told *Illinois Times* that almost 100,000 people would be affected by Aetna’s and Health Alliance’s exit. They also warned of how people on marketplace insurance plans should expect to pay substantially more for health care next year.

“Everybody is going to see a decrease in their tax credits, drastically,” said Melissa Shepherd, a licensed broker who was recently appointed to an advisory committee for the upcoming state-based marketplace. “Compound that with the fact that carriers are asking for large (rate) increases this year.”

The lack of tax credits means insurance enrollees may feel the brunt of rate hikes for the first time in years. Last year, the average monthly premium that marketplace enrollees in Sangamon County were charged was near \$850 before tax credits brought the average down below \$200.

Health insurance companies filed their initial rates for 2026 with the Department of Insurance last month; half of all submitted insurance plans increase the average premium rate by double digits, including a nearly 30% average increase for Blue Cross plans. Blue Cross also submitted the highest rate increases for next year’s individual and small group plans, though all companies proposed decreasing rates for their lowest-level plans on the individual marketplace.

Rates are finalized after the Department of Insurance reviews filings submitted by insurers.

Keeping in line with the national average, about 90% of central Illinoisans on marketplace insurance plans have government subsidies to help them out, according to KFF, the nonprofit formerly known as Kaiser Family Foundation.

Shepherd said the tax credits are likely expiring due to “bad actor” insurance agents who, with access to enrollee personal information, switched people over into zero-premium plans, even if they shouldn’t have qualified based on their income level.

Sherri Stewart, a licensed broker at American Central Insurance in Springfield, said Illinois had few zero-premium plans due to state mandates requiring more coverage from health insurers.

“That was an unintended consequence

of the tax credits being expanded,” Stewart said. “It did happen in other states; it was very rampant.” The Centers for Medicare and Medicaid Services finalized rules last month that aimed to limit federal spending and increase a variety of eligibility checks.

Sara Walker-Hite, a licensed broker and president of NABIP-IL, said while it was not something that happened in Illinois, “we all certainly pay the price.”

Aetna and Health Alliance’s exit may open the market for Blue Cross Blue Shield’s Health Care Service Corporation, which already issues more than half of all health insurance plans in Springfield, according to the American Medical Association, and insures more than 500,000 Illinoisans.

Blue Cross and Springfield Clinic, a provider that claims to serve almost one million patients across nearly 100 locations in central Illinois, had a public standoff during contract negotiations in 2021 that resulted in the insurer removing Springfield Clinic from in-network coverage for almost two years. The two for-profit companies eventually struck a five-year deal that categorized Springfield Clinic as an in-network provider through 2028.

This spring, Springfield Clinic laid off almost 70 employees while citing nationwide economic concerns and “insurance reimbursement constraints,” according to an internal memo obtained by *IT*. □

Editor’s note

It was a step toward world peace when China visited Springfield July 25. The occasion was China’s gratitude for Minnie Vautrin of the tiny town of Secor, north of Bloomington, who was a teacher in Nanjing, China, when the Japanese captured the city in 1937 and massacred thousands. In her school, Vautrin sheltered many women and children, saving them from death. On this year’s 80th anniversary of the end of World War II, the Chinese Consulate General in Chicago bought lunch at the Illini Country Club for a group assembled by the Illinois State Historical Society. In his speech, Consul General Wang Baodong addressed issues facing today’s world. “The tragedies of history must never be repeated, and the value of peace must be firmly upheld,” he said. While the U.S. is withdrawing from international development, he emphasized China’s global development initiatives. “China resolutely opposes all forms of unilateralism, protectionism and hegemonic bullying,” he said, while expressing hope for success in current U.S.-China trade talks. “There is no winner in tariff wars or trade wars.” Negotiating with the current U.S. administration has been “difficult,” but peace can be achieved by “resolving confrontation through cooperation and replacing zero-sum competition with win-win outcomes.” From China to Springfield last week, an adult entered the room. — Fletcher Farrar, editor

Get Covered Illinois, the state’s health insurance marketplace, has a frequently asked questions webpage about changes to next year’s marketplace. In addition to the department sending out more information in October, Get Covered Illinois plans to have call center representatives available “to help people choose a comparable plan.”

Although open enrollment doesn’t begin until November, Illinois has a network of navigators that can provide free, in-person assistance any time of the year. Springfield has two such navigators: Springfield Urban League and Central Counties Health Centers. Visit getcovered.illinois.gov to schedule an appointment.

Grayson's attorneys drop cease-and-desist request

Previously accused Massey Commission of "meddling in the impartial jury pool of Peoria County"

The citizen commission working on racial justice and reconciliation in the wake of the 2024 death of Sonya Massey won't be restricted in its activities by the judge presiding in the murder case against Massey's alleged killer.

That's because Mark Wykoff, one of the attorneys for former Sangamon County sheriff's deputy Sean Grayson, accused of murdering Massey in her home a year ago, withdrew a request to force the Massey Commission to "cease and desist" its activities in Peoria County.

The withdrawal took place at a hearing July 25 in front of Sangamon County Circuit Court Judge Ryan Cadagin.

Grayson, 31, of Riverton, is charged with first-degree murder in the July 6, 2024, killing of Sonya Massey, 36, in unincorporated Woodside Township. Grayson has pleaded not guilty and is scheduled to go on trial Oct. 20.

The trial was moved from Springfield to Peoria at the request of Grayson's attorneys because of pretrial publicity.

Jurors in the trial will be Peoria County residents, though the case will be prosecuted by the Sangamon County State's Attorney's Office, Grayson will continue to be represented by Springfield lawyers Wykoff and Dan Fultz, and Cadagin will continue to preside as judge.

Wykoff asked for the cease-and-desist order in a July 23 filing that alleged the commission, funded with about \$250,000 from Sangamon County government, was "meddling in the impartial jury pool of Peoria County."

Wykoff pointed to an advertised "Sonya Massey Town Hall" on June 12 in Peoria that was covered by the news media there. A flyer produced by the nonprofit group Change Peoria said the event was hosted by Change Peoria and the Massey Commission.

Wykoff and Fultz said in court documents that they would be forced to seek another change of venue "that has not been jaundiced by the affirmative actions of the commission" if the court didn't intervene.

However, the commission said in a news release July 24 that it didn't vote to sponsor or endorse the event, and the flyer and other promotional materials weren't approved or reviewed by the commission.

The release said the commission "fully endorses the idea of educating our community and remains true to the values of transparency, accountability, community and unity."

Springfield resident Sontae Massey, 54, a cousin of Sonya Massey, said he spoke at the event in Peoria as a Massey family member but not on behalf of the commission. Sontae Massey is a former member of the commission and now is a paid member of the commission's staff.

Cadagin allowed Wykoff to withdraw the cease-and-desist request and granted Wykoff's request to throw out a related filing by commission member Calvin T. Christian III in opposition to the proposed cease-and-desist order. Fellow commission members Sunshine Clemons, Susan Phillips, Breonna Roberts and Robert Wesley joined Christian in the filing.

Cadagin said Wykoff's withdrawal rendered Christian's filing moot.

When asked why he withdrew the original request, Wykoff told *Illinois Times*, "Sometimes matters resolve themselves before the need to seek court intervention."

Cadagin scheduled a Sept. 12 hearing to consider other pretrial motions from Grayson's attorneys, including one to admit evidence at the trial about Sonya Massey's mental state.

Authorities have said Massey was dealing with mental illness, and Grayson's lawyers contended that Massey's "propensity for violence" will be part of their argument that Grayson acted in self-defense when he fired shots at Massey, including one to the head that produced a fatal injury, after Massey called 911 to summon police to her home when she feared a prowler in the neighborhood.

Grayson's lawyers noted in documents that earlier in the same day of the shooting, Massey is "alleged to have battered/assaulted a neighbor with a brick," and she "had been in a dispute the day prior in reference to a car window being broke." Massey was never charged in connection with those alleged incidents.

In a nationally publicized case with racial overtones, Grayson, who is white, told police he feared for his life and shot Massey, a Black single mother of two teenagers, when he thought Massey was about to throw a pot of heated water in his direction.

Prosecutors have said police-worn body camera video of the incident makes it clear that Grayson overreacted and showed "disregard for human life."

Grayson, who previously had been held at the Macon County Jail in Decatur, was transferred to the Sangamon County Jail on July 23. The transfer, according to a statement from Sangamon County Sheriff Paula Crouch, was necessary "to accommodate ongoing medical procedures and follow-up appointments that, due to operational needs of the Sheriff's Office, require him to be housed in Springfield."

Crouch said Grayson, who according to Fultz was diagnosed with Stage 3 colon cancer in October 2023, "will be housed in a secure unit" within the Sangamon jail and is expected to remain at the jail until his trial.

Sontae Massey said the Massey family is looking forward to justice being served through Grayson's trial. And Massey said the family hopes there will be cameras in the courtroom in Peoria to help inform the public with video and photographs and make sure the legal system is held accountable.

Cadagin so far has turned down all requests from the media to allow cameras in the courtroom for hearings leading up to the trial. The judge hasn't given any explanation for his position and hasn't indicated whether his position will change.

Sontae Massey said the trial needs nationwide exposure.

"We want to make sure that justice is served, and when there are not spotlights on, there is a tendency of not receiving justice," he said. "So we definitely want cameras in the courtroom." □

Police and public action plan

City unveils action plan after months of meetings with community stakeholders

Springfield officials pledged to work harder to diversify the police department, inform the public about existing channels for holding law-enforcement officers accountable and “promote transparency for the community.”

Those were among steps outlined in an “action plan” released by members of Mayor Misty Buscher’s administration, local nonprofits and religious leaders after more than 20 private meetings to improve relations between the public and the police since the July 2024 killing of Sonya Massey.

About 60 people attended a July 28 evening open house at Southeast High School when the plan was released by Springfield Police Department representatives and other members of Springfield Community Partners - United for Change.

In addition to the police department, the mayor and members of her cabinet, partners included the NAACP’s Springfield branch, Springfield School District 186, Springfield Urban League, Ministerial Alliance of Springfield and Vicinity, Faith Coalition for the Common Good, Black Lives Matter Springfield and the Sangamon County State’s Attorney’s Office.

The killing of Massey, involving a Black woman with mental-health issues who was shot to death by a white Sangamon County sheriff’s deputy in a confrontation captured on police-worn body camera footage, attracted international media attention and increased tensions between police and the public in Springfield.

Springfield Community Partners said in a document handed out at the open house that it formed “to ensure a structured and sustainable response.” The document is available on the Springfield Police Department’s website (<https://tinyurl.com/SPIActionPlan>).

“The group’s mission is to categorize community concerns, collaborate on viable solutions and implement policies and practices that will enhance police-community relations in Springfield,” the document said.

Plans by SPD and city officials call for them to:

- Expand partnerships with “key stakeholders” to host future community recruitment events for SPD jobs.
- Increase public awareness on how to file

and follow up on complaints about police conduct and distribute a new information flyer about the mayor-appointed Springfield Police Community Review Commission. That flyer is available online at <https://tinyurl.com/SpringfieldPCRC>. The commission can make nonbinding recommendations to the police chief. The Springfield City Council soon will consider a suggested ordinance from the commission to extend the time period from 15 to 30 days for a citizen to activate the commission’s review process after the citizen receives results of an internal-affairs investigation.

- Expand training for police on de-escalation and the historical context of policing in Springfield.
 - Expand the information available on the SPD transparency website regarding crime data, complaint reports, news releases and department updates.
 - Expand and increase awareness of the SPD peer-support network to encourage police to seek mental-health support.
- Springfield Community Partners’ meetings grew out of a public listening session attended by more than 500 people and held at Union Baptist Church just weeks after Massey’s death. The follow-up meetings were private, and most were held with a representative of the U.S. Department

of Justice’s Community Relations Service, Buscher said.

Ward 2 Ald. Shawn Gregory took issue with the process to produce the plan, saying that he and the two other members of the Springfield Black Aldermanic Caucus – Ward 3 Ald. Roy Williams Jr. and Ward 5 Ald. Lakeisha Purchase – weren’t informed about the closed-door meetings or consulted.

The three alderpersons should have been included, Gregory said, because they often are the first to receive complaints from their constituents about police, and they help hold the Buscher administration accountable.

Even though there can be improvements within SPD, Gregory said, “We have one of the better police departments in the state.” He faulted the Buscher administration, rather than police department officials, for the lack of transparency.

“They don’t want to be hearing my mouth,” he said.

Gregory, who attended the open house, said afterward that he hadn’t had a chance to study all the recommendations, but some appeared vague. Regardless, Gregory said he is willing to work with Springfield Community Partners in the future.

When asked by *Illinois Times* to respond to Gregory’s comments, Buscher and Police Chief Joseph Behl said in a joint statement, “This process was never about any one individual; aside from honoring the memory of Sonya Massey, it was about addressing the relationship between the community and policing in the wake of a tragic incident. That tragedy called for healing, accountability and meaningful dialogue.”

The statement added, in part, “Elected officials were not included in this particular structure, not because their voices aren’t valued, but because the (Department of Justice Community Relations Service) model intentionally centers direct community-law enforcement dialogue, separate from political leadership.

“That said, moving forward, we are absolutely committed to ensuring that all voices, including those of our elected officials, are part of advancing this work. We would welcome the opportunity to sit down with the alderman and members of the Black Caucus to explore how we can deepen collaboration and ensure that the process we’ve made continues with shared purpose and unity.” □

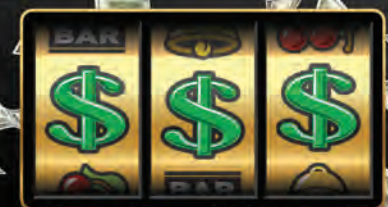

Fighting for the right to try

Springfield parents in race against time to treat daughter's rare disease

Lottie Milburn is a bright-eyed Springfield 4-year-old who brings joy wherever she goes.

"Lottie is hilarious. I feel like for somebody who really is not very verbal she communicates pretty well. She is really, truly, the sweetest little soul you've ever met," her mother, Abby, told *Illinois Times*.

But in April, Abby and her husband, Steven, received the most devastating news any parent can hear. Their daughter has a rare, fatal disease. Only between 4,000 and 5,000 cases are known worldwide.

Lottie was diagnosed with Sanfilippo Syndrome, a genetic disease that affects the brain and spinal cord. It is caused by a problem with how the body breaks down certain large sugar molecules. In children with this condition, these sugar molecules build up in the body and eventually lead to damage of the central nervous system.

Symptoms of the disease rarely manifest themselves at birth. But as a child grows, they may begin having trouble learning and lose previously learned skills. As the disease progresses, children often develop seizures and movement disorders. Most children with Sanfilippo Syndrome die in adolescence or early adulthood.

In addition to Sanfilippo, Lottie was born with an unrelated condition: Down syndrome.

Abby was a teacher before becoming a stay-at-home mom for Lottie and her three siblings. Steven is a lawyer for the state of Illinois.

"We both grew up Catholic," Abby said. "With everything going on, my husband has probably been better about reminding me that all of this just has to be in God's plan – even if we don't like it. It is hard.

"I think we trusted that from the beginning when we learned that Lottie would be born with Down syndrome. I know this sounds crazy, but I always had a feeling I would have a child with a disability, whether that was naturally or we adopted," she said.

One of the hardest things the family has encountered is the federal bureaucracy that reviews whether medications should be approved for use within the U.S.

A promising drug to treat Sanfilippo recently finished its clinical trials and was submitted for approval to the U.S. Food and Drug Administration. The treatment developed by Ultragenyx is a gene therapy that is administered intravenously.

"It did very well in clinical trials," Abby said. "There were 30 children (participating in the study). Everyone did well. They were

able to prove... that either the regression slowed significantly or stopped. Children were regaining skills back that they had lost before the treatment. Some children who had stopped being able to feed themselves well were able to start independently feeding again. Cognitively, they noticed some speech and communication skills returning."

Although it is experimental, this is the first treatment developed for Sanfilippo. But the FDA has yet to approve the medication, which leaves children like Lottie with few good options.

"We were just very hopeful that this would be something to help prolong Lottie's life," Abby said. "And not just prolong it, but do it in a meaningful way."

This is a common predicament, said Brian Norman, director of state affairs for the Phoenix-based Goldwater Institute, a libertarian organization that lobbies for streamlining the approval of medications.

The FDA has prided itself in protecting the public from medications that could have had harmful consequences. For example, in the 1950s and 1960s European regulators approved the sedative thalidomide, while the FDA did not. Ultimately, thousands of European children whose mothers took the medication during their pregnancies were born with missing limbs but American children were spared this tragedy.

But Norman said the FDA's cautious approach has a downside.

"They never bring up the invisible graveyard of individuals who are not able to access promising investigational treatments because of their slow-moving nature," he

said. "Being overly cautious comes at a cost. ... Some individuals are going to lose, and oftentimes it's terminally ill patients who end up paying the ultimate cost."

To work around the bureaucratic inertia, 41 states and Congress passed the original "Right to Try" law, which allows patients with terminal illnesses, in some instances, to access investigational treatments that have not yet received the FDA's approval.

Norman said the foremost authority on these laws is Naomi Lopez, who ironically lives in Springfield and only about a block from the Milburns' home.

In 2017, Lopez testified before Congress in favor of the "Right to Try" legislation that was signed into federal law in 2018 by President Donald Trump.

Lopez has lobbied 30 state legislatures and has been working with the Goldwater Institute on the newer Right to Try for Individualized Treatments laws, which offer a new pathway for rare patients to access bespoke treatments. That law has now passed in 16 states and will eventually be introduced in Congress.

Lopez and the Milburns do not know each other but said they are eager to meet.

Under the federal Right to Try law, "The child's physician would have to be recommending the treatment, and the manufacturer would have to agree to be providing the treatment," Lopez said. "If everyone is onboard and the treatment has passed the basic safety trial, they actually don't have to get the FDA's permission to proceed with treatment."

Sometimes gene therapies call for making a custom medication for just one patient, Lopez said. This can be done more easily in states that have the Right to Try for Individualized Treatments laws on the books. Illinois is not one of them. But neighboring Iowa and Indiana are, she said.

The Milburns are investigating options and are considering reaching out to members of Congress. They have expressed frustration with the FDA.

"Sometimes it can take upwards of a decade to get a drug from start to finish through approval," Norman said. "The FDA is risk averse. It doesn't really take into account the urgency faced by individual patients. ... The FDA, generally speaking, is a slow-moving behemoth that is not responsive to the needs of individual patients who are suffering with their terminal illnesses or life-threatening illnesses on a day-to-day basis." □

Candidates vying for statewide offices

According to the 2020 Census, Cook County is 40% white, 26% Latino, 22% Black and 8% Asian. Chicago is 21% of the state's population.

But the statewide ticket recently endorsed by the Cook County Democratic Party is overwhelmingly made up of white Chicagoans (JB Pritzker, Alexi Giannoulas, Mike Frerichs and Margaret Croke), with two Black Chicagoans (lieutenant governor candidate Christian Mitchell and Kwame Raoul) and no Latinos or Asian Americans.

Outgoing Latina Comptroller Susana Mendoza did not endorse a replacement, and it seems unlikely she would've endorsed the only Latina who tossed her hat into the ring, Sen. Karina Villa, D-West Chicago. Villa is unabashedly progressive, while Mendoza is a far more conservative Democrat.

Villa's progressive views may have cost her the party slating, which Rep. Margaret Croke, D-Chicago, obtained by a super-slim margin.

One contributing issue was Villa's co-sponsorship of a bill (SB2462) to repeal the state ban on investing pension funds into companies that are boycotting Israel. Perhaps to quell any speculation, Cook County Board President Toni Preckwinkle asked Villa during a party meeting if she had ever said that Israel didn't have the right to exist. Villa "adamantly denied it," said one top source.

Villa did not win the support of conservative-to-moderate Latino committeepersons like Aids. Gil Villegas, Ray Lopez and Silvana Tabares.

Some Black committeepersons, except for state Senators, also went with Rep. Croke partly because they wanted to move away from progressive politics (quite a few were with Paul Vallas in the last mayoral election, you may recall). Others were with her because she's a House colleague. Others obviously thought she had the best chance to win and could help them raise funds.

The bottom line, though, is that the worst-kept secret of the past several months is that Croke would run for comptroller if the incumbent Mendoza decided to step aside in favor of a probable run for mayor. Croke therefore had a big head start over Villa and Lake County Treasurer Holly Kim.

Croke, an ally of Pritzker and a favorite of Pritzker's top staff, was able to line up powerful backers and gathered some expert advice. More importantly, though, she did the work, and as microscopically narrow as her victory was, a win is a win.

Unlike Croke, Villa and Clerk Kim kind

of came out of nowhere. And Villa reported a paltry \$12,000 in her campaign account at the end of June. Kim reported just \$44,000. That's not the sort of presentation you want to make to a bunch of folks who hardly knew you even existed until Friday. Croke had \$262,000 in the bank, but it's assumed she has access to much, much more.

Senate President Don Harmon pointed to the potential of an all-Chicago, white-dominated statewide ticket to argue for either his member Villa's slating or for an open primary. It didn't work. Mayor Brandon Johnson has severely damaged the local progressive brand, and Latino voters and their leaders aren't tied to identity politics if it conflicts with their own (or their constituents') ideologies. Not to mention that Villa lives in DuPage County and has no local base and didn't give herself time to make inroads.

No word at this writing on whether Villa or Kim will move ahead with campaigns. Also, Rep. Stephanie Kifowit, D-Oswego, has told some people she's interested in running for comptroller.

Meanwhile, the Cook County

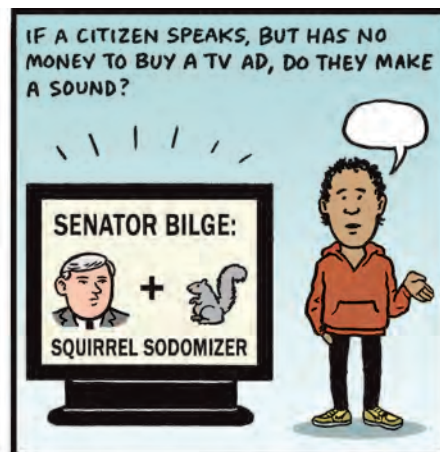
Democrats' decision not to slate anyone for U.S. Senate was a big win for U.S. Rep. Raja Krishnamoorthi. He has such a huge monetary advantage in this race (\$21 million cash on hand) that avoiding the threat of the party backing another candidate means he can continue flooding the ad zone without worrying about a coordinated effort to defeat him in the party's most influential county. Frankly, a slating might have made him look "too inevitable."

Was this a loss for Pritzker, who has endorsed Lt. Gov. Juliana Stratton? Yes, at least on the surface.

But I've had the impression from the beginning that, while Pritzker is definitely supporting her, Stratton has to go out and prove herself.

Her quarterly campaign contribution report didn't impress anyone, and that had to weigh against Stratton during slating.


Right now, all three candidates, including U.S. Rep. Robin Kelly, are running cautious, generic Democratic campaigns, with few differences between them. The person with the most money will always win that race. □

Repeat offender

Friends and family say custody is where he belongs

Michael Gansbauer, 49, has spent fewer than four years out of prison since the age of 18. Convicted for first-degree murder 32 years ago in Springfield, he has spent only an eighth of his adult life out of jail or prison.

Victims' family members, prison reform advocates and childhood friends have agreed that his current home – in custody – is where Gansbauer belongs.

Crystal Page has been advocating for justice for her younger brother, 14-year-old Harold "H.P." Page III, since Gansbauer shot and killed him in 1993. This case gave Gansbauer his first conviction for a violent crime, but not his last.

In an upcoming trial in Springfield, Gansbauer will face charges for possession of a weapon by a felon and being an armed habitual criminal.

Illinois' armed habitual criminal statute is designed to penalize repeat felony offenders for unlawful possession of weapons.

Conviction under this charge requires the state to prove the accused unlawfully possessed a firearm and has been convicted of two or more qualifying past felony offenses.

Gansbauer has at least two qualifying convictions, including unlawful possession of a weapon in 2016 and aggravated robbery in 2021. To avoid the new weapons charge, Gansbauer's lawyer will have to prove that Gansbauer did not receive, sell, possess or transfer a firearm.

Those harmed by Gansbauer in past cases are hoping the state will finally take his record seriously, five criminal charges and three convictions later.

"He is dangerous, he can't even get off parole," Page said. "Enough is enough. Where is the state to protect us victims?"

In November 1993, then 17-year-old Gansbauer and 20-year-old John Rockwood had been drinking before they went to the Page house in Springfield. Rockwood's bike had gone missing, and they blamed the youngest Page for its disappearance.

With promises of beer, Gansbauer and Rockwood lured Page to a stairwell at Ridgely Elementary School on North Eighth Street, where they beat him. In his confession, Gansbauer described standing over Page, pushing the barrel of the gun against Page's head as the boy looked up at him from the floor. Gansbauer shot him twice in the head.

Gansbauer was convicted of first-degree

murder and sentenced to 40 years in prison. After serving 20 years at Jacksonville Correctional Center – half his sentence – he was released.

Such early release was possible because Gansbauer's 1994 conviction came prior to the 1998 passage of "truth-in-sentencing" legislation in Illinois. Before 1998, incarcerated people in Illinois could earn time off court-appointed sentences through good behavior and completion of prison courses. Now, people are required to strictly serve a

predetermined percentage of their sentence, depending on their conviction.

Prison reform advocates say that truth-in-sentencing has resulted in longer overall prison stays without deterring crime or reducing recidivism rates.

Yet, even opponents of tough-on-crime policies like truth-in-sentencing think that Gansbauer's pattern of recidivism calls for a stricter response.

Jodi Rabich Frailey of Pawnee runs RbrokenSystems, a prison reform advocacy

nonprofit that lobbies against the truth-in-sentencing legislation. She is also Page's sister-in-law.

Rabich Frailey's connection to reform efforts is rooted close to home. Her husband is currently serving a 55-year sentence for first-degree murder. Convicted in 2000 at the age of 22, under current laws her husband will not be released until he is 77 years old.

Gansbauer's behavior makes it harder for prison reform proponents to advocate for incarcerated people who want to grow and

repay their debts to society, Rabich Frailey said. She said she has seen many incarcerated people work hard to complete educational and rehabilitation programs to prove they are worthy of a second chance.

“And there are some like Michael Gansbauer who should never, ever be let out,” Rabich Frailey said. “If you can manipulate that system to that point and you get out and you still are threatening the life of someone, you are a threat to society and you need to be locked up forever and a day.”

In a civil suit brought by the Page family, a judge ordered Gansbauer and Rockwood to each pay \$1 million in damages for the wrongful death of H.P. Now, Crystal Page says she has given up on hoping to see the full sum, but still hopes to see Gansbauer pay \$10,000 to cover the cost of burying her brother in 1993.

Acquaintances and court records identify Gansbauer as a member of a local street and prison gang, the Simon City Royals, although a recent court filing notes that Gansbauer “claims to be retired.” In the past, the Springfield Police Department has said that there are no gangs in Springfield, only unorganized groups who like to call themselves gangbangers and copy the behavior and symbols of gangs from other cities.

Illinois Times spoke with a close childhood friend of Gansbauer’s under the condition of anonymity, requested for fear of retribution by the Royals.

Despite his fear, Gansbauer’s friend spoke fondly of good times they spent together.

“This guy’s a real-life killer, but he’ll buy you a beer,” the friend said.

He described Gansbauer as well-meaning and fun to be around but acknowledged that he could flip a switch to a darker side.

“If he wants something, he will take it,” Gansbauer’s friend said. “Some people are just not to be let out. He’s a better version of himself when he’s in

prison.”
Gansbauer has not gone more than two years out of prison since 2014 without racking up new charges.

In 2016, less than two years after being released after serving time for the death of H.P., Gansbauer was facing another charge, this time for possession, manufacture and delivery of cannabis. Within four months of being released on bond for the cannabis charges, Gansbauer was again arrested by Springfield police on charges of home invasion, residential burglary, aggravated unlawful restraint, intimidation and unlawful possession of a weapon by a felon.

The *State Journal-Register* reported at the time that Gansbauer was accused of forcing his way into a home on St. Mary’s Court in Springfield looking for someone who was not there. Upon encountering someone else inside, Gansbauer allegedly pointed his gun at the man when he failed to disclose the location of the person sought.

Gansbauer pleaded guilty in 2018 to one charge for the incident: unlawful possession of a weapon by a felon. The rest of the charges were dismissed by the plea deal. He was sentenced to three years of imprisonment for the weapons charge, the minimum possible sentence for the Class 2 felony.

At the same time, Gansbauer pleaded guilty to the manufacture and delivery of cannabis charge, earning him seven years, to be served consecutively with the weapons charge. Consecutive

sentences are designed to be served one after the other, meaning that Gansbauer's 2018 sentences totaled 10 years, minus almost two served while awaiting trial.

It is unclear how much of that sentence he served, but by mid-2021, he was back in custody.

Charges this time included armed robbery, aggravated robbery, vehicular invasion, aggravated intimidation and aggravated unlawful restraint.

The charges were associated with a June 2021 attack on Heather Jones at her then-boyfriend's home on Cincinnati Avenue in Springfield. Like Gansbauer, the boyfriend is alleged to be a member of the Simon City Royals.

According to Jones, she walked into an ambush at the house. She said she felt like a sitting duck. She heard rustling in the kitchen, but her boyfriend blamed it on the dog.

"It's Roscoe," he said.

It was not Roscoe, but rather a friend of Gansbauer's, and he had a gun. Jones said she ran to her car to try to get away, but her passenger-side window was broken and she could not roll it up. She threw her purse as a distraction, but before she could get away, Gansbauer allegedly opened her driver-side door and took her keys.

Jones said Gansbauer pulled her out of the car and began to hit her in the face. As she pleaded and reached from the ground toward her boyfriend, who had followed them outside, Jones said Gansbauer stomped on her arm and leg. Her boyfriend was able to position himself between Jones and Gansbauer. He saved her life, Jones said.

The three men then took Jones back inside the house. She said she could hear her boyfriend trying to convince Gansbauer not to kill her. She said she was able to push an air conditioner unit out of the wall and escape.

Jones further alleged to *IT* that Gansbauer chased her down the driveway, firing a handgun and threatening to shoot her in the

back as she ran.

Gansbauer's lawyer once again secured a plea deal, with Gansbauer pleading guilty to Class 1 felony aggravated robbery. The other charges were dropped. Sentencing options for aggravated robbery range from four to 15 years. In August 2022, Gansbauer was sentenced to serve six years, minus a little over a year spent in custody while awaiting trial, leaving him to serve just under five years.

He served less than two before being arrested in June 2024 for the weapons charges he is now facing.

A statement submitted by the Sangamon County Sheriff's Office as justification for Gansbauer's recent arrest states that, while conducting a parolee compliance check, officers found a silver Smith & Wesson

.38-caliber revolver in the apartment Gansbauer shares with his girlfriend.

Armed habitual criminal is a Class X felony, the most serious felony level under Illinois law. If convicted, Gansbauer faces a sentence of six to 30 years for that charge alone.

Survivors and victims' families want to see strict sentencing, both to prevent harm to future victims and out of fear for their own safety.

Crystal Page, the older sister of H.P., is the last living family member to fight for justice in her brother's 1993 murder. Both of their parents were diagnosed with cancer and died within three years of H.P., dying 11 days apart from each other in February of 1996. Page said they died of broken hearts.

Sometime before his 2021 charge, Page said Gansbauer walked into a Qik-n-EZ where she was working to use an ATM. To avoid him, she asked her manager to take over operating the register, but she thought he recognized her. Seeing him there caused her an anxiety attack, she said.

"I hope that glass is bulletproof," she recalled thinking. "I feel my brother and my mom above me."

She was not alone in fearing retribution. For Heather Jones, survivor of Gansbauer's 2021 aggravated robbery, it was a tangible concern.

Someone broke into her home after WICS ABC NewsChannel 20 ran a story about Gansbauer's 2021 charges, Jones said. She provided a photo to *Illinois Times* showing red paint dripped on her comforter and in a heart shape on a piece of paper. Jones interpreted it as imitating blood and assumed it was left by Gansbauer's friends.

Jones alleged that members of the Simon City Royals put a gun to her stepson's head after the attack. It was the final straw for her. She later moved out of Springfield.

"They idolize him," Jones said of the Royals.

Both Page and Jones said they hope the judge in Gansbauer's upcoming case will take his past behavior into consideration.

"I would just like the judge to not take my life in vain and let something come of it," Jones said. "I'd beg the judge to not let him out."

Page echoed Jones, asking the state to prevent future victims and allow past survivors closure.

"You [the state] have the authority to protect us from the monster of Michael Gansbauer," Page said. "We need to heal, and Michael needs to be off the streets." □

The solution for oversized zucchini

Try this recipe for zucchini focaccia

Anyone who has grown zucchini in a garden will inevitably end up with a few mammoth squash that seemingly appear out of nowhere, especially after a generous dose of summer rain. Too tough and fibery to sauté or grill, I'd grate the first jumbo zucchinis of the season to use in quick breads, but toward the end of summer most of them would end up getting tossed out to the chickens because honestly, how many zucchini muffins can a person reasonably eat?

Then one day I had the crazy idea to use puréed zucchini instead of water in a batch of focaccia. Although I'm loath to turn on my oven in summer, I routinely make batch after batch of chewy, pillowy focaccia for grilled bruschetta and big-batch picnic sandwiches. If zucchini is 95 percent water, I wondered, could I get away with using it as the liquid component in bread? The answer turned out to be a resounding yes, and from that point on zucchini focaccia became my standard recipe year-round. In spite of my diligent efforts to harvest them when tender and small, I still end up with enough oversized zucchini to purée and freeze in recipe-ready portions to keep me baking bread until the following summer. The procedure is much the same as making a standard focaccia and the finished product has no discernible vegetable flavor or texture. While the raw dough is most definitely a vibrant shade of green, the color mostly bakes out with just little flecks of green remaining visible, reminiscent of savory herb bread.

Once the dough is made and in the pan, this bread becomes a further canvas for garden creativity. It can be kept simple with just a sprinkle of salt, or act as a base for a myriad of thinly sliced vegetables, grated cheese, herbs and berries or orchard fruit such as apples and pears. Raw vegetables such as zucchini (use small ones for topping), potatoes, peppers and onions should be sliced as thinly as possible and tossed with a teaspoon of salt and allowed to sit for at least 30 minutes (this can happen while the dough goes through its second rise) before being squeezed dry in a clean cloth in order to draw out excess moisture and prevent the bread from becoming soggy. Traditional, delicious topping combinations include grapes and fresh thyme, jalapenos and cheddar, zucchini and potato with herbs and cheese, bell peppers with onions and asiago, or pears with blue cheese and rosemary.

Zucchini focaccia

Ingredients:

1 jumbo zucchini

1 teaspoon sugar
1 packet (2 ¼ teaspoons) active dry yeast
5 cups bread or all-purpose flour (or use a mixture of white and whole wheat)
1 tablespoon salt
6 tablespoons olive oil (divided)
1 tablespoon butter
Flaky sea salt for sprinkling
Toppings, if desired, such as thinly sliced vegetables, cheese, herbs, salami and/or fruit

If the zucchini is quite large with mature, hard seeds, scoop them out and discard. Chop the zucchini into large chunks and purée in a food processor. You can also grate the zucchini on the large holes of a box grater. Measure out 24 ounces of the zucchini puree and transfer to a mixing bowl. Any remaining purée can be frozen in zip-top freezer bags for future use.

Mix in the sugar and yeast and let rest for five minutes to proof the yeast (the mixture will become foamy, indicating a healthy, active ferment) and allow the sugar to draw the water out of the zucchini. Add the flour and salt. Mix with a rubber spatula to create a loose,

shaggy dough with no remaining streaks of flour. Pour four tablespoons of the olive oil into a large bowl and swirl it to coat the sides of the bowl. Transfer the dough into the bowl with oil. With clean, oiled hands, pick up the dough and fold it over onto itself two to three times to gently incorporate the oil into the dough. Cover and let rise until doubled in size – about three hours at room temperature or in the fridge for eight to 24 hours. The longer and slower the rise, the more flavorful the finished bread will be.

This bread can be baked in a 9-by-13-inch baking dish or in a rimmed 13-by-18-inch baking sheet. The former will result in a thick, pillowy bread ideal for sandwiches, while the baking sheet will create a thinner, chewier bread perfect for nibbling. Generously butter your pan of choice to prevent the dough from sticking.

Pour the remaining two tablespoons of oil over the dough, and using oiled hands, once again fold the dough over itself two to three times to gently deflate the dough. Tip the dough into the prepared pan and use oiled

fingers to push the dough into the corners of the pan. Cover and let rise for 90 minutes and up to three hours, depending on the ambient temperature. The warmer the temperature, the faster it will rise.

About 30 minutes before baking, preheat the oven to 450 degrees F. Uncover the dough and use oiled fingers to create deep dimples in the dough. Arrange toppings over the dough if using (Be generous as the toppings will shrink while baking.) Sprinkle with coarse salt if desired, then transfer the dough to the preheated oven and bake for 20-30 minutes, until puffed and golden brown. Focaccia with lots of vegetable toppings will take closer to 30 minutes – keep an eye on it and reduce the heat to 425 degrees F halfway through baking if the toppings begin to get too brown. Let the bread rest five minutes after removal from the oven, then turn the bread out onto a rack over a baking sheet to cool. The baking sheet will catch any oil that may drip. □

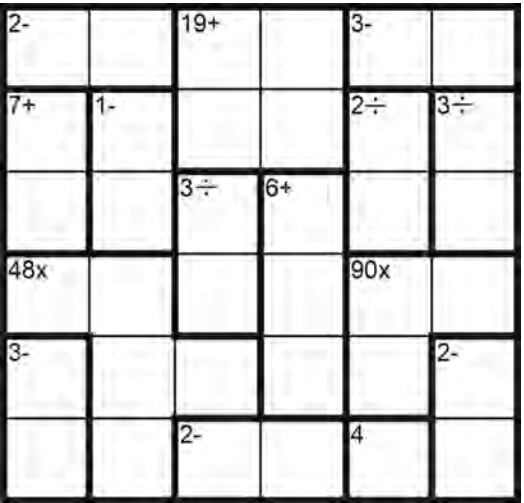

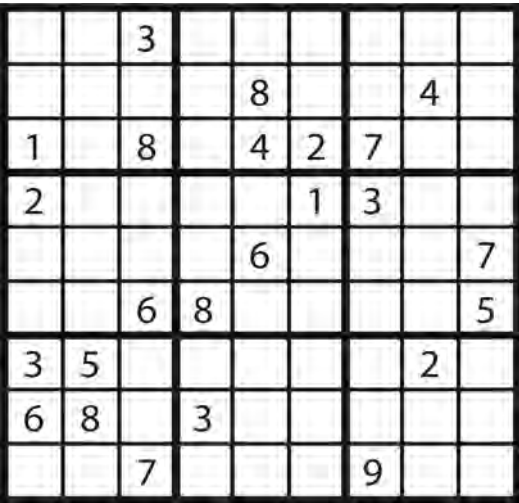
