# Trump's trans ban affects Chatham resident

"We're strong enough to not be allowed in women's sports but we're too weak for the military?"

To Dahlia Dahl, President Donald Trump's ban on transgender people serving in the military – more expansive than the one that eventually took effect during the Republican's first term – is unfair and unwise.

Dahl, 22, a Chatham resident and the daughter of Dave and Corrina Dahl, enlisted in the Illinois Army National Guard in late 2020 to help pay for college. The Glenwood High School graduate and cinema major beginning her junior year at Southern Illinois University Carbondale went through basic training in June 2021 and is a specialist in the East St. Louis-based 1844th Transportation Company, for which she serves as a part-time truck driver.

She began coming out as a transgender woman in 2022 and started her medical transition in January of this year. Dahl filed for voluntary separation from the military to meet a July 6 deadline set by the Trump administration. That way, she can receive an honorable discharge, call herself a veteran and maintain some benefits rather than be removed from the military. Her service with the National Guard was originally supposed to extend until December 2026.

"I signed a contract, and I was willing to see it through to the end, and the government with whom I made the contract is not willing to see it through the end," Dahl said. "And for what? What has changed between the Biden administration and

the Trump administration? Only one thing, and that's who's in charge. I'm the same soldier that I was."

Dahl is one of 12 Illinois National Guard soldiers who have volunteered for separation in response to orders issued by Trump and Defense Secretary Pete Hegseth following a May ruling by the U.S. Supreme Court.

No soldiers or airmen in the Guard have been involuntarily separated in connection with the Trump administration mandate, according to Maj. William "Dutch" Grove, an Illinois National Guard spokesperson.

Trump, as commander in chief, first announced his ban on transgender troops via Twitter in 2017. After multiple court challenges from civil rights groups, and a change that his administration made to the policy in 2018, the orders that went into effect in April 2019 allowed active transgender members of the military to serve openly if they received a gender dysphoria diagnosis before April 2019, according to PolitiFact.

Active members who received a diagnosis after the policy was implemented would have to serve under the gender assigned to them at birth, PolitiFact said. People diagnosed with gender dysphoria after April 2019 or who had already undergone a transition couldn't enlist.

Democrat Joe Biden, who beat Trump in the 2020 presidential election, rescinded the policy in

January 2021.

The new policy, allowed by the Supreme Court to proceed while other legal challenges continue, is based on a Trump executive order that says anyone who is transgender can't serve in the military because being trans conflicts "with a soldier's commitment to an honorable, truthful and disciplined lifestyle." The order also says trans people lack the "selflessness and humility" required for military service.

The Pentagon says about 0.2% of the U.S. military's members, or approximately 4,200 of the 2.1 million troops serving, experience gender dysphoria. The Pentagon so far has said as many as 1,000 openly identifying trans service members have filed for voluntary separation.

Dahl enlisted in the Guard during Trump's first term and never expected him to return to office. She said many of her superiors in her unit have told her the Guard is losing a good soldier.

Dahl said everyone in her unit has known she is trans for several years. The notion that trans service members reduce the military's combat readiness is false, she said. It's not a philosophy that she has felt from her fellow soldiers, and it will further hinder the military's recruitment efforts, she said

Dahl noted that the approximately 4,200 members of the military who could leave because of the ban is more than the number of American troops killed on D-Day, on June 6, 1944, as the amphibious invasion of Normandy, France, began during World War II.

"Donald Trump and Pete Hegseth are willing to part with 1,700 more than those who gave their lives on D-Day because of what? We're weak?" Dahl asked. "We're strong enough to not be allowed in women's sports but we're too weak for the military? My gender dysphoria, my being trans, has not impacted anything I've had to do as a soldier."

Dahl, who wears her hair short, said she has never been deployed in the U.S. or abroad but has participated in required monthly training, summer training and fulfilled other basic responsibilities of being a soldier such as maintaining fitness, firing her weapon and not taking illicit drugs. The uniform is the same for male and female soldiers.

She is technically on administrative leave from the Guard – receiving pay but not participating in training or deployments – while an investigation of her and others' applications take place to make sure they are not making up their transgender status to get out of the military.

Dahl said her commitment to the Guard will

result in her college tuition being paid at least through the current school year. She would like to work in the film or television industry after graduation and said she may have to come up with tuition for the fall 2026 semester, which would be her last before graduating with a bachelor's degree.

She said she has been encouraged by comments from state Rep. Kelly Cassidy, D-Chicago, who is working on potential legislation to provide tuition waivers for Illinois university students whose scholarships are being affected by Trump's actions.

Dahl said she was well aware of Trump's views on trans people. Still, when the trans ban began to take effect this summer, she said it added to an already devastating year for her personally. Her fiancé, a 24-year-old genderqueer person from Virginia whom Dahl met on the internet, died in a car crash there on March 18.

"So this was more like another block in the Jenga tower that was falling," said Dahl. "I think it is unfair that I'm being removed from the military for something that was not a problem ... and it's happening to other people," she said. "And I don't like to have to choose between being a woman and being a soldier." □

#### Editor's note -

On March 5, 1770, British troops were patrolling the streets of Boston, where colonists resented the presence of armed men in their city uninvited. Rocks and verbal abuse were thrown at the soldiers, whose tempers flared and military weapons were fired, resulting in deaths of civilians. The event became known as the Boston Massacre, which was followed by courageous statesmen demanding, and getting, the withdrawal of British troops from their city. That situation is not the same as Illinois faces, but it is a reminder that resistance to government overreach can change history. With Texas National Guard troops preparing to occupy Chicago, Gov. JB Pritzker has made clear they are unneeded and unwanted. At his Cabinet meeting last week, President Donald Trump said Pritzker should approve sending in the National Guard, but added, "Not that I don't have. . . the right to do anything I want to do." To which Pritzker responded on social media, "No, Donald. You can't do whatever you want." – Fletcher Farrar, editor

# A compassionate kind of care

SIU medical students and residents experience simulated challenges of poverty

For the second year in a row, Southern Illinois University School of Medicine resident physicians and medical students spent a few hours experiencing some of the nonclinical challenges associated with being a patient in poverty. Roughly 14,000 people live below the federal poverty line in Springfield, according to the most recent census data.

Almost 60 SIU residents and medical students participated in the poverty simulation on Aug. 27, where participants were given unique scenarios, sets of tasks and a randomized allotment of fake money to complete said tasks, such as filling prescriptions or getting their child registered for school. The simulation, aptly held at the Memorial Learning Center, had a number of community health workers playing various institutional roles the participants had to interact

with – such as a bank, community shelter, the Department of Human Services, Springfield Police Department and others.

Josh Sabo, executive director of Heartland Housed, told *Illinois Times* his organization reviewed some of the scenarios drawn up by SIU's Office of Community Health Work. He emphasized that such a simulation could benefit many kinds of health care providers.

"I'm just super impressed by the level of detail that's gone into this as an exercise, especially for health care providers," he said. "There's so much about that job that's very complex, but I think it's exciting to see the work that's going on to see health care as one important component of the whole person."

It's a stark contrast to the hundreds of hours of clinical work completed in medical school, where future doctors study case examinations and medical procedures. Sabo said the simulation could be something he tries out with his own staff.

"One of the things I'm thinking about as

I look across this room is how beneficial this, or something like this, could be for the folks that work in our system day in and day out. I think anything we can do to elevate the level of empathy is so, so important," he said.

Some participants had to wear headphones that played near constant voices or sounds made out to simulate auditory hallucinations that are most commonly associated with schizophrenia or PTSD.

An *Illinois Times* reporter wore a pair of headphones for about 20 minutes and noticed the audio would sometimes add in bits of real music, including "Soul Man" by Sam & Dave.

All participants had unique circumstances for the simulation that were inspired by real situations observed by SIU community health workers.

"They all have different situations and scenarios that they start off with, so some might be single, some might have a family. If you look around, someone might be in a wheelchair or with kids," said Haley Klein, a

community health worker who was playing the role of a pharmacist for the simulation.

The entire process was simulated through four 20-minute "weeks" with varied errands that could be difficult without a car and money for gas or transportation.

"They'll also get a new scenario for the week – they will still be the same person but something might have happened: they might have been evicted, especially if they haven't paid their rent, they might have to get groceries that week," Klein said.

Sarah Knowlton, a doula and community health worker, said she was impressed by the scale of the simulation.

She said it was important to "not have the residents and students see their patients as just their medical problems but the whole of what they go through."

Knowlton, who was playing the role of the administrators at a school and day care, noted how it may not be an option for every medical school, but all should consider more holistic elements of learning. "This takes a lot of time to put together, so I understand not every school may have the resources or the time to do it, but I do think there needs to be education about what actual people in the community go through and talk about these issues with the residents and the students," Knowlton said.

Resident doctors seemed to appreciate the programming. Dr. Taiwo Akinsoji, a resident family physician, said she benefited from last year's poverty simulation and decided to attend this year's as well.

"I'm more proactive with referring (patients) to social workers, providing them resources like calling the pharmacy for discount programs," Akinsoji said. "I'm more involved when it comes to my patients."

Erin Jones, SIU's director of community health, reminded participants that real patients who can't afford to pay for their prescriptions could be referred to Kumler Outreach Ministries.

Dr. Martin De Venecia, a resident family physician, was given a scenario where he was a single parent with two babies. He said it was "pretty difficult."

"This has helped us put into perspective how many tasks our patient population has to go through to manage everything," De Venecia said.

Dr. Vincent Tran, also a resident physician practicing family medicine, said the simulation provides valuable insight for doctors but is still far from the real struggle some patients experience.

"In real life, it's probably a lot harder than what's actually being placed into the simulation," Tran said. "Like this aspect of getting a Social Security card takes a lot longer and such."

# **Learning trades and theology**

New Catholic college welcomes all-male freshman class

A new college began classes Sept. 2 in Springfield with 24 students from across the nation learning building trades – and theology.

The motto of San Damiano College for the Trades is "Rebuild my church," which can be interpreted in a variety of ways, from the physical rebuilding of religious edifices to the spiritual rebuilding of people within the Catholic faith.

The college is the brainchild of Bishop Thomas Paprocki, one of the most prominent conservative prelates in the U.S., and is unapologetically traditional in its outlook.

"The Church of San Damiano is where St. Francis heard Jesus say, 'Rebuild my church,'" college President Kent Lasnoski said. "And so, we felt like that should be the motto of the school. We start with physically (rebuilding the church) and then we move into all the other elements. I think Bishop Paprocki is a holistic thinker. I think he would want to say that what we're doing here at San Damiano is a part of the larger project, which is ultimately about bringing people together in Christ."


The college is on the campus of the former Chiara Center, located on the grounds of the Hospital Sisters of St. Francis in Springfield. The Franciscan Brothers of the Holy Cross operated the St. James Trade School there from 1928 to 1972.

The three-year program includes technical instruction and on-the-job training in one of seven trades, and San Damiano is seeking approval from the Illinois Board of Higher Education to offer associate's degrees in theology. The school is working in partnership with another Catholic school, Quincy University, to offer online classes in the classics for credit-bearing coursework.

The students attending the college are all Catholic and many have not followed a traditional educational path.

"I was homeschooled," said John Falter, a 19-year-old from Wisconsin. "A lot of guys here were homeschooled. "I think that in public schools the quality of education there is very low and contains a lot of things that are contrary to church teaching and morality. And unfortunately, a lot of Catholic schools aren't that much better."

Falter says he aspires to be a carpenter.
"I like carpentry because I love making stuff," he said. "I like making things that look

good and are useful and will last a long time because of quality work."

Henry Trainor, a 19-year-old from Texas, also was homeschooled but worked full time at a Chick-fil-A for a year before entering San Damiano. He said a traditional college environment did not appeal to him.

"I've seen my siblings go to traditional colleges," he said. "Whenever they came back, they changed a little bit. I wouldn't say in a bad way, but they're different. That was part of the reason I thought college might not be something I want to go do – a traditional one. But I also know, there's a lot of things changing in the world and I want to get a good, secure job working with my hands. This is something that would definitely be useful to a lot of people. The theology and all the things that I've been learning, I feel like they would be very constructive to introduce into my life."

John Lawless, an 18-year-old student from Oklahoma, said he chose San Damiano because of its promise that students will complete their studies debt-free.

"You graduate debt-free, you learn a trade and you also have some liberal arts (taught) in the seminar method of learning," he said. "Everyone is in the circle, and the professor is leading the conversation. But everyone gives their two cents. It's not a full-on lecture. I really enjoy that."

San Damiano requires three years of schooling. In the final year, students would apprentice 40 hours per week in their chosen trade. The student body is entirely male.

Lasnoski said the school anticipates admitting women after it has been open several years. But he said there is a particular need in society to reach young men, who are not as likely to pursue higher education.

"I read somewhere that a young man basically has three options when he graduates high school: join the military, go to college, join the workforce," said Alex Hurla, a 29-year-old Marine Corps veteran with a bachelor's degree from Kansas State.

"I've done all three of those, and I'm grateful for each experience. I got a lot out of each one. But I still feel like there was a piece missing to become the man that God is calling me to be. I've been in the liberal arts. I enjoy that. I like the trades, too. And I especially like having those from the Catholic perspective. Being able to combine the works of the hand and the works of the mind under a Catholic umbrella appealed to me."

The school will offer training in a variety of trades such as carpentry, plumbing and electrical contracting.

Lasnoski said although there is a shortage of people in the trades, it has been relatively easy to find experienced tradesmen willing to teach.

"In the next 10 years, half of the trades workforce is going to be retiring," he said. "(But)there's a lot of interest in the community (in teaching) among not only those who are retired from the trades, but also those who are currently still working in the trades."

# U of I to begin drilling test well this winter

Cost and technology will prevent CWLP carbon storage for Dallman

Dr. Kathleen Campbell spoke in front of the Springfield City Council in June to express opposition to plans for drilling of a test well by University of Illinois Urbana Champaign's Prairie Research Institute in partnership with City Water, Light and Power. Campbell, an emeritus professor at SIU School of Medicine and a Glenarm resident, lives roughly 5 miles from the test site – a rural plot off Pond Road in Pawnee.

"I urge you to postpone, and preferably reconsider, the installation of this well," Campbell told the council. "Though we are not CWLP customers, my neighbors and I are expected to bear the risk of a future carbon sequestration project. Experience tells us those risks are real."

In simple terms, the process of carbon sequestration involves taking carbon dioxide – either from the atmosphere or captured directly at the site of emissions from power plants like CWLP's Dallman – and inserting it thousands of feet underground.

The UIUC project at hand does not involve building a pipeline or injecting carbon into the earth, although it would provide information needed to implement future carbon sequestration projects. The test well will drill deep into the ground for samples and research.

The scientists working on the project say drilling the test well will provide valuable information about the geology of the area, including potential uses of the region for geothermal energy, natural gas storage and oil extraction. It will also provide information about potential sites for any future sequestration projects in the area, should CWLP or commercial entities seek to drill an injection well.

Data collected through the project "will be used to determine the feasibility of geologic sequestration of 50 million tonnes or more of carbon dioxide that will be injected over 30

years," according to a pre-drilling site assessment obtained through a public records request.

Many experts consider carbon sequestration to be an important piece of the puzzle in mitigating global warming.

#### The fight for net zero

Carbon dioxide emissions are released into the atmosphere primarily by burning fossil fuels – coal, oil and gas. Carbon dioxide is a greenhouse

gas, meaning that it traps the sun's heat in the atmosphere, causing changes in weather patterns. The impact can already be seen, with more intense storms, droughts, wildfires and rising sea levels.

Reaching net zero emissions means reducing carbon dioxide emissions to a low enough level that emissions can be absorbed by natural systems or other mechanisms for removing carbon from the atmosphere. The Intergovernmental Panel on Climate Change and other scientific organizations have identified carbon storage as one way to move toward that goal.

Campbell, who sought the cancellation of the test well, is not a climate change denialist. Rather, she wanted the City Council to consider the potential risks that come with the transportation and injection of carbon.

Transporting large quantities of carbon most often requires pipelines. If pipelines break, they can release carbon back into the atmosphere, causing severe health risks to those near the leak,

including suffocation from the lack of oxygen. When a pipeline burst in Satartia, Mississippi, in 2020, it hospitalized dozens of residents and caused 250 others to evacuate. The gas also prevents combustion engines from functioning, hindering emergency response in the event of a major leak.

"We're dealing with risk and doing so under the guise of a climate solution," said Pam Richart, co-founder of the Champaign-based Eco-Justice Collaborative, which has fought to stop pipelines and injection projects.

Other energy solutions, like wind and solar, are more viable and less expensive to implement than carbon sequestration, according to Richart and other experts interviewed.

#### 'Little viability' of storage for Dallman

Seismic testing, the last step before drilling the test well, was set to end late last month. UIUC scientists said they had not yet procured a rig, but that they expect to begin drilling the test well this winter.

The well drilled by UIUC and partners this winter will not be used for any future carbon storage projects, according to assistant reservoir geologist Kendall Taft. The test well will not even be drilled in accordance with the Environmental Protection Agency's standards for a Class VI well – the type needed for carbon sequestration.

"That kind of confirms it will never be an injection well," Taft said.

Although CWLP could theoretically pursue carbon sequestration to offset emissions from Dallman 4, CWLP spokesperson Amber Sabin said there is little chance of that happening before Dallman shuts down in 2045 in accordance with the Illinois Climate and Equitable Jobs Act. To stay open, Dallman 4 would need to achieve a 45% reduction in emissions by 2035 and be carbon neutral by 2045.

"There is little viability of storage projects based on that timeline," Sabin said in an email.

"There currently isn't any technology to do that. CWLP does not believe that a full-size carbon capture facility could be built that would meet CEJA requirements nor could it be done without a new significant source of external funding." □

# Not the usual rally crowd

The breadth of invited attendees at the event organized last week by Gov. JB Pritzker really stood out for me.

The event along the Chicago River was designed to publicly warn President Donald Trump not to send National Guard or regular military troops into the city. The usual collection of Democratic politicians, union leaders and several anti-violence and progressive activists were on hand and several spoke.

But what made this rally seem different was the presence of people who aren't usually at these things.

On the list of attendees were six university and college presidents or chancellors, including University of Illinois System President Tim Killeen and Illinois Institute of Technology President Raj Echambadi.

Several business types also showed up.
Derek Douglas, president of the Civic
Committee and the Commercial Club of
Chicago, called the possible deployment
"unprecedented and unwarranted" during his
speech.

"Deploying federal troops or federalizing the National Guard without engaging state and local government, business, philanthropic and community leaders – the ones who understand Chicago's needs and are on the ground working daily to make our city safer – is unprecedented and unwarranted." Douglas said.

The Commercial Club of Chicago is not a bunch of lefties. It was founded in 1877 by many of the city's wealthiest people. Fifteen years ago, the Civic Committee was best known for demanding that public employee pensions be reduced.

Billionaire philanthropist James Crown formed a public safety task force in 2022 within the Civic Committee. Crown's task force set a goal of reducing the number of murders from 805 the year before to below 400 by 2029. That looked impossible at the time, and when Crown died the following year, hopes sank.

But Crown's original goal appears to be easily within reach this year, four years ahead of schedule. The murder rate has been declining both in the city and around the country for the past couple of years, at least partly because of a big surge in federal funding of the sort of antiviolence programs advocated by Crown. That federal funding has now been cut off.

Douglas admitted during his speech last week that even with the progress, Chicago still "has a ways to go" on violent crime. He also said, "there is a critical role for federal support that could benefit our city," but that what they need is "aligned action."

"What we don't need," Douglas said, "are

disruptions to our economy and our businesses. Active duty military patrolling the streets of our city sends the wrong message and risks slowing our economy and disrupting the progress we've made together. It will impact businesses' bottom lines and ability to operate efficiently. It will impact tourism and employees getting to their jobs. It will impact morale."

Douglas concluded his speech by saying: "The kind of sweeping, uncoordinated, indiscriminate action being threatened sets a dangerous precedent, and we stand with our city and all Chicagoans to encourage the administration to productively engage with us, to help us continue to make progress on this critical issue."

Others in the business community attended and contributed written statements.

"We have seen how the sudden deployment of federal troops in other cities can needlessly disrupt communities and businesses, hurt local economies, and deter tourism," said Chicagoland Chamber of Commerce CEO Jack Lavin. "The best path forward is partnership and collaboration. If the federal government wants to work constructively with local leaders and community partners, we welcome that engagement to keep making progress toward a safer, stronger city."

Like Douglas, Lavin said he would welcome "constructive engagement" from the federal government.


Civic Federation of Chicago President Joe Ferguson claimed sending in the troops is not "legally justified," adding, "investment and partnership is what is needed to move this city and state to a better future."

McPier CEO Larita Clark said none of her convention center's clients "have expressed the need for federal intervention in Chicago." She said her team had met recently with nearly two dozen of the convention center's largest clients. "What we heard from them was that public safety concerns in Chicago had actually lessened in the past year."

This is not meant in any way to lessen any of the other speakers and attendees, some of whom made strong arguments against a possible federal military deployment. It's just that I wasn't all that surprised that they showed up. And, yes, the biz types are all somehow politically connected in various ways.

But they're not the usual rally folks and, like the other speakers who got most of the news media's attention, their messages were worth a look. Also, I think Jim Crown might've been proud.

# **Bringing back working-class Democrats**

Many abandoned the party for Trump. Can they be persuaded to return?

Larry Acton was once a Democrat but today, like many rural, working-class voters, the Springfield man supports Republicans. "The party changed – not me. The Democratic Party has become elitist and focused on issues that have nothing to do with how I live my life," the 61-year-old livestock feed salesman said.

Acton reflects a national trend – rural, working-class voters who are abandoning the Democratic Party.

Springfield native and former U.S. Rep. Cheri Bustos recently issued a report examining the exodus of working-class people from the party that was once synonymous with blue-collar laborers.

The report, written by Bustos and Monmouth College faculty member Robin Johnson, is a collection of interviews with 22 Democratic officeholders in working-class, "toss-up" Midwestern districts that can be won by either party.

In all the districts the percentage of college-educated voters was less than the

national average of 35% and the candidate received less than 60% of the general election vote, indicating significant Republican opposition. Just six Democratic members of Congress in the Midwest meet these criteria, according to the report.

"We issued a report right after the 2016 election, after the 2020 election and now after the 2024 election. Each time we have decided to only focus on Democrats who win in the toughest districts in the center part of the country," Bustos told *Illinois Times*. "We want to focus on the people who win every election and how they won. And what they did that was different."

Bustos expressed frustration with the quality of public commentary about elections and wanted her report to be different.

"If you watch some of these political shows or (listen to) some of the podcasts, many of them have people who ran or served in high-level positions but then ended up losing – and then they go on to be political pundits."

#### It's the economy, stupid

Bustos said a key takeaway from the report is that successful Democratic candidates in working-class districts need to focus on economic issues and steer clear of cultural fights such as transgender rights, abortion or gun control.

"They don't focus on social issues because that is what has gotten the Democratic party in so much trouble," she said. "People in these swing districts want to know that you're looking out for them, whether you're Black or white or brown or anything else. It is not a check-the-box mentality from these voters. They don't like the segmentation. If you're focusing on any one group, they end up feeling left out. They just want somebody who's going in and fighting for them and making sure that their families can do well."

Her view was echoed by James Carville. In an interview with *IT*, the chief political strategist for President Bill Clinton said the Democratic Party's brand has been damaged in rural areas.

"I don't think you can overestimate the damage that the language of the identity left has (done to) hurt rural Democrats. ...

Language really took a toll on the brand of the party, and you know, thank God people are pushing back on it. I'll give you an example: 'Defund the police.' They are the stupidest three words in the history of the English language. Only 15% of the party (liked) this language, but its damage to the general party brand was much greater. This was an idiotic idea, and everybody knows it now. And it's going to take probably this (election) cycle to wash most of the stench off of us."

Carville is known for coining the phrase, "It's the economy, stupid," during the 1992 presidential election. Incumbent George W. Bush had 90% approval ratings in March 1991, days after the ground war in Kuwait, but by August 1992, 64% of polled Americans disapproved of his job performance. Carville stressed that economic issues were the most important factor for voters, and Clinton's campaign used the growing concerns of a

recession to successfully unseat Bush.

David Axlerod, the chief political adviser to President Barack Obama, agreed with this analysis, telling *IT*, "Today, these economic issues are paramount to most working-class people in small towns and large. And there's a fundamental feeling that the system has failed. That it's not fair. That it's rigged against everyday people. I think people are looking for fundamental change and fundamental reforms that will ensure that their voices and their interests are heard and represented and these big corporate interests won't dictate the agenda in Washington.

"They've heard a lot of rhetoric about these things for a long time, but it doesn't feel as if it's getting better. ... Donald Trump is tearing down the status quo in Washington. The destruction of some of the things that he's tearing down will have long-term and negative implications for these communities, but people are not looking for the Democratic Party to run candidates of restoration. They don't want to go back. They want to go forward and build something better."

Axlerod said urban Democrats working campaigns in rural districts often approach elections either as "missionaries" trying to convert folks to their way of thinking or "anthropologists" trying to figure out why rural voters believe certain things. Both approaches alienate rural voters who find them condescending and elitist, he said. Instead, he contends they need to collaborate, listen to

and learn from rural constituencies.

Missouri state Rep. Jeremy Dean, one of the politicians profiled in the report, stressed the importance of creating opportunities "not just for the wealthy." But he spoke in terms of helping people, not taxing them. "It's not an 'I hate rich people' mindset," said Dean, whose district is 82% working class. "It's an 'I want everyone to be rich' mindset."

#### **Avoid identity politics**

In the report, Iowa state Rep. Josh Turek, a Democrat whose district is 85% working class, said its critical for Democrats in rural districts to focus on local issues. Turek, who won in a county that President Donald Trump carried by 20 points, stressed that successful candidates steer clear of "culture war issues or identity politics."

Professor Johnson, who wrote the report with Bustos, acknowledged that some in the party won't agree with this approach. But he noted that working-class voters have been a critical part of the Democratic coalition since President Franklin Roosevelt's New Deal in the 1930s. And he added it is critical to win these voters back, if it wants to be a majority party.

"These candidates, for the most part, have got to win Republican votes. They have to win Trump voters. We have an element to the party that doesn't want to listen to folks that have to do that. Well, (if you don't) you're going to be in minority status for a long time.

In a lot of these districts, people have to win over Republicans and Trump voters and they have done so successfully. So, we put the spotlight on them."

Miles Coleman, associate editor of *Sabato's Crystal Ball* at the University of Virginia Center for Politics, told *IT* it goes beyond what Democrats choose to emphasize. He said the party needs to be open to fielding candidates in rural areas who are more conservative on social issues than their urban counterparts.

And this does not always resonate with urban Democrats.

"In some of these (election) post-mortems, you see some talking head or some of the kind of Democratic thought leaders online talk about how we need to moderate some of our stances. The thing they hear back from the grassroots often is, 'What group are you going to throw under the bus to moderate?' That's something that the trans community, sadly right now, feels like they're kind of bearing the brunt of."

Carville agreed that the trans rights debate has become an albatross for Democrats, particularly those in rural areas.

"It got ginned up," he said. "When we were using phrases like 'defund the police,' or 'reparations' or that kind of stuff, people were willing to believe other things about Democrats like we wanted to have males running in girls' track meets or we wanted to have gender-neutral bathrooms. ... as we recede from this identity stupidity, it's going to become less and less potent. ... This was a giant mistake. There's no other way to say it."

So, why are working-class, rural voters increasingly supporting Trump?

Johnson said much of it has to do with the president's blunt rhetoric.

"They like Trump because he talks in a very plain language, and he addresses issues that they care about. I go back to 2016 when he ran for president. I listened to him on satellite radio, and he was talking about trade and infrastructure. I remember thinking, that's a message that's going to appeal to a lot of blue-collar voters. He paid attention to issues that people out here care about. There's a lot of criticism of his tariff policy, but the effects of these tariffs, so far, have not been as bad as what economists said. It shows that he's trying to stand up for domestic industries, which, if you go to these working-class areas, that's what a lot of people feel that we need to do."

Jim Nowlan, a retired University of Illinois political science instructor, was more blunt.

"Trump is the evil genius who can appeal to small-town and rural folks. He says, 'We're going to solve the Ukraine problem on Day One.' Well, you and I might laugh at that. But to the Trump base and to many Americans who find something attractive in Trump, they understand that he's not going to solve it on Day One, but he's going to try to solve it on Day One. ... I think of myself as a moderate

Republican. But I just can't abide Trump. I'm afraid that the Democratic Party doesn't have a message that is attractive to rural voters."

#### No litmus tests

The concerns of voters in rural areas are distinct, Bill Houlihan, head of the Sangamon County Democratic Party, said.

"Let's be honest, people in rural districts are more conservative. They're more moderate. Being pro-choice is not a top 10 issue for them," he said.

To win in rural areas, the party may need to support candidates who are more conservative on social issues than their urban peers, he said.

"If you're a (Democratic) candidate for office and you're trying to win the majority, there should not be a litmus test. I just don't believe there should be on any issue. I don't think it helps recruitment. It scares some people away. They don't understand it, so they decide not to run," Houlihan said. "But those that decide to run need room to have some flexibility. If they are 70% right on every issue, man, that's a hell of a lot better than a Republican is when you go to try to pass a piece of legislation."

Former U.S. Rep. Glenn Poshard, a southern Illinois Democrat who ran unsuccessfully for Illinois governor in 1998, said the party has to be more open to socially conservative candidates if it wants to prevail in rural communities.

"There are deeply felt religious beliefs around issues. If you start saying to people, 'You can't be a Democrat unless you hold to this particular thing,' you're asking people to desert a basic tenet of their faith. To do that, people are going to say, 'Wait a second, what's more important to me here? My faith in my church? Or the political party?' And when you force people to make those kind of choices, they're going to desert you."

Poshard, who was the last pro-life Democrat to be nominated for Illinois governor, said abortion rights are a good example of an issue where many voters feel forced to choose between their religious beliefs and the Democratic Party.

He said the party needs to move away from a litmus test for candidates on such issues.

Axlerod agreed, noting that Franklin Roosevelt passed the New Deal with a coalition of Southern segregationists, Northern unionists and Northern liberals.

"They were very much unified by economic issues but had vastly different opinions on those very important fundamental matters," he said.

Axlerod added, "It is a losing proposition to demand complete ideological purity on cultural issues and any issues other than the most fundamental, which is that everyone who wants to work hard deserves a fair shot in this country to get ahead and share in its prosperity and growth."







# Chefs solve perishable produce problem

At Prairie Fruits Farm and Creamery's Caprae Restaurant in Champaign, we have developed close relationships with our farmers. It's truly a two-way street. Being a farm-to-table restaurant, our menu is driven by what our farmers can provide for us. Often, they go out of their way to accommodate our needs. In return, if they have perishable products in excess of their orders, we will take them off their hands as a courtesy.

Recently, we accepted a delivery of a large amount of shisito peppers and both Japanese and fairy tale eggplants. They weren't part of the current menu and were occupying valuable space in our produce cooler. I'm always the first one in the kitchen every morning, and I received the following text message from our executive chef, Garron Sanchez: "Do you have any ideas of what to do with the eggplants and shishitos we have? Maybe we can do a special. Eggplant can be a tough sell. If we put enough cheese and sauce on it, they'll usually buy anything, LOL!"

The shishito peppers were easy. Shishitos are small, mild peppers (though one in 10 can be hot). They are best prepared simply. Place them on a lightly oiled griddle or skillet and cook until they are blistered. Sprinkle with a little flaky salt. Give them a squeeze of lemon and serve with citrusspiked aioli or mayo.

The eggplants took a bit more thought. The long Japanese eggplants became eggplant involtini, an Italian-American dish also known as eggplant rollatini, which translates to "small roll or bundle" in Italian and features cheese and sauce. For the tiny fairy tale eggplants, I opted for miso-glazed nasu dengaku, a popular drinking snack in informal Japanese bars.

The eggplant presented two challenges. Its flesh rapidly browns after cutting due to an enzymatic reaction to oxygen and it tends to become mushy when cooked. Applying vinegar to the cut surfaces helps by lowering the pH, which in turn inhibits the browning enzymes and slows the breakdown of pectin.

At Caprae, we offered the blistered shishitos and miso-glazed fairy tale eggplants as appetizers, and the involtini as a vegetarian entrée. Happily, all my "specials" sold out, freeing up valuable cooler space!

#### **Blistered shishito peppers**

Serves four as an appetizer.

Ingredients:
½ pound shishito peppers
1 tablespoon avocado or grapeseed oil
Lemon wedge, for squeezing
Flaky sea salt, to taste

For the dipping sauce: ½ cup mayonnaise 1 garlic clove, grated ½ tablespoon lemon juice Salt and pepper, to taste

#### Preparation:

In a small bowl, stir together all the dipping sauce ingredients.

In another bowl, toss the peppers in the oil. Preheat a cast-iron pan or griddle over mediumhigh heat. Add the peppers and sear until they are blistered, for about two-three minutes. Turn over and sear the other side. Transfer to a bowl and sprinkle with lemon juice and salt. Serve warm with the dipping sauce.

# Involtini di melanzane – eggplant involtini

Serves four as an entrée.

Ingredients:
4 Japanese eggplants
1/4 cup distilled white vinegar
1 teaspoon kosher salt
1/4 cup neutral oil

For the tomato sauce:

1 28-ounce can San Marzano whole peeled tomatoes

5 tablespoons butter

1 medium yellow onion, peeled and halved A pinch of salt

For the filling:

8 ounces fresh chèvre (goat cheese) ½ cup pine nuts, lightly toasted

1/4 cup raisins, soaked in hot water until plump,

then drained

4/4 cup extra-virgin olive oil, plus more for brushing
the expolant slices

the eggplant slices
2 tablespoons panko or breadcrumbs

1 garlic clove, minced

Zest of 1 lemon

1 tablespoon mint, finely chopped

2 tablespoons flat-leaf parsley, finely chopped

1 large egg

Salt and freshly ground black pepper

#### Preparation:

Remove the stems from the eggplants and slice them lengthwise into ¼-inch pieces. Arrange the slices on a rack over a sheet pan, then brush both sides with vinegar and sprinkle with salt. Let sit for one hour.

To make the sauce, combine the tomatoes (with their juices), butter, and halved onion in a

saucepan. Season to taste with salt. Place the pan over medium heat and bring the mixture to a simmer. Cook uncovered for 45 minutes, stirring occasionally and mashing the tomatoes. Discard the onion halves.

Preheat the oven to 375 degrees F.

In a large bowl, combine the chèvre, pine nuts, raisins, ¼ cup extra-virgin olive oil, panko, garlic, lemon zest, mint and parsley. Beat the egg and stir it into the cheese mixture—season with salt and pepper to taste.

Thoroughly dry the eggplant slices. Brush them with oil and arrange them on a parchment-lined sheet tray. Roast for five-eight minutes, or until softened.

Once cooled, spread the cheese mixture evenly over each eggplant slice. Tightly roll them up and arrange them snugly in a small baking dish. Spoon the tomato sauce around the roll-ups.

Bake for 20 minutes, then remove from the heat and let stand for 10 minutes before serving.

#### Nasu dengaku - miso-glazed eggplant

Serves eight as an appetizer or four as a side dish

Ingredients:

8 fairy tale eggplants

1/4 cup distilled white vinegar

1 teaspoon kosher salt

1 teaspoon sesame oil, plus more for brushing the eggplants

2 tablespoons white or yellow miso

1 tablespoon mirin

1 tablespoon maple syrup

Furikake or toasted sesame seeds, for garnish

#### Preparation:

Remove the stems and cut the eggplants in half lengthwise. Using the tip of a small knife, score the cut surface in a cosshatch pattern. Brush with vinegar and sprinkle with salt. Let sit for 20 minutes.

Preheat the oven to 400 degrees F.

Thoroughly dry the eggplant slices. Brush with sesame oil and arrange them on a parchment-lined sheet tray, cut side down. Roast until the skin begins to shrivel and the flesh is slightly softened, about five to eight minutes. Remove from the oven and preheat the broiler.

Meanwhile, in a small bowl, whisk together the miso, mirin, maple syrup and sesame oil until smooth.

Remove the eggplants from the oven and brush the cut sides evenly with the miso glaze. Return to the oven and broil until the glaze begins to bubble, about one minute.

Transfer to a platter and garnish with furikake or toasted sesame seeds.  $\square$


