## **Banning printed materials**

IDOC seeks emergency ruling, citing contraband crackdown

An emergency rule being implemented by Illinois prisons may soon deny prisoners access to letters, cards and books sent to them by family members.

Department of Corrections officials are concerned that drugs such as fentanyl are being smuggled into prisons through inmate mail. But critics say the measure is overtly cruel and will do little to stem the flow of narcotics into penal institutions.

"The real question is: how does the contraband get into prisons?" said Jennifer Vollen-Katz, executive director of the John Howard Association, a Chicago-based prison reform group.

She said the Illinois General Assembly recently approved a study to determine how illicit drugs are entering penitentiaries. But Vollen-Katz noted the prison system is now taking drastic and harmful action before any data has been collected.

The emergency rule allows prison officials to electronically scan letters and cards and email their images to tablet computers issued to inmates. Books could no longer be sent directly from families to their loved ones behind bars.

"When you are in prison, you are in a controlled environment and sometimes some of the prison guards take advantage of that and use their power to work against you," said Lynard Joiner, a Springfield man who served 17 years in federal prison. "A physical letter and physical pictures mean more to you than something



electronic. The pictures mean a thousand words. That's something you can hold on to – a birthday card, something your kid made you. We live for those letters in prison. You love to hear your name called at mail call. Now that they are doing it electronically, it's just not the same."

Typically, new administrative rules must go through a public hearing process before a legislative commission: the Joint Committee on Administrative Rules, or JCAR. Opponents and proponents are allowed to testify about the proposed rules and then the commission votes.

But the Department of Corrections is sidestepping the usual process by declaring an emergency – when one doesn't exist, Vollen-Katz said. Instead, the emergency rule will be presented to JCAR Sept. 16 in Chicago. But opponents will be prohibited from testifying because it is being presented as an "emergency."

"We are concerned about them filing this as an emergency rule when there's no evidence to suggest that there's an emergency," she said. "There is no evidence or data to suggest that the numbers (of prison drug cases) have gone up or that the situation has changed. There haven't been more people exposed or more medical interventions."

In an emailed statement, IDOC spokeswoman Naomi Puzzello said, "The Illinois Department of Corrections' top priority is the safety of staff, individuals in custody and all who enter our facilities. In recent years and on a continuing basis, IDOC has seen an increase in incidents involving chemical-laced paper being introduced into facilities. To address this ongoing threat, the Department has filed an emergency rule in an effort to gain the ability to implement mail scanning as part of a broader, multi-pronged strategy to prevent dangerous and illegal substances from entering correctional facilities."

Joiner, who now leads a program helping exoffenders reintegrate into society, said it appears the state agency is ignoring the most obvious source of illegal drugs in prison: staff members.

"Believe me, they have got it wrong. Drugs are not entering prison through the mail. There are several other ways that drugs get into a facility. During my time in incarceration, I never got a piece of mail that they had not opened and read. ... So how are drugs getting into the facility? You have to look at staff. They have more ways of bringing it in than we do because we are locked up."

Katrina Baugh, the Illinois consultant for the prison-reform group FAMM, said this new rule erodes the ties between those serving time and their families

"The most important thing for most people who are incarcerated is their relationship with their loved ones on the outside," she said. "And most of those people have those relationships hindered greatly by distance. Many folks live hundreds of miles away from where they're held in captivity. So regular meetings are not an option. It's very rare that people get visits from family or loved ones. So, holding something that they held and wrote for you is the closest thing to a real connection that most people have most days. To take this away feels cruel."

Her view was echoed by Julie Anderson, outreach director for the Restore Justice Foundation, a reform group dedicated to developing less punitive but more effective consequences for offenders.

She has a son who served 27 years in Illinois prisons for a Chicago homicide committed when he was a juvenile.

During prison visits, she routinely brought books for her son to read after they were vetted by staff to ensure they did not contain contraband. This practice could end under the new emergency rule.

"My son had a love of reading. I always thought that saved him. It really did. But this also affects educational materials. There are several colleges that do courses and depend on the mail," Anderson said. "The primary source of drugs coming into prison is not through the mail. When we spoke with the DOC, all of them have admitted this won't get rid of the problem. I don't see them taking correctional officers, contractors or whoever works there and saying, 'You can't bring in a piece of paper.' The problem (of drugs) needs to be addressed, but this isn't the solution."

This upcoming 50th anniversary of Illinois Times has us digging deep into the archives, call it IT archivology. Here's an issue from May 16, 1991. Things were so different back then. A cartoon by Bob Waldmire showed a limo with VIPs, one balloon saying, "What're we doing in this neighborhood?" Another VIP answers, "This place looks historic. Let's make it a parking lot." A news headline: "Israel is brutalizing Palestinians, ex-congressman says." There was a comment on Springfield's garbage system: "If someone set out to devise the worst program imaginable, this is what they'd come up with." The young publisher, Fletcher Farrar, wrote an editorial about a forum at Lincoln Library, one of a series to discuss and find "common ground" on controversial issues like racial inequality and economic competition. The recent program was about abortion. One woman had said she was glad her mother, 15 and unwed when she gave birth to her, "didn't have the opportunity to abort me." Another participant answered, "All of us are glad that our mothers decided to have us. But are you really glad your mother's choices were so limited? Are you glad she wasn't informed about adoption?" The editorialist wrote: "This kind of exchange of views – any exchange of views – is rare in American public discourse these days." He concluded with the hope that "Americans will learn again how to listen to each other, to reason together, and to make social progress despite a lack of consensus." – Fletcher Farrar, editor

## Illinois to keep public health dollars while red states lose out

After Trump slashed billions in CDC funding, states that sued got to keep much of their money

After the Trump administration slashed billions in state and local public health funding from the federal Centers for Disease Control and Prevention earlier this year, the eventual impact on states split sharply along political lines.

Democratic-led states that sued to block the cuts – including Illinois – kept much of their funding, while Republican-led states lost the bulk of theirs, according to a new analysis from health research organization KFF.

The uneven fallout underscores how politics continues shaping health care in the United States. The nearly 700 CDC grants were worth about \$11 billion and had been allocated by Congress during the COVID-19 pandemic.

#### Not just COVID-19 spending

Since then, state and local health departments had spent or planned to spend the money not just on COVID-related efforts, but also on prevention of other infectious diseases, support for mental health and substance use, shoring up aging public health infrastructure, and other needs.

The CDC grant terminations initially affected red and blue states about evenly, according to KFF. California, the District of Columbia, Illinois and Massachusetts – all led by Democrats – had among the largest numbers of terminated grants.

The Illinois Department of Public

Health announced on March 26 that the federal government was pulling back over \$400 million in grant funding that previously had been approved. That included \$125 million that was earmarked to support laboratory operations in 97 local health departments as well as \$324 million for future work to prevent and treat infectious diseases in Illinois.

#### **Blue states sue**

Illinois was one of nearly two dozen blue states and the District of Columbia that sued the Trump administration in April, asking the court to block the grant terminations. They argued the federal government lacked the authority to rescind funding it had already allocated.

The suit, filed in federal court in Rhode Island, argued that Congress appropriated those funds in various pandemic-related spending bills, and the administration's decisions to terminate the grants violated the federal Administrative Procedures Act.

"Illinois and states across the nation rely on federal grants to provide state public health services that protect our children and residents from serious diseases or health crises," Raoul said in a statement at the time. "The abrupt termination of this funding that impacts millions of American lives is both callous and unlawful."

A federal judge sided with the blue states and blocked the cancellations – but she limited her injunction to the jurisdictions that filed in the lawsuit. Nearly 80% of the grant cuts have now been restored in blue states,

according to the KFF analysis, compared with less than 5% in red states.

According to the KFF analysis, 21 grants in Illinois were targeted for termination prior to the lawsuit, but just two have been terminated following the judge's injunction.

#### **Cuts hit red states hardest**

Now four of the five states with the most canceled grants are led by Republicans:
Georgia, Ohio, Oklahoma and Texas.
California, which is dominated by Democrats, kept all of its grants that had been initially

In the West and Midwest, Democratic-led Colorado – which joined the lawsuit – had 10 of its 11 grant terminations reversed. Its Republican-led neighbors that did not sue, including Kansas, Nebraska, Oklahoma, Utah and Wyoming, lost all of their grants, according to the KFF analysis. □



## **Springfield Clinic seeks new west-side location**

Former furniture store would become retail site for medical supplies

Springfield Clinic wants to use the former site of Ashley Furniture Outlet and Barney's Furniture on Springfield's west side for storage and eventually for retail sales of medical equipment and devices.

The multispecialty physician group's request for zoning to allow for those plans at 1987 Wabash Ave. will be considered Sept. 17 by the Springfield Planning and Zoning Commission for an advisory recommendation to the Springfield City Council. The council, which has the final say on zoning matters, is scheduled to hear and potentially vote on the clinic's request Oct. 21.

The Seidman family closed Barney's Furniture at the site in 2020 to convert the location to an Ashley Furniture Outlet. The Ashley store opened in April 2021, but owner Barry Seidman told *Springfield Business Journal* in 2024 that he was making changes to the business model and listing the building for sale. The building has been vacant since March 1, Seidman said.

The Seidman family owns Ashley HomeStore locations in Springfield, Jacksonville, Quincy and Terre Haute, Indiana. The Springfield store, at 2325 Chuckwagon Drive in Prairie Crossing, has been open since 2006, and Barry Seidman said he is offering items at the main location without having to operate a second store in Springfield.

The Springfield resident said he would sell the 46,000-square-foot building on Wabash Avenue to the clinic if zoning is approved.

The staff of the Springfield-Sangamon County Regional Planning

Commission recently issued a nonbinding recommendation that the clinic be granted a zoning change and a use variance to allow for both storage and retail sales.

Springfield Clinic officials wouldn't comment on the zoning request, which doesn't represent the for-profit clinic's first foray into medical equipment and supply sales.

Springfield Clinic says on its website that Vono Medical Supplies, based at 400 N. First St. in Springfield, has become a nonprofit "affiliate" of the clinic. Vono has sold medical supplies and equipment in central Illinois

since 1982.

A Vono employee who answered the phone said the acquisition took place in fall 2024. The previous owner, Sue Cain, who still works at Vono, wouldn't speak with *Illinois Times* when contacted Sept. 10.

Springfield Clinic spokespersons didn't respond to phone calls and emails. Daniel Hamilton, a lawyer with Brown Hay and Stephens who is representing the clinic in the zoning case, also wouldn't comment.

Sangamon County property records currently list Vono's 8,300-square-foot building in Springfield as being owned by Vono Real Estate in Riverview, Florida, with \$42,112 in property tax paid in 2025.

The Wabash property includes 30,000 square feet of space formerly used for retail sales and 15,500 square feet for storage. The building, constructed in the 1970s, previously was a Hobby Lobby location and, before that, a Jewel-Osco grocery and drugstore, Seidman said. □



## 'Three readings rule' lawsuit thrown out

I'm coming a bit late to this (national current events having overtaken everything), but a lawsuit filed by House and Senate Republicans was recently tossed out by Sangamon County Circuit Court Judge Jack Davis II. The suit sought to strike down a new law backed by trial lawyers (Senate Bill 328). The Republicans say they will appeal.

The Republican lawsuit claimed that the majority Democrats had violated the Illinois Constitution's "three readings rule."

The titles of bills are required to be read aloud on three separate session days in each chamber. In the state's early days, the entire bills had to be read aloud apparently because so many legislators were illiterate.

Often, though, bills that have already passed one chamber are gutted and replaced with amendments by different legislation, usually after the bills have been moved in the second chamber to Third Reading. The final bills can then be passed by both chambers in a single day without committee hearings because their titles had already been read three times in each body. And as long as both legislative leaders certify that the bills complied with procedural requirements, known as the "Enrolled Bill Doctrine," the legislation is considered constitutionally passed.

"This special interest proposal was passed by the Democratic Majority using a shady process that clearly violates the substance and spirit of the Illinois Constitution," said Illinois Senate Republican Leader John Curran when he and others filed the suit in June.

The Republicans noted in their lawsuit that even though the Illinois Supreme Court had shot down other lawsuits attempting to kill legislation based on alleged violations of the Enrolled Bill Doctrine, justices on the state's top court had sternly warned the legislature in 1992 that their judicial patience was wearing thin: "(T)he General Assembly has shown remarkably poor self-discipline in policing itself," the court said at the time. "Indeed, both parties agree that ignoring the three-readings requirement has become a procedural regularity."

But Davis countered that the Supreme Court has since addressed three readings challenges "on several occasions and has, without exception, followed the enrolled bill rule." All appellate courts have also done the same, he wrote. Davis said he was therefore bound by precedent.

The judge also ruled that the plaintiffs lacked standing to sue because the legislation, allowing out of state businesses to now be

sued for "exposure to a substance defined as toxic," can "never affect plaintiffs."

Earlier last month, Sangamon County Circuit Court Judge Adam Giganti used the exact same enrolled bill doctrine history cited by Davis to throw out a lawsuit filed by several members of the Illinois Freedom Caucus against the new state budget.

Giganti also ruled that because people involved in actually implementing the budget were not included as defendants in the lawsuit – including the governor, the comptroller, the treasurer and the Illinois Department of Revenue director – then that required dismissal as well under Section 2-615 of the Code of Civil Procedure.

Aside from the obvious press pops that the lawsuits have already attracted and will continue to receive, the object here is to eventually get these lawsuits in front of the Illinois Supreme Court to see if they can convince the justices to finally follow through on their 33-year-old warning.

A 2003 Supreme Court ruling referenced its own 1992 "remarkably poor self-discipline in policing itself" comment in a new case involving a similar constitutional

challenge. However, the top court noted that the record of alleged violations had not been "sufficiently developed to support or contradict this claim" of a violation.

"Nevertheless," the opinion continued, "because this court is ever mindful of its duty to enforce the constitution of this state, we take the opportunity to urge the legislature to follow the three-readings rule. While separation of powers concerns militate in favor of the enrolled-bill doctrine, our responsibility to ensure obedience to the constitution remains an equally important concern."


So, as I told my blog readers when the Republican lawsuit was filed, "the Republicans are likely hoping that if they keep bringing these cases to the court's attention, the Supremes will eventually decide that the record has been 'sufficiently developed' to support their claim.

But it's highly doubtful, to say the least, that the 5-2 Democratic majority will accede to the Republicans' wishes even then. □

## **Cracks in the earth**

"Lutheran high school as hellmouth?" is a headline that I'd hoped to read when I heard that the ground at 3500 W. Washington beneath Springfield's new Lutheran High School opened up beneath it in 2022. Disappointingly, no bloody hand had thrust up out of its grave to pull innocents down into the bowels of the earth. The cause of the rupture was more prosaic. Pillars of coal propping up a long-abandoned coal mine hundreds of feet below the school had collapsed.

The earth opened up only a crack but through that crack Jori Lewis saw another Springfield that had been hidden from her view. The young writer and sometime journalist who now resides in Chicago and Senegal grew up on the west side not far from the Lutherans' property. As a girl she knew of the Springfield area only what she could see and what she could see was corn. What she couldn't see was uncounted miles of tunnels that miners had burrowed through the No. 5 coal seam like termites through a sill plate during the decades when mining was Springfield's biggest industry. Her church, her middle school, her favorite park – all undercut.

When I was her age a Springfield kid could still see artifacts of that furious excavation. Nature put coal almost everywhere Downstate, but mine owners choose where to put mines and they usually sink the shafts next to rail lines, even if those lines were in the crowded city. As a boy I'd bicycle to and fro to downtown from the east side past the rusting surface works and slag pile of Peabody's No. 57 mine, The "Capital." Such relics did not last long. Atop the entrance to the Citizens Coal Company "A" mine the city built a new fire station and Peabody's Capital mine was converted into a baseball park.

Jori Lewis's curiosity was piqued, so she set out to uncover more buried history.

What she found she recalled in an essay that appeared in the *New York Review of Books* ("Buried Sunshine") of July 26, 2025. You start a journey in an underground mine and it is easy to get lost. Lewis's excursion has her wandering here and there from coal to slavery to labor history. The result is not a bildungsroman, more like Mister Rogers explores the neighborhood. Among her stops was Macoupin County's Mt. Olive and Gillespie, the birthplace of the Progressive Miners of America, a rebel union group whose fraternal violence fueled open warfare in and around Sangamon in the 1930s. Along the way she introduces readers to Virden and

Pana, Mother Jones and John L. Lewis – giant names that used to be on the front pages but are now reduced in every way to tourist brochures.

Happily, museums can un-bury history too. Lewis visited the Illinois Coal Museum at Gillespie (https://www.gillespiecoalmuseum. org/); well-funded and drawing on recent scholarship, it is superior to most local history museums. (Too bad Lincoln didn't dig coal instead of splitting rails; Springfield might have a first-class museum about the coal industry here too.) Such displays tend toward the celebratory, and with reason. Underground mining was hard and men who

did it were proud to do it well. The mines made towns different from their farm town neighbors (if only in the number of taverns they supported) and they are proud of that too. The darker side – the racial and ethnic antagonisms, the violence committed by the owners' goons against the miners and by miners against each other, the social violence practiced when men with money exploit men without it – are left to the historians.

It is a story that I know fairly well, but Lewis opened a crack in my world too, out of which walked miner Big Henry Stephens, the Black labor union activist and civil rights agitator in Sangamon and Christian counties. I'd never heard of him. Carl Sandburg was an itinerant labor-party organizer as well a poet who knew Stephens (who died in 1939). Sandburg reimagined one of these encounters (slightly, one suspects) in a 1917 poem "The Sayings of Henry Stephens." A lifelong aversion to Sandburg's verse left Stephens buried on the shelf of my library all these years. (For more about Stephens, see https://sangamoncountyhistory.org/wp/harrystephens-miner-carl-sandburg-muse/.)

Future Springfieldans need not rely on a poet for their history. Alert readers will recall that in June the Illinois State Historical Society erected a memorial marker to Henry Stephens at 11th and Washington in Springfield near where he used to live. Markers recalling our inconvenient citizens are to be praised, although I can't help wishing they'd installed this one on the grounds of the country club or at least near a high school. No matter. As Lewis reminds us, you learn your history where you find it.

## Addressing children's mental health

#### Required student screenings raise concerns about accessing services, privacy issues

Anxiety, depression and other mood disorders in children have become more prevalent due to influence from a rapidly increasing number of technology and social media offerings in the past two decades.

"I feel like we have an anxious generation," social worker Melissa Warwick told *Illinois Times* in her Auburn Community School District office. Students try to find solace in Warwick's office, decorated with welcoming posters and friendly messages threaded into pillow covers. The walls display artwork from students. She has been with the district for 17 years and said there's been more children visiting her office over recent years.

"I would say our enrollment has been decreasing, but our caseloads have been increasing," she said. State data indicates the district's enrollment is currently around 1,100 students and has shrunk by 20%, almost 300 students, over the past seven years.

Data from the largest long-term study of brain development in the U.S. was used in a study published earlier this year in the Journal of the American Medical Association and showed that symptoms of depression in children increased as social media use grew. More studies over the years have indicated a rise in other symptoms associated with mood disorders as a result of increased time spent on social media. The World Health Organization estimates more than 1 billion people live with diagnosable mental health disorders, a statistic that the organization says is a call for countries to "scale up services to protect and promote people's mental health."

In addition to working with elementary students, Warwick also does one-on-one meetings with some high schoolers and said the anxieties she sees manifest in a variety of ways. She said it's clear how mental health can be impacted by increased access to the internet's endless information.

"It was paper and pencil activities 10 years ago – even that's just different now,

everything is really computer-based," she said. "They didn't have a Chromebook or a laptop that was with them all the time. Now these kids have access 24-7 to absolutely everything."

Modern technology can stoke common anxieties for teenagers, Warwick said.

"Thinking about junior high (or) high school kids that are very impressionable – having access to social media – they know where everyone is, they can locate everyone," she said. "My friends are here and I didn't get an invitation,' and that causes some major anxiety."

Those problems multiply for some Auburn students who are in need of counseling or therapy, as the closest providers are in Springfield. Ashley Weber-LeBar, also a social worker at Auburn Community School District 10, said the distance to medical professionals is a real barrier.

"Even just medical needs, anything in Springfield is just really hard to get to for most of our population," Weber-LeBar said.

At a Sangamon County Mental Health Commission meeting in August, the two Auburn social workers informed the commission about children they have worked with who struggled to get transportation to therapists and doctors.

"There are agencies that will go to Auburn and pick up, but they're not reliable. We've got families that call the number and set it up for the date and time, and then the car is a no-show, and then the family has then missed their appointment," Warwick said last month. "If you miss one or two appointments, you're bumped from the list, and then they lost their counseling spot."

Warwick, who is also the district's homeless liaison, told the commission roughly 40 students in the district were experiencing some kind of homelessness and Springfield's resources felt out of reach.

"Even though it's a very small community, it's difficult sometimes to identify these families and doubled-up situations. They're embarrassed; they don't want to talk about it or share their private situations," she said. "Once I identify them, we try to give them as many resources as possible. Obviously, that's here in Springfield. We don't have those types of resources down in the Auburn area – transportation to Springfield is huge – that's our biggest boundary we have."

For families with more significant needs, finding a children's therapist can be difficult as most providers have waitlists that often span weeks or longer.

Melissa Fisher Paoni, a licensed psychologist and co-owner of Springfield Psychological Center, said waitlists for her practice have consistently been quite long.

"It depends on the provider, it's either



several weeks or several months depending on the time of service," Paoni said. "I think that's been the case for years."

She added that today's digital world is particularly likely to increase anxieties in young girls – though all children are susceptible to mental health effects from overuse of social media.

"Social media, in particular, affects girls more so in terms of negative comparison," Paoni said. "And this is true for all kids and adolescents. The constant scrolling with looking at other people's profiles and things like that leads to negative comparisons and negative self-concept issues."

Consuming large amounts of digital media without aim, Paoni says, can have harmful effects.

"Kids who are watching these short, intense videos one after the next have an almost obsessive-compulsive quality to their actions because of this homogeneous content that's (viewed) over and over and over again," she said. "That's a different kind of anxiety where you have this dopamine rush and then you want more of it. It's different than maybe (what we saw) prior to the prevalence of screens."

### State law introduces mental health screenings

Gov. JB Pritzker has made children's health a major focus of his office through a number of executive actions and laws since becoming governor six years ago. This July, he signed a bill into law requiring mental health screenings for public school students in grades 3 through 12 – which goes into effect during the 2027-28 school year – though parents can waive their child's participation.

At the signing, Pritzker was asked how the screenings fit into the state's capacity to care for the children that screenings could catch.

"Those are steps we've been taking for some number of years and will need to continue to take, expanding the availability of providers that you can refer somebody to," he said. "We have so many challenges we're trying to overcome at once; it starts with overcoming the stigma that people are experiencing."

While some people may still think of mental health problems as less than substantial issues, school social workers, often with hundreds of students on their caseload, are on the front lines.

Weber-LeBar – who administered and scored mental health screening paper questionnaires when working at Waverly Community School District 6 – said the law will be good for the state's students. However, she believes additional resources need to be put toward people who manage and care for those children because of the amount of work it puts onto social work staff.

"I loved it," she said about the standardized

questionnaire, "because it caught so many students that otherwise would have completely flown under the radar. Kids that I never would have thought needed services scored really high and those are kids that totally would have fallen through the cracks... we just also need some support because it's going to blow up once they start doing this. But overall, I think it'll be good for the future of the state."

The Waverly school district implemented mental health screenings in the summer of 2020, shortly after the pandemic prompted remote schooling, which only exacerbated social and emotional problems for many students.

Weber-LeBar said the process resulted in more referrals for students to see a social worker or counselor, even though some parents decided not to sign their child up for the questionnaire.

"It really, really increased my workload, but it was worth it to me because we were able to help kids," she said, "but I mean, it requires a ton of extra work."

She said a school district larger than Waverly, which had just about 350 students enrolled while Weber-LeBar was there, would likely need to score questionnaires digitally.

Dana Weiner, a child welfare expert and chief of the state's Children's Behavioral Health Transformation Initiative, told an Illinois Times reporter last year that BEACON – the online platform the state will use to administer mental health screenings – acts as a routing tool "so that parents and other concerned adults don't have to do a lot of searching to find the appropriate (service) for kids"

She emphasized that it will not solve grander systemic problems Illinois mental health care providers are facing, but it can streamline how families or teachers find resources children might need.

"It is not a diagnostic tool. It does not make appointments," Weiner said, "or address any of our capacity concerns. What it does is it puts all the information in one place. It gives parents the opportunity to almost immediately connect with a person."

#### **Privacy concerns**

BEACON, which stands for Behavioral Health Care and Ongoing Navigation, will act as an online one-stop location to search for mental health resources and connect children to state programs run by an array of different state agencies. It marks another step by the administration to consolidate and streamline government services for families following the creation of the Department of Early Childhood, which is set to be operational within the next year.

The tool being utilized to administer the mental health screening was originally touted as being "powered by Google Cloud's secure, scalable, and advanced artificial intelligence and cloud computing technology" in a January 2024 press release announcing the platform.

There has been no mention of Google's artificial intelligence in any government press materials released about BEACON since the platform's initial announcement.

The mental health screening law requires state officials to outline "model procedures and guidance" by next September and must include "the option to opt-out, confidentiality and privacy considerations, communication with families and communities about the use of mental health screenings, data sharing, and storage of mental health screening results and plans for follow-up and linkage to resources after screenings."

Fred Cate, an information privacy professor at Indiana University Bloomington's Maurer School of Law, said even if the data is being stored by the state, Google's involvement with BEACON means some level of interaction with the data.

"In other words, the state may be retaining legal control of it but, why do you go to Google if it's not to provide services to the data or for the data? And so, I have to think

the data are being stored, or analyzed, by Google," Cate told an *Illinois Times* reporter last year. "The press release said they're using AI to do this. Well, for AI to work, the data and AI have to touch each other, and I have to think that's the service Google's providing."

A one-stop system to find services and manage mental health records could come at the cost of privacy for the hundreds of thousands of children who may eventually utilize the platform. State agencies have experienced dozens of cybersecurity attacks in the past decade.

Last year, Google was required to delete billions of files containing private browsing data collected through 'incognito' mode on its Chrome browser, though it was not required to pay plaintiffs who asked for billions of dollars. More recently, a federal jury ordered the company valued at trillions of dollars to pay \$425 million in damages for illegally tracking data accessed through private browsing settings, though Google said it would be appealing the decision. Lawyers who filed the case argued the tech giant was collecting data from users through apps that connect to Google accounts in order to sell ads.

In response to questions from *Illinois Times* about Cate's comments, the Department of Human Services said Google does not have access to the state's data.

"The state of Illinois hosts its data in a private Google Cloud environment that is exclusively managed and controlled by the state of Illinois, not Google," the statement reads. "The AI model powering BEACON's features, such as resource matching and navigation, is deployed privately within the state's environment on Google Cloud.

"While the data resides on Google Cloud's infrastructure, it is fully isolated, and only authorized state of Illinois personnel with proper credentials can access it," according to the IDHS statement. "Google's role is strictly limited to providing the underlying infrastructure, with no ability to interact with or extract the state's data."

Cate, who has served on various federal panels and subcommittees regarding cybersecurity, said people will likely use BEACON but that doesn't guarantee trust in the platform.

"People will feel like they don't have much choice," he said. "I think it's more likely you'll say, 'I don't have the time or energy to really care.""

Cate explained that in times of crisis, people are less concerned with their privacy.

"If you're the parent of a child that needs mental health services, you're probably feeling pretty desperate to start with," Cate said. "You might trade your privacy concerns for the convenience of this service."

## New law increases mental health access for college students

UIS counselors say they already meet new mandate

As part of efforts to increase mental health care across the state, Gov. JB Pritzker signed a law last month requiring public colleges and universities to have a certain number of mental health professionals available to students.

University of Illinois Springfield, one of the state's smaller public universities, is in line with the new mandated ratio of one counselor for every 1,250 students enrolled. Bethany Bilyeu, a counselor and executive director of student support services at UIS, said the university is uniquely positioned to offer counseling services without session limits or a waitlist.

"We've been very blessed to not have a waitlist, so you can get in same day, same week, whatever's convenient for you to see somebody. We don't bill insurance," Bilyeu said. "We have a student fee that covers health and counseling, so all students pay into that – it's only \$82.50 per semester, which is still relatively low compared to other schools."

She said the efforts to increase access to mental health care is appreciated. "Trying to get the right level of supports at the right times in people's lives can be difficult."

Despite offering telehealth and having many students who commute to school, Bilyeu said most students using the counseling center's services tend to visit with their counselor in person.

"A lot of people made that shift (to offer telehealth) during COVID, and we have just sustained it. We definitely have way more students that prefer in-person (visits). We really thought after COVID that it might end up in almost like a 50-50 world, but that does not bear out when we look at our data," she said.

The personal connection with a mental health provider is a benefit a smaller community like UIS can offer.

"Given our size, we don't have session limits, so you can see the same person. If you go here for undergrad and graduate school, you could end up with the same person for seven or eight years," Bilyeu said.

Tim Moody, who has been working for the counseling center full time since 2019, said he enjoys working with students as they progress through college.

"It's really a wonderful thing when you can spend time with a student that maybe comes in as a freshman, and you get to spend their whole college career with them. The growth is just magnificent to see," Moody said.

He said social media is still a problem for college students, however, as communication splintered across so many different apps and platforms can complicate friendships.

"Often, their relationships are run through text messaging and Snapchat and these kinds of things, so having to try to communicate effectively is a real struggle," he said, "I think that creates conditions for an uptick in anxiety." —Dilpreet Raju



## **Culinary gold**

Bacon fat transforms good dishes into great ones **FOOD I** Ashley Meyer

With tomato season in full swing, so is the jar of rendered bacon fat that lives in my fridge. A happy byproduct of countless bacon and tomato sandwiches, this culinary gold has been finding its way into everything from salad dressing and snacks to soups and even cookies. A versatile and old-fashioned ingredient, many have memories of frugal grandmothers keeping a can of bacon grease at the ready, and with good reason. Bacon fat can effortlessly transform a good dish into a great one and, even better, it's practically free.

Memaw may keep her can of bacon fat on the counter, but I prefer to keep it in the fridge, where it will keep in an airtight jar for several weeks. If frozen, it will last almost indefinitely. Bacon fat does have a slightly lower smoke point than canola oil, but it's still resilient enough to provide a good sear on a piece of steak or a heaping pile of peppers and onions. It can form the essential base layer to hearty comfort and soul food classics, including collard greens, red beans and rice and stick-to-your-ribs soups. In the salad corner, bacon fat makes an excellent foundation for a sweet-savory warm vinaigrette, excellent on lettuces as well as roasted carrots or potatoes. For added texture, sauté breadcrumbs in melted bacon fat until brown and crispy. I highly recommend scattering these crispy, baconinfused breadcrumbs with wild abandon over everything from vibrant green salads to simple bowls of garlicky herbed spaghetti.

Beyond infusing layers of savory, smokey flavor on the stovetop, it also has many uses in baking. It can easily be substituted in any recipe that calls for vegetable shortening and is the secret star of my mother's irrationally delicious snickerdoodle cookies. Some, like my favorite Southern-style cornbread, are made with just bacon fat, while other recipes, like quiche crust, scones and cookies, work best using a 50/50 mixture of butter and bacon fat.

To render bacon fat, cook the bacon slowly over medium-low heat for 10-12 minutes, flipping once. Alternatively, bacon can be baked on a sheet pan in a 375-degree oven for 10-15 minutes, until crispy. Once the bacon is cooked, remove it from the fat and drain on paper towels. Allow the fat to cool for a bit, then pour the still warm but not hot contents of the pan into a heatproof bowl or jar. If desired, the fat can be poured through a fine meshed sieve to catch any crispy bits. It's now ready to use or be refrigerated or frozen for several months.



#### Stovetop bacon fat popcorn

Ingredients: 1/4 cup bacon fat ½ cup popcorn Salt and pepper to taste

Melt the fat in a heavy-bottomed pot with a tight-fitting lid over medium high heat. Add the popcorn kernels and stir to coat, then place the lid on the pot. Stay close to the stove, and as soon as you can hear the kernels start to pop, use potholders to vigorously shake the kernels and keep the unpopped kernels at the bottom of the pot. When the popping slows to a pop or so every few seconds, remove the pot from the heat and leave the lid on for a moment to let it finish popping. Carefully remove the lid, being cautious of steam, and season the popcorn to taste with salt and pepper.

#### Warm mustard-bacon vinaigrette

Ingredients: 1/4 cup bacon fat

1/4 cup cider vinegar 1-2 teaspoons minced shallot 1 tablespoon grainy mustard 1-2 teaspoons sugar or honey, to taste Salt and pepper to taste

Heat the bacon fat to bubbling in a jar in the microwave or over the stove in a nonreactive saucepan. Carefully add the remaining ingredients along with a tablespoon of water and mix vigorously to combine. Season to taste with salt and pepper.

#### **Bacon beer cheese cauliflower soup**

Ingredients: 1/4 cup bacon fat 1 onion, roughly diced 1 carrot, roughly diced 1 stalk celery, roughly diced Salt and black pepper, to taste 12 ounces beer, such as a dark lager 2 quarts unsalted chicken stock 1 head cauliflower, broken into large florets 4 ounces white cheddar, grated, plus more for

Crispy bacon breadcrumbs and minced parsley, optional, for garnish

Melt the bacon fat over medium-high heat in a large heavy-bottomed soup pot. Add the diced onion, carrot and celery to the hot fat and season with a pinch of salt. Cook until the vegetables are fragrant and just beginning to soften, then add the beer. Bring the beer to a simmer and then add the stock and cauliflower. Bring to a boil, then reduce the heat and simmer until the vegetables are very soft, about 20 minutes. Use an immersion blender to puree the soup until smooth. If using a closed blender, be sure to cool the soup first before pureeing to avoid the blender exploding. Rewarm the soup if necessary, then remove from the heat and add the cheese, stirring to melt. Season to taste with salt and pepper. Garnish individual bowls with herbs, cheese and garlic breadcrumbs.

#### **Bacon fat snickerdoodles**

Ingredients: ½ cup bacon fat

½ cup unsalted butter, softened 1 ½ cup granulated sugar

2 large eggs

2 teaspoons baking powder ½ teaspoon salt

2 3/4 cup bread flour (or use all-purpose) Cinnamon sugar for rolling

Cream the butter, bacon fat and sugar until light and fluffy. Beat in the eggs, mixing until smooth and light in color. In a separate bowl, whisk together the baking powder, salt and flour, then add this to the egg mixture. Mix gently but thoroughly to combine, then transfer the dough to the fridge for 30 minutes to chill.

While the dough chills, preheat the oven to 375 degrees. Line two baking sheets with parchment paper. Place the cinnamon sugar in a wide shallow bowl.

Scoop tablespoons of the chilled dough into the cinnamon sugar and roll to coat with the sugar before placing them on the baking sheet, leaving about one and a half inches between each dough ball. Bake for about 12 minutes, until just set and golden, then transfer to a rack to cool. □



We find solace in knowing that Meyers is now enveloped in peace and love, carried ever onward by the souls who went before him.






