Springfield gets a city planner, again

New hire is an architect with urban planning experience

The city of Springfield has hired Suraksha Bhandari as its new professional planner, bringing a blend of international experience, architectural training and research-driven urban planning to city hall.

Bhandari comes to Springfield from Salt Lake City, where she completed a master's degree in city and metropolitan planning at the University of Utah and worked in both academic and professional planning roles. Before moving to the U.S., she worked for five years as an architect and planner in Nepal and earned a master's degree in disaster risk management – experience she says drives her interest in building resilient cities.

In an interview with *Illinois Times*, Bhandari said Springfield's blend of history and opportunity drew her to the job.

"Springfield is a city with historical and cultural background," she said. "I want to bring my educational and professional expertise to work with the mayor's vision and find opportunities for growth citywide. I'm honored to join the city of Springfield and excited to work with the community to help build a vibrant and resilient city for today and for the future."

Bhandari said she had been familiarizing herself with the city for several months before applying and has now been in Springfield for about three weeks. She said her background in architecture helps her approach planning holistically, from understanding the city's history to communicating ideas through maps, sketches and visual tools.

"When we talk about planning, there are different phases – from envisioning to plan-making to implementation," she said. "Architecture has helped me respect the city's

character and prioritize work that honors history while planning for the future."

Amy Rasing, director of the city's Office of Planning and Economic Development, said Bhandari stood out among a strong field of candidates.

"You're not just talking about someone who has a degree – you're talking about someone who has been working in the field across the United States as well as her home country," Rasing said. "She brings insight, experience and a completely fresh set of eyes. Many of us who have lived here a long time forget what we have to offer. She sees those

strengths and brings ideas informed by places she's worked before."

Rasing noted that Bhandari had already spent time in Springfield prior to applying and arrived with a working familiarity with its neighborhoods, downtown and local culture – something the interview team said set her apart.

Bhandari's appointment comes less than a year after the city created the professional planner position – an effort that initially drew public scrutiny when Mayor Misty Buscher appointed Sean Pritchard as Springfield's first city planner.

Pritchard was named to the role despite not having a college degree. His background included work in insurance, finance and business development, as well as a position at the Illinois Department of Commerce and Economic Opportunity, where he helped manage statewide business incentive programs.

While Pritchard emphasized his various professional certifications and career experience, his appointment raised concerns within the planning field. Urban planning experts noted that mid-sized cities typically hire planners with formal training, often including master's degrees and professional certifications.

The situation also highlighted Springfield's unusual history of operating without a city

planner on staff. For decades, the capital city has outsourced planning work to the Springfield-Sangamon County Regional Planning Commission. The closest equivalent to a municipal planner had been architect Paul O'Shea, who advised the city on planning and design until 2015 but intentionally declined the title of "city planner."

City officials defended Pritchard's selection at the time, emphasizing his economic development background and "outside-the-box" thinking. Pritchard identified the city's east side and downtown as priorities for revitalization. But he left the position this year after serving about six months on the job.

Ward 3 Ald. Roy Williams expressed frustration with how the city has handled its urban planning, adding he has yet to meet Bhandari.

"I thought the last guy was going to try to do good, but I don't know what happened because we just came one day and then boom, he's gone. We heard nothing official, just through word of mouth, 'He's no longer with us."

Williams said for too long the city has ignored the needs of Springfield's east side.

"When are we going to start working on (implementing) a plan for the east side?" he said. "They keep coming up with every other plan. ... How long have we got to wait? I found a plan that's dated 1992. There are like three or four east-side plans on the books in (the Office of Planning and) Economic Development, but they're just paper. We never take action and actually start implementing a plan."

Ryan McCrady, president and CEO at Springfield Sangamon Growth Alliance, called Bhandari's hiring a positive step for the city.

"I think she will do a great job for the citizens of Springfield. People don't always realize the benefits of good planning until they see it done well. ... Her architecture background will not only be good for planning development but also its underlying infrastructure."

Bhandari says she's eager to listen, collaborate and begin the work of shaping Springfield's future.

"This is my home now," she said. "I'm excited to get to work." \Box

Data center debates

Organized labor pushes for project, while critics question long-term effects

Organized labor showed out in force at a public meeting Dec. 3 to support a proposed \$500 million data center in southwest Sangamon County, while a smaller yet vocal coalition of critics questioned the project's long-term impact on the local economy and electric rates.

"This project is about more than steel and concrete," Aaron Gurnsey, president of the Central Illinois Building and Construction Trades Council, told the audience at the BOS Center in downtown Springfield. "These people are your neighbors."

Gurnsey and Brad Schaive, retired business manager of Laborers Local 477, told the Sangamon County Board, which took no action at the meeting, that board members would be supporting middle-class families by granting zoning approval for the project.

Schaive called members of building trades unions "the absolute economic engine" of Sangamon County. "Our success is together," he said.

Gurnsey agreed, adding, "If your electric rates were to rise, it's not because of this data center."

Union supporters applauding their leaders appeared to represent the majority of the more than 500 people at the peak of attendance during the five-hour meeting.

CyrusOne plans to seek an advisory recommendation from the Sangamon County Zoning Board of Appeals for a conditional permitted use in an area zoned for agriculture after a Jan. 15 zoning board meeting.

Company officials said they hope the full Sangamon County Board will take a final vote on the zoning issue by the end of March. Construction on the first of six one-story, 232,000-square-foot buildings would begin later in 2026.

Few board members appear to be concerned enough about the proposal to vote against it.

Dallas-based CyrusOne says the project – on 230 acres of farmland in the 13000 block of Thayer Road in rural Talkington Township – would create more than 500 temporary construction jobs and 100 permanent jobs. The company says the 636-megawatt complex, which would be completed over a six-year period, would support at least 350 other permanent jobs in the community.

Opponents, led by the Coalition for Springfield's Utility Future, didn't question the number of potential new jobs. They said profits related to artificial intelligence – the technology fueling the national data center

building boom – could fall, prompting CyrusOne to close or abandon the site in the future.

They also questioned whether any projected new property tax revenue created by the six one-story, 232,000-square-foot buildings would decline significantly after construction if the company appealed the buildings' assessed valuations.

"Are we relying on promises and assurances that are not legally binding?" asked Robert Hirschfeld, director of water policy for the Champaign-based Prairie Rivers Network.

He called upon the county to hire an outside property tax assessor and not rely only on estimates from Sangamon County Supervisor of Assessments Byron Deaner.

Deaner estimated the project would generate about \$98 million in total new property taxes over the next 20 years for area taxing bodies. That amount would work out to an average of about \$5 million a year to spread among several taxing bodies, including the North Mac school district, Sangamon County government, Lincoln Land Community College, Talkington Township and Virden Fire Protection District.

Opponents said they fear that the data center, which would be the largest indoor construction project in the county's history, would contribute to rising electric rates and help prolong the lifespan of climate change-causing power plants burning fossil fuels.

Some opponents said they don't want prime farmland taken out of production. And some said they don't want Sangamon County to contribute to an AI-fueled future that could eliminate jobs in the longer term and promote

online surveillance that infringes on individual rights.

Hirschfeld said he understands the allure of jobs and tax revenue.

"But do we even want to build the thing that we are building?" he asked. "Many of us are building a technological world we don't even like"

Anne Logue, a member of the coalition, said, "Rural communities have been targeted by these data centers because they haven't protected themselves."

Potential property tax revenue impact

If construction on the data center buildings begins in 2026, taxing bodies likely would begin to see additional revenue in 2027, Deaner said. The project would use 0.06% of the county's farmland, he said.

Critics of the project pointed to Prince William County in Maryland, where some of the biggest technology companies in the world, including Microsoft and Amazon, are suing the county to reduce their property tax bills. Deaner said he doubts Sangamon County would face such legal challenges.

Deaner said CyrusOne's buildings – which would rent space to contracting technology companies for those companies' computer servers – would go onto the tax rolls one at a time, every year to 18 months, giving the county and the company more time to work out accurate assessments and resolve disputes.

And he said he was conservative in his estimate of total fair-market value of the project at completion – \$212.5 million. Deaner said he was careful to subtract costs that wouldn't be considered for property taxes,

such as costly equipment that ensures no power interruptions at the complex.

He said he examined nine CyrusOne projects constructed in recent years — including two in the Chicago area and several in suburban Cincinnati and northern Virginia. CyrusOne appealed its property taxes for only one those centers — in Florence, Kentucky. Deaner said the company's dispute appeared justified.

CyrusOne officials said they have never appealed tax assessments for the company's data centers in Illinois, which are in the Chicago suburbs of Aurora and Lombard and smaller than what is proposed for Sangamon County.

A second CyrusOne campus is being built in Aurora, a Wood Dale campus is under construction, and ground is expected to be broken in 2026 for a campus in Yorkville that would be similar in size to the Sangamon County project, according to Bradd Hout, CyrusOne location and power strategy director.

CyrusOne previously told *Illinois Times* that promising tax benefits in Sangamon County and then seeking substantial reductions would be "disingenuous," "unheard of" in the company's history and "not aligned with CyrusOne's commitment to being a transparent, responsible partner in communities where we operate."

Power rates and capacity

The entire 632 megawatts of electricity that CyrusOne would need to operate the completed data center in Sangamon County could be supplied without a problem by the regional power grid, according to the grid's nonprofit regulator, known as Midcontinent Independent System Operator Inc., based in suburban Indianapolis.

Mark Pruitt, an Indiana-based consultant hired by Sangamon County, said in his analysis that there would be "not much, if any" impact on energy prices in central Illinois energy costs because of the increased demand from the Sangamon County data center.

Pruitt's analysis didn't examine the overall impact of data centers on regional and national power costs.

He told *Illinois Times* that short-term price increases caused by electric demand related to data centers may be offset by reduced rates in later years because that demand creates financial incentives for the potential development of renewable energy sources and new nuclear power plants. □

Former emergency medical workers to be tried separately

Earl Moore's mother says she is anxious for murder trials to start

The two ambulance workers charged with first-degree murder in the 2022 death of Earl Moore Jr. will be tried separately, a Sangamon County judge has ruled.

Circuit Court Judge Robin Schmidt on Dec. 2 granted the request from both defendants, Peter Cadigan, 53, and Peggy Finley, 47, both of Springfield. The former employees of LifeStar Ambulance Service had been scheduled to go on trial together beginning May 11.

Lawyers for both defendants contended that going on trial at the same time and in front of the same jury would create unnecessary conflicts in their defense arguments, and Schmidt agreed.

"Each of the defendants will be pointing the finger at each other," Justin Kuehn, Cadigan's lawyer, told the judge.

A trial that is expected to last two weeks still could begin on that date, court officials indicated. Who will be tried first is up to Sangamon County State's Attorney John Milhiser, and Milhiser is expected to notify the court of his preference in the coming weeks. The next hearing on the case's status is scheduled for Jan. 5.

Cadigan was working as an emergency medical technician, and Finley was working as Cadigan's supervising paramedic, when the two transported Moore, 35, face-down on a stretcher, rather than the recommended position – on his back – from his Springfield home to HSHS St. John's Hospital in 2022.

Moore was pronounced dead by St. John's officials at 3:14 a.m. on Dec. 18, 2022, after an ambulance ride that lasted two to three minutes.

Forensic pathologist Dr. Scott Denton of Bloomington concluded after an autopsy that Moore, a former McDonald's shift manager,

died from "compressional and positional asphyxia" because of being placed face-down, or prone, and being tied down tightly by Cadigan.

Former Sangamon County State's Attorney Dan Wright, who since then has been appointed an associate circuit judge, said in charging documents that the EMS workers "did acts without lawful justification" that caused Moore's death and that the worker knew, based on their "training, experience and the surrounding circumstances" that their acts "would cause a substantial probability of great bodily harm or death."

Cadigan and Finley, who have been released while awaiting trial, have pleaded not guilty. Their attorneys have said the situation, while

tragic, didn't justify a murder charge. The attorneys have indicated that they plan to call experts to the stand at trial disagreeing with Denton on whether suffocation was Moore's cause of death.

The EMS workers were summoned to Moore's home after he called 911 while hallucinating during an episode of alcohol withdrawal, according to authorities.

A toxicology report after his death indicated his blood-alcohol level was 0.077%, or just under the legal limit of 0.08% for driving in Illinois.

Civil rights attorney Ben Crump and Texasbased lawyer Robert Hilliard, who represented Moore's family in a wrongful death lawsuit against Centralia-based LifeStar, previously said Moore's case might have been the first in the United States in which first responders were charged with murder in the death of a patient.

Hilliard said he believed the fact that Moore was Black and the EMS workers were white played a role in the rough, rude and ultimately deadly treatment of Moore that is depicted on police-worn camera footage of the incident.

Moore's mother, Rose Washington, 59, of Springfield, said after the Dec. 2 hearing that she is anxious for Cadigan and Finley to go on trial, and she believes the murder charges were appropriate.

"They need to go ahead and get this trial over with," Washington said.

Springfield resident Teresa Haley, an advocate for Moore's family, said, "This family is really concerned. They have no faith in the justice system, but we're hoping that justice is served for Earl Moore."

Washington said she is upset she will have to sit through two trials.

"They was together when it happened, so it should have been one trial," Washington said. "Look how long it's taking. This happened so long ago. I hurt every day for this. My son ain't never coming back. Never. And we're still going through this, and this happened years and years ago. ... I sit and mourn all the time. They took one of my kids away from me. ... He didn't deserve that. He didn't hurt anybody. He just laid on a gurney. If they would have turned him over, maybe that wouldn't have happened."



Massey Commission issues final report

Co-chairs and staff present recommendations at Dec. 9 Sangamon County Board meeting

The Massey Commission has released a final report that details more than two dozen recommendations, specifically labeling them "calls to action," and listed entities that should be responsible for carrying them out. Members of the commission and its staff presented the final report to the Sangamon County Board at its Dec. 9 meeting.

A handful of County Board members thanked the commission for its work.

"I really look to the County Board members to work hard on this report. Our community does deserve a lot better; (the Massey) family does deserve a lot better," said board member Greg Stumpf.

Each call to action is also categorized under one of five "signature priorities" that the commission identified. The full report is 63 pages long and details specific actions localities could take to make marginalized residents safer across Sangamon County.

The commission was created by Sangamon County Board Chair Andy Van Meter and state Sen. Doris Turner to address "systemic issues in law enforcement practices, mental health responses and community relations" one month after Sonya Massey called 911, only to be shot and killed in her home by a sheriff's deputy.

"The concepts that are identified for the County Board, we're hoping to be able to assign those to one of the (County Board's) discipline committees," Van Meter said at the Dec. 9 meeting. "Some of the projects may require an interdisciplinary group of community leaders, but we're working through those assignments."

Community partners plan to organize avenues for the public to provide feedback on the final report, according to a statement issued Dec. 4 when the report was posted online.

While there are no more scheduled meetings, members of the commission have said they would like to continue operating in some way. In August, the group hosted members of the Ferguson Commission to discuss transitioning the Massey Commission into a nonprofit, although no specific plans have been announced.

Sontae Massey, Sonya Massey's cousin and a staff member of the Massey Commission, addressed the County Board during its December meeting and urged the work to continue.

"My family didn't choose this path. The community didn't choose the conditions that made this commission necessary, but we do have a choice today to move forward with honesty, courage and commitment," he said. \square

LONG-TERM CONSEQUENCES

Sangamon County has already been bought and sold on the data center by CyrusOne, and the public hearing was a joke. The project is being rushed forward on the basis of info overwhelmingly produced by the developer, not impartial experts. The self-serving Q&A page on the county website is extremely biased and includes no fair and alternative analysis; the main "source" the county uses to answer any questions is CyrusOne, not independent experts.

This massive project only creates 100 permanent jobs, and the economic promises CyrusOne makes are vague, inflated and structured to evaporate over time. The project relies on temporary construction labor and yields tax revenue that can be aggressively appealed the moment the facility becomes operational (as has happened with data centers across the country).

The environmental impacts are far greater than CyrusOne will admit, and their promises of "no increase on electric bills"

or "no impact on water" cannot realistically or scientifically be kept. Data centers are one of the fastest-growing drivers of carbon emissions, electricity consumption and diesel exhaust in the U.S. Look at what happened last week at the CyrusOne data center in Aurora, where it shut down for 10 hours from overheating. These centers become de facto diesel plants during grid stress, injecting particle pollution, nitrogen oxides and carbon emissions directly into our vulnerable local environment.

As for water, no independent hydrological study has been released and no maximum buildout numbers have been provided, so analysis of seasonal stress, drought years or emergency cooling scenarios has not been outlined by CyrusOne. A closed loop system still requires chemical treatments and periodic replacement. CyrusOne's claims that it will have no meaningful impact on groundwater or septic discharge strains are simply unscientific, vague promises.

We can never go back if we approve this project. It will be a permanent resource basin for corporate data processing and we, the people, will absorb all of the environmental, infrastructural and land-use impacts while the majority of profits leave our region.

No one can predict when the AI bubble will burst, but when it does, this massive building full of used computer equipment will be nothing more than another Pillsbury Mills – a problem shuffled around for decades until the taxpayers have to foot the bill to have it torn down. *John Baermann Springfield*

SAFE-T Act criticized again

In the days after the horrific burning of a woman on a Chicago CTA train by a clearly deranged habitual criminal suspect last month, some in the news media immediately focused on their go-to issue: The SAFE-T Act.

"Illinois leaders blast SAFE-T Act after repeat offender charged with lighting woman on fire on CTA Blue Line," reported WGN TV, as just one example. Former Cook County and federal prosecutor Bob Milan told the station: "The SAFE-T Act forces state's attorneys to file petitions instead of just giving judges the discretion (to detain arrested suspects)."

Kankakee County Sheriff Mike Downey also demanded that judges be given "100% discretion" to detain anyone they viewed as a danger to society. Several other sheriffs have since weighed in with the same demand, although some also want to increase the number of what are known as "detainable offenses," which are the alleged crimes that allow judges to keep suspects locked up ahead of trial.

The state law was mentioned repeatedly because the prime suspect, Lawrence Reed, was not held in custody in August after he attacked a social worker at a psychiatric center, knocking her unconscious, giving her a concussion and damaging her eye.

However, Reed was charged in August with aggravated battery resulting in great bodily harm, which is a detainable offense under the SAFE-T Act. Considering his long criminal history and lots of other factors, he was a prime candidate for pre-trial detention.

Cook County Judge Teresa Molina-Gonzalez instead sided against prosecutors, who argued for detention, and with the public defender in the case, who said that Reed was back on his meds and doing better. During the hearing, Molina-Gonzalez publicly acknowledged Reed's long list of 70-plus arrests and convictions, and, according to CWBChicago.com, took a report from a court officer claiming that Reed's chances of committing another crime was "four out of six" if released, with a likelihood of violence. After saying she couldn't lock up everyone that prosecutors wanted detained, the judge ended up placing Reed on monitored home confinement, then another judge subsequently loosened that restriction.

So much for the idea of giving judges complete discretion without prosecutor involvement.

It's worth noting that pretty much all of Reed's previous offenses and releases happened under the cash bail system, before the SAFE-T Act's Pre-Trial Fairness provisions took effect in September of 2023 – a fact ignored by the detractors

Also, the Cook County Jail has experienced a 16% increase in inmates between the end of last year through the end of this year's third quarter, according to a Loyola tracking dashboard. The county jail's population was about 8% higher at the end of the third quarter than it was just before the SAFE-T Act was fully enacted.

And a chart recently posted by CWBChicago.com, which focuses exclusively on crime and is not exactly known as a liberal site, shows that a wide array of violent offenses committed by people awaiting trial in Cook County dropped from 116 victims in 2021 (before the SAFE-T Act) to 52 last year and 37 so far this year. Attempted murder victims dropped from 50 victims in 2022 to 8 so far this year.

Is the SAFE-T Act perfect? Of course not. No law designed by human beings can ever be perfect. Could it be improved? Again, humans should always try to improve on their work.

But the people at the table should not be the ones who are angrily and ignorantly preening for the TV cameras.

Also, one of those downstate sheriffs advocating for changes in the SAFE-T Act kinda let the cat out of the bag last week.

In addition to granting judges more discretion and increasing the number of detainable offense, Jefferson County Sheriff Jeff Bullard talked about the loss of local revenues with the abolition of cash bail.

The old bail system helped fund an array of things like jail staffing, victim services and law enforcement, Bullard said. "The elimination of cash bail has created financial gaps for counties statewide," the sheriff claimed.

Oddly, though, Bullard also griped that "some arrestees are now being held longer while awaiting a judge, where previously they could bond out quickly."


So, the sheriff is upset that people deemed dangerous by judges are being held too long behind bars?

Coach and caregiver connect

Now they coach and care for each other

Latasha Friarson is a caregiver with Abcor Home Health. For the past several months she's been assisting Mike Suhadolnik, a health and fitness coach, to be more independent after a fall a year ago. Friarson goes to Suhadolnik's home Monday-Friday, three hours each day. Having a caregiver does not come naturally for Suhadolnik, and he is not a typical client for Friarson. Yet they've developed a collaboration between patient and client and are now each other's coach and caregiver. While Friarson is helping Suhadolnik maintain his independence, Suhadolnik is helping Friarson improve her health and nutrition.

Friarson, 42, grew up in St. Louis and moved to Springfield in 2000. She worked at St. John's Hospital before deciding to try something new. She also took care of her mother, who died at the age of 49. Abcor Home Health provides nonmedical and skilled nursing care, enabling individuals to preserve their independence and quality of life in the comfort of their own homes. Since working for Abcor Home Health, Friarson had two clients die, which has been heartbreaking. She gets very attached to the people she's helped. She considers it "my honor to do for those who need it" and says "you have to love people" to do her job.

Suhadolnik, 82, fell and broke his arm and leg a year ago. That led to a lengthy hospital stay, which took its toll on Suhadolnik, who is incredibly active and before his injuries was typically at the gym by 4 a.m. It has been a long recovery. He uses a walker and no longer drives, but that has not dampened his energy or enthusiasm. He does four 20-minute relatively high-intensity workouts daily. He rides his Airdyne bike, does step-ups, walks 600 steps with his walker, and uses resistance bands and a chin-up bar.

He intends to live to 100.

Friarson is diabetic and weighed 317 pounds when she met Suhadolnik. She was down to 250 in November, and her goal is to weigh 200 pounds by January. Suhadolnik has helped many people transform their lives and lose weight by getting them to change their diet, avoid processed food and focus on nutrition and exercise. With Friarson he has a captive audience.

Friarson shops, cooks, cleans, helps with personal care and provides companionship

for Suhadolnik. He is particular about what he eats, with meals being 40% carbohydrates, 30% protein and 30% healthy fats. He provides the grocery list and guides Friarson on how to cook using fresh produce. "He motivates me," Friarson told Illinois Times. She's changed what she eats, drinks water and citrus green tea instead of drinking Mountain Dew all day and can now walk without being out of breath. She says many in her family are "on the big side." Now she is trying to motivate her family members as Suhadolnik has motivated her. Friarson has an 11-year-old son in sixth grade, who also inspires her to stay motivated.

Friarson says the next step for Suhadolnik is to help him get off the walker, while her goal is to get off insulin. Suhadolnik is a former math teacher, longtime building contractor and CrossFit coach. He's read a lot of nonfiction books over many years and now is focused more on writing to keep his brain active. Although he isn't back in the gym at Instinct Health and Fitness (formerly CrossFit Instinct), he has a weekly phone call with the Longevity class at 7 a.m. on Saturdays, sharing words of inspiration and encouragement. He puts a great deal of thought into his weekly messages and works on this throughout the week.

Suhadolnik started the CrossFit Longevity class for people 55 and older and trained others individually with the goal of helping people become more fit, active and healthy as they age. Mobility, balance, weightlifting and high-intensity workouts are all part of the program, along with consistent messages related to food and nutrition.

Suhadolnik believes there is no age limit to learning something new, and that "I can't" is a mindset that can be changed. He is committed to overcoming obstacles. He is a fan of Steven Pressfield, who wrote the book *Do the Work* to help people overcome all those obstacles that get in the way of completing a project that was started and never finished. Overcoming resistance is the focus of the book.

Coach Mike and caregiver Latasha are open with each other. "I'm interested in life and creating life," said Suhadolnik. "I couldn't be any happier." As for Friarson, she says she's a good worker and a loving person. "I love what I do." Sadly, Friarson's mother passed at age 49. That is also motivation for Friarson to improve her own health and fitness and be there for her son. Suhadolnik will encourage her every step of the way. "She's such a good person and has a heart of gold," he said. □

Old friends

Poetry unites this duo at the retirement home

George King and Dick Bilinsky didn't know each other until they and their wives moved into Concordia Village around the same time in 2023. The couples happened to join each other at dinner one night and, as George says, "We just clicked." Bilinsky adds, "I knew we were going to be friends when George revealed he'd dabbled in poetry and then regaled us with his dialects." Bilinsky, too, had written poetry over the years.

The two started meeting in the atrium at Concordia every Wednesday, sharing their lives. They discovered connections – King had worked in New York and Bilinsky had grown up there. They are both artists – King paints pastel works and Bilinsky is a sculptor. Bilinsky says, "We talked about problems of the world, art, politics, how to make life better at Concordia and started writing poems." People would stop and talk. The duo sometimes drew a crowd, and many teasingly asked, "What mischief are you two up to now?"

They had so many poems they decided to publish them in a book they titled, *Serendipity*, which describes the way the two happened to meet. The proceeds from the book went to help support the Concordia Art program.

Recently, they have published a second book, *Concordia Village: Life and Times in Rhyme.*

Greta Huseman, director of community enrichment at Concordia, says, "The book is now given to new residents in their welcome bag."

The poems are witty, poignant, thought-provoking and range in subject matter. There are comments about staff at Concordia, as in the poem, *Whistling Chef*, that reads "Cheers to Stephane, our great chef/Who whistles in all kinds of clef." Or the poem *Wonderful Waitpersons*, who "bring our daily bread, serve our vital vittles and napkins to blot our spittles." There are poems about the incessant geese hanging around the complex, views of life looking out the windows, comments on aging (calling life a game of pick-up-sticks), and accepting new realities.

"I've not experienced as stifling woes, As those from my compression hose. Once they're on, well, that's OK. But getting there I have to say Is just akin to reasoning with teens Or putting on some very tight jeans." King is a retired public relations and marketing executive. Bilinsky is a retired nephrologist. Their story proves that new horizons are possible at every stage of life.

For the men, life is still full. King says, "You never know what might light up someone. People can be in the doldrums, but something might trigger them to get engaged. That is true here at Concordia. There are so many things to do, it would be hard to be a hermit. Our apartment looks out over Meadowbrook and the Casey's Pub, and you realize there is still life out there."

Bilinsky says, "I never expected to find someone who has so many things in common with me. It has been refreshing, and we just keep writing."

Some might think the door is shutting as age sets in, but it is always ready to be reopened. George King and Dick Bilinsky are proof of that. □






Mysteries of central Illinois

Two local writers - Ladd Mitchell and Mike Stutz (Ray Roentgen) - bring stories home

Sports, mystery, intrigue – two local authors have recently published novels that have similar ingredients but different themes. Mitchell's book, *Theory Markspurn*, takes readers deep into the world of volleyball. Those who know little about the sport will quickly learn terms and rules. Mike Stutz, in his novel *Murder in Athens (pronounced Aythens)*, spins a tale around former high school soccer team buddies. Both books add a bit of mystery and intrigue. In both novels, the main character struggles with identity, and both show that we may not know a person as well as we might think.

Murder in Athens (pronounced Ay-thens) by Ray Roentgen – aka Michael Stutz

Ike Lowe has just moved back to central Illinois after his wife's death and struggles with what he wants to do with his oncology practice. On his way to the hospital one morning, he sees something on the side of the road and stops, discovering a dead body. He realizes the victim is one of his former soccer buddies from high school. What transpires is a mystery. Lowe joins forces with FBI agent Asteria Papadopoulos to find out who has killed several African American women in the area.

Lowe pursues clues and discovers all his former soccer teammates could be the murderer, and then he, too, is named a suspect. As the story unfolds, Lowe discovers hidden secrets about people in his hometown and the guys he thought he knew. Lowe fights against blackmail and must confront his friends to get to the truth, a process that leaves him dismayed at what he finds.


Stutz, now a radiation oncologist at Northwestern Medical Group in Geneva, Illinois, grew up in Springfield and still has family here. He wrote the book under the pseudonym of Ray Roentgen, as he explains, "William Roentgen discovered the x-ray so I used Ray Roentgen for my name." The novel is full of names of places in the Land of Lincoln. Of course the title, explaining the correct

pronunciation of Athens, Illinois, is a clever reminder for those who incorrectly pronounce the town after the Greek city.

"I was spurred to write about the hometown where I grew up," Stutz says, "and to use the concept of not really knowing some truths. We weren't taught about the 1908 race riot, so finding out much later about that when thinking our city was the home of the E-mancipator was a big disconnect. In the novel, people discover hidden truths about others."

The novel is available on Amazon for \$15. Stutz donates part of his sales to charities, in Springfield, to the Boys and Girls Club. He has another book in the works which will be a prequel to *Murder in Athens*.


Both books are interesting reads – one a murder mystery, the other a mental mystery.

Theory Markspurn by Ladd Mitchell

Theory Markspurn is a collegiate star on Petrusia University's volleyball team – driven, committed and overly disciplined. Whether at practice or in a game, or in her kinesiology class taught by the toughest professor on campus, Theory never deviates from the task at hand. That is until she finds a book, secretly left in her locker, that whirls her into a world that isn't real – yet; it seems real as it is the story of Katy who has all the traits of Theory. In this story, Katy (Theory) does things Theory would never do, such as break into a locked campus building. Theory begins to live vicariously through the story.

Theory may show strength and confidence, but underneath that façade exists her feelings of not being good enough and the hatred of the after-game interviews that she disguises by counting off the seconds to herself to get through them. The book takes her into a journey asking why. Mitchell says, "We look up to athletes and see their expertise in their game, but what stress are they facing underneath? I chose the sport of volleyball after watching my wife play and then realizing very little coverage of that sport is televised."

Theory's friends see her carrying the book with her – wondering why, since they

only see blank pages inside. As Theory reads more, she begins to see visions, confuses what is real and what is not, and begins to fall under a spell that continues to draw her to the book, even touching it in her pocket for comfort. But the spell spins her into deeper problems.

Mitchell creates a twist-and-turn plot that becomes a thriller and exposes the need to stop and question what we do, what drives a passion, why we pursue that passion, and then ask the hard question – Is this really what I want? Mitchell says, "My book may be about an athlete, but anyone pursuing a passion may need to think about their why."

A museum for the right to vote

Tiny El Paso celebrates a cornerstone of democracy

When El Paso, Illinois, high school history teacher Michael Melick decided to have his advanced class focus on local history, he didn't predict it would result in a museum devoted to voting rights in this heart-of-corn-country town, population 2,730. El Paso is north of Bloomington, 87 miles from Springfield.

But while Melick initially may not have envisioned the Project XV Museum coming to life in downtown El Paso, others soon joined him in creating what promises to be unique in Illinois. The museum devotes itself to the 15th Amendment to the U.S. Constitution, seeking to "honor the legacy of those who have fought for (the vote) and empower others to use it," according to its website.

Melick may have been wary of tackling such a big project but now sees its importance. "Here we are in 2025 and the next generation has to fight to preserve (the right to vote)," he says. Historically, more than half of Americans didn't have that right to vote. "We've moved in the right direction but we have more to go."

The museum is open from noon to 4 p.m. on Mondays and by appointment but should add days as more exhibits are funded and completed. The goal is to have all major ones ready in April, a year since the first exhibit opened.

Already, exhibits detail the struggles for voting rights for minorities and women and include such artifacts as slave shackles and a voting booth, complete with hanging chads on Florida ballots from the 2000 presidential election. Also part of the museum is the restored 1872 barbershop of David Strother, the first Black man to vote in Illinois and the inspiration for those high school history students.

The students started studying El Paso history in 2019 and came across Strother, who was born in 1843 to free Blacks in the slave state of Missouri. After his father died, his mother moved the family to Peoria, so she could raise her children in a free state.

Strother worked on riverboats, served as a cook with General Ulysses S. Grant's troops in the Civil War and later moved to a relatively young El Paso. Several of his war buddies encouraged him to start a barbershop in the town, which grew because it was on a train line.

"He must have been good, as he shaved David Davis," says Museum Curator Brian Ulrich. Davis was a prominent judge, friend of Abraham Lincoln and one of the many white customers Strother groomed. Ulrich noted that Black barbers at the time had to choose Black or white customers, and with El Paso having only a few Blacks, Strother served only whites.

"He was beloved here but had to make a choice," Ulrich says. "You couldn't step over the color line"

El Paso held a mayoral election soon after the 15th Amendment, ratified on Feb. 3, 1870, gave Black men the vote. That lead to Strother being among the first Black men in the country to vote, and the first in Illinois. The amendment was so new that one election official initially turned Strother away, but reversed when shown evidence the Constitution had changed.

Next to Strother's barbershop with chairs, shaving mugs and a rainwater shower, other exhibits explain his life and the practice of early barbering. You can strap on a virtual reality headset and an actor's voice helps you maneuver through the shop and adjoining exhibits.

The virtual reality exhibit is likely popular with the school groups the museum is already hosting. The museum includes a small classroom and two play areas for children, including their own voting booths.

Melick says the museum plans to add a big exhibit on the Voting Rights Act of 1964 and gather ballot boxes from different eras. An interactive literacy test will help tell the story of how Blacks were discouraged from exercising their right to vote in certain areas.

A recording studio devoted to "Your Vote, Your Voice" will allow visitors to add their narratives to voting rights history and researchers to focus on such human-based experiences rather than solely on numbers, Melick says.

Ulrich has had a major hand in planning and organizing the exhibits, assisted by a board of university history professors, local businesspeople and Melick. A native of El Paso, Ulrich spent years working in various media in Los Angeles before moving back to lend his expertise. He produced the museum's introductory video introducing Strother.

Another planned exhibit will have different filters for news sources, illustrating how voters don't always get a full picture of events. An interactive display for lesser offices should make better voters, Ulrich says, adding the museum would like to become an official polling place.

He emphasizes the Project XV Museum is nonpartisan, "We take great pains to keep things fair." The museum has not faced negative pushback and has support from private and corporate foundation grants. A spring gala is a major fundraiser, and visitors are encouraged to leave donations of \$15 for adults, \$10 for students and \$5 for those aged 3-10.

Melick says it is important for the museum to be in El Paso. "Strother was from here so it is our story to tell."

Panna cotta

This chilled, rich dessert hailing from northern Italy is easy to make

Panna cotta is a chilled dessert that manages to be simultaneously rich yet delicate and perfectly elegant while still economical and make-ahead friendly. Hailing from the northern Italian region of Piedmont, the name panna cotta literally translates to "cooked cream," though in reality it spends very little time on the stove. The preparation is simple and calls for briefly heating cream and sugar before incorporating gelatin and allowing the mixture to set.

Though it is traditionally served as a dessert, the first panna cotta I ever had was indeed a savory offering, served as an impossibly decadent first course of a meal at Chicago's gorgeous North Pond restaurant. The pearl white creation was topped with a generous dollop of caviar and a shower of chives. The memory of it is still imprinted on my brain as one of the most delicious things I have ever eaten, a worthy foil to a crisp glass of Champagne.

Whether you are making a sweet or savory preparation, it's important to use the best quality cream you can find. Because the recipe has such a short ingredient list, the quality of the components really stand out. The panna cotta itself can have melted chocolate, pumpkin purée or lemon zest incorporated into the cream mixture for a boost of flavor. When it comes to toppings the variations that can be produced are virtually limitless, from caramel to berries to clouds of fluffy whipped cream. Savory panna cotta can be augmented with a whole host of vegetables, including beets, broccoli, carrots or spinach and topped with luxe caviar, shrimp or fresh herbs.

Panna cotta with vanilla poached citrus

Ingredients:
For the panna cotta:
2 ½ teaspoons (1 pouch) gelatin
½ cup sugar
A pinch of salt
2 cups cream
1/2 cup whole milk

For the poached citrus:

1 teaspoon vanilla bean paste

1/4 cup water

1/4 cup sugar

4 oranges (a mixture of naval and Cara Cara oranges is pretty)

First, prepare six ramekins on a baking sheet



and chill in the refrigerator until thoroughly chilled. Next, bloom the gelatin. Add three tablespoons of cold water in a bowl and sprinkle the gelatin over the top and let rest for five minutes to soften the gelatin.

Combine the cream, sugar and a pinch of salt in a saucepan over medium high heat and cook, stirring constantly, until it just begins to simmer. Pour the cream mixture into the bowl with the softened gelatin and stir until the gelatin is dissolved, then stir in the milk and vanilla. Pour the mixture through a fine meshed sieve into the ramekins and chill for at least four hours, or preferably overnight.

While the panna cotta in the ramekins chills, make the poached citrus. Slice off both ends of the oranges so they'll sit flat. Lightly slice off the peel and pith, following the curve of the fruit. Holding the orange over a bowl to catch the juice as you segment the fruit, remove the segments of fruit by slicing along the side of the segments to cut away the membrane, continuing until all of the segments have been released.

Squeeze any excess juice from the remaining flesh/membranes into a small

non-reactive saucepan. Add the water, sugar and a pinch of salt and bring to a simmer over medium heat, stirring occasionally. Add the supremed oranges and simmer for five minutes, then remove from heat and let cool to room temperature before transferring to a container. Refrigerate until chilled.

When ready to unmold the panna cotta, dip the ramekin in hot water for 20-30 seconds, being careful not to get water over the rim. Invert the ramekin onto a plate and jiggle it gently to release. Top with a spoonful of the poached citrus and a drizzle of the syrup and serve.

Cauliflower panna cotta with caviar

Ingredients:
2 tablespoons butter
8 ounces cauliflower florets
1 cup heavy cream
Salt
Chives, lemon zest and caviar, to serve

Place six ramekins on a baking sheet and chill. Brown the butter in a saucepan over medium heat. Add the cauliflower florets and just enough water to come to the top of the vegetables (don't submerge them). Simmer over medium heat until the vegetables are very tender and the liquid has reduced by half, about 15 minutes. Add the cream and simmer for an additional 15-20 minutes until the liquid has reduced by half. The total volume of the contents should be roughly two cups.

Transfer the contents of the saucepan and puree until totally smooth. Season to taste with salt, then pour the mixture through a fine meshed sieve back into the saucepan.

Place 2 tablespoons of water in a small bowl and sprinkle in the gelatin to soften it. Gently warm the cauliflower puree until it's just beginning to bubble but not fully simmering. Turn off the heat and stir in the softened gelatin, then spoon the puree into the chilled ramekins. Refrigerate until thoroughly chilled, at least four hours. Unmold as directed above, then garnish with a dollop of caviar and a sprinkle of chives and lemon zest. □

Put on a happy face

Bye Bye Birdie at the Hoogland

Bye Bye Birdie is a satirically corny, upbeat and schmaltzy musical waxing nostalgia about the 1950s. The show was a hit on Broadway when it debuted in 1961 and only grew in popularity with the release of the 1963 Ann-Margret film. It delivers a hefty songbook of toe-tapping tunes including "How Lovely to be a Woman," "Hymn for a Sunday Evening" and "A Lot of Livin' to Do," but some of it hasn't aged well. Bye Bye Birdie is not nostalgia seen through a contemporary lens – it is of and from its real time.

Director Kevin Hart believes that although pieces of it are dated, it is still deserving of high praise. "This is one of my favorite camp musicals. It's a sweet, funny show with golden-age music," said Hart. It does deliver an uplifting message, and with a large cast comprised of children, teens and adults, it offers a chance for all audience members to be engaged in its storyline.

The plot centers around a two-fold dynamic. One is teenage girls swooning over an Elvis-like character, Conrad Birdie, who is leaving for the military and bestowing a goodbye kiss to one lucky gal, Kim McAfee (played by Julia Rolens), in small-town Ohio for a wholesome public relations stunt. The

other is a love story between businessman Albert Peterson (played by Elijah Sadler) and his secretary, Rosie Alvarz (played by Bella Gauna), and the thorn that keeps them apart – his racist and narcissistic mother, Mae (played by Lisa Goldbergbelle). This rock 'n' roll mania colliding with deeply dysfunctional family dynamics makes for a funny, but sometimes cringy, look at 1960s American culture.

A shining point in this production is the portrayal of McAfee by the exuberantly talented Rolens. She perfectly embodies the character's quirky, girlish personality and even resembles a young Ann-Margret. Her charming rendition of "How Lovely to be a Woman" is much funnier than the on-screen version because Rolens actually does appear to be 15 years old. She's the type of performer who draws your attention and will likely have a line of leads in her future.

"Kim is a lot like me, but playing a more mature role has been a challenge because I've never had to act like I'm smoking cigarettes before," said Rolens. Regardless of her inexperience with 1950s teenage rebellion lungcancer props, she nails the part.

Kim's friend, the Conrad-obsessed Ursula played deftly by Shelby Cass, also has highly tuned comedic timing. Her characterization is hilarious and reminiscent of Lily Moscovitz in *The Princess Diaries*. One would never guess she's 10 years older than the rest of the onstage "teens," and she leads her Conrad cult with a witty and youthful commitment.

The star of the show, both in plot and presence, is Jakob Hankins in his portrayal of the pelvic-thrusting icon, Conrad Birdie. From his entrance – which is comedically silent and exquisitely timed – Hankins feels larger than life, commanding the stage with the right balance of charismatic swagger and self-absorption. His physical performance is ceaseless: As he continually saunters across the stage, some part of him – from his shoes to his pompadour, is perpetually gyrating. His magnetic control with clear and confident vocals solidifies his performance as a genuine, irresistible rock 'n' roll legend.

Part of these actors' success is due to their period-perfect attire. Female leads Rosie and Kim, who each have multiple costume changes, are dressed especially well throughout. With an enormous cast, this show is a difficult one to costume, and everyone from ensemble to Birdie looks spectacular. This is a feat not often achieved in community theater. Costume

designer Jessica Kent deserves applause for her great success here.

Unfortunately, there are some uncomfortable moments – such as an exceptionally long dance break where Rosie performs a watered-down burlesque show for a group of slapstick Shriners. The problem is not with the performance itself, but the fact it is happening at all. This scene is often cut in modern productions, as sensibilities have changed, and it's understandable as to why. As an audience member, one feels they should avert their gaze or jump in to save her from whatever is about to transpire.

There are lovely singing bits, especially when the McAfee family harmonizes, and it is always a joy to watch groups of kids and teens having a fun time onstage together. Although *Bye Bye Birdie* struggles to meet today's societal standards, it works as a period piece – a highenergy, colorful wink-and-a-nod to a time gone by.

Bye Bye Birdie continues its run Dec. 12-14 at the Hoogland Center for the Arts in the LRS Theatre. Friday and Saturday performances start at 7:30 p.m. and the Sunday matinee begins at 2 p.m. Tickets are available by calling 217-523-2787 or visiting HCFTA.org. □


