



# The cost of free speech

Federal employee forced into early retirement after social media post criticizing the government

Larry Criscione has it pretty good by most people's standards. He's a nuclear engineer who paid off his house many years ago. The Springfield resident owns 17 rental properties in the area and, at the age of 57, recently took an early retirement pension package from the Nuclear Regulatory Commission at \$3,350 a month. That will allow him to spend a lot more time with a family that includes nine grandchildren, after a career that often required him to be away from home months at a time.

Criscione, though, is angry. Angry at essentially being forced out of his job as an operations engineer at the NRC, which has a regional office in Naperville. Angry that a social media post, in which he referred to a top NRC official as "spineless," was used as justification to begin a termination process. Angry that, included in his initial notice of potential termination, other incidents from his long career in nuclear power were dragged into the picture.

"Most humans cannot stand hypocrisy," said Criscione, always twisting a napkin into a skinny rope as he talked. "But they also have this selfpreservation instinct where they're not going to yell at the king if he has no clothes. Whereas, I've always been willing to point it out."

As many federal government employees in the second administration of President Donald Trump have learned, critics can be subject to harsh reprisal despite what the law says are First Amendment rights. On Sept. 30, while on furlough due to the government shutdown that officially began the next day, Criscione opened this email from the NRC:

"President Trump opposes a government shutdown and strongly supports enactment of a House-passed continuing resolution that would keep agencies funded through Nov. 21. Unfortunately, Democrats are blocking this continuing resolution in the U.S. Senate due to unrelated policy demands," the email said. "If Congressional Democrats maintain their current posture and refuse to pass a clean continuing resolution to keep the government funded before midnight on September 30, 2025, federal appropriated funding will lapse."

The NRC's email to its roughly 8,800 employees had the name of associate director Jody Martin attached, and Criscione took to his personal LinkedIn account later that day.

"What kind of a man looks the other way as laws are disregarded? What kind of a man does what they know to be wrong?" Criscione wrote. "What kind of a system allows such a man to rise to the upper levels of 'leadership' at a vital federal regulatory agency? The framers of the Constitution predicted Trump. And they predicted Jody Martin and the rest of the spineless bureaucrats who do his bidding."

On Nov. 3, Martin's colleague at the NRC, deputy executive director of operations Sabrina Atack, had a conference call with Criscione. She would be recommending that he be terminated for his comments and cited other incidents in his employee file that, despite being cleared of any wrongdoing, she nonetheless thought were germane to the situation.

"Your comments regarding NRC senior leadership were unbecoming and disruptive because they subjected Mr. Martin to public ridicule and targeted him for public harassment," Atack wrote in a memorandum to Criscione. "Moreover, your unauthorized postings fostered a disruptive working environment within the NRC, with the potential for inciting fear and violence towards NRC leadership, thereby undermining NRC supervisory authority."

# Criscione, through a Freedom of Information Act request, showed that nothing in his LinkedIn post, nor anything else in his HR file, had broken any First Amendment rights of federal employees. There was no public disclosure of any information that shouldn't have been made public. When confronted with the FOIA findings, the NRC quickly offered an enhanced early retirement package instead of a firing. In agreeing to the deal, Criscione gave up his right to sue the NRC, but not the right to talk about it.

"When you're a person like me, the cards are stacked against you. They've got the whole treasury of the U.S. government to pay attorneys and fight me. And I've got NGOs or I've got to fund this out of my own pocket," Criscione, a U.S. Navy veteran, said. "In terms of calling the guy spineless on LinkedIn, I used to do that all the time on agency-wide emails. But I was a union steward. It was my job to point out when they were being hypocrites. With this LinkedIn post, I was a citizen expressing my disgust in a public forum on the partisan email that I got. They're making all these agencies partisan. They are not supposed to be."

Criscione said he was threatened with prison time by the federal government over a situation when, while working at the Callaway nuclear plant in Kansas in the early 2000s, he alerted members of Congress to potential flooding and safety issues there – the kind that happened at the Fukushima nuclear plant disaster in 2011. Criscione said someone in Congress then leaked his concerns to *The Huffington Post*.

That caused a firestorm, with Criscione being threatened with charges of computer fraud. It was a weak case, which is why the office of the Inspector General declined to press charges. But, Criscione said, he was left to twist in the wind for more than a year, unsure if he'd be indicted any day. He eventually won a \$550,000 settlement from Callaway, but moved on to more of an office job at the NRC in Maryland.

"I had a target on my back, not because my boss didn't like me, but because upper management hated me. I would call them out as liars all the time for violating the union contract. I don't call people out like on the playground. I give the facts," Criscione said. "I talked to 30 scientists who had real concerns with the flooding. They envisioned the Fukushima accident before it even happened at Fukushima. There was no reason why this had to be kept from the public. It was just me transparently sharing with the public what's going on."

In response to an interview request from *IT*, an NRC spokesperson wrote, "It would be inappropriate for the agency to discuss personnel issues."

Attorney Tom Pavlik of Delano Law Offices in Springfield, which has expertise in employment law, said his firm is seeing more employers implement strict social media policies. Social media can be dangerous, he said, for anyone employed in private industry, noting that many people nationwide were fired for their social media comments about the recent murder of political activist Charlie Kirk.

"Frankly, the biggest misconception is that far too many people incorrectly think the First Amendment applies to private citizens," Pavlik said. "It restricts the government from disciplining workers, not private employers — and even then, those protections are still not absolute."

While not working for Criscione in any capacity, Pavlik offered some analysis of his

"(It) centers on whether he was speaking as a private citizen, if it was a legitimate issue of public concern, and did it disrupt the workplace or interfere with his workplace duties?" Pavlik said.

Criscione said, "I got in trouble because the No. 2 person in the agency didn't like me sharing an email with a coworker's name on it on a LinkedIn post. I don't think that's any way to be stewards of the public trust."

What will Criscione do moving forward? Other than being a husband, father, granddad and landlord, he's not sure. But one thing already seems assured: Larry Criscione won't go quietly into the night. □

#### Editor's note -

In Springfield Monday Gov. JB Pritzker set the right tone for this season when he and other Jewish leaders assembled to light the state menorah. He first expressed his grief about the mass shooting in Australia which killed 15 at a Hanukkah celebration. Pritzker said he is angry "at those who stoke the embers of a fire that seems to continue to burn in the hearts of bigots everywhere," and "Antisemitism and hatred across the board have been on the rise for the last several years." # More state funds to help Springfield's unhoused

Three local agencies will share \$2 million in additional funding that could offset federal cuts

Gov. JB Pritzker's decision to more than double state funding for programs designed to reduce homelessness in Sangamon County will help the community make meaningful progress and blunt a potential reduction in federal funding from the Trump administration, Springfield officials say.

"We're just not used to this type of investment," Josh Sabo, executive director of nonprofit Heartland Housed, said after a Dec. 15 announcement by the governor at Helping Hands of Springfield. "But all of the work that has gone into strategic planning has created a foundation where we know what to do – our organizations are growing and scaling up, and they're already housing people with this money."

Christine Haley, the Democratic governor's chief homelessness officer, said the Pritzker administration reallocated money within this fiscal year's \$263 million Home Illinois program to give Springfield service providers \$2 million more on top of the \$1.2 million that the local system receives from the program annually.

"Today we are recognizing the lifesaving work of the Springfield community to protect its poorest residents," Haley said at the news conference at Helping Hands, 2200 Shale St. "The state of Illinois is proud to partner with Springfield to end homelessness."

Haley noted that people experiencing homelessness are 38 times more likely to die from cold weather-related health problems, and their average age of death is 56, almost 20 years younger than people who have stable housing.

Sabo said state officials approached Heartland Housed earlier this year to discuss ways of supplementing local efforts to serve people experiencing homelessness after learning about the community's strategic plan to address the issue and how constraints in funding were creating challenges.

The goal with the \$2 million in additional funds is to demonstrate success so the supplemental money can be added to the \$1.2 million in future years, he said.

Heartland Housed wants to reach

"functional zero," which would mean the number of people experiencing homelessness and entering social-service programs each year roughly equals the number exiting the system and finding or being placed in permanent housing.

The new funding, Sabo said, is designed "to see if a community our size can really make a significant impact in the direction of functional zero, so it's a bit of a pilot project from that standpoint."

Sabo said the additional money already has begun to flow to the community's three nonprofit groups administering permanent supportive housing programs – Helping Hands, Fifth Street Renaissance and Mercy Communities.

Those organizations, he said, are using the money to pay rent and provide counseling and other supportive services to people who previously were unhoused.

Sabo estimated that the \$2 million would help create 200 more permanent housing slots.

Pritzker said state Sen. Doris Turner, D-Springfield, Springfield Mayor Misty Buscher and Sangamon County Board Chairperson Andy Van Meter are working together "to make historic investments in our state's beautiful capital city to ensure it has a vibrant, thriving future."

Pointing to the Springfield and Sangamon County 2022-2028 Strategic Plan to Address Homelessness, Van Meter, a Springfield Republican, said, "If we had not done that preparation, we would not have been eligible for the funding that Gov. Pritzker has made available. We were very carefully vetted to make sure that we had a system that could appropriately deploy the funds."

Buscher commended the governor and local officials for caring about "our most vulnerable citizens." She said she talks with mayors across the country, and homelessness, along with mental health and drug addiction, are the biggest problems their cities face.

"Our governor in Illinois is committed to making Illinois a state that is a leader in these issues," Buscher said. "Not all states have this. We have to remember how lucky we are for this leadership."

Pritzker and Haley said the Home Illinois program, funded with state general revenue fund dollars and formed three years ago, has seen progress in reducing homelessness in many parts of the state, including Springfield.

But Pritzker, widely discussed as a potential candidate for president in 2028, said, "The MAGA Republican administration in Washington is attempting to turn back the clock."

Trump issued an executive order in July directing federal agencies to make changes to policies in response to what Trump called billions of dollars in federal funding "on failed programs that address homelessness but not its root causes, leaving other citizens vulnerable to public safety threats."

At Trump's direction, the U.S. Department of Housing and Urban Development signaled that it would reduce future funding for permanent supportive housing by 60% to 70% in favor of other priorities such as transitional housing.

Facing lawsuits, HUD has temporarily paused the new funding priorities. Those new priorities would, among other things, reward communities that crack down on

"illicit drug use" and enact local laws to fine and jail homeless people when they sleep on public property.

If not changed, the new funding rules would reduce the current \$600,000 in annual funding for Springfield-area homeless agencies to \$180,000 and reduce the number of formerly homeless people receiving housing support from the current 79 to 23.

The federal government's mandated one-day count of homeless people in Sangamon County totaled 374 in 2025, a slight decrease from 388 in 2024. But the one-day count was 284 in 2019, so the one-day count has risen by 32% over that five-year period.

The number of people needing homeless services locally has risen while the number of homeless people finding permanent housing in Sangamon County has jumped by more than 300% in the past six years, Sabo said. In 2019, 94 found housing, compared with 380 in 2025 as of Nov. 1, he said. □



# **Town & Country Shopping Center staying the course**

After center fails to sell at auction, current owner says he still plans to redevelop it

The future of the Town & Country Shopping Center on MacArthur Boulevard is unclear after the aging strip mall failed to sell at auction this month, but the owner of the property says he remains hopeful it will be redeveloped.

"I'm always optimistic because as a real estate developer, you have to be optimistic," David Bernstein, president of Miami-based Larkspur Properties, told *Illinois Times*.

Larkspur purchased the 260,000-square-foot shopping center in 2022. The investment firm, which specializes in distressed residential and commercial projects, was the top bidder at \$5.77 million.

The retail area, built in 1961, was Springfield's first outlying shopping center. At the time of the sale, it was 65% vacant.

Following the sale, then-Ward 7 Ald. Joe McMenamin told *Illinois Times* he had walked the site with Bernstein and was "very impressed" with his company's plans for the property. Bernstein's concept has called for building 40 to 50 apartments in a three-story complex that would be perpendicular to MacArthur Boulevard, creating more green space by leveling some storefronts and transforming the former Burlington Coat Factory store into climate-controlled units for indoor storage.

In November 2024, the Springfield Planning and Zoning Commission approved a conditional permitted use, which would allow apartments to be built on the site along with retail space.

But Michael Higgins, president of the MacArthur Boulevard Association, said little

has been heard from the developer since then. When the property went up for auction again recently, local officials expressed dismay.

Higgins cited the recent opening of Scheels Sports Park at Legacy Pointe and planned widening and extension of MacArthur Boulevard by the Illinois Department of Transportation as key parts of the revitalization of the business corridor.

"Town & Country (redevelopment) would be a major piece of a lot of pieces going together," he said.

When he spoke with *IT* this month, Bernstein was mum about potential business partners or the strategy behind putting the shopping center on the auction block. But McMenamin, who no longer serves on the city council but remains active in the MacArthur Boulevard Association, told *IT* in October when he spoke with Bernstein earlier this year the developer told him he was concerned inflation was raising the cost of the building supplies needed for redeveloping the site.

McMenamin and another MBA member spoke with Bernstein and was told a planned business partner dropped out, leaving him in the lurch.

Sometimes auctions are used by developers to identify potential co-investors in projects by setting the minimum selling price high and then contacting bidders in the wake of the unsuccessful sale.

"I can't comment on that because there may be negotiations ongoing," Bernstein said. "The answer is to be determined. It obviously just happened, so we don't know the answer."

The property previously was owned by an investor group that included Springfield developer Corky Joyner and former city attorney Jim Zerkle. Ownership later transferred from Joyner and Zerkle's limited liability company to JPMorgan Chase before being sold to Larkspur Properties. □



# **Illinois' George Washington**

Nathanial Pope, the man who gave Chicago to Illinois

Every December, Illinoisans celebrate the commonwealth's admission to the Union as the 21st state in 1818. Well, some do. Actually, hardly any do. Most Illinoisans seem reconciled to their membership in the commonwealth but seldom proud of it; a not insignificant number of downstaters hereabouts daydream about secession that might free them of that yoke and allow them to be reborn as Hoosiers. They must feel about Nathanial Pope the way white Georgians feel about Lincoln.


If they've heard the name of Nathaniel Pope at all. He was the portly Kentuckian who more than anyone was responsible for creating the modern, cosmopolitan, industrial Illinois the rest of us know and some of us love. Illinois was carved from the old Northwest Territory; Pope was the legislative delegate to Congress who negotiated the terms of admission, including, crucially, the borders of the new state.

Congress had suggested that the northern border of the new state extend west from the southern tip of Lake Michigan. Pope hadn't forgotten that French explorers as early as the 1670s had realized that a canal could easily link Lake Michigan at Chicago with the Des Plaines and Illinois rivers and ultimately the Mississippi and the world. Pope thus amended the statehood legislation in part to shift that border north to the 42° 30' parallel. That gave Illinois 43 miles of shoreline, including the spot where the Chicago River dribbled into the lake. As a result, most of what we know as northern Illinois was spared becoming southern Wisconsin.

When that canal was eventually built it made Chicago and Chicago made Illinois. But just as important to Pope as making Illinois an important state was keeping it free. Even in 1818 the smell of rebellion was in the air. As Gov. Thomas Ford would later explain, "If a large portion of [Illinois] could be made dependent upon the commerce and navigation of the great northern lakes connected as they are with the eastern States a rival interest would be created to check the wish for a western and southern [proslavery] confederacy. To accomplish this object effectually, it was not only necessary to give to Illinois . . . a considerable coast on Lake Michigan, with a country back of it sufficiently extensive to contain a population capable of exercising a decided influence upon the councils of the State."

It probably doesn't need to be pointed out that among those who wished for a proslavery western and southern confederacy were the many downstaters who hailed from the South, or that the people capable of exercising a decided influence upon Illinois' new government were the pro-Union emigrants likely to pour into the enlarged Illinois from the east. By giving Illinois Chicago and its hinterland, Pope gave Illinois to the North – and Lincoln to the nation.

Often dismissed as a sleazy bit of Illinoisstyle politics, Pope's triumph in Washington was in fact well-earned; Illinois College historian James E. Davis judged delegate Pope as "politically astute, focused and tireless." No one in Congress was bought off or bullied to pass Pope's amended statehood law, nor did

Pope's actions pervert the aims of Congress regarding the development of the Northwest Territory. Yes, he persuaded the relevant congressional powers to shift the boundary; so did Indiana when it petitioned for statehood and for the same reason.

Pope's performance came closer to statecraft than mere politics. Might he be thought of as Illinois' George Washington perhaps? (Historian Robert Howard thought he even looked like Washington.) Like Washington, Pope's ambition was for Illinois, not himself. Pope was satisfied to spend the rest of a quiet life on the federal bench and never entered politics save for an unsuccessful run for the U.S. Senate in 1824.

Perhaps for that reason Pope remains little known. The bookshelves groan under the weight of books about has-beens and never-shoulda-beens in Illinois politics and government, but we have no full-length scholarly biography of Pope. In spite of the fact that, as Howard put it, "few men have achieved as much for Illinois as Pope did," his memory is honored by being attached to one of the state's poorest and remotest counties.

A statue of Judge Pope in the Statehouse seems not enough of a tribute as it would put him in company of so many smaller men. Considering that Chicago wouldn't be in Illinois had it not been for Pope, the state's wise men might have named the State of Illinois' new main office building in downtown Chicago after Pope rather than for a careerist pol whose achievement was to shorten lines to get a driver's license by 10 minutes. Alas, Illinois often hasn't been able to distinguish its great citizens from its merely successful ones.  $\square$

# From planning to implementation

How the town of Normal revitalized its downtown and is building on success

Imagine a vibrant town center that serves as a hub of cultural and social activity. There's a beautiful, tree-lined roundabout and plaza in the middle of it all, with a water feature that serves as a splash pad for children on a summer day, and a nice spot to read a book or to catch up with friends. All the while, it dutifully purifies the town's stormwater. A multimodal transportation hub makes getting to the heart of downtown convenient and safe. Attractive storefronts with a variety of retail options invite eager shoppers. Wide sidewalks fringed with unique plantings invite pedestrians to explore. A full-service convention center is only steps away.

In 2000, the town of Normal dreamed it. Then they did it.

#### A downtown going downhill

In 1999, downtown Normal was like a lot of other downtowns across the country. It had lost its shine. Historic buildings were showing their years. Many were in a state of disrepair, having lacked investment for a decade or more. Some suffered in the hands of absentee owners.

Marginal retail uses predominated. Smoke shops, tattoo parlors, piercing salons and a few restaurants primarily served the student population at Illinois State University, which is embedded in downtown.

There was a lot of turnover. Longestablished retailers were leaving for the east side, where new commercial development was enlarging Normal's footprint with a combination of big box retailers and strip malls. Most non-student residents weren't venturing downtown.

"It was generally shabby," said Mark Peterson, who served as Normal's city manager for 30 years.

#### The turnaround plan

The city council identified that the downtown needed an intervention and hired Farr Associates Architecture & Urban Design to codesign the downtown with the community. There were more than 60 public meetings – a herculean task in itself, but key to community buy-in, which was, at times, hard-fought. Farr Associates provided several options, ranging from modest in scope to ambitious.

The council aligned on the need to be bold, approving an ambitious project, said Peterson, knowing that "the clean-up, paint-up, patch-up, fix-up was a short-term solution that would just delay the decline."

The Downtown Renewal Plan was adopted in July 2000. The town had no debt, which put it in a great financial position for a major undertaking.

The town implemented a tax increment financing (TIF) district in 2003 to spur reinvestment, ultimately acquiring \$297 million in funding from a mix of federal, state and local sources. The financing included nearly \$85 million in bonded debt.

Peterson recalls a conversation with Mayor Gary Funk, who said he'd staked his political career on a pay-as-you-go philosophy. The planning consultant in the room said, "No developer is going to come in with a hope and a prayer that this kind of development is going to take place. You've got to do that up front." So, they did.

#### **Getting it done**

Prioritizing projects was key, Peterson noted. "We completely removed almost all the streets and replaced all the underground utilities. Most of them were 50 to 100 years old. You know, it doesn't make sense to build new stuff on top of a public infrastructure that's falling apart. So, we bit that bullet, because we knew it would have to be done at some point."

Things got worse before they got better. "You couldn't use the front door of a business," Peterson said.

He described an intensive effort for the city's public relations director to visit businesses daily to check in and share updates. It was a strain, and a few businesses closed.

The Children's Discovery Museum, which Normal owns and the museum operates in

partnership with the town, was an early win that set the bar for development. The Marriott Convention Center was another milestone.

Engineer Wayne Aldrich was the downtown development director. He said that a plan is only as good as its implementation. "You have to have the vision, the leadership, and the fortitude to get things done," he said.

Aldrich emphasized the role of city staff and professional consultants in the implementation process. "Politicians can come and go, but staff stick it out," he said.

Virtually every significant project involved a public-private partnership. There were inducements for developers including TIF, façade grants, discounted parking and cash for operating.

"The numbers have to work," Peterson said. "That's the bottom line. The cost of construction is much more in an urban area than in a cornfield."

#### The impact

Mercy Davison was the city planner hired to undertake the project. She is currently Normal's director of planning and zoning.

"There are more people in Uptown than there have been in many, many decades. Property values are way up. Tax revenue is way up. It's where people take visitors. Uptown is basically 'the place to be' – just as we had hoped," she said.

Mayor Chris Koos, now serving his sixth

term, said: "The initial plan led to many businesses locating in Uptown Normal and the construction of two hotels and a multimodal transportation center. The Amtrak station in Uptown Normal is one of the busiest stations in Illinois, second only to the station in Chicago. In 2025, Uptown Normal is the most visited area of the community, and the central business district continues to grow."

#### **Building on success**

A quote on Normal's website reads: "At the Town, we have long held to the tenet of 'planning our work and working our plan.' It's the foundation of all we do."

It is clear that is true, and that Normal continues to take action. Mayor Koos highlighted the construction of an underpass, which will provide a safer connection to both sides of the railroad tracks for pedestrians, bicyclists and Amtrak passengers. Connecting the north and south plazas is expected to further enhance economic development, giving residents and visitors alike more reasons to head Uptown. □

# **Congressional remap unlikely**

The two most intense state legislative pressure campaigns I've witnessed both ended in failure.

Back in 2017, Gov. Bruce Rauner tried everything he could think of to stop legislative Republicans from voting to increase the income tax to about where it was right before he took office for his one and only term.

Both political and personal threats were made against a large number of Republicans. They'd be primaried out of office if they crossed Rauner, they were warned. At least one was told that some details about their afterhours behavior might somehow find its way back to their district.

The political atmosphere was ginned up against the Republicans to the point where one Republican House member revealed that someone had come to his home's front door to leave a threatening written message.

They mostly stuck to their guns and Rauner lost. But quite a few of those "traitors" decided not to run again. Rauner ended up losing his reelection in a landslide.

A few years later, Rauner's former nemesis House Speaker Michael Madigan turned his allies loose on a group of 19 Democratic House members who refused to vote for his reelection.

Members were threatened in all sorts of ways. Some felt physically intimidated. Many were promised nasty and well-funded primary races if they didn't reverse course.

That didn't work either and Madigan had to step aside after 50 years in the House, 36 years as House speaker and 23 years as the state Democratic Party chair. He's now in prison.

But as crazy as those two fights were, they didn't come close to what just happened in the Indiana state Senate.

As you likely know by now, a majority of the Senate's Republican super-majority sided with Democrats and overwhelmingly voted down a bill that would have redrawn the state's congressional maps to give the Republicans every U.S. House seat in the state.

The bill had been pushed hard by President Donald Trump and the White House. The idea is their way of protecting against what's expected to be a very good electoral year for Democrats in 2026.

President Trump threatened to field primary opponents against any Republican who dared cross him. Several members received anonymous threats of violence. And the remap bill's sponsor and the state's Republican lieutenant governor both said that

the president had threatened to pull all federal funding from Indiana if he didn't get his way.

An elderly senator claimed her grandson and his basketball team each received negative text messages about her.

Yeah, things got weirdly creepy. Illinois has nothing on that.

Gov. JB Pritzker had vowed that if Indiana passed a redistricting bill, Illinois would follow suit and redraw its own maps to give the Democrats at least one more seat. It was unclear whether he could gather the votes for such a ploy, but it was pretty good political rhetoric. And, who knows, it might've worked. But the point is now moot.

But I've been saying for a long time that I didn't think a mid-decade congressional remap bill could pass here. The Black Caucus didn't want it, and their members have enough votes to stop it.

And even though Pritzker refused to take the idea off the table after the Indiana vote, I still don't see it happening here.

The Indiana Republicans' arguments against the bill were sound, not only because they were under so much pressure from DC, but because it just wasn't the right thing to do.

Indiana's map is already quite gerrymandered, and some complained a new map would've expanded the influence of wealthy Indianapolis over rural counties.

Illinois' current congressional map is even more heavily gerrymandered than Indiana's, and a new map would further expand the influence of urban and suburban areas over rural areas. Plus, there's also that fairness thing. When is enough enough?

I seriously doubt Pritzker will be calling a reluctant legislature into special session if another "red" state steps up because he has bigger fish to fry in the coming spring. And no way will he ever risk alienating legislative Democrats anywhere close to the way Indiana Gov. Mike Braun has declared open war on his own Republican senators.

Maybe Pritzker should just use some of his vast wealth to contribute heavily to the underfunded grassroots Missouri campaign to place a measure on their ballot that would reverse its Republican remap, which could, under Missouri law, pause the new map until the public votes. More than enough petitions were already submitted, but they'll need help with legal fees to counter the coming pushback. □





# Kids with many needs have few options

But some parents question care of children at Hope's residential facilities

The family of a nonverbal 11-year-old boy with autism who lives at a Hope Learning Academy residential home called *Illinois Times* in late August, detailing how the child, Noah, was admitted to HSHS St. John's Hospital in Springfield with a blood infection and bruises all over his body. He stayed at the hospital for multiple days.

Jeff Otte, Noah's father, told *Illinois Times* that a caseworker instructed him to contact

the newspaper and the governor's office about potential neglect at Hope's residential units. Noah has a tendency to injure himself, and his father said he was unsure if residential staff were properly protecting Noah from himself.

He told *IT* dozens of reports filed about his son in the past three years or so – by staff mandated to report any signs of physical harm – allege various problems, injuries and neglect by Hope residential staff. Otte did not provide

copies of the reports to *IT*, citing legal and privacy concerns.

"This just keeps getting worse and worse, and then they try and fix it and it just keeps getting worse. We're going around in circles now," he said of his attempts to get Noah relocated to a different residential facility. "We've even tried to take it through the (Department of Human Services) in the state and we keep hitting roadblocks."

Otte said it's not feasible for him to care for Noah himself, although the ultimate "goal is to get him home."

Otte, a retired firefighter who lives near Joliet, said he now works as a transportation specialist for organ transplant teams in Illinois, a job which requires him to be on-call for 24 hours at a time. In addition to Noah, he has six other children.

While Otte expressed concern with the care

his son is receiving, Hope Learning Academy is an option he said is rare in Illinois: residential living for children with autism who require extra care. There are only eight residential facilities in the entire state that accept these children, and Otte said they all have waiting lists.

Hope was founded in 1957 after Dr. Charles Jordan and his wife couldn't find a school anywhere in the U.S. to serve their daughter, Judith Ann, who had multiple disabilities. By 1963, Hope had moved from a modest house to its present 26-acre campus near Lake Springfield. The nonprofit opened its first group home in 1999. In addition to the family-style homes it operates throughout the community, Hope provides a variety of outpatient services to children with autism spectrum disorders and other developmental disabilities. Other programs include The Autism Clinic at Hope, Therapy Relief at Hope, The Illinois Crisis Prevention Network and The Autism Program of Illinois.

A Freedom of Information Act request from *IT* for the corresponding police report associated with Noah's August hospitalization was rejected by the Springfield Police Department on the basis that redacting involved names "would not properly protect his/her identity."

Otte's lawyers did provide *IT* with the police report, which did not indicate an investigation would be opened. The report outlines how a DCFS caseworker reached out to police after seeing bruises on areas of Noah's body that the caseworker did not believe Noah easily could reach.


The police report states that Springfield officer Brady Parrish visited Hope's main campus the same day Noah was hospitalized. There, according to the redacted police report, staff told Parrish about Noah's behaviors and tendency to injure himself and gave explanations for the unusual bruising.

CEO Clint Paul also informed Parrish that Hope manages 15 residential homes in Sangamon County and "each home is manned by two or more workers at any given time with no more than six kids in one (REDACTED)," the report reads. The officer noted, "I did not have to make a DCFS report due to (REDACTED) contacting me and already having an open case for (REDACTED). I have nothing further at this time."

When reached by phone Aug. 27 and asked about the hospitalization of Noah one day prior, a Hope Learning Academy employee told a reporter, "We don't have a comment at this time."

Since then, *IT* has spoken to parents of four other children who currently reside, or used to stay, at Hope residential homes and reviewed hundreds of pages of DCFS investigations and hospital records provided by parents of children currently living at Hope facilities. Some of the records had portions redacted.

An anonymous complainant filed a DCFS

report on May 8, 2021, alleging "multiple sanitary concerns" and understaffing at one of Hope's group homes. The complainant said "the bedrooms are covered in feces and urine on the walls, floor and beds," "the bathroom is also covered in feces and urine," and that the staff would leave it there for days rather than cleaning it up. "This has been a continuous problem for months now," the complaint alleges.

The report was determined to be unfounded, but the resulting investigation depicts the challenges of staffing and caring for children with significant needs around the clock. The same day the complaint was filed, a DCFS investigator visited the Hope home named in the allegation and reported that "while some issues were observed, it was not to the degree that it is unsafe for the children to be there," according to records obtained by *IT*.

DCFS visited the residence again in the days and weeks after the complaint was filed. During a visit three days later, a caseworker wrote: "the home smelled strongly of human urine and human feces." One month later, DCFS investigators following up on the same case spoke to a Hope nurse who said residential staff were not properly administering medications, according to the report.

Some parents agreed to speak to an *IT* reporter on background but requested anonymity because their children still live in group homes operated by Hope. The parents provided *IT* with copies of five DCFS reports filed between 2020-2024, each two to three dozen pages long. Two reports were found to be "indicated," meaning DCFS concluded an instance of abuse had occurred. One resulted in the employee responsible for the abuse being fired. *IT* is not making these reports public in order to protect the identities of the victims.

Hope's guidelines on how staff should intervene when a child is exhibiting erratic behavior is outlined in one of the DCFS reports and specifically forbids corporal punishment. The guidelines also state that an employee can be discharged for child abuse or neglect, mistreatment of a client or conduct which endangers the safety or welfare of the clients.

Otte said he's worried about the well-being of other children living in Hope's residential facilities.

"We need to expose the problem because I don't think we're the only family," he said. "Someone's life is on the line, and I don't want it to be Noah. I don't want it to be anyone; I want it to be stopped before that."

#### **Limited options for care**

Missouri resident Tess Cook-Gurcio said her son, Luke, needed to attend a residential program, as in-home care became unaffordable and inadequate for his needs. While she faced the same challenges in trying to care for her son as Otte, Cook-Gurcio said she was very pleased with the residential environment at Hope.

"He was a big guy, so by the time he was 9, it was really tough for our in-home staff – that we were paying out of pocket for anywhere from 25 to 40 hours a week – to keep him safe," Cook-Guercio said. "There were a couple times where he took me down. I managed to break a tailbone one time, managed to pull my shoulder out of (its) joint and he didn't intend to be aggressive, he just was so impulsive."

She and her husband ended up paying \$200,000 out of pocket for Luke's behavioral therapy services before he entered Hope at the age of 9. She said they lived with her parents and saved rigorously to afford Luke's care.

"We were exceptionally blessed. There are people who have a lot fewer resources, who are in much more dire straits when it comes to trying to get help," she said. "We have so much support, and it was still hard to survive even with great supports."

Cook-Gurcio said the decision to send Luke to a residential home hundreds of miles away was far from an easy one, but a choice that many parents across the country face.


"It's really hard for a lot of people to imagine... (you're) living with someone who your entire household revolves around, and how mentally exhausting it is to do 24/7, yearround," she said. "It's an exceptionally difficult decision for parents, even when you do it as thoughtfully as you possibly can... I did about six months of therapy before Luke entered Hope school and then for a while after," she said. "That was a very tough time in life for us to have to make that decision, but he's done amazing. He is Mr. Happy-go-lucky, as long as he has Wi-Fi and orange Gatorade and some chips, life is awesome. I think Luke is probably happier than most of the people I know."

During his time at Hope, Luke would spend most weekends at home, with his grandparents around as additional help. He aged out of the program when he turned 22, like all other residents.

Luke, now 24 years old and over 6 feet tall, attends a day program in Jacksonville and is in a good spot, his mother said. She praised Hope for instilling good social skills.

"Overwhelmingly, he learned so many good skills there," Cook-Guercio said. "Now he transitioned into an adult program, a day program where they do different kinds of odd jobs and he seems to really enjoy that. He can't be a guy who doesn't have something to do. He needs a lot of structure and he needs any kind of task to engage him."

Diane Hudson, a fellow parent of a child with special needs, said her experience with

Hope was far different from Cook-Guercio's. She shared Otte's concerns around staffing and housing conditions. Hudson's daughter, Brionna, lived in various Hope residential homes from age 9 until the day she turned 22 last year.

"Us together don't have enough fingers and toes to keep count of all the DCFS cases and allegations," Hudson told an *IT* reporter, referring to the treatment of her daughter during that time.

At first, Hope seemed like a godsend, with no residential programs upstate near where she lived in Kankakee County able to provide care for her daughter. Central Illinois Service Access, an advocacy network for people with disabilities, told *IT* there are only eight providers in the state that offer residential programming for children with disabilities.

Hope is the sole provider in Sangamon and surrounding counties. Other counties that have childhood residential programming include DuPage, McHenry, Perry, Will and Winnebago, while there are just two such providers in Cook County.

"The things that were up there, there were long waiting lists. I was in a situation where I had to go back to work, and I couldn't go back to work because I didn't have anybody to take care of her... initially it was the only option," Hudson said. "Who wants to move their 9-year-old into a group home, right? But when you don't have a choice, you just don't have a choice."

It was an immensely difficult decision that

hundreds of other parents of children at Hope also had to make. But Hudson said she was impressed with the home Brionna originally lived in, which was located on Hope's main campus at 15 Hazel Dell Lane.

"It was a brand-new house that was just built, beautiful. You'd want to live there, it was so beautiful," she said.

Eventually, Hudson grew tired of driving hours across the state to check on her daughter, so six years ago she moved to central Illinois.

"I moved down here to be closer," she said. "I felt like I couldn't supervise the things that were going on. There were always incidents happening and so we packed up and moved down here."

Hudson said the quality of care that Brionna received depended almost entirely on which residential house she was placed at. At first, she said, it was alright.

"It wasn't too bad; I became good friends with a lot of the girls that worked in

the house and formed a good relationship with them. I feel like for the most part, they cared for her fairly well," she said. "Not like I would care for her, but considering the situation."

When the second house Brionna lived at closed and she was subsequently moved, "things began to get worse. The house was constantly filthy and unkept, she would have dirt caked on the bottom of her feet that you could scrape off with a butter knife. It was so bad – stains in her underwear, not being bathed."

She said sometimes when she made calls to her daughter, she would hear staffers swearing and yelling at other children in the background. Her mother said Brionna had multiple injuries during her time at Hope, including burns on her fingers from touching a hot stove while unsupervised and cuts after she reached for loose razors. She was hospitalized once for a separate incident where she needed stitches on her head after staffers informed her that Brionna fell onto a chair, Hudson said.

"There's worse places than Hope," Hudson said. "Just because there's worse places to go doesn't mean you shouldn't raise your standards and be better... They get a lot of money from the state to take care of these children and they don't."

#### Hope's leadership and finances

Hope receives millions in state grants each year and reported almost 550 employees in its most recent tax filing.

The structure of Hope, at least for tax

purposes, is spread among four nonprofits that file separately with the IRS. According to the most recent tax filings, the four arms of Hope reported nearly \$60 million in assets, though it's unclear if any assets are shared. Hope School Foundation, the nonprofit's fundraising arm, reported almost \$15 million in liquid assets.

Kathy Carmody is the CEO of The Institute on Public Policy for People with Disabilities and leader of the first Illinois project to conduct community-based support services in 1988. She told *IT* that building up a cash reserve has become the focus of most nonprofits.

"The turbulence of the [impending cuts to] Medicaid funding and the turbulence generated through COVID – there's a lot of instability. This is just industry-wide, it's not even specific to Illinois, and I think organizations are realizing the importance of managing their businesses," she said. "Now, that's going to require some assets that they have in liquidity."

Carmody, who advises multiple social service organizations that support individuals with developmental disabilities through The Institute on Public Policy, said she has not worked with Hope but said its reputation is positive among social service circles.

"What I will say in defense of any agency that has a strong asset base is that they're a strong organization," she said. "The general perception is we want agencies to have bake sales to pay their staff and you can't run a business on a bake sale; we are past those days."

Hope's website notes that the organization created its first 10-year strategic plan in 2015 and grew from serving fewer than 1,000 individuals in 2014 to more than 5,000 by 2021. In addition to its residential facilities, Hope operates a vocational academy which provides job training and in-house employment programs. Some participants in Springfield work with a job coach to find placement in community-based employment.

Brionna aged out of Hope's residential program last year and now attends a day program run by Hope for adults with disabilities, which Hudson praised.

"They have an adult day program that just opened in May – completely night and day from the residential program. Things are going well," she said. "She's got a one-on-one (worker) there. They do different activities and provide services, stuff like that, and then she goes home, so I don't have any complaints from the day program."

Hudson said the day program doesn't excuse the residential home settings she witnessed and that Hope's leadership ought to be overhauled if they're knowingly allowing filthy living conditions.

"They need new management, they need new administration, they need people in there that actually care about their jobs and not line their pockets with whatever they're getting because it's not fair to those kids," she said. Paul, the current CEO, made almost \$400,000 in 2024, according to the nonprofit's tax filings. He assumed the position after the prior CEO, Karen Foley, was placed on administrative leave in 2014 following an abuse incident that prompted Hope to adopt new trainings for its employees.

Illinois Times reached out to Hope multiple times over several weeks before receiving a response from a public relations firm. IT requested information regarding current enrollment and staffing for the residential program, protocols for intervening when children are engaged in self-injurious behavior, protocols for responding to DCFS investigations and clarification on fundraising, among other things. None were directly addressed by Hope's statement:

"For nearly seven decades, Hope has proudly served individuals with developmental disabilities and behavioral disorders, providing compassionate, person-centered care that consistently exceeds all regulatory standards," the statement reads. "We take any concerns about our residential programs very seriously and act swiftly to ensure a thorough and transparent resolution. Hope's programs continually surpass rigorous standards in staff training, environment of care, crisis intervention and quality assurance.

"Hope remains open to dialogue with the media, families and the broader community. We welcome opportunities to share our ongoing quality improvements, success stories and the dedication of our staff. Our doors are always open to constructive engagement grounded in fairness and shared concern for those we serve."

Otte spoke with Hope Learning Academy staff soon after his son's hospitalization in August. He said the nonprofit's representatives outlined a plan for one-on-one care at all times Otte had believed was already in place.

Hope petitioned the Illinois Department of Human Service's Division of Developmental Disabilities to allow the Springfield nonprofit to release Noah from its residential placement in September and then again in October, according to letters provided to *IT*.

"Noah exhibits extreme self-injurious behaviors of such intensity and frequency that Hope cannot ensure his safety," the Oct. 29 letter reads. "Additionally, the relationship between our clinical team and Noah's guardian has become untenable. Hope has received multiple letters from Mr. Otte's attorneys threatening legal action and issuing litigation holds. More recently, Mr. Otte has contacted local media alleging mistreatment, despite our transparent communication that Hope cannot meet Noah's acute medical and behavioral needs."

Otte said he's unsure of where his son will end up, but worries that he will be transferred to a facility out of state.

"He has to go somewhere," Otte said. □





# A culinary pilgrimage

Discovering the art of pintxos (appetizers) in the Basque Country of Spain

As I emerged from my late adolescence into early adulthood, I harbored dreams of traveling the world. But like the derailed plans of George Bailey in It's a Wonderful Life, my hippieinspired dream of backpacking through Europe had to be put on hold. Marriage, children and the practical demands of paying off student loan debt rerouted my life down a more responsible path. My passion for global cuisine and exploring distant lands was, for a long time, an appetite I could only satisfy vicariously through books and television, especially Anthony Bourdain's culinary travelogues. Inspired by Bourdain's shows, which for so long fueled my deep desire to travel and eat fine food, I finally fulfilled my dream after nearly half a century of

This fall, I embarked on my long-anticipated culinary pilgrimage, beginning in the Spanish coastal city of San Sebastián. This small city is famous, in part, because it was the only place Anthony Bourdain visited three times during the 16-year run of his travel shows. With lush green cliffs that descend into surf-friendly, turquoise waters, San Sebastián is a small city in the Basque Country, a region stretching across the northern coast of Spain and into the southwest of France. The Basque people are known for their unique language, Euskara, which predates the Roman Empire and is unrelated to any other language in Europe. San Sebastián is renowned worldwide for its gastronomy, boasting the highest concentration of Michelin-starred restaurants per square meter in Europe.

Although we splurged on an incredible (and budget-breaking) meal at three-Michelin-starred Arzak, our most unforgettable food experience was going on a Basque bar crawl, known as a txikiteo (chi-kee-tay-o). A txikiteo involves bar hopping from one establishment to the next, having one small drink and a little snack known as a pintxo. Pintxos (pronounced PEEN-choss) are sophisticated, elaborate appetizers often regarded as the elevated relatives of Spanish tapas. These small, artful snacks are characterized by the toothpick that typically skewers the ingredients onto a piece of bread, setting them apart from traditional, larger and more shareable tapas. They are generally eaten while standing at the bar.

On this memorable evening, we were accompanied by Gabriella Ranelli, who was Anthony Bourdain's local guide during his three San Sebastián episodes. Gabriella, an American expat (and very fortuitously, a friend of a friend), is an expert on Basque culinary culture and the author of the cookbook *Arzak* + *Arzak*. We were to meet up with Gabriella at Federiko Taberna, a pintxos bar located on a

crowded, narrow cobblestone pedestrian street in San Sebastián's historic Old Town. Though it was drizzling, its outdoor stand-up table was fully occupied, and the bar inside was packed. While waiting for Gabriella, I ducked into a hat shop across the street and bought a Basque beret to keep my head dry. Through the crowd, we spotted Gabriella, whom we recognized from the Bourdain episodes.

After sharing introductions, Gabriella explained that these bars are always crowded and standing-room-only. She worked her way up to the bar and returned with small glasses of txakoli, a local, slightly effervescent white wine, and mini spider crab tartlets. She explained the tradition: "You meet up with your friends, enjoy a drink and a pintxo, and then move on to the next bar. It's a culinary journey and social event rolled into one."

Following this, we moved on to the next bar. The rain had stopped, and the bar was crowded, so Gabriella instructed us to wait outside while she brought out more txakoli and small bowls of risotto con Idiazábal, a creamy orzo dish with Basque sheep's milk cheese.

The lively street teemed with pintxo bars, their counters showcasing a spectacular array of cold pintxos – everything from tortilla de patatas to elaborate seafood and meat creations. Hot pintxos, meanwhile, were ordered from a chalkboard menu and cooked fresh. Prices ranged from \$3 to \$6 a piece. This engaging ritual – a single glass of wine, one pintxo, then moving on to the next bar – lasted for three hours. A txikiteo is much more than just a bar crawl; it is a cultural immersion, a communal dining experience, and a vibrant celebration of authentic Basque regional cuisine.

#### The Gilda

The Gilda, perhaps the most iconic pintxo, is a simple skewer of olive, anchovy and pickled guindilla pepper. It is named after Rita Hayworth's "salty, green and spicy" character in the 1946 film *Gilda*.

Makes 4

Ingredients: 8 pickled guindilla peppers 8 green pitted manzanilla olives 4 oil-packed anchovy fillets Extra-virgin olive oil, for drizzling 4 4-inch wooden skewers

#### Preparation

Cut the stems off the peppers. Cut each pepper in half cross-wise.

With the skewer, pierce one olive through the center, followed by two pieces of the pepper. Add an anchovy, threading it into an "S" shape. Add two more pieces of pepper and finish with another olive.

#### Tortilla de patatas

A Spanish tapas bar classic, this omelette is frequently served in mini portions as a pintxos offering.

#### Ingredients:

6 large waxy boiling potatoes

1 large onion, thinly sliced

3 tablespoons olive oil

6 eggs

Kosher salt, black pepper, and smoked paprika to taste

#### Preparation:

Preĥeat the broiler.

Boil or steam the potatoes until tender enough to be easily pierced with a knife. Once cool enough, peel the potatoes and slice them into 1/4-inch-thick pieces. Spread the slices out to cool completely.

Heat the oil in a 9- or 10-inch non-stick skillet over medium-high heat. Add the onions and a pinch of salt, then sauté. Cook until the onions are tender and translucent, taking care not to let them brown. Finally, remove the skillet from the heat and allow the contents to cool completely.

Crack the eggs into a bowl and add ½ teaspoon of salt. Beat the mixture vigorously with a whisk until frothy, with no visible streaks of white

Gently stir the potatoes into the egg mixture with a rubber spatula. Let the mixture rest for five to 10 minutes

Pour the egg and potato mixture into the skillet. Stir it briefly to ensure the potatoes are evenly distributed among the onions. Reduce the heat to medium and cook for two minutes without stirring.

Once the underside of the tortilla is a solid mass, move it to the broiler and check it often. After a solid "crust" forms on top, mix the cooked surface into the liquid egg mixture underneath, then return to the broiler. Repeat this process until the tortilla is fully cooked.

Garnish with a sprinkle of smoked paprika, slice into wedges and serve warm or at room temperature.  $\Box$




