

# Innovate Springfield moving to Horace Mann building

University of Illinois Springfield has pivoted from plans to open its new "Innovation Center" in a three-story building downtown and now will rent space for the center three blocks east, on half of the third floor inside Horace Mann Educators Corp.'s headquarters.

A rental contract, finalized between UIS and Horace Mann in recent days, will allow Innovate Springfield to relocate from rented space it has occupied for the past decade at 15 S. Old State Capitol Plaza to more spacious digs at Horace Mann in September.

The 2.5-year lease for 9,800 square feet inside the six-floor Horace Mann building also will allow UIS to formally launch the innovation center, of which the Innovate Springfield business incubator will be a part, according to Robert Kerr, UIS executive director of innovation and opportunity.

The effort will allow UIS to "expand programs that support economic development in the region" and "allow the center to broaden programming and services focused on innovation, entrepreneurship and collaboration," according to a July 2 joint news release issued by UIS and Horace Mann.

"This strategic relocation will enable us to bring more people into our innovation

ecosystem, including students, faculty, corporate partners, civic organizations and entrepreneurs," Kerr said.

UIS Chancellor Janet Gooch said in the news release, "This move deepens our connection to the downtown community and allows us to expand our innovation efforts. We are grateful to Horace Mann for supporting our vision and helping us

increase opportunities for students and entrepreneurs alike."

Don Carley, executive vice president and general counsel for Horace Mann, a publicly traded company based in Springfield that provides insurance and other financial services to educators nationwide, said the company is excited to work with UIS.

"This is a perfect fit," he told Illinois Times.

The Horace Mann lease can be extended for another two years. UIS will pay \$196,000 in rent each year, Kerr said. The rent includes parking, security and utilities, he said.

UIS announced in December 2022 that it purchased a three-story, 24,600-square-foot building at 401 E. Washington St., for the UIS Innovation Center, and the university planned to open the center – housing Innovate Springfield – sometime in 2025.

Kerr wouldn't say what prompted UIS to change its plans from 401 E. Washington St. The latest lease for Innovate Springfield's current location expires soon, so he said the opportunity at Horace Mann, which provides almost 3,000 more square feet, allows for an easy transition.

As for the Washington Street building, "all I can say is that conversations are continuing" regarding its future use, Kerr said.

The uncertainty surrounding future use of the Washington Street building is

one reason the Horace Mann lease doesn't reserve space for long-term occupancy, Kerr said.

The building on Washington is empty, and UIS, which bought it for \$950,000 from the Illinois Sheriffs' Association and planned to use \$15 million in capital funds to renovate the structure, hasn't spent the \$15 million elsewhere, Kerr said.

The UIS Center for State Policy and Leadership may eventually move into the Horace Mann space, as well, he said.

Operating out of a building with a cafe on its top floor and offices in the basement and on floors two through six, the UIS Innovation Center will be able to expand workforce development programs through continuing and professional development with a variety of corporate and nonprofit clients, Kerr said.

Horace Mann has the space available for lease because the company, like others around the country during and after the COVID-19 pandemic, "continues to embrace hybrid work to support work-life balance," according to the UIS-Horace Mann news release.

Horace Mann is reconfiguring office space to welcome UIS, and the company is open to leasing one or 1.5 more floors, Carley said.

Between 500 and 600 Horace Mann employees work part time or full time in the building, he said. The building was constructed in the early 1970s and has undergone major improvements in recent years, he said.

Horace Mann employs about 1,800 people in Springfield and at offices in suburban Madison, Wisconsin, and in Cherry Hill, New Jersey, Carley said. The company works with about 600 agents who are independent contractors.

It will be exciting to have more people working in the building, Carley said. "I think it will be viewed as a positive for employees," he said.

There's plenty of parking available for Horace Mann employees, UIS employees and clients of the innovation center in Horace Mann's three nearby surface parking lots, he said.

Innovate Springfield became part of UIS in 2018. It supports more than 50 member companies that have added more than 280 jobs to the local economy, according to UIS. □

# Mental health is a community responsibility

Citizens Club panel educates Springfield on mental health resources

"It is not 'them,' it is 'us,'" Jill Steiner said, addressing an audience at Hoogland Center for the Arts last Friday. She asked attendees to approach the morning's discussion with listening and empathy.

"Put aside the belief that it's just 'pull yourself up by the bootstraps,' 'get over it,' 'move on,' or 'it's just that generation.' Denial and platitudes cost lives."

Steiner, Citizens Club board member and human resource and risk management director of the YMCA of Springfield, was moderating a panel hosted by Citizens Club to educate attendees on the available resources and gaps for mental health. The panel featured medical providers and mental health experts, a member of the police and a representative from the Massey Commission.

Mental health is an everyday challenge in Sangamon County, panelists said.

Deputy Police Chief Joshua Stuenkel said the Springfield Police Department engages daily with individuals struggling with mental illness.

"Maybe not for every officer every day, but from our homeless outreach team to our neighborhood police officers and our patrol officers, someone is having this response every day and every shift," Stuenkel said.

Dr. Christopher McDowell is an emergency physician with Memorial Health and Executive Associate Dean and Professor of Emergency Medicine at SIU School of Medicine. Similarly he said it was "assured" he would see a patient with mental health concerns when he went to work that day.

The panelists shared tips and resources to educate the audience on how best to support neighbors suffering with mental illness, from reducing stigma through sensitive language to recognizing warning signs of suicide.

Lauren Yogerst, crisis clinician at Memorial Behavioral Health, explained the best hotline numbers to call, including 988 for suicide intervention and substance use crisis support and 211 for referrals to community resources for food, shelter, utility assistance and more. These numbers help de-escalate potential crises before they reach emergency status, at which stage people should call 911, she said. Both hotlines are available 24/7.

Those who contact 988 may remain anonymous, Yogerst said, but if some risk of immediate harm presents itself, the person on the line may ask questions about where the caller is and whether intervention is needed. Should in-person help be required, the hotline can geolocate from the three major phone companies, T-Mobile, Verizon and AT&T.

When the issue cannot be handled over the phone, a Mobile Crisis Response team of behavioral health clinicians and peers will be deployed. Mobile crisis response is a grant-funded, statewide initiative, but it is run locally through Memorial Behavior Health and available 24/7. Those who need to contact the mobile unit can call directly at 217-788-7070.

In addition to the Mobile Crisis Response team, Springfield has worked to pair police officers with mental health professionals in responding to mental health crises. Officers on these teams receive Critical Intervention Team training, designed to educate officers on recognizing and de-escalating mental health crises.

"As law enforcement, while we are that first call, we recognize that we are not always the right tool," Stuenkel said. He said the

partnership, which was initially met with some hesitancy, is now received well by officers. "They see this as a resource," he added.

Multiple panelists said Springfield is rich in resources for addressing the mental health needs of the community, but that coordination of service and access to them continues to be a challenge.

John Ridley, director of public health for Sangamon and Menard Counties, introduced Community Mental Health Boards, or 708 Boards, as a missing piece of the puzzle. Establishing a 708 Board was the first recommendation passed by the Massey Commission.

Precedent for the boards was created in 1976 in Illinois by the Community Mental Health Act, introduced by Illinois House Bill 708. Such boards exist in over 90 counties, municipalities and townships across Illinois, according to the League of Women Voters.

"If you look at what counties have community mental health boards, Sangamon County is kind of the hole of the donut," Ridley said. He urged attendees to support a tax referendum, scheduled for spring 2026, to fund the board. □

# Remembering Henry Stephens, Springfield civil rights activist

Immortalized by Carl Sandburg, memorialized with a historical marker

Henry Stephens, a Springfield resident and civil rights advocate in the late 1800s and early 1900s, was celebrated in two poems by Carl Sandburg. Now he is memorialized with a historical marker, which the Illinois State Historical Society officially unveiled June 17 at the Springfield Transportation Hub, on the southwest corner of 11<sup>th</sup> and Washington streets.

Stephens, who was an Alabama native before moving to Pana, and then Springfield in 1901, was an African American miner. Stephens was a descendant of enslaved people living on the Alabama plantation of Alexander Stephens, vice president of the Confederacy. He was an essential part of bringing equal rights into the mines, and to all jobs in Illinois.

Stephens moved to Pana in 1899 as a "scab worker," meaning that he was replacing miners on strike because the Pana mines were unwilling to pay the going rate for their work. It was cheaper for the Pana mines to bring in new miners from Alabama, who they would then exploit. The scab miners coming in had been notified of the working conditions. This, combined with Pana's reputation for racism, kept many African American workers from coming. However, some miners from Alabama, including Stephens, still came to Pana and protested for their rights there. Protests were led by Henry Stephens himself, and the final one ended in violence. Five African Americans were killed while protesting, and the National Guard had to be called in to quell the violence. Most African Americans fled Pana after this violence. But Stephens kept trying to fight for what he believed in.

Stephens moved to Springfield in 1901. It is obvious that at that point Stephens had reached his limit with the racism in the mines because he was quoted in the poem that Carl Sandburg wrote about him, *The Sayings of Henry Stephens* saying, "A Union means united. But they's mines runnin' twenty-five years and the white man never lets the negro in." He also stated in the

same text he would have to walk upwards of two miles to get to work. Stephens decided he needed to change this. He fought to get better working rights for miners in Springfield. He did so by helping lead Black miners to join the United Mine Workers of America, which promised to cross racial barriers and allow equal rights for Black and white miners alike. In 1908 Black miners made even more progress locally by gaining a Black president of a local mining union in Sangamon County.

Stephens can also be credited for trying to desegregate Springfield's theaters. He partnered with a white man in 1907 to help. He was ultimately unsuccessful, but this did not deter him. Stephens became the president of the Springfield Working Men's Association with the intention of helping push for civil rights in the workplace even more. With this organization, Stephens and other Black miners were able to win a provision in the union contract that banned hiring discrimination in the mines, the first provision of its kind in Illinois. Stephens also helped support transportation strikers in 1917 by walking a long way home during the sunset to support the streetcar workers' strike. The strike achieved its goal of having the streetcar company recognize the union,

meaning that there would be no more racially biased hiring. Stephens' marker was erected close to the route that Stephens walked home.

Stephens is well known for saying, "I'd live in the fields on hard corn for a just cause." That quote made its way into the poem, *Sayings of Henry Stephens*, in which Carl Sandburg wrote in the first person as Henry Stephens. The poem described Stephens' thoughts about life as an African American in Springfield where he was facing prejudice and oppression. Stephens stated in the poem that he could only work at 8 out of 20 of the mines in Sangamon County just because he was not white. Stephens' ideals were also mentioned in Carl Sandburg's most famous poem, *The People, Yes*. Sandburg's works not only strongly discouraged racism, but also memorialized Henry Stephens' dedication to making Illinois a better place for everyone.

As a civil rights activist, Stephens helped change the state forever. The marker in his honor shows just how much of an impact he made. □

# Chelsey Farley tells her story

She hopes retired police sergeant who injured her will serve time

Chelsey Farley burst into tears while speaking with a reporter almost 10 months after a motorcycle she was riding on collided with a car driven by a recently retired Springfield police officer.

Farley, 32, cried as she explained why she was wearing a medical boot to stabilize the lower section of her left leg. She accidentally broke her leg June 26 when she stumbled inside the Springfield home she shares with her 12-year-old son and 7-year-old daughter.

She blamed her recent injury on former police sergeant Michael Egan because of the lasting impact the crash has had on her ability to be steady on her feet. "This is still him," she said, looking down at her leg.

"I shouldn't be walking through my house and falling and breaking my leg," Farley said as she sat inside The Soul Shoppe, an arts, crafts and cannabis smoking supplies store that she and her cousin, Missy Hoover, operate at 1052 E. Stanford Ave. in Springfield.

Farley spoke with *Illinois Times* on June 27 and after a June 23 status hearing on Egan's criminal case in Sangamon County Circuit Court. She said she has attended several of the hearings. Outside the courtroom, she has yelled at Egan and his lawyers with profanity-laced language expressing her frustration with Egan and what she considers his lack of regret.

Egan, 51, has pleaded not guilty to two counts of aggravated DUI, DUI and making an improper left turn in connection with the incident. He retired from the Springfield Police Department the same day as the crash and hasn't commented.

If convicted, the potential punishment for Egan, who has no prior convictions, could range from probation and no jail time to 12 years in prison. Egan has remained free while awaiting trial. One of his attorneys, Dan Fultz, declined comment.

Farley, whose supporters have demonstrated outside the Sangamon County courthouse to keep a spotlight on the case, said it's uncomfortable for her to relive the trauma of the crash and its aftermath. She said she attends the hearings because she worries Egan won't be held accountable.

Accountability, for her, means that Egan sees time in jail or prison.

"He seems to have no remorse," Farley said. "I don't want anything but for that man to do the time for his crime. He broke the law. As any other citizen, he needs to be treated the same as us. He is not better than the rest of us."

"We're all taught young in America – don't drink and drive. So that goes for you, too, Springfield police."

It's not uncommon for people charged in criminal or civil cases to be advised by their lawyers not to speak or apologize to alleged victims until cases are resolved, according to Frank Lynch, a Springfield lawyer not involved in the Egan case.

That's because certain statements made outside of court can be introduced in court as admissions of guilt or used in some way against people making the statements, Lynch said.

Police reports said Egan was driving a 2018 Toyota SUV eastbound on East Lake Shore Drive at 9:20 p.m. Sept. 5, 2024, when he failed to yield the right of way and made a left turn, without using a turn signal, in front of a southbound Kawasaki motorcycle near the entrance to the Anchor Boat Club.

The motorcycle, driven by Trevor Hopkins, with his then-girlfriend, Farley, riding as a passenger, then struck the passenger side of Egan's car. Neither Hopkins nor Farley was wearing a helmet.

Farley lost consciousness and doesn't remember the crash. She broke her pelvis in three places. She also broke her tailbone and both collarbones, and the trauma caused bleeding in her brain. Doctors placed metal pins and screws and a metal plate in her body to hold it together and promote healing.

She was intubated, put on a respirator and placed in a medically induced coma for about two weeks and was hospitalized for a month, first at HSHS St. John's Hospital and then at Springfield Memorial Hospital.

"I'm very lucky that I'm not dead," Farley said.

Hopkins, 32, a self-employed auto mechanic from Springfield, also was injured, but not as severely.

Egan, whose base pay as a police officer with 20 or more years of experience in 2024 was \$125,508, wasn't hurt. A blood test after the accident showed Egan's blood-alcohol level more than twice the legal limit, according to recently retired Springfield police chief Kenneth Scarlette.

The physical effects of the crash will remain for the rest of her life, Farley said.

"I have nerve damage in parts of my body and permanent hardware that will have to be

monitored for the rest of my life," Farley said. "This accident affects my life daily, on many levels: emotionally, physically and publicly. I'm never going to forget it, and I'm going to make sure that Michael Egan does not forget it, either."

Farley, who is covered by Medicaid, said she received a \$100,000 out-of-court settlement from Egan based on a personal injury lawsuit she filed against him. The money will help pay medical bills. The financial strain to her family and her business – which opened a few days before the crash – has been eased by about \$22,000 donated through GoFundMe.

Farley's civil claim against The Stadium Bar & Grill, 2300 N. Peoria Road, where Egan allegedly consumed alcohol at a retirement party in the hours before the crash, remains pending. Hopkins' civil lawsuit against Egan also remains pending.

Greg Gaz, the attorney representing the bar, and Andrew Toennies, who represents Hopkins, didn't respond to messages left by *Illinois Times*. Alex Rabin, who represents Farley, wouldn't comment.

Farley said she believes Egan received preferential treatment by police responding to the scene of the accident. Public concern about the way Egan was treated was part of a public protest outside City Hall on Sept. 9. Activists also were protesting the July 6, 2024, shooting of Sonya Massey by a Sangamon County sheriff's deputy inside her rural Woodside Township home.

Four Springfield police officers who responded to the crash later were disciplined by the police department. The officer receiving the most severe penalty was ordered to serve a six-day, unpaid suspension.

Because of a lack of details released by SPD, it remains unclear whether the department believed Egan was given preferential treatment. Scarlette previously said Egan embarrassed the police force.

Farley, who is divorced from her children's father, said her relationship with Hopkins ended because of stress related to the accident. She said Hopkins moved to Florida.

Born and raised in Springfield, Farley, who previously worked as a postal clerk, said friends and family members helped her and her cousin keep their shop running.

She said she is grateful for all of the financial and moral support she has received from the community in her recovery and her efforts to keep Egan's case in the public eye.

"If there's not attention to this case, I am worried that it will be able to be swept under the rug," she said. "I am worried that they will let Michael Egan off with no time served ... and probably smack someone else with his car." □

# Pritzker touts need to protect progress

"I ran for governor in 2018 to change our story," Gov. JB Pritzker told a Chicago crowd June 26 as he announced his bid for a third term. "I ran for governor in 2022 to keep telling our story. And I am running for governor in 2026 to protect our story."

This general theme of protecting what Pritzker maintains is Illinois' progress from damage by President Donald Trump will be the foundation of the governor's reelection bid – at least for the foreseeable future.

The governor's state office provided an example of this potential harm earlier in the week, when it warned of a provision in the congressional budget proposal to shift billions of dollars in Supplemental Nutrition Assistance Program costs from the federal government to the states.

"For Illinois, that shift could mean taking on more than \$1.2 billion in additional costs annually, placing a massive strain on Illinois' budget and threatening funding for other essential services like education and health care," the statement read.

The U.S. Senate's parliamentarian had originally ruled against the SNAP provision in the chamber's budget reconciliation bill, but the majority Republicans revised the language and it was approved June 26.

That \$1.2 billion will likely pale in comparison to expected Medicaid cuts. Illinois simply doesn't have the recurring revenue needed to make up the difference.

"Earthquakes are coming," Pritzker warned in his address about the coming months and years.

So, for now, it's "Pritzker the Protector."

But, eventually, it would be nice to see some fresh and new ideas.

The governor's 2021 reelection announcement was all about looking back at his leadership during the pandemic. Four years

later, his latest announcement was heavy on his accomplishments and little about the future, except that it looks really bleak under Trump and he will do his best to shield the state from it.

The Trump references were so thick that you could conceivably call this the first kick-off speech of the 2028 presidential campaign.

"The workers of today and tomorrow choose Illinois because we built an iron wall around their freedoms – and because we told the fascist freakshow fanatics to run their experiments on ending democracy somewhere else," the governor said.

Except Pritzker's currently only running for reelection. Maybe try one election at a time. And while 2019 – his first year in office – was a whirlwind of activity, much more still needs to be done.

For example, the Illinois Economic Policy Institute and the Project for Middle Class Renewal at the University of Illinois at Urbana-Champaign released a study this week showing the state has an existing housing shortage of 142,000 units and needs to build 227,000 new homes over the next five years "to keep pace with demand."

The governor said housing costs too much during his speech, but didn't say what he'd do about it.

You may recall that Pritzker demanded action on the housing shortage during his State of the State address in February, saying his special task force on housing affordability had come up with some solutions and those should be enacted. But, after some progress, the bill stalled out.

One of the panel's short-term ideas was to require the state's pension funds to invest in housing development. But the provisions to require or incentivize local governments to remove barriers to new housing was a big sticking point.

Pritzker's implementation record leaves much

to be desired. Six years after legalizing cannabis, for instance, the original equity promises are nowhere near fulfilled. If they were, it would be a whole lot easier to convince the Illinois House to regulate the intoxicating hemp "gray market."

And the governor was right when he said, "the answer starts with growing Illinois' economy." But economic growth as a whole has most definitely lagged here.

"Let me be clear," Pritzker said, "There is no Mission Accomplished banner to stand under today. Yes, we have addressed so many of our old

problems – but new ones always arise. History is an endless relay race. Our job is not to look for the finish line but to protect the baton as we run our assigned leg."

Are we better off as a state than we were in 2018? Governmentally, yes. Of course. I would never want to revert to the state governments we had during the first 18 years of this century.

Could we as a state be much better? Absolutely. And it's time to try. But that requires some concrete plans. □

# Revitalize Robin Roberts Stadium

State of disrepair is unacceptable, dangerous

On June 26, I sent the following letter to the Springfield Park District board of directors.

I am writing to you with a profound sense of urgency and concern regarding the current state of Robin Roberts Stadium – a facility that should be a source of pride for the city of Springfield, especially as we prepare to host 17 visiting communities from across the Midwest for the 2025 Prospect League All-Star Game July 7-8.

Unfortunately, the stadium is in a state of disrepair that is not only unacceptable, but potentially dangerous, and undeniably embarrassing for a city with such a rich baseball tradition. While we appreciate the Springfield Park District's efforts in the past, the current approach to maintenance and facility management has proven unsustainable. We are at a critical tipping point, and it is imperative that immediate, decisive action be taken to ensure that Robin Roberts Stadium does not follow the path of other neglected facilities like Chamberlain Park.

To cite just a few urgent and pressing issues:

- Air conditioning failures:** Four AC units have been down for over a week, subjecting staff, umpires and players to extreme and unsafe temperatures.
- Field and stadium conditions:** The warning track poses safety risks, field drainage is inadequate and there is zero maintenance beyond mowing and lining. Weeds, flowers and other plants are overtaking the playing surface and inconsistent irrigation is leading to dead grass and dangerously dusty playing conditions.

**Concession and restroom facilities:**

There are active leaks in the main concession area, raising serious health code concerns. Women's restrooms have locked stalls due to deferred maintenance, reducing access for fans. Rotting wood on concession doors adds to the unsafe and unsightly environment.

**Electrical and lighting failures:**

Stadium lights are out, common area bulbs go unreplaced and electrical failures have impacted both the scoreboard and the public address system – vital components of the fan and player experience.

**Sanitation and cleanliness:** Trash and debris are regularly left uncollected. Stains and messes remain after events. Overgrowth of weeds and nonfunctional facade lighting at the entrance create a poor first impression of the stadium.

**ADA noncompliance:** The lack of sufficient ADA seating is a recurring concern from senior and disabled attendees. This is both a moral and legal issue that cannot be ignored.

The cumulative impact of these issues cannot be overstated. The facility is not just aging – it is deteriorating rapidly. And as we prepare to welcome regional attention in less than two weeks, the risks to our city's reputation and the safety of everyone who uses the stadium grow by the day.

We respectfully urge the Springfield Park District board of directors to take immediate steps to pressure the executive director and relevant departments to address these problems without further

delay. Robin Roberts Stadium deserves not just to be preserved but revitalized. We owe it to the legacy of the stadium, to our players and fans, and to the city of Springfield – particularly the taxpayers – to ensure that this venue reflects the pride and professionalism our community is known for.

Time is of the essence. We ask for your leadership and swift action to prevent this

historic stadium from becoming another lost facility. □

# Chatham Strong Fest

Music festival will honor Chatham victims and raise money

A daylong family-friendly music festival featuring six performers will give people an opportunity to pay tribute to the April 28 accident victims in Chatham and raise money to support them.

Billed as the Chatham Strong Fest, it will run from 1 to 9 p.m. Sunday, July 6, at the Chatham Community Park, 711 S. Park St. There is no admission fee. Some seating will be available, but people may want to bring their own chairs and blankets.

Killed on the day of the accident when a driver crashed through the YNOT after-school building in Chatham were Kathryn Corley, 7, Alma Buhnerkempe, 7, Ainsley Johnson, 8, and Rylee Britton, 18. Six other children were taken to the hospital. One of them, Bradley Lund, 8, died June 2 from his injuries.

"Chatham Strong" has emerged as the rallying cry in response to the accident and in support of its victims and their families. Local residents, schools and businesses have hosted gatherings and blood drives, and Chatham Strong yard signs, T-shirts and other items have been for sale, with vendors typically promising to donate to the families of victims. As of June 24, more than \$437,000 had been pledged on six GoFundMe sites, while at least three local banks were also accepting donations for the benefit of one or more of the victims. A linktr.ee site is tracking dozens of these events and fundraising opportunities.

The Chatham Strong Fest will feature live music, food trucks, kids' activities and an online auction. The kids' activities will include a petting zoo, carnival games and arts and craft stations. Food and beverages will be available for purchase. The online auction being conducted by Cory Craig Auctions began June 28 and will close at 7 p.m. July 6. Cory Craig is donating his services for this effort.

Also, a ceremony for the planting of a 15-foot Unity Tree at 5 p.m. during the festival will honor the deceased children as a permanent memorial near the main playground.

Net proceeds from the auction, donations and sponsors will be deposited into the Ball-Chatham School District YNOT Tragedy Fund. Funds will be

allocated for funeral and memorial services, medical expenses, long-term care and other essential needs. According to the Chatham Strong Fest website, a committee of Glenwood High School administrators and Student Council members will review needs and oversee the distribution of funds, and all funds will be fully disbursed within six months.

The idea for the Chatham Strong Fest, according to a press release, originated when Jason Dolby's 15-year-old son, who attended the YNOT after-school program as a child, started playing music as a way to cope.

"When he told me it was his way to deal with what had happened," Dolby said, "I thought maybe others could use music to do the same thing. So I called my friend Jeff Loftus, who is a great local musician, and we started organizing the next day."

Dolby and Loftus got help from Jeff Stauffer in organizing the music festival. "We wanted to organize an event that not only gave people an outlet to participate by raising money, but maybe more importantly, to heal through music and a chance to honor those involved by keeping their memory alive forever in a big way," Stauffer said.

That is how the Chatham Strong Fest arose organically as an initiative of the three civic-minded citizens, not any specific organization or group. Local sponsors have stepped up to defray costs, including Springfield Clinic, Memorial Health, HSHS Health System, SIU School of Medicine, Levi, Ray & Shoup and The Group Insurance Agency.

Those sponsors, along with the online auction and donations that can be made online or at the event, will provide the proceeds to be donated to the victims' families.

# A redneck ruckus

This year's Original Redneck Fishing Tournament is canceled

Below its muddy banks, the water is as quiet as the village of Bath itself, which is just how the easily spooked invasive Asian silver carp that pour down from the chutes of the Illinois River like it.

Normally, the voracious carp that plague the ecosystem of the rivers and lakes of the Midwest would soon get a rude three-day invasion of their own from beer-drinking, flag-waving, music-cracking participants of the annual Original Redneck Fishing Tournament that put this village of 274 on the map with its inception in 2005.

What started that year as a small gathering of those who wanted to address the problematic carp and raise money for veterans' causes evolved into a yearly event that garnered national TV coverage and visits from publications ranging from *Time* to *National Geographic*. Tournament-goers in the tens of thousands from across the country and overseas crowded into Mason

County not just to catch the thousands of carp that jump clean out of the water from the disturbance of engine motors, but also to commune with fellow rednecks for a good old-fashioned weekend of uninhibited, booze-fueled fun.

"They had Illinois State Police directing traffic in the middle of town, it got so big," village of Bath president Jason DeFord said.

The carp get a reprieve this year. The tournament was recently canceled by its organizers, citing financial issues relating to a lack of sponsors and insurance costs, much of the latter centering on a giant beer tent whose roughly \$5,000 cost was previously covered by the village itself. The cancellation has led to a lot of finger-pointing and heated accusations from two camps – one led by tournament founder Betty DeFord and the other by her successor and current organizer, Nikki Gregerson.

The controversy has spilled onto the pages of Facebook, where profane vitriol has been lobbed from one camp to the other.

"People are always going to talk in small towns," Gregerson said with a weary sigh.

In the kitchen of 70-year-old Betty DeFord's Bath home hangs a framed, knitted saying that reads "I'm not bossy, I just know what you should be doing."

To DeFord's critics, she has been too bossy toward Gregerson and the tournament's organizers since she relinquished control of it in 2021. That led to a confrontation between Gregerson and DeFord at last year's tourney that, DeFord said, "left me in tears" and shattered the goodwill surrounding the event. Sponsors seemed to have been turned off by the controversy, leaving Gregerson and other organizers too financially strapped to hold it this year.

All of which could have been avoided,

Betty DeFord said, if Gregerson hadn't "poisoned the water" to patrons and sponsors alike.

"I think there was a big deal with jealousy with her, and she thought she could make money. I never made money off of it. We spent money out of our own pockets," DeFord says, looking at photos of past tournaments. "She wanted the notoriety that I have received from this and felt that I was taking from her, because at every event, everybody was looking for Betty DeFord."

DeFord, indeed, always was the person the TV crews and print reporters sought out when looking for a face to put on the tournament. After all, her name is in the original title of the event that she launched following an outing on the Illinois River that saw the frightened carp jump by the dozens around and into their jon boat, some hitting her and her grandchildren smack in the face.

"This was a good thing. It brought people together," DeFord said of the event. "In 2013, it became a benefit for Illinois homeless veterans. After expenses, everything was donated. Without the veterans, where would we be?"

But, in 2021, DeFord notified everyone it would be the final year of the Redneck Fishing Tournament. An ongoing battle with breast cancer was the major reason, she said, along with having to be the primary caretaker to her husband, a Vietnam veteran battling dementia.

It was at the end of the 2021 tourney, DeFord said, that Gregerson approached her and implored her to keep the event going. DeFord said she just couldn't devote the time needed, but would serve as an adviser if Gregerson wanted to take over. For a couple of years, the tournament seemed to continue in harmony. But last year came the confrontation between Gregerson and DeFord, the accounts of which differ depending on who is doing the talking.

As DeFord sees it, she was taking ticket money and mingling with others when she was "jumped" by Gregerson and accused of, among other things, badmouthing her to sponsors that had a negative effect on their ongoing participation.

"She accused me of setting up a board meeting to get her evicted from it. You can't set up a board meeting as a private citizen. Everybody called me, because they know I've set up this tournament, and I forwarded her every message and she did not respond to these people," DeFord said. "I didn't run around telling people, 'Oh, don't give her any sponsorship money.' But I sure got the blame for it."

DeFord said some of the vendors from last year told her they will "never, ever come back, because she mouthed off to them. This is the help I got? She ruined it, and I've spent many sleepless nights in tears over it."

Reached by phone, Gregerson, while saying she hasn't spoken with DeFord since last year, seemed incredulous at such accusations.

"I really don't know where Betty is coming from," said Gregerson, who lives a retired life in Browning. "I haven't spoken ill of Betty to anyone. I haven't seen anybody badmouth Betty, or else I would have said something, because it doesn't need to be that way. I couldn't care less about any notoriety for myself."

Audrea Cleer, a Bath resident and acknowledged member of Camp DeFord, recalls the situation last year thusly: "I'm sitting there selling shirts and (Gregerson)

was going to talk bad about Betty. I'm like, 'Just so you know, I love Betty and I'm just here to help her,'" Cleer said. "I feel like Nikki was more jealous because of the people who were coming from out of state who all wanted to see Betty."

Cleer said she thinks lack of organization is to blame for this year's cancellation.

"(Gregerson) didn't get her stuff together and tried to blame something else. If she had her ducks in a row, the tournament would still go on. It's a shame," Cleer said.

Members of Camp Gregerson, however, have portrayed DeFord in a more unfavorable light and say Gregerson should be credited with doing her best to keep it going after DeFord stepped down.

Gregerson, when asked if the tournament might be finished for good, said she's already receiving offers from nearby towns to hold it starting next year.

When asked why, in her opinion, the tournament had such a big drop in sponsors – from about 35 to five – Gregerson said: "I think the tone itself of the tournament kind of changed a little bit. Not all of the people in Bath enjoyed it. Not all of them hate it. The majority of the people there are always very helpful. I just think the tone changed, and when we took it over, we were trying to bring that fun back. And we had to change some things, and it wasn't a popular choice with everybody. But the majority of the people liked it. So, it may be the economy or I don't know what it is for sure."

The person seemingly most caught in the middle of all this is Jason DeFord, Betty's nephew, who has only been on the job as the mayor of Bath for two months now. He swears he has no dog in this hunt, despite the family name.

"This is all pretty new to me," Jason DeFord said. "But to be clear, the village of Bath did not cancel the tournament. They (Camp Gregerson) did. What the village did was, we decided we couldn't do a beer tent due to some other financial obligations and problems that are unrelated to the Redneck. Why they're canceling it altogether, I'll leave that to them."

Betty DeFord, meanwhile, is organizing a Bring Back Bath celebration Aug. 1-2 in the village square to aid Illinois veterans and rehab the local playground. There will be food, games, a cake walk, raffle baskets and open-mic karaoke.

"We're looking for some sponsors," she said. □

# Visit Illinois Beach State Park

An easy drive to access Lake Michigan

East from Illinois Beach State Park, Lake Michigan glistens and beckons anyone seeking summer fun in the sun. Plenty of beach lovers answer the call, if packed parking lots on the weekends are any indication.

Tucked into the far northeastern part of the state, the park offers a variety of outdoor activities four hours from Springfield. It also hosts the state's last natural shore of Lake Michigan, according to Chase Firth, the park's natural resources coordinator.

"It is unique in that it is the last chunk of dune and swale in all of Illinois," he said. "Every other piece of lakefront in Illinois has been developed."

The park features more than 650 plant species, including wildflowers, cacti, grasses, sedges, black oak and pine trees in dry and marshy areas and aquatic life in ponds.

Firth said it is the second most visited

state park in Illinois, behind Starved Rock. The 4,160-acre park features 6.5 miles of sandy shore, nature trails, fishing, camping and picnicking. Also part of the officially named Adeline Jay Geo-Karis Illinois Beach State Park Cullerton Complex is the North Point Marina, owned by the state but leased out.

You can learn about the park's features and its unusual history at the visitor center/nature center, open Thursday through Monday from 9 a.m. to 4:30 p.m. in the park's south half. You can pitch a tent, park your RV or book a room at a resort hotel on site if you want a longer stay.

The big draw, of course, is Lake Michigan in the last few Illinois miles before its waves lap in Wisconsin. Native Americans, hunters, trappers and explorers tromped across the dunes, and preservationists such as landscape architect

Jens Jensen recognized the area's value.

The U.S. Army also liked the spot, turning the northern part of today's park into Camp Logan, training riflemen and tank crews during World Wars I and II. Firth said the FBI also used the rifle ranges. The Illinois National Guard took over the land in the late 1940s, and the state started working on the first park parcels in 1948.

In 1964 the southern part became Illinois' first nature preserve, but it took until 1982 for the state to get the northern part, which stretches from a decommissioned Commonwealth Edison nuclear power plant to the Wisconsin border.

Today, the two park units have separate entrances off Sheridan Road in Zion and Winthrop Harbor with a third entrance to North Point Marina. Entry at any leads to those seemingly endless Lake Michigan

views, trails and picnic areas. Park entrance and parking are free.

The south unit includes the nature center, campground with showers and electricity, camp store in season and hotel. Some campsites can be reserved but most of the more than 200 are first come, first served. Firth acknowledged that maintenance of the heavily used campground had drawn complaints in previous years but says past staff shortages are resolved and bathrooms have new doors and locks.

The state pumped more than \$70 million into park improvements, he said, pointing to more water safety signs and rings, bilingual signage, 23 new breakwaters to stop erosion and 50 acres of beach replenishment in the last two years.

Renovation of the hotel, built in 1958 and leased by the state to a private group,

is ongoing with an indoor pool remodel and other improvements. Until those are made, visitors can expect rooms that are a little dated, weeds in the courtyard and some areas blocked off. The onsite restaurant, Nolan's, remains popular for meals and events and affords the best views of the lake from the hotel.

Like the south unit, the north one has parking for the beach, showers and restrooms and also Sand Pond for fishing.

Head to the North Point Marina to find two restaurants, large and small boats, fishing charters, a playground and an outdoor pool. Firth said it is one of the biggest marinas on all of the Great Lakes with 1,500 slips and a boat service center. The marina is a good place to sit back, admire the many boats and gaze at Lake Michigan's sparkling water and far-off horizon.

And if you are in the mood for a quintessential Wisconsin supper club, you can slip over the nearby border and find one within a few miles.

# Bring on the brats

Fresh sausages a tasty addition to summer diet

We've been on a bratwurst kick in my house lately. It's high season around here with summer theater and sports and way too much garden to look after, so simple meals that yield easy leftovers have been on regular rotation. Brats, once eschewed by my kids, have suddenly become the new favorite. I've taken to cooking a double batch for supper early in the week and within days any remaining links are quickly scarfed up under a pile of kraut or stuffed into a roll for a quick lunch.

And while a juicy brat isn't exactly considered health food, I'd argue that fresh sausages are a fine addition to any omnivore's diet, especially when they're sourced from a local farm and made with good quality ingredients. Farmer Mitch Cave owns 4-Lees farm, a fourth-generation family farm west of Springfield in Virginia, where he raises pastured, free-range chicken and pork which he sends off to a local processor to be transformed into roasts and sausages, which are made without fillers or nitrates. The farm's Korean barbecue brat is a particular favorite in our house, grilled and served with punchy kimchi and a squeeze of sriracha mayo. 4-Lees takes online orders and makes deliveries (all products come frozen) to the Springfield area every Friday.

For those seeking fresh brats on demand, Humphrey's Market, Springfield's oldest locally owned and family run grocery, is open six days a week and serves up a hearty helping of nostalgia in addition to fresh chops and

steaks cut by actual butchers. Humphrey's, 1821 S. 15th St., also makes a dizzying array of fresh sausages daily, including its traditional family recipe apple brats as well as new flavors such as Philly cheesesteak, spicy jalapeno cheddar and "cowboy butter." Cowboy butter is a new flavor that one of the Humphrey's butchers described as "comfort food with a little kick of spice."

## Warm Swiss chard and brat salad

This recipe makes the most of one of summer's most generous greens. It started out as a riff on the iconic hot spinach salad with bacon dressing, but then took a pub house turn with the addition of juicy brats, beer mustard and crispy pretzel crumbs.

### Ingredients:

1 large bunch Swiss chard, trimmed  
1 tablespoon butter or bacon fat  
½ cup breadcrumbs or broken pretzel pieces  
4 bratwurst  
2 tablespoons olive oil or bacon fat, as needed  
1 medium red onion, sliced  
2 tablespoons cider vinegar  
2-3 teaspoons brown sugar, to taste  
1 tablespoon grainy beer mustard  
Salt and black pepper

Wash the chard and dice the large bottom section of the stems and set aside. Roll up the leaves like a cigar and finely slice them into fine ribbons.

Melt the butter in a large, non-reactive skillet over medium heat. Toast the breadcrumbs or pretzel pieces in the skillet until they're crispy and golden brown. Transfer to a small, paper towel-lined bowl and set aside. Wipe out the skillet and return it to the heat.

Cook the sausages in the skillet until they're nicely browned and cooked through, then set aside. Add two tablespoons of oil to the skillet if needed (depending how fatty the sausages are – you'll want 2-3 tablespoons of fat in the skillet) and sliced onion and diced chard, cooking until softened and lightly caramelized, about 5-8 minutes. Add the vinegar, sugar, mustard and two tablespoons of water along with any juices from the resting sausages. Bring the dressing to a bubbly simmer, then remove the skillet from the heat. Add the julienned chard leaves to the hot dressing in the skillet and toss until just beginning to wilt. Season to taste with salt and pepper, then divide the greens between four plates and top with the sausages and a sprinkle of crispy crumbs.

## Curried sausages

This was one of the only meals that my college roommate in New Zealand knew how to make so we had it often, which was totally fine because it was cheap and tasty. Undoubtedly inspired by German currywurst, this retro dish will stick to your ribs. It is standard fare throughout New Zealand and Australia.

### Ingredients:

1 tablespoon olive oil or bacon fat  
8 bratwurst  
1 onion, sliced  
1 apple, peeled, cored and diced  
1 carrot, sliced into thin coins  
1 tablespoon mild curry powder  
1 teaspoon paprika  
1 cup chicken stock  
¼ cup ketchup  
1 tablespoon cider vinegar  
1 teaspoon each soy sauce and Worcestershire sauce  
Cornstarch, if needed to thicken  
Salt, black pepper and brown sugar, to taste  
Cook the sausages in a large skillet over medium high heat, then set aside. Add the onion, apple and carrot and sauté until softened, about five minutes. Add the curry powder, paprika, chicken stock, ketchup, soy sauce vinegar and Worcestershire sauce. Bring to a simmer over medium heat. Slice the cooked sausages and add them along with any accumulated juices to the skillet and cook 10-15 minutes more until the sauce is thick (to make a thicker sauce, add a teaspoon of cornstarch dissolved in cold water to the pan and simmer five minutes more). Season to taste with salt, pepper and brown sugar as needed. Serve with mashed potatoes, rice or, for a truly authentic experience, french fries. □

# The Prom at the Hoogland is an inspiration

In 2010, a controversy erupted in the Itawamba County School District in Indiana. A lesbian student wanted to bring her girlfriend to the school prom and the school refused, choosing instead to cancel the prom for all students. A second prom was scheduled which was also canceled, a lawsuit was filed with the ACLU, a few celebrities got involved and then came worldwide attention.

The journey of this brave student and her fight for inclusion and acceptance in her small town was the inspiration for a new musical that opened on Broadway in 2018 and is currently playing at the Hoogland Center for the Arts as part of its education program. *The Prom* shines with equal parts good-old-fashioned musical comedy and modern day righteousness. It overflows with heart and humor, expressed buoyantly through a multitude of musical numbers and stellar performances all around, complete with an 11th-hour powerhouse number. And yet, amid the string lights and streamers, it speaks to us softly about some relatable heartaches and struggles.

*The Prom* (music by Matthew Sklar, lyrics by Chad Beguelin and book by Bob Martin and Beguelin, based on an original concept by Jack Viertel) begins by introducing us to four eccentric and superficial New York actors (Carly Shank, Kenny Kendall, Lori Ann McCabe and Craig Williams II) who are either between jobs or just got panned after a scathing review of their latest flop. In an attempt to repair their reputations and prove they're not deeply narcissistic, they seek out a cause, "preferably a low-risk injustice they can drive to." A Twitter search brings up the story of Emma, an Indiana high schooler whose prom was canceled because she wanted to bring her girlfriend as her date. The actors seize on what they see as an opportunity to change lives and, at the same time, their own misfortunes. They board a *Godspell* tour bus for the town of Edgewater, Indiana, fully unprepared for how – and whose – lives will ultimately be impacted.

In Edgewater, we meet a confident Emma (Cam Lecocq) and the rest of the student and faculty population. Emma is bullied and ostracized by almost everyone as they cruelly mock her sexuality and blame her for prom being canceled. The only exceptions are a compassionate principal (Greg Donathan)

and Emma's anxious girlfriend, Alyssa (Briara Mckinnie), though she is still in the closet, fearing her mother's reaction. The New York actors burst onto the scene to rally around Emma, initially (albeit hilariously) making matters worse. But this being an old-fashioned love story and musical comedy, all works out in the end, to life-affirming results.

Director and choreographer Anna Maisenbacher and the rest of her talented staff (assistant director Cory Blissett, co-choreographer Michellina McNaughton and vocal director Christie Lazarides) have assembled a spot-on, high-energy cast, whose members thoughtfully tell this courageous story of love, discovery and acceptance. I had the chance to chat with some of the actors about what the show means to them and what audiences can expect.

"If you tell a story about unconventional love," said Carly Shank, who sizzles as actress Angie Dickinson, "it can be either the pain or the dramatic, risqué part, but what evolved here is more like watching a traditional love story. It's crafted so well. We're all seeking love – gender and sexual preference are irrelevant."

As for what drew Cam Lecocq to the show, who excels in the role of Emma: "I was drawn to it after *Fun Home* (where she played Small Alison). I enjoy being able to see myself in a role. I like the idea of being able to do that for others, too – that they might see themselves in a character."

Craig Williams, so funny and sweet as Barry Glickman, echoed this idea. "Playing a gay character is like paying it forward for those who have not had that opportunity before. Hopefully, it empowers someone else who sees it." Barry's impassioned appeal to Alyssa's mom at the show's climax is a testament to how telling these stories has the power do just that – move, motivate and empower.

Mckinnie admitted she didn't initially have *The Prom* on her radar until Williams gave her a nudge one day, and she's glad he did. So are we, as she is a joy to witness.

"I feel kinda close to Alyssa Green," Mckinnie said. "I know what it feels like to not be your true self because of the expectations placed on you. (Alyssa's) whole thing is she feels like she can't be herself because of her mother. But she has to speak her truth at the end, and it's important for people to see it." □

## Why Take PrEP?

PrEP reduces the risk of getting HIV from sex by about 99% when taken as prescribed. Among people who inject drugs, it reduces the risk by at least 74% when taken as prescribed.

## Is PrEP Right for You?

PrEP may benefit you if you test negative for HIV and -

**you have had anal or vaginal sex in the past 6 months,** and you:

- have a sexual partner with HIV (especially if the partner has an unknown or detectable viral load),
- have not consistently used a condom, or
- have been diagnosed with an STD in the past 6 months.

**you inject drugs** and

- have an injection partner with HIV, or
- share needles, syringes, or other injection equipment.
