New dispensary planned on Dirksen

California company seeks zoning approval for vacant building

If he had his druthers, Ward 3 Ald. Roy Williams Jr. would rather see something besides a proposed new recreational cannabis dispensary going into 1401 S. Dirksen Parkway, a currently abandoned property in his ward.

“But I don’t like empty buildings or empty houses,” Williams said.

So, albeit with some reluctance, Williams said he would vote to recommend zoning approval for a 4,582-square-foot adult dispensary to be operated by Spring Lucius Community LLC, a licensed cannabis retailer that would lease the property from RTD MC II, LLC. The building would be improved by new masonry and framing, with newly paved parking.

The building’s previous tenants have included restaurants such as Sambo’s and Daphne’s Family Restaurant, along with a title

loan company, but it has been largely vacant in recent years. It sits in front of County Market and just down the street from one of two Springfield Godfather’s Pizza stores owned by local businessmen Mike Monseur and John Leskovisek.

Williams said he wouldn’t vote for approval if business owners near the proposed dispensary objected, and while Monseur echoed Williams’ overall sentiments, he is in favor.

“That building has been sitting vacant for a long time and had a lot of issues with – how do I put this nicely – with the homeless issue and stuff,” Monseur said. “I’m always pro-development. If they run a good business and keep their place looking good, I’m all for it.”

Springfield attorney Gordon Gates and his firm, Gates Wise Schlosser & Goebel, are representing the company at the Springfield

Planning and Zoning Commission, which held a public meeting Feb. 18 on the issue. The Zoning Commission makes a nonbinding recommendation to the Springfield City Council, which then has the final say on zoning cases.

“(Spring Lucius) has done their homework on this,” Gates said, who told *Illinois Times* he doesn’t anticipate opposition to the project. “The businesses surrounding this are fired up about it.”

Gates said the company applying for the zoning is represented by Kimble Cannon, an attorney who, records show, has previous experience with cannabis operations.

Williams indicated that the still-unnamed dispensary would have some high-end features, such as a lounge area for customers. While he reaffirmed his support for the city’s latest dispensary, he said he won’t be so amenable to any others in his ward in the near future.

“This will be the last one that I would support on Dirksen Parkway; (this is) the third store near each other,” Williams said. “I do wish that the powers that be, i.e., the city, (Springfield Sangamon) Growth Alliance, all these people who are paid to develop more of Springfield. ... it seems lately in my ward, along Dirksen Parkway, all I can attract is liquor, marijuana and gaming. And that’s kind of offensive to me.”

But Williams said he is encouraged, not just by the budding new dispensary, but by a Long John Silvers that “has decided to (relocate) across (from its current location at 2929 S. Dirksen Parkway), which kept it in my ward and kept it on Dirksen.”

“I’m so thrilled about that, because usually when businesses close down, we lose them

to the west side or other parts of the city,” Williams said. “I wish it were other things going into (1401 S. Dirksen Parkway), but I’ll have to accept things as they are. Once (cannabis) became legalized in 2020, I follow the law.”

Monseur, who, along with Leskovisek has owned the Godfather’s just down the street for the last 22 years, said business development in that area and city overall has been hampered by too many restrictive state policies.

“With lawmakers talking about \$27-an-hour minimum wage now and \$19 is supposed to be in July, Illinois is just chasing everybody away,” Monseur said. “It’s surprising that anyone wants to invest in Illinois right now. We have seven stores (overall) here that have leases coming up, and we’re torn on if we’re going to stay. The stores do well, they’re moneymakers, but we’re torn with how hard it is to get help. Every time you wake up in the morning, they’re talking about a new fee, new tax, new something instead of, ‘How can we attract revenue?’

“So that’s why I’m liking this (dispensary) coming in, because it’s new revenue coming in and it’s a development on an eyesore that’s been there. That building has been a danger to the community there. I think it’ll bring the crime rate down there, because there will be legitimate activity going on,” Monseur said.

Recently, local businessman Justin Conder received zoning approval for a new craft grow cannabis business in the former Comcast building at 701 S. Dirksen Parkway.

“This would be our fourth (cannabis business) on Dirksen. They are legit businesses, but I think I’ve got my share now,” Williams said. □

Jack Campbell speaks out

Former sheriff addresses union president's letter to judge asking for clemency for Grayson

The former Sangamon County sheriff – who refused calls for his resignation after Sonya Massey's 2024 murder, then abruptly retired, citing stress on his family and the sheriff's office – recently defended the office against recent allegations of “institutional shortcomings.”

Jack Campbell, 61, responded to questions from *Illinois Times* after Sangamon County deputy Travis Koester told a local judge that “systemic failures in training and supervision within the sheriff's office” justified a less-than-maximum sentence for former sheriff's deputy and convicted murderer Sean Grayson.

Campbell, who hired Grayson, said in an emailed response that Koester's letter was “full of lies and was an attempt to deflect from Grayson's actions and place blame on the sheriff's office.”

Campbell condemned Grayson's decisions leading to the fatal shooting of Massey inside her Woodside Township home but said there were no obvious warning signs before hiring that Grayson would disregard his training and become a murderer.

“He had double the training mandated by the state,” Campbell said.

Campbell said Koester's assertion that Grayson lacked training “is denigrating almost every deputy working” at the sheriff's office. And Campbell said he disagreed with the “content and premise” of Koester's letter requesting mercy for Grayson.

Grayson, 31, who is white, was convicted of second-degree murder in connection with the shooting death of Massey, 36, an unarmed Black woman, before the judge sentenced Grayson on Jan. 29 to the maximum, a 20-year state prison sentence, for Massey's murder. With good behavior and time already served, he could be released in 8½ years.

Koester, who signed his letter as president of Fraternal Order of Police Lodge 55, which represents Sangamon County Sheriff's Office staff, said in a letter to Circuit Judge Ryan Cadagin before sentencing that Grayson, hired by the sheriff's office in 2023, was a “product” of a bad environment there.

“Over the years,” Koester wrote, “I have witnessed firsthand how inadequate or inconsistent training, insufficient remedial instruction and a lack of meaningful mentorship can leave deputies ill-equipped to manage high-pressure situations appropriately.”

Campbell worked for the sheriff's office for more than two decades before being elected

sheriff in 2018. As a member of the FOP since 1996, Campbell said he was disappointed to learn that Koester's letter was sent “without the knowledge of the membership.”

Campbell, a Republican, denied allegations from Sangamon County Board member Marc Ayers, a Springfield Democrat, that Grayson's hiring was the result of nepotism.

Retired deputy Scott Butterfield, the father of Grayson's fiancée, wrote a recommendation for Grayson before the former Logan County sheriff's deputy was hired by Sangamon County.

Ayers sits on the Sangamon County Board's jail committee, which oversees the sheriff's office. He said the inadequate training and lack of mentorship referred to in Koester's letter was the fault of Campbell and Campbell's predecessors.

Campbell told *Illinois Times*: “Ayers' anti-police rhetoric shows lack of research and is using a tragedy to gain political favor. As stated, Grayson received more than adequate training. I, as almost anyone would when hiring or contracting, took a recommendation from a longtime deputy and trusted friend, along with another retired officer from a different agency, to interview Grayson, the same way people take recommendations from people they trust to hire contractors, lawyers and the like. Those references could not have predicted this event, either.”

Campbell declined an interview request but agreed to answer written questions from the newspaper. With minor editing, here are more questions posed by *Illinois Times* and Campbell's responses:

Question: Did you know about Grayson's two prior misdemeanor driving while intoxicated convictions when you hired him?

Answer: “Yes, and the board appointed by the governor – the Illinois Law Enforcement Training and Standards Board, or ILETSB – certified him as qualified for hire six times after those DUIs. If the governor or legislature wants to prevent people who get DUIs from being hired as a police officer, they have the power to do so.”

Q: Why did you hire Grayson when a psychologist who examined him as part of the screening process said he had a quick temper and scored low on the cognitive exam?

A: “Grayson was given two psychological tests and passed both of them. After passing the second examination by Sangamon County Sheriff's Office, he was sent through a police academy for the second time. (He attended his first training academy earlier in his law-enforcement career.) The second academy was not required by ILETSBE. He could

have went to work immediately. He had no reported issues at that academy.”

Q: Did you or other members of your command staff know about the problems that Grayson had at the Logan County Sheriff's Office and other police departments he worked at when you hired him?

A: “We were made aware of some of the issues. Not all of them. Complaints against law enforcement are investigated. And he had no major discipline at any of the agencies he worked for, certainly no use-of-force issues or racial complaints.”

Q: If you had known all of the details that came out about Grayson and his background prior to his hiring, would you still have hired him? Do you have any regrets about hiring Grayson?

A: “Of course, with 20/20 hindsight, which doesn't exist in the real world, had he not been hired, this tragedy wouldn't have happened. It is impossible to predict human behavior. And there was nothing in his background, nothing revealed in his psychological exams, nor experiences at any agency he worked for that could have told us this would happen. Contrary to some media reporting, Grayson was let go by only one agency (Kincaid), and that was for not moving within a 10-mile radius of the city. He changed part-time agencies frequently for better pay, larger departments, then eventually, full-time work.”

Q: What do you think about the job Paula Crouch has been doing? (Campbell has endorsed Crouch over retired deputy David Timm in the March 17 GOP primary for county sheriff and has contributed \$2,500 to Crouch's campaign, according to filings with the Illinois State Board of Elections.)

A: “I think she is doing a good job. Paula took over SCSO at a very difficult time and has led the sheriff's office admirably.”

Q: What reforms need to be made in Sangamon County or statewide to prevent another Sonya Massey tragedy?

A: “Reforms can't prevent unlawful, snap decisions. Without a method to predict human behavior, tragedy and crime cannot be fully avoided.” □

Med District could expand

Bill tied to Downtown Master Plan moving through Statehouse

Lawmakers could consider expanding the overall region, and special district powers, of the Mid-Illinois Medical District due to a new bill filed by state Sen. Doris Turner, D-Springfield, last month.

Senate Bill 2829 proposes adjustments to the existing Mid-Illinois Medical District Act by essentially doubling the size of the district's region, extending the southern boundary from Madison Street down to South Grand Avenue. The other boundaries would remain the same, North Grand Avenue to the north, Walnut Street to the west and 11th Street to the east.

The expansion would integrate Springfield Clinic's Main Campus, 1025 S. Sixth St., into the Medical District but exclude "all local, state and federal government properties within the area."

The bill also further specifies the special district "is created to improve the city center of Springfield."

Jen Boyer, acting CEO of Springfield Clinic, welcomed the medical district's expansion to include more Springfield Clinic facilities in a written statement shared with *Illinois Times*.

"Becoming part of the Mid-Illinois Medical District will strengthen collaboration among local health care organizations and physicians, expand access to innovative services and support economic development in the heart of our city," Boyer wrote. "We believe this effort aligns with our ongoing commitment to improving health outcomes, expanding access to care and serving the greater Springfield community with excellence and integrity."

While the existing act allows the Mid-Illinois Medical District Commission to construct hospitals, clinics and laboratories, the proposed legislation would allow the commission to also construct "housing, educational buildings (and) research facilities."

The bill also provides more regulations for the commission itself by removing a requirement that someone appointed by the governor or mayor of Springfield shall serve as the commission's president

and vice president.

Instead, SB 2829 would institute a commission election through "a regular meeting on the second Thursday of February in even-numbered years for the election of a president, vice-president, secretary, and treasurer from among its members." If passed during this legislative session, February 2028 would be the next election cycle for the commission.

The bill as it stands suggests no changes to the commission's makeup, which consists of four gubernatorial appointees, four mayoral appointees and one appointee from the Sangamon County Board Chair.

The Downtown and Medical District Master Plan, published in late 2024, suggests the city of Springfield "work with the state of Illinois to conduct a study to determine the impacts of expanding the MIMD boundary. The intent is to incorporate properties closer to the downtown core and encourage redevelopment and residential infill."

About 13 months after the master plan was published, Turner filed SB 2829, which currently sits in the Senate Local Government committee.

Ryan Croke, president of the commission, referenced the master plan when discussing SB 2829 at a Feb. 12 meeting of the Mid-Illinois Medical District Commission.

"That, I think folks will recall, was intended, in part, to strengthen the tie, collaboration and development efforts of our downtown institutions and the Medical District institutions. That, not coincidentally, also allows the Medical District zone to include the headquarters of Springfield Clinic, which we thought everybody agreed just made sense," said Croke, who works for the state as the first assistant deputy governor for health and human services.

"The bill was assigned to the local government committee in the state Senate. It was moved out of the assignments committee and into a substantive committee, which is a good sign," he said. □

State seeks new revenue streams

As I write this, Gov. JB Pritzker is preparing to give his annual budget address. It's an unenviable task.

Earlier this month, the Governor's Office of Management and Budget released a report showing federal tax cuts caused a \$587 million reduction in state revenues this fiscal year.

The governor announced last month that he was withholding \$482 million in state spending to help mitigate federal attacks on the state budget.

It's not all horrible news. The latest monthly revenue report from the legislature's Commission on Government Forecasting and Accountability showed January revenues from state sources were up, according to COGFA.

Personal income tax receipts increased 2.1 percent in January compared to the previous January (which is still below inflation). Corporate income tax revenues rose by 3.5 percent after months of lagging. Gross sales tax revenues increased by 3 percent.

Estate tax receipts are up 60 percent, or about \$200 million, so far this fiscal year compared to last year at this time, COGFA reported. The commission said asset valuation increases, including the stock market, likely contributed to the increase.

So far this fiscal year, revenues are up a bit more than \$1 billion, or 3.5 percent, compared to the same period in Fiscal Year 2025.

But there is that big federal downside. According to COGFA's report, federal revenues experienced a "notable decline," falling \$169 million, or almost 36 percent in January, compared to the same month last year.

During the fiscal year to date, federal sources have dropped by about 8 percent. But January marked the third straight month for federal revenue declines, so it may be accelerating.

"To meet initial fiscal year estimates, Federal Sources will need to show meaningful improvement over the remaining five months," the monthly report declared. The fiscal year ends June 30.

And nobody knows what tomorrow may bring. Heck, by the time you read this, something new could've happened. At any given moment, White House operatives could try to pull funding for whatever program they can dream up.

Last week, the Trump administration announced that it was canceling \$100 million for local public health grants in Illinois.

Illinois was one of just four Democratic-led states that were targeted for the cuts.

According to the Illinois Department of Public Health, some of the cuts were for "HIV Prevention and Surveillance, which includes

programs to expand HIV testing to cover more people who may not be aware they have HIV; linking newly-diagnosed patients to appropriate care; expanding access to PrEP, medication which can reduce the spread of HIV; and conducting partner notification."

Attorney General Kwame Raoul quickly won a temporary restraining order last week, giving the state a 14-day reprieve.

Raoul has so far fought off numerous federal attempts to withhold money from the state. But there's just no way of knowing what could happen as the litigation moves up the federal judicial food chain.

In other words, there is just no way to craft a reliable fiscal plan in this environment.

My associate Isabel Miller wrote a subscribers-only story last week for my newsletter about how more than 40 Democratic members of the Illinois House and Senate have been meeting weekly to come up with a plan to find some government efficiencies and create new revenue streams to help the state meet its obligations.

"We must lean into transforming our tax system and creating sustainable revenue to protect people and the services we all depend on," the Affordability and Tax Justice Coalition declared in a statement.

I was told that six ideas are under discussion, and four have been introduced into bill form: A digital advertising tax (SB3353/HB4894); A billionaire wealth tax (SB3376/HB5215); Expanded tax haven reporting (HB5318/SB3486) and closing corporate loopholes (SB3796/HB5125).

As Isabel noted, House Speaker Chris Welch has also been promoting a tax on millionaires, which has heartened the progressives.

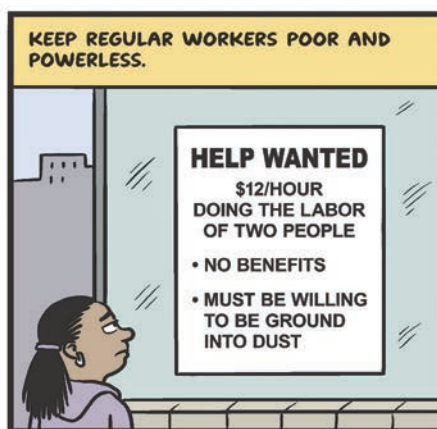
"I think right now the growing sentiment is 'Let's get as much revenue as possible,'" Sen. Guzmán told Isabel.

Sen. Guzmán also said the coalition is pressing revenue advocates for specifics, including projected revenues for each proposal, constitutionality and implementation.

Too often, these groups just throw together proposals and hope for the best. But Guzmán said they're focusing on whether these ideas can pass both chambers and be signed into law.

"The roll call is something that we keep talking about every week because we know the votes that we have to get up to in any one of these proposals," Guzmán told Isabel.

A lot is riding on those efforts. □

A real planner this time

The City of Springfield tries reading the instructions

The city of Springfield has hired its own city planner, a real one this time. Her name is Suraksha Bhandari. She studied at the University of Utah after life in Nepal but she might find Springfield's city hall no less strange a place than Mormon Salt Lake. She brings to the job degrees in architecture and metropolitan planning but she also knows about disaster risk management. We can pretty much guess which one she'll need most.

That city hall needs better advice about regulating development has been plain for years. In 2015 the *State Journal-Register* complained that many of Springfield's problems with drainage, traffic, sprawl, parking and the like "could have been averted had the city paid better attention to planning." Having its own planner will make that easier to do, but we can only hope that Bhandari was not hired simply to spare everyone else at city hall having to pay attention to planning. That's because it is not planners who decide how a city will be built. Developers and elected officials decide, and it would be nice if they stopped building Springfield without bothering to read the instructions first.

All a planner can do officially is research, explain and recommend. However, there remain lots of ways short of a veto power that she can make herself useful. For example, every project review raises the same issues. Does a proposed new strip mall or subdivision conform to the zoning map? Is it a good project? Will the project be good for Springfield? These are distinct questions, and a good planner can clarify them for decision-makers. She also can look at site plans (as apparently no one else did) to avoid cockups like the one that dumped traffic from a large strip mall onto small strip of street where Hedley meets White Oaks West near Wabash.

The city's planner also can remind alderpersons and mayors that things that are done wrong today will stay wrong for a long time. Springfield still has unconnected streets left by haphazard platting in the 1800s. In the 1960s Sandburg school was built on the

wrong side of a multilane highway from where its students lived and it will stay on the wrong side until it falls down. As Myron West, the author of Springfield's very first city plan, pointed out a century ago, urban planning, inexpensive, may prevent mistakes which cost millions.

The city's new planner might also explain that good development does not always mean building things. The city has lost to new construction too much of the stream-cut terrain better preserved for vistas or parks. And while she's at it, Bhandari might whisper in the ears of decision-makers that God's 11th commandment was not that any street with enough car traffic to support commercial uses must be surrendered to commercial uses.

Much of her work will be technical, but any good urban planner must also be a teacher. Much of the local private sector, for instance, tends to see planning as an

intrusion into the private sphere, but development is just as plausibly understood as an intrusion into the public sphere. Planners are our advocates for the public sphere, looking at the city as a whole and not lot by lot or plat by plat, taking into consideration how new shops or houses sit on the street, how they relate to their neighbor buildings, how their operations affect the environment and what they add to the visual environment that is, after all, Springfieldians' only universally shared experience of the city.

Alas, changing minds on those points inside or outside of city hall would require not just a conversation but something more like a religious conversion. Elected officials in particular tend to confuse good urban planning, which most of them regard as a nuisance, with economic development, which they regard as their main job. Bhandari will be working out of the mayor's Office of Planning and Economic Development, which might be more accurately titled the Office of Planning for Economic Development. But Springfield's first planner argued that to make Springfield a better place

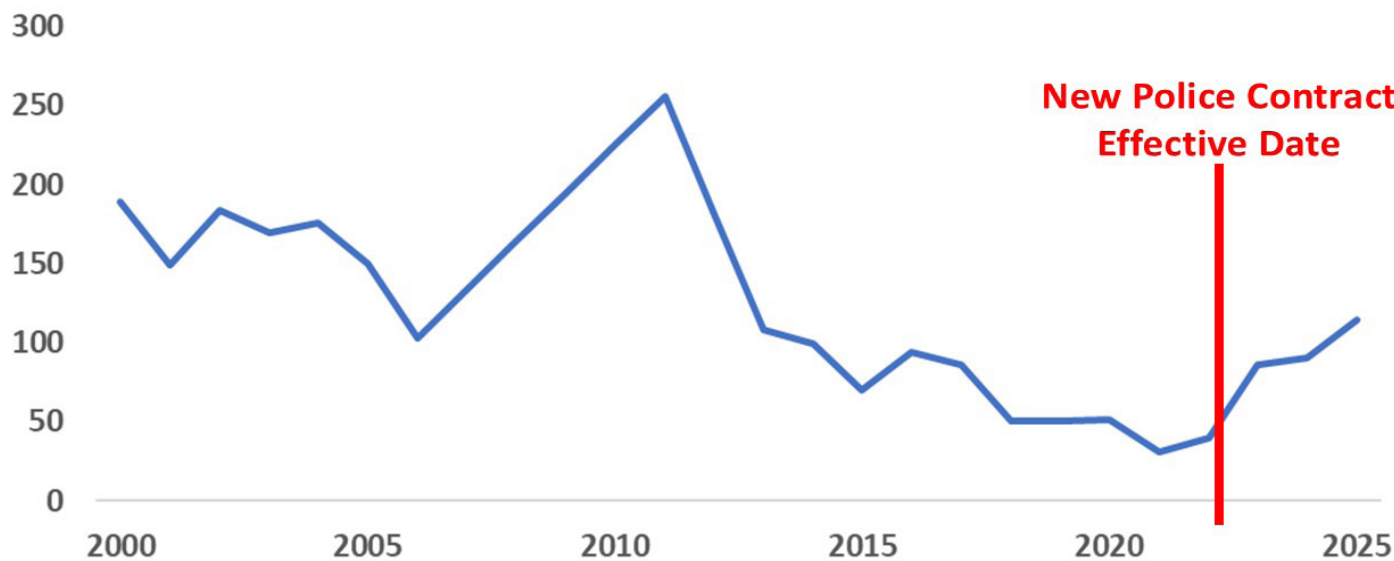
for business you first make it a better place for people by ameliorating the effect that unplanned business development has on a city. Wrote West in 1924, "It is not enough to advertise a city. This advertising must be accompanied by proof that the city in question is built and operated as to offer real quality to newcomers."

There is much more that might be said about all of this and I hope to say some of it in future columns – about how politics affects planning decisions, about how lack of funds presses the city council to make decisions that are good for the City of Springfield but bad for the city of Springfield, about how city hall might learn from its mistakes. In the meantime, every patriotic Springfieldian ought to wish Ms. Bhandari well. □

Saving money on police costs safety

Lowering police hiring standards to improve the bottom line has a price

The Jan. 22 edition of *Illinois Times* included an article by Dean Olsen with an overview of the upcoming city budget (“City has more expenses, less revenue”). Former Springfield budget director Bill McCarty blames the police and fire contracts for causing a “structural deficit” and pats himself on the back for the work he and former mayor Jim Langfelder did to “rebuild the city” and create “record reserves.”

These may make great talking points for elections, but how this was accomplished needs to be discussed before we go back down the road that McCarty is urging.

In short, McCarty and Langfelder balanced their budgets by eroding public safety. Under them, the Springfield Police Department hit record lows in recruitment and was forced to lower standards significantly just to attract new recruits. They accomplished this by cramming wages down the throats of our first responders that were vastly lower than those of comparable cities. At the beginning of their administration, Springfield was considered one of the most desirable workplaces for top police and fire recruits – by the end, they were hiring anyone that had a pulse – and still could not attract enough candidates.

So, at a time when the public was demanding higher standards from police, our city was actively lowering standards. This had a dire impact on public safety. With headcounts and skillsets lagging, emergency response times soared. Springfield police

officers experienced such a large backlog of calls that it could take two to three hours to respond to active domestic violence calls. And the officers who responded were less capable, less trained and less motivated than at any point in the department’s modern history.

Sound like exaggeration? Consider these numbers: Before McCarty was appointed in 2011, more than 250 candidates were testing to be Springfield police officers. After 10 years of McCarty, less than 40 candidates were testing annually. That meant the police department was forced to hire people that just a decade ago never would be Springfield cops. This was at a time when the public expected higher standards from police.

McCarty also caused delays in vehicle maintenance and procurement. This directly led to police officers being forced to drive vehicles that were unsafe. In one of the more audacious examples, carbon monoxide was found seeping into the interior cabin of police cars due to rusted-out floors, poisoning cops and detainees. This resulted in hospitalizations. The city’s solution? Weld old street signs to the floor of police vehicles.

McCarty and Langfelder, in effect, refused to use the garden hose as their house burnt down – and expect us to congratulate them on their water conservation skills.

The Springfield Police Department has been on an upward trajectory in performance, morale, efficiency and recruitment ever since McCarty and Langfelder left. Since the

current police contract went into effect, we have attracted record numbers of lateral hires from other agencies – experienced officers who we don’t have to spend money training to be cops. Morale is up, training is up, and we are – for the first time in over a decade – on a course toward a fully staffed department.

While slashing public services in order to create the appearance of a balanced budget may sound like a good bargain in some wealthy collar-county suburb, Springfield is a real city with real issues. Our police are called out more than 100,000 times per year, and Springfield has one of the highest per-capita crime rates in the state. We need to attract highly skilled professionals to our police department – the kind of person who meets the high standards our residents expect of modern policing, men and women who can be calm and judicious on the street but also capable of responding decisively and correctly when called upon.

We are on the right path, finally. We now have a city administration that actually listens to the concerns of rank-and-file emergency workers and takes the day-to-day management of Springfield seriously. This administration isn’t willing to risk our community’s health and safety out of political ambition or for tidy campaign talking points. □

From substitute teacher to superintendent

Terrance Jordan prepares to take the reins at District 186

Dr. Terrance Jordan did not like attending school as a youth.

"I had bad experiences in school growing up in rural Mississippi," Jordan said. "I was mistreated by teachers and by some of my peers, so going to school was not something that I had any desire to do."

Jordan, a self-professed slow learner at the time, recalled that his childhood education "wasn't caring, it was punitive."

"I remember getting paddled for not being able to spell on a spelling test, spelling words in front of everybody," Jordan said. "The teachers, instead of providing me with some sort of intervention and support as motivation, made it more embarrassing and

degrading. That just turned me off to school."

Growing from those early life experiences to the new Springfield School District 186 superintendent was something that Jordan could not have envisioned several decades ago. When he officially begins his new duties on July 1, Jordan wants to make sure that no student goes through the same educational trauma that he experienced as a youth.

"My early life has significantly impacted how I treat kids, how I support educators and how I provide coaching and professional development to show educators that there's a different way," Jordan said. "I want our students to leave high school college and career ready. I want to make sure every student

has the opportunity to be successful, whatever that looks like for them, and we want to be the catalyst to provide that opportunity. I don't want any student leaving school feeling like I felt."

The 48-year-old Jordan was approved by the District 186 Board of Education in January to succeed Jennifer Gill, who is retiring June 30 following 12 years as superintendent. Gill asked Jordan to be a member of her cabinet in 2021 and he is currently assistant superintendent of family, community and school leadership.

Jordan has also served on the boards of many local organizations, including the Springfield Art Association, United Way,

YMCA and Big Brothers Big Sisters of Central Illinois. He currently serves on the Heartland Continuum of Care Youth Homelessness Task Group, the Community Health Roundtable and the Faith Coalition for the Common Good Education Task Force.

"That's one of the things that has been beneficial to me, being out and visible, meeting people and organizations, finding all of the resources that are available for the district," Jordan said. "I am already meeting with people to prepare for taking over as superintendent. I want to listen, get into the schools and the community, see the needs in the schools and see what they have to say about the direction we're heading."

District 186 encompasses 35 schools, approximately 13,000 students and 1,100 staff, and its 2026 budget is \$268 million. The district’s geographic footprint includes Springfield, Grandview, Leland Grove, Jerome, Southern View and some rural areas to the north of Springfield. That’s a large entity to lead, but Jordan feels he is ready.

“A first priority of mine is to determine whether our academic investment is giving us what we need to be successful. We are in a deficit, but it’s an opportunity to reset, to do some things differently,” Jordan said. “There are going to be tough times coming up. It’s not the first time we’ve been here and it won’t be the last, but as I look at things, I try to see the positive in everything.”

Jordan’s journey from rural Mississippi to District 186 superintendent began modestly. Following high school he earned a physical education degree from Mississippi Valley

State University, but Jordan did so only because he wanted to coach football. Jordan moved to Springfield, where he still has many extended family members, and got a job in the construction industry. He said it was great during the warmer months but not so good during the winter when the paychecks just weren’t coming in.

“I needed employment, and my uncle said I should put in for a substitute teacher certificate and get a job in the local school system,” Jordan recalled. “He probably told me that because I was living with him at the time; I was broke and he didn’t want to support me.

“Honestly, working in the school system didn’t cross my mind before then,” Jordan added. “I didn’t take on that position out of desire, it was more of a necessity.”

Jordan vividly recalls the day in 2003 when he walked into Springfield’s Feitshans Elementary School as a substitute

kindergarten teacher, “the day that changed my life forever.”

“I can still remember that day like it was yesterday, walking up to Feitshans, already having some reservations about going into the school, thinking about the way I had been treated in Mississippi,” Jordan said. “I saw the school and how grand it was, and I was intimidated. But then I got in there and started working with the kids and saw I had the opportunity to make sure that they didn’t experience some of the things I did. I fell in love and felt that this is where I was supposed to be.”

Jordan later served as a library technology specialist and parent educator at Feitshans. He then taught first and third grade at Dubois, Feitshans and Enos elementary schools while earning his administrative license and received the Horace Mann Rising Star Teaching Award.

After earning a master’s degree in educational leadership, Jordan served as a guidance dean at Washington Middle School. In 2014 he was named principal of Black Hawk Elementary, where he served for seven years and was recognized with the District 186 Administrator of the Year Award and the Illinois State Board of Education Award of Excellence. Jordan was also named one of *Springfield Business Journal’s* Forty Under 40.

Jordan became acquainted with retiring superintendent Gill when she was an elementary school principal.

“Jennifer Gill is more than a mentor, she’s a friend. When she was principal at Vachel Lindsay I was a parent educator at the time, and back then she saw things in me and we stayed in touch,” Jordan said. “She has poured into me over the years. It’s not about the legacy you leave, it’s about how many leaders you develop, and she’s developed some great leaders.”

Gill encouraged Jordan to seek his doctorate degree. His dissertation focused on an issue close to his heart – multitiered systems of support that provide students exactly what they need to be successful. These systems are now in place at District 186 schools.

Gill feels that Jordan’s selection was a wise decision.

“Dr. Jordan is the right person at the right time. His community connections run deep and his focus is on students and their futures,” Gill said. “I cannot be more pleased to spend the next four months alongside Terrance to provide a strong transition for District 186, students, staff and families.”

“Show them who Terrance Jordan was.”

Jordan didn’t think about eventually becoming superintendent until after he joined Gill’s cabinet in 2021.

“I saw that every job I took impacted more

students, so about four or five years ago I said OK, I want to be superintendent, but it took me almost 20 years to come to that decision,” Jordan said. “I started preparing myself: I attended superintendent conferences, started reading leadership books and I graduated from the Greater Springfield Chamber of Commerce’s Leadership Springfield.”

Jordan applied for the position when Gill announced her retirement. The selection process included six separate interviews and involved the board of education, district and community stakeholders, teachers, paraprofessionals, administrators, cabinet members, parents and business owners. The District 186 Board of Education used the Illinois Association of School Boards, a nonprofit group that has members across the state, to search nationally for candidates.

Jordan made it to the final round of the selection process and then had to make a presentation to the school board and interview with them again.

District 186 Board member Buffy Lael-Wolf said that Jordan stood out from the many internal and external candidates who applied for the position.

“Dr. Jordan brings both vision and heart to this role,” Lael-Wolf said. “He understands our district because he has lived our work. He knows our students, our families and our schools, and he has earned trust through years of service.”

Jordan was ecstatic when he was offered the job.

“I was overcome with joy and excitement,” Jordan said “My ultimate goal during the process was to show them who Terrance Jordan was and let them decide if that aligned with their needs for a new superintendent.”

The Springfield Education Association (SEA), the union representing District 186 personnel, looks forward to working with Jordan as they have during his two-decade tenure in the district.

“We congratulate Dr. Jordan for his promotional appointment and very much desire for him to continue to be an outspoken part of the push for positive change, what is best for all of our schools and kids, and work in collaboration with our 1,200 committed educational union members,” said SEA President Aaron Graves. “Education is hard and leading it toward better is a challenge that is every bit as hard, and something we must all commit to.”

The SEA recognized Jordan “as a very effective and respected principal” at Black Hawk Elementary and noted “he would always do what is right, despite the challenges, and engage students, staff and parents in difficult discussions in order to prioritize the value of school, all while pulling his share of the load,” Graves said. “Servant leadership

matters. Terrance and I have spoken extensively about continuing to improve public education for the youth of Springfield, and that success cannot be found in a silo approach. We must all share the burden if we are to share in the success.”

Jordan acknowledged that he is a servant leader “who believes in service, leading with integrity and doing the right thing, I believe in standing up for what’s right even if you’re standing by yourself,” he said. Jordan agrees with the SEA that together they need to “build an environment where everybody feels important, everybody’s included and everybody feels welcome and wants to be a part of the environment. We also want to make sure that anyone who walks into our buildings feels safe, so that’s going to be a focus as well.”

“Learn about the exciting things that we do every single day.”

Addressing the district’s chronic absenteeism rate, which stood at 41% in the latest Illinois State Board of Education Report Card on all of the state’s schools, will be a priority for Jordan. He observed, “You can’t learn if you’re not here.” Jordan also wants to improve the state report card scores for several local schools by “honing our multitiered system of support, making sure we’re providing students exactly what they need to be successful.”

Despite the district facing an \$18 million budget deficit, Jordan doesn’t immediately foresee the need for a possible tax increase, noting that voters have already supported the district by passing a one-cent sales tax increase that took effect in 2019.

Jordan was asked if he would keep all of Gill’s current District 186 cabinet members, given the financial constraints.

“It’s only right that if we’re asking everybody else to trim and do things more efficiently, that we do the same with the cabinet,” Jordan said. “So if there’s an opportunity to save funds, then we’re going to do that.”

Jordan said it’s important to show the

great things that occur in District 186, and he invites families and other community members to get involved with local schools.

“During the pandemic people were told to stay away from our schools, but now I want them to come back,” Jordan said. “Support our schools and learn about the exciting things that we do every single day to make sure our kids are getting the best education they possibly can.”


Jordan hit the ground running from the day of his selection as he prepares to officially take the reins of District 186. Jordan’s wife, Ashley Jenkins-Jordan, is chief of staff for Illinois Senate President Don Harmon, so the super-busy Jordans only have salt water fish at home instead of other pets because “we don’t have to go home and let them out,” Jordan said.

The couple have a 28-year-old daughter who lives in Nashville, Tennessee. Jordan also has a large extended family in the Springfield area “so be careful what you say about me because you might be talking to a relative,” he joked.

Jordan currently earns \$192,000 as assistant superintendent and will earn \$230,000 as District 186 superintendent.

Looking toward the future, when Jordan finishes his tenure as superintendent, how does he hope people will view his service?

“I want them to think the same thing they thought when they found out I was named superintendent,” Jordan said. “My being named brought so many people joy, and they felt the urge to reach out to me.” □



Sax and romance, ISO style

Valentine's Day weekend provided local music lovers with an appropriately bright and romantic concert from the Illinois Symphony Orchestra, continuing its season at its temporary home at the First United Methodist Church. Jazzy dance numbers, a sweeping Russian symphony and a matched pair of soloists all contributed to a lushly burnished and enjoyable evening for the Feb. 13 "Love Notes" performance.

The music began with Leonard Bernstein's "Three Dance Episodes" from the 1944 musical *On the Town*. In just over 10 minutes, each episode delivered a distinct flavor, moving from a jittery and jazzy opening to a darker, more sensual mood and ending with an ebullient Broadway-style blow out of a climax. The brief but impactful sequence acted as a fitting fanfare for a varied and accessible evening.

Next, the guest saxophone duo of Valentin Kovalev and Aiwen Zhang took the stage for a performance of English composer Paul Carr's Double Concerto for Two Saxophones and Chamber Orchestra, described by ISO conductor and music director Taichi Fukumura as "one of the only double concertos for saxophone and orchestra in existence." Putting a fine point on the evening's Valentine's Day theme, Kovalev and Zhang turned out to be not only a married couple but also expecting their first child. The easy rapport between the two horn virtuosos was both palpable and charming and the piece lived up to its composer's description as "light romantic," perfectly exemplifying the date-night vibe and resulted in a hearty standing ovation.

More whimsical and sonically unexpected was the duo's short encore performance of a piece called "Slap Me" by composer Barry Cockcroft, which foregrounded Zhang's percussive "slap" reed technique, a sound more frequently heard in progressive jazz settings than at a classical concert. The pair's display of easygoing charisma and playful musicianship brought the first half of the concert to an enjoyable close.

The second half of the evening's program consisted of a rousing rendition of Pyotr Ilyich Tchaikovsky's Symphony No. 5 (1888). Described by Maestro Fukumura as "one of the most passionate and heartfelt pieces in classical music," it was the second-to-last symphony completed by the composer before his mysterious death in 1893 at age 53. As an artist in Russia in the late 19th century, Tchaikovsky found himself forced to balance his work between pressures from a prevalent Russian nationalism and his own European musical training. Regardless, the piece's emotional resonance is undeniable, and the ISO's alternately energetic and delicate performance brought a rapturous audience to its feet once again.

The next ISO concert is scheduled for March 3, featuring Mahler's Symphony No. 4 with renowned guest soloist Madison Leonard, soprano. □

Chicken in wine

Coq au vin is a nourishing cold-weather dish known for its tender meat and flavorful sauce

“Don’t look around. The leaves are brown. And the sky is a hazy shade of winter.”

It’s a dreary, frigid Saturday morning in Springfield, and I’m playing Simon and Garfunkel’s 1966 album “Bookends” as background music for my weekly chore ritual. My Saturday chores involve the stereotypical “husband duties” of vacuuming the carpet and emptying the wastebaskets. (Yes, I know, it’s a cliché, while my wife handles the more physically demanding tasks like scrubbing the toilet and tub, mopping the floors and doing all the bending and heavy lifting. To my credit, though, I do most of the cooking.)

For the past three weeks, my wife and I have been battling what feels like an endless cold or the flu, evidenced by wastebaskets overflowing with used tissues. She has sought medical attention twice, resulting in a course of Z-Pak and prednisone. I’ve opted to simply “tough it out” and am no worse off than she is. The cold temperatures and dreary, gray skies of Springfield are making me wistful for the warmer Florida winters we enjoyed while sheltering in place on our bus during the pandemic.

I’ve spent the past week immersed in a flurry of culinary preparations for my inaugural classes at the newly completed education building at Prairie Fruits Farm and Creamery in Champaign. The air in my kitchen is thick with the pungent aroma of microbial activity. Batches of tangy sauerkraut and fiery kimchi are actively fermenting, bubbling happily in their crocks, all destined to star in my introduction to lacto-fermentation class.

This weekend, I’m shifting from fermentation to preparing two large batches of ramen broth for the following week’s art of ramen class. I’ll be making tori chintan, a clear chicken broth that requires a gentle simmer for clarity, and tonkotsu, a rich, creamy pork broth that needs a vigorous, continuous boil to achieve its milky texture and deep flavor. The cold, single-digit weather we’re experiencing is beneficial, helping me cool and freeze all my finished stock.

Although the stock-making process is largely hands-off, it does require occasional monitoring. Battling a cold has left me low on energy, and as I plan the evening’s dinner, I’m craving something warm, comforting and not too labor-intensive. Looking at the abundance of chicken I bought for my tori chintan, I recalled a dish I enjoyed last November during my trip to France: *Coq au vin*.

Coq au vin is a deeply comforting and nourishing cold-weather dish, known for its tender meat and intensely flavorful sauce. Originating in the Burgundy region, the name literally means “cock in wine,” referring to its initial purpose: as a way making a delicious, tender meal from a tough old rooster. Traditional coq au vin required several hours of marination in red wine and a lengthy, slow braise to make it tender enough to chew. The acids in the wine helped denature the meat’s proteins.

Since I can’t get my hands on an old rooster, I’ll substitute dark meat (thighs and drumsticks) and braise the more tender chicken parts for a shorter time. I’ll make a recipe for four; my wife and I eat half tonight and have the leftovers as a quick meal next week. Coq au vin’s flavors actually deepen and improve the next day. The leftovers also reheat beautifully.

Coq au vin

Traditional coq au vin includes lardons, mushrooms and pearl onions. Lardons are made from salt-cured pork belly cut into matchsticks or cubes. Salt-cured pork belly isn’t easily available here; slab bacon makes a good substitute. Buy pre-peeled frozen pearl onions to avoid the hassle of peeling.

Four servings

Ingredients:

2 tablespoons good olive oil
¼ pound slab bacon, cut into matchsticks
4 bone-in, skin-on thighs or drumsticks
2 medium carrots, cut diagonally into 1-inch pieces
Kosher salt and freshly ground black pepper
1 medium yellow onion, sliced
1 teaspoon chopped garlic

½ bottle dry red wine
1 cup good chicken stock, preferably homemade
10 fresh thyme sprigs
2 tablespoons unsalted butter, at room temperature
1 ½ tablespoon all-purpose flour
1 cup frozen pearl onions
½ pound cremini mushrooms, stems removed and thickly sliced

Preparation:

Preheat the oven to 275 F (or 250 F if using a convection oven)

Pat the chicken dry with paper towels.

Season all over with salt and pepper.

Heat the olive oil in a large Dutch oven over medium heat. Add the bacon until lightly browned, about eight minutes. Remove with a slotted spoon and transfer to a plate, then add the chicken pieces to the Dutch oven in a single layer, skin-side down. When nicely browned, turn over and repeat on the other sides. Transfer to the plate with the bacon.

Cook the carrots and onions in the pan over medium heat for 10 to 12 minutes, stirring occasionally, until the onions are lightly browned. Season with 2 teaspoons of salt and 1 teaspoon of pepper. Stir in the garlic and cook for an additional minute.

Return the chicken (skin-side down in one layer), the bacon, and any accumulated juices back into the pot. Pour in the wine and chicken stock, then add the thyme and bring the mixture to a simmer. Cover the pot tightly and transfer to the oven for 30 to 40 minutes, or until the chicken is no longer pink. Once cooked, remove the pot from the oven and place it on the stovetop.

Make a *beurre manié*: Mash the butter and flour together into a paste, then stir it into the braising liquid. Add the frozen pearl onions.

In a dry skillet, cook the mushrooms over medium-high heat until they release their liquid and begin to brown, stirring occasionally. Add these browned mushrooms to the stew. Bring the stew to a simmer and continue to cook for 10 minutes. Finally, taste the broth and adjust the seasoning with salt and pepper as necessary.

Serve hot with potatoes, noodles, or crusty bread to soak up the sauce.

Coq au vin can be refrigerated for up to three days. Before reheating, the sauce should be degreased. This can be done by spooning out the congealed fat. To reheat, turn the chicken pieces skin-side up and bake in the oven for 30 minutes at 325 F. □

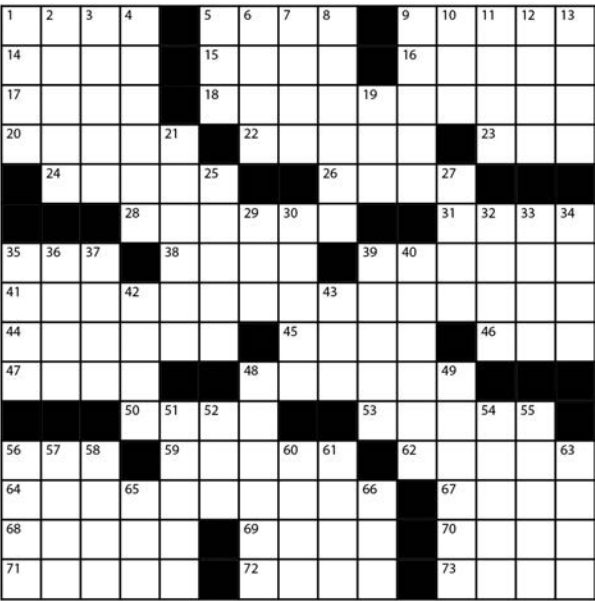
